RACING INCIDENTS
(124 - 131)

GOING : Good

PENETROMETER READING : 4.1 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 124. The Turf Authorities of India Trophy - (About) 1800 metres. Horses rated 40 to 65 (7 Runners).

SERDAR (Y. S. Srinath) ran detached from the field. The horse was subjected to veterinary examination. On examination, it was found to be lame on right fore and burst its blood vessels (on endoscopy Grade - III). Trainer Mr. J.S. Pillay was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f INSPIRE.

2nd Race: 125. The Indian Pattern Committee Trophy - Div. I - (About) 1200 metres. Horses rated 20 to 45 (11 Runners).

EXTRAORDINARY (N. B. Kuldeep) after jumping out did not raise a fluent gallop for the first 100 Metres. In view of its behaviour, Trainer Mr. Joseph B. Awale was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SIRA (R. Vaibhav) jumped awkwardly outwards onto ZIVA (Aleemuddin) soon after the start.

BELLAVITA (Y. S. Srinath) took a fly jump.

Jockey Akshay Kumar, the rider of MONEY BAGS was fined Rs.5,000/- for coming 'in ' and causing interference to the horses on his inside viz; MYSTIC CHARM (C.A.Brisson) and HIGGS BOSON (Angad) before passing the red marker post.

Jockey D'nuSingh Deora, the rider of GLORIOUS SPECTRE reported that he could not get a clear run in the final 100 Metres due to a closely packed field.

It was reported after the race that MYSTIC CHARM (C.A.Brisson) pulled up lame on right fore. Trainer Mr. M. Rajendra Singh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g MONEY BAGS.

3rd Race: 126. The Mumbai Cup - (About) 1200 metres. Horses rated 80 and above (9 Runners).

Routine Sample was taken for analysis from the winner b c UCHCHAIHSHRAVAS.

4th Race: 127. The Amokbash B. T. C. Anniversary Cup(Grade II) - (About) 1400 metres. 4 years old and over. (6 Runners).

Trainer Mr. A. Imran Khan was fined Rs.10,000/- by the Stewards for not declaring his charge BERRETTINI to start after having accepted with it to run in the above race.

Jockey Suraj Narredu, the rider of PRANA was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

AFRICAN GOLD (Akshay Kumar) was subjected to veterinary examination but no abnormality was reported.

Compulsory urine and blood samples were taken for analysis from the following I, II & III placed horses viz:

5th Race: 128. The Five Stars Shipping Million - (About) 1600 metres. Maiden 3-year-old Horses. (7 Runners).

It was observed that BAYCHIMO (A. Prakash) drifted out under pressure in the final 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b c BAYCHIMO.

6th Race: 129. The Zavaray S. Poonawalla Bangalore Summer Derby (Grade I) - (About) 2000 metres. 3-year-old Indian Horses (foaled in 2022) (16 Runners).

SOVEREIGN KING (Antony Raj S.) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Adhiraj Singh Jodha was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey K. Sai Kiran, the rider of NORTHERN WAVES was fined Rs.1,000/- for shifting out and causing interference to RED BISHOP (A. Sandesh) and SUNSHINE (S. Saqlain) on his outside approaching 1900 Metres.

Jockey Yash Narredu, the rider of MINDFUL was fined Rs.3,000/- for shifting 'in' and causing interference to SUNSHINE (S. Saqlain) and NORTHERN WAVES (K. Sai Kiran) on his inside passing the 1800 Metres.

Jockey Vivek.G, the rider of MOON STAR was fined Rs.3,000/- for shifting 'in' and tightening MIRACLE STAR (Neeraj Rawal), which in turn passed it onto FYNBOS (P. Trevor), whereby MINDFUL (Yash Narredu) and RED BISHOP (A. Sandesh) which were travelling directly behind also had to be checked by its respective riders on his inside approaching 1700 Metres.

Compulsory urine and blood samples were taken for analysis from the following I, II & III placed horses viz:

7th Race: 130. The Hyderabad Salver - (About) 1400 metres. Horses rated 40 to 65 (8 Runners).

DON CARLOS (P. Trevor) reared up as the gates opened and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Angad, the rider of HIDDEN DREAMS was fined Rs.25,000/- for riding in an injudicious manner, thereby contravening Rule No.161 (ii) of the B.T.C Rules of Racing in the above race.

Jockey Angad, the rider of HIDDEN DREAMS was fine Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

HIDDEN DREAMS (Angad) was subjected to veterinary examination. On examination, it was found to be lame on right fore and sustained injury on right hind fetlock. Trainer Mr. Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry was held by the Stipendiary Stewards into the interference caused by Jockey Shivam, the rider of SASSY in the above race. In that he shifted 'in' and caused severe interference to the horses on his inside viz; SIMOLA (P.Vikram), PROMISEOFTHEFUTURE (Pavan), MOUNTAIN JEWEL (Antony Raj S.) and ANIGRAHA (Hindu Singh) on his inside before passing the red marker post.

Jockey Shivam was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey Shivam and after viewing the CCTV replay decided to charge Jockey Shivam for Careless Riding.

The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to Shivam **for four (4) race days of BSM 2025 i.e., 26/07/2025, 27/07/2025, 31/07/2025 & 01/08/2025** as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount SASSY (he was permitted to ride work) and was informed of his right to appeal.

Routine Sample was taken for analysis from the winner ch g PROMISEOFTHEFUTURE.

8th Race: 131. The Indian Pattern. Committee Trophy - Div. II - (About) 1200 metres. Horses rated 20 to 45 (10 Runners).

FEELING GOOD (Vinod Shinde) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey K. Sai Kiran, the rider of SLICE OF LUCK placed 2nd by the judge objected against Jockey P. Trevor, the rider of FLAMING SWORD placed 1st for "In the last 400 Metres the winner interfered me badly, whereby I had to stop riding and lost 3 to 4 lengths which cost me a certain race". The Stewards held an enquiry immediately after the race and interviewed the Jockeys concerned. After deliberations, they decided to overrule the objection.

(A)

An enquiry was held by the Stipendiary Stewards into the interference caused by Jockey K. Sai Kiran, the rider of SLICE OF LUCK in the above race. In that soon after jumping out he tightened FEMME FATALE (A.Ramu) and CHISOX (Anish Anamo Hangal) on his inside, thereafter he has shifted 'in' and caused severe interference to the horses on his inside viz; THUTMOSE (Shivam), which in turn passed it onto to ECLIPSE PULSE (Vivek.G) passing the 1000 Metres.

Jockey K. Sai Kiran was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey K. Sai Kiran and after viewing the CCTV replay decided to charge Jockey K. Sai Kiran for Careless Riding.

The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to K. Sai Kiran **for two (2) race days of BSM 2025 i.e., 26/07/2025 & 27/07/2025** as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount SLICE OF LUCK (he was permitted to ride work) and was informed of his right to appeal.

(B)

An enquiry was held by the Stipendiary Stewards into the interference caused by Jockey P. Trevor, the rider of FLAMING SWORD in the above race. In that he shifted 'in' and caused severe interference to SLICE OF LUCK (K. Sai Kiran) approaching 350 Metres.

Jockey P. Trevor was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey P. Trevor and after viewing the CCTV replay decided to charge Jockey P. Trevor for Careless Riding.

The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to P. Trevor **on 26/07/2025** as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount FLAMING SWORD (he was permitted to ride work) and was informed of his right to appeal.

An enquiry is being held into the relative performance of GLAZE (Rajesh Kumar M), trained by Mr. Narayana Gowda V. in the above race as compared to its previous run in Race No. 41 i.e, The Aureole Time Plate - (About) 1200 metres. Horses rated 00 to 25 run on 01/06/2025 wherein it won.

Routine Sample was taken for analysis from the winner b g FLAMING SWORD.
