**RACING INCIDENTS**  
**(132 - 137)**

**GOING : Good**

**PENETROMETER READING : 4.1 Cms.**

**RAILING POSITION: Railing fixed at an average width of 6.5 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 132. The Amazing Grace Plate - (About) 1400 metres. Horses rated 00 to 25, 6 years old and over (8 Runners).**

Jockey Antony Raj S., the rider of MY SOLITAIRE was fined Rs.1,000/- for shifting 'in' and tightening the horses on his inside viz; SACRED CREATOR (Rajesh Kumar M) and RECREATOR (Girish R.) approaching 1200 Metres.

It was reported after the race that SACRED CREATOR (Rajesh Kumar M) returned bleeding from both nostrils. Trainer Mr. Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch m MY SOLITAIRE.

**2<sup>nd</sup> Race: 133. The Bold Gesture Plate - (About) 1200 metres. Horses rated 00 to 25 (Whips not allowed) (9 Runners).**

Permission was granted to Trainer Mr.S. Inayathulla to withdraw AMAZING STORM on veterinary grounds as it was found to be lame on right fore due to cellulitis on cannon region. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Permission was granted to Trainer Mr.V. Lokanath to withdraw GOLDEN GALLERY (Vivek.G) on veterinary grounds as it was found to be lame on left hind. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

As Jockey Ganesh Shingade was unable to fulfil his riding engagement due to reasons beyond control. Permission was granted to Trainer Mr. S. Narredu to declare Jockey Aleemuddin to ride GOLDEN GLORY in place of the declared rider.

Jockey Faiz, the rider of N R I GOLD was reprimanded for shifting 'in' and inconveniencing JULLY (Asirvatham) on his inside soon after the start.

Jockey Faiz, the rider of N R I GOLD was fined Rs.1,000/- for shifting 'in' and causing interference to the horses viz; WAKIZASHI (Dharshan Antony.B) and ABSOLUTE KATRINA (D'nuSingh Deora) on his inside approaching 900 Metres.

Jockey Pavan, the rider of SHE'S SO BEAUTIFUL reported that his mount was hanging 'in' from 300 Metres. The horse was impounded for veterinary examination but no abnormality was reported.

TOTALLY EPIC (Abhishek Mhatre) sustained clip injury on left knee.

JULLY (Asirvatham) sustained bleeding injury on left hind cannon.

Surprise sample was taken for analysis from b f SHE'S SO BEAUTIFUL.

Routine Sample was taken for analysis from the winner ch f GOLDEN GLORY.

**3<sup>rd</sup> Race: 134. The Yeravada Stud Plate - (About) 1400 metres. Horses rated 40 to 65, 4 years old and over (10 Runners).**

Jockey R. Robert, the rider of SCARLETTE LADY was fined Rs.1,000/- for not exercising sufficient control over his mount, thereby causing interference to RIEKO (K. Sai Kiran) soon after the start.

Jockey K. Sai Kiran, the rider of RIEKO was fined Rs.1,000/- for shifting 'in' and causing interference to DISCIPLE (Antony Raj S.) on his inside at the start.

Jockey A. Sandesh, the rider of CHARDIKALA was fined Rs.1,000/- for shifting 'in' and tightening MYSTIKOS (Neeraj Rawal), which in turn passed it onto DYNAMIC FORCE (C.Umesh) passing the 1200 Metres.

Jockey C.Umesh, the rider of DYNAMIC FORCE was fined Rs.1,000/- for shifting out and causing interference to the horses on his outside viz; DISCIPLE (Antony Raj S.) and SCARLETTE LADY (R. Robert) passing the 900 Metres.

Jockey M. Prabhakaran, the rider of BOOSTER SHOT reported that he accidentally struck the front runner DISCIPLE (Antony Raj S.) and stumbled passing the 900 Metres.

Jockey P. Trevor, the rider of AQUASTIC reported that his mount did not find its footings during race and accidentally stumbled passing the 800 Metres. The horse was impounded for veterinary examination but no abnormality was reported.

Jockey C. Umesh, the rider of DYNAMIC FORCE was reprimanded for shifting 'in' and inconveniencing DISCIPLE (Antony Raj S.) on his inside passing the 300 Metres.

BOOSTER SHOT (M. Prabhakaran) was subjected to veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b f AQUASTIC.

Routine Sample was taken for analysis from the winner b g RIEKO.

**4<sup>th</sup> Race: 135. The Dr. K.M. Srinivasa Gowda Memorial Cup - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (10 Runners).**

**It rained significantly before the start of 4<sup>th</sup> race.**

SANAYA (Darshan R.N) stood in the gates and lost many lengths at the start. In view of its behaviour, Trainer Mr.Bharath Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

BLUE STORM (Arvind Kumar. N) was slowly away and slightly swerved towards the left at the start. In view of its behaviour, Trainer Mr.Irfan Ghatala was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Vivek.G, the rider of VIBRANT QUEEN reported that his mount had a soft mouth and as such threw its head up between the 1000 Metres to 800 Metres.

Jockey Suraj Narredu, the rider of HUSANARA reported that his mount accidentally stumbled twice between the 750 Metres and 700 Metres.

Jockey Vinod Shinde, the rider of QUEENDOM was reprimanded for shifting out and inconveniencing BLUE PICASSO (C.Umesh) on his outside between the 950 Metres and 700 Metres.

It was observed that REPUBLICAN STAR (Koshi Kumar) inclined to run out between the 800 Metres and 700 Metres.

Jockey Antony Raj S., the rider of ROSALINE reported that he could not get a clear view due to the kick back of the track between the 800 Metres to 600 Metres.

Jockey Vinod Shinde, the rider of QUEENDOM reported that he could not get a clear view due to the kick back of the track between the 800 Metres to 600 Metres.

Jockey Darshan R.N, the rider of SANAYA reported that he could not get a clear view due to the kick back of the track between the 800 Metres to 600 Metres.

QUEENDOM (Vinod Shinde) was subjected to veterinary examination. On examination, it was found to have bit injury on left oral commissure. Trainer Mr. Prasanna Kumar was informed to take remedial measures before accepting with it again.

Routine Sample was taken for analysis from the winner ch f SCENT OF RAIN.

**5<sup>th</sup> Race: 136. The Karnataka Police Cup - (About) 1800 metres. Horses rated 60 to 85 (5 Runners).**

An enquiry is being held into the relative performance of VICTOR HUGO (Vivek.G), trained by Trainer Mr. Irfan Ghatala in the above race as compared to its previous run in Race No. 96 i.e, The Astronomic Plate - (About) 2000 metres. Horses rated 40 to 65 run on 29/06/2025 when ridden by Jockey L. Alex Rozario wherein it ran unplaced.

It was reported after the race that THE LEADER (Neeraj Rawal) returned bleeding from both nostrils. Trainer Mr.Azhar Ali was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SECRET SAINT (P. Trevor) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from dk b g SECRET SAINT

Routine Sample was taken for analysis from the winner b g VICTOR HUGO.

**Due to heavy rain, the underfoot conditions of the track was not conducive for racing, as such the Stewards of the Bangalore Turf Club Limited decided to postpone the last race of the day [i.e., 6<sup>th</sup> Race: 137. The Azhar Plate - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over] to tomorrow (i.e., 20/07/2025) before the first race at 01:30 P.M.**

**6<sup>th</sup> Race: 137. The Azhar Plate - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (12 Runners) held on Sunday, 20/07/2025 at 01:30 P.M.**

WOMAN AT WAR (Neeraj Rawal) jumped awkwardly outwards onto CONTINUES (K. Sai Kiran) soon after the start.

Jockey K. Sai Kiran, the rider of CONTINUES was fined Rs.2,000/- for shifting 'in' and continuously tightening WOMAN AT WAR (Neeraj Rawal) on his inside from the start till about 1300 Metres.

Jockey Anish Anamo Hangal, the rider of DOMINA reported that his mount stopped galloping in the final 150 Metres, thereby Jockey dismounted immediately after the winning post. On immediate examination by the clubs' Veterinary Officer, it was reported that DOMINA had collapsed and died.

CONTINUES (K. Sai Kiran) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (on Endoscopy Grade - III) & sustained superficial injury on right fore fetlock. Trainer Mr. Warren Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from ch g CONTINUES.

Routine Sample was taken for analysis from the winner gr f WINFIELD.
