BANGALORE SUMMER MEETING 2025 TWENTIETH DAY, SUNDAY, 20THJULY 2025 RACING INCIDENTS (138 - 143)

GOING: Soft

PENETROMETER READING: 4.7 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 138. The Flirting Vision Plate - Div. II - (About) 1100 metres. Horses rated 20 to 45 (8 Runners).

It rained heavily for about 15 Minutes before the start of the race.

ACANTHA (Y. S. Srinath) jumped awkwardly outwards and inconvenienced LORVEN'S GLORY (Shreyas Singh S) at the start.

Jockey Pavan, the rider of DAYS DATE reported that his mount accidentally stumbled passing the 600 Metres.

It was observed that HONEST DESIRE (Aleemuddin) drifted out under pressure in the final 150 Metres.

ACANTHA (Y. S. Srinath) sustained bleeding injury on left nostril.

Trainer Mr. M. Rajendra Singh and Jockey K. Sai Kiran were questioned regarding the running and riding of PURSUIT OF WEALTH in the above race.

The trainer stated that:-

- a) He had instructed the jockey to go to the front and do his best in the straight:
- b) His horse did not have the initial speed as to compared to the other runners in the race, the rider had to urge his mount as he was drawn badly and had to travel wide to obtain the forward position;
- c) The horse had performed well in the Mock Race with the Blinkers and Tongue Strap as such he fancied it to win in the above race.

The Jockey while corroborating the statements of the trainer added that despite him riding out his mount fully, he could only finish 3rd.

Their explanations were noted for future reference.

Routine Sample was taken for analysis from the winner b g MOST AND MORE.

2nd Race: 139. The Mamma's Mink Plate - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (10 Runners).

MUTUAL TRUST (P. Trevor) jumped awkwardly outwards onto STAR OF THE FUTURE (Tousif Khan) and MY HONEY (L. Alex Rozario) soon after the start.

ANNABELLE (Antony Raj S.) took a fly jump.

Jockey Darshan R.N, the rider of TYAARAA reported that his mount was running green throughout the race.

BEAUTY STAR (K. Sai Kiran) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f BEAUTY STAR.

3rd Race: 140. The Flirting Vision Plate - Div. I - (About) 1100 metres. Horses rated 20 to 45 (8 Runners).

ETERNAL GLORY (Vivek.G) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Salman Khan, the rider of D FRONX reported that the ground was very soft.

Jockey Vivek.G, the rider of ETERNAL GLORY was fined Rs.5,000/- for the excessive use of the whip on his mount during the race (2nd infringement).

Routine Sample was taken for analysis from the winner b f ETERNAL GLORY.

4th Race: 141. The Raja of Bobbili Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65, 6 years old and over (8 Runners).

GOLDEN TIME (Koshi Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Koshi Kumar, the rider of GOLDEN TIME was fined Rs.1,000/- for shifting out and causing interference to the horses viz; AUGUSTO (Arvind Kumar. N) and THE STRIKINGLY (K. Sai Kiran) on his outside passing the 1100 Metres.

Jockey Rushal G.A, the rider of KALLU SAKKARE was fined Rs.2,000/- for dropping hands in the final 250 Metres for no apparent reason.

KALLU SAKKARE (Rushal G.A) was subjected to veterinary examination but no abnormality was reported.

LADY INVICTUS (P. Trevor) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b m ARMORY.

5th Race: 142. The Bangalore St. Leger(Grade III) - (About) 2800 metres. Indian Horses 4 years old and over (Foaled in 2021 or before). (6 Runners).

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

6th Race: 143. The Aboline Plate - (About) 1200 metres. Horses rated 20 to 45, 6 years old and over (12 Runners).

As Jockey N. Tauseef Ahmed was unable to fulfill his riding engagement due to reasons beyond control. Permission was granted to Trainer Mr. Pradeep Annaiah to declare Jockey Afsar to ride SOLO PRINCE in place of the declared rider.

Jockey Shreyas Singh S replaced the indisposed Jockey K. Sai Kiran on THE GREY GERANIUM.

PRINCESS JASMINE (Suhas. K) took a fly jump.

Routine Sample was taken for analysis from the winner dk b g SUPER KIND.

Permission was granted to trainers M/s. Neil B. Devaney, S. Shobhan Babu and S.S. Attaollahi to deputize on behalf of trainers M/s. Prasanna Kumar, G.Y. Rajesh Babu and Adhiraj Singh Jodha who were unable to attend the races.

The Stipendiary Stewards reported Trainer Mr. Pradeep Annaiah to the Stewards for Contravention of Rule No. 114 (b) (i) of the B.T.C Rules of Racing in respect of his charge EAGLE EYE in the above race.

The Stewards at their meeting held on 18/07/2025 examined Trainer Mr. Pradeep Annaiah.

The Stewards considered the following:

- a) The Minutes of the Preliminary enquiry conducted by the enquiry officers;
- b) Charge sheet issued to Trainer Mr. Pradeep Annaiah by the Stipendiary Steward;
- c) The Submissions made by Trainer Mr. Pradeep Annaiah during the enquiry;

After deliberations, they decided as under: -

- a) To fine Trainer Mr. Pradeep Annaiah a sum of Rs.10,000/- for his negligence in discharge of his duties as a licenced professional, thereby contravening Rule No. 114 (b)(i) of the BTC Rules of Racing in respect of his charge EAGLE EYE.
- b) He was informed of his right to appeal.

(B)

The Stipendiary Stewards reported Assistant Trainer Mr. Raju Aradya under the care of Trainer Mr. Prasanna Kumar to the Stewards for Contravention of the written instructions issued to him while renewal of his Assistant Trainer's Licence for the year 2025-26.

The Stewards at their meeting held on 18/07/2025 examined Assistant Trainer Mr. Raju Aradya to Trainer Mr. Prasanna Kumar.

The Stewards considered the following:

- a) The Minutes of the Preliminary enquiry conducted by the enquiry officers;
- b) Charge sheet issued to Assistant Trainer Mr. Raju Aradya by the Stipendiary Steward;
- c) The Submissions made by Assistant Trainer Mr. Raju Aradya during the enquiry;

After deliberations, they decided as under: -

- a) To suspend the Assistant Trainer's Licence granted to Mr. Raju Aradya for two (2) race days of BSM 2025 i.e., (26/07/2025 & 27/07/2025) for Contravention of the written instructions issued to him while renewal of his Assistant Trainer's Licence for the year 2025-26.
- b) He was informed of his right to appeal.

(C)

The Stipendiary Stewards reported Trainer Mr. Prasanna Kumar to the Stewards for Contravention of Rule No. 114 (b) (i) of the B.T.C Rules of Racing with respect to lending his assistant trainer Mr. Raju Aradya's services to Trainer Mr. Pradeep Annaiah to saddle EAGLE EYE.

The Stewards at their meeting held on 18/07/2025 examined Trainer Mr. Prasanna Kumar who appeared on virtual call as he was not in station.

The Stewards considered the following:

- a) The Minutes of the Preliminary enquiry conducted by the enquiry officers;
- b) Charge sheets issued to Trainer Mr. Prasanna Kumar by the Stipendiary Steward;
- c) The Submissions made by Trainer Mr. Prasanna Kumar during the enquiry;

After deliberations, they decided as under: -

- a) To fine Trainer Mr. Prasanna Kumar a sum of Rs.10,000/- for his negligence in discharge of his duties as a licenced professional, thereby contravening Rule No. 114 (b)(i) of the BTC Rules of Racing.
- b) He was informed of his right to appeal.

SIXTH DAY, SUNDAY, 01ST JUNE 2025

Race: 41. The Aureole Time Plate - (About) 1200 metres. Horses rated 00 to 25.

The Stipendiary Stewards reported Trainer Mr. Narayana Gowda. V to the Stewards for Contravention of B.T.C Calendar Notification under the heading "Punishment to trainers by Stipendiary Steward / Stewards" for inconsistent running of his charge GLAZE.

The Stewards at their meeting held on 18/07/2025 examined Trainer Mr. Narayana Gowda. V and Mr. Shehzad Abbas (Spokesperson) for Trainer Mr. Narayana Gowda. V himself.

The Stewards considered the following:

- a) The Minutes of the Preliminary enquiry conducted by the enquiry officers;
- b) Chargesheet issued to Trainer Mr. Narayana Gowda. V by the Stipendiary Steward;
- c) The Submissions made by Trainer Mr. Narayana Gowda. V and Mr. Shehzad Abbas (Spokesperson) for Trainer Mr. Narayana Gowda. V during the enquiry;

The Stewards decided as under:

- 1. To fine Trainer Mr. Narayana Gowda. V a sum of Rs.10,000/- Contravention of B.T.C Calendar Notification under the heading "Punishment to trainers by Stipendiary Steward / Stewards" in respect of his charge GLAZE and severely reprimanded for future running of his charges.
- 2. He was informed of his right to appeal.

TWELFTH DAY, SUNDAY, 22ND JUNE 2025

Race: 78. The Guindy Plate - (About) 1200 metres. Horses rated 00 to 25.

An enquiry was held on 21/07/2025 by the Stipendiary Stewards pertaining to the running of MYSTIC CHARM (Md.Akram), trained by Mr. M. Rajendra Singh in the above race as compared to its previous run in Race No. 36 i.e., The Endorsement Plate - (About) 1600 metres. Maiden Horses 3 years old only run on 01/6/2025 wherein it ran unplaced. After due enquiry, Trainer Mr. M. Rajendra Singh was fined Rs.10,000/- for the inconsistent pattern of running of his charge MYSTIC CHARM in the above race.

THIRTEENTHDAY, SATURDAY, 28THJUNE 2025

(A)

Race: 89. The Malakpet Plate - Div. II - (About) 1300 metres. Horses rated 20 to 45.

The Stipendiary Stewards reported Trainer Mr. G.Y. Rajesh Babu for Contravention of Rule No. 202 of the BTC Rules of Racing pertaining to the difference in weight with respect to his charge ADELANTO.

The Stewards held an enquiry on 18/07/2025 and examined Spokesperson Mr. S.S. Attaollahi for Trainer Mr. G.Y. Rajesh Babu and Trainer Mr. G.Y. Rajesh Babu himself.

The Stewards considered the following:

- a) The Minutes of the Preliminary enquiry conducted by the enquiry officers;
- b) Charge sheet issued to Trainer Mr. G.Y. Rajesh Babu by the Stipendiary Stewards;
- c) The Submissions made by Spokesperson Mr. S.S. Attaollahi for Trainer Mr. G.Y. Rajesh Babu during the enquiry;
- d) Stewards review the previous weights of the horse records with reference to the difference in weight during the enquiry;
- e) The Stewards noted that Trainer Mr. G.Y. Rajesh Babu had not pleaded guilty to the alleged breach of Contravening Rule No. 202 of the BTC Rules of Racingas charged by the Stipendiary Steward.
- f) The Stewards also noted that sudden increase in weight of the horse could be attributed to the poor performance of the horse as the Spokesperson Mr. S.S. Attaollahi for Trainer Mr. G.Y. Rajesh Babu could not offer satisfactory explanations for the 12 kilos weight gain of the horse from the acceptance day to the race day.

In light of the above, the Stewards decided as under:

- To treat Mr. G.Y. Rajesh Babu as a disqualified person w.e.f 28/07/2025 to 28/06/2026 [Both days inclusive] for Contravention of Rule No. 202 of the BTC Rules of Racing pertaining to the difference in weight in respect of his charge ADELANTO.
- 2. He was informed of his right to appeal.

<u>(B)</u>

Race: 92. The Poonawalla Stud Plate - Div. I - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over.

The Stipendiary Stewards reported Trainer Mr. Narayana Gowda.V for Contravening Rule No. 159 (a) of the BTC Rules of Racing in respect of his charge LAUTERBRUNNEN and Jockey Rajesh Kumar.M to the Stewards for Contravening Rule No. 159 (b) of the B.T.C Rules of Racing on his mount LAUTERBRUNNEN.

The Stewards held an enquiry on 18/07/2025 and examined Jockey Rajesh Kumar. M and Mr. Shehzad Abbas (Spokesperson) for Trainer Mr. Narayana Gowda. V both themselves.

The Stewards considered the following:

- a) The Minutes of the Preliminary enquiry conducted by the enquiry officers;
- b) Charge sheets issued to Trainer Mr. Narayana Gowda. V and Jockey Rajesh Kumar. M by the Stipendiary Stewards;
- c) The Submissions made by Spokesperson Mr. Shehzad Abbas (Spokesperson) for Trainer Mr. Narayana Gowda. V and Jockey Rajesh Kumar. M during the enquiry;

- d) Stewards viewed various angles of the race with specific reference to the running and riding of Jockey Rajesh Kumar. M in the above race;
- e) The Stewards noted that Trainer Mr. Mr. Narayana Gowda. V had not pleaded guilty to the alleged breach of Contravening Rule No. 159 (a) of the BTC Rules of Racing as charged by the Stipendiary Steward.
- f) The Stewards noted that Jockey Rajesh Kumar. M had not pleaded guilty to the alleged breach of Contravening Rule No. 159 (b) of the BTC Rules of Racing as charged by the Stipendiary Steward.

Thereafter, the Stewards unanimously decided that Jockey Rajesh Kumar. M was "Guilty" as charged in the matter.

In light of the above, the Stewards decided as under:

- (a) To treat Jockey Rajesh Kumar.M as a disqualified person w.e.f **28/07/2025 to 28/01/2026 [Both days inclusive]** for Contravening Rule No. 159 (b) of the BTC Rules of Racing on his mount LAUTERBRUNNEN (He is not permitted to ride work).
- (b) To fine Trainer Mr. Narayana Gowda.V a sum of **Rs.50,000/-** for the Unsatisfactory running of his charge LAUTERBRUNNEN.
- (c) They were informed of their right to appeal to the Board of Appeal.
