

**BANGALORE SUMMER MEETING 2025**  
**TWENTYSECOND DAY, SUNDAY, 27<sup>TH</sup>JULY 2025**

**RACING INCIDENTS**

**(151- 157)**

**GOING : Soft**

**PENETROMETER READING : 4.6 Cms.**

**RAILING POSITION: Railing fixed at an average width of 3.5 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 151. The Lively Emprey Plate - (About) 1200 metres. Horses rated 00 to 25, 5 years old and over (Whips not allowed) (8 Runners).**

Permission was granted to Trainer Mr.Md Sajid Qureshi to withdraw N R I MILLENNIUM (D'nuSingh Deora) on veterinary grounds as it was found to be lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ESTEFANIA (Aleemuddin) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Arjun Mangalorkar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Pavan, the rider of PHOENIX SURPRISE was fined Rs.3,000/- for not making sufficient effort on his mount from the start till about 600 Metres.

Trainer Mr. Warren Singh was fined Rs.10,000/- for the inconsistent pattern of running of MEGHANN (Laxman Singh) in the above race as compared to its previous run in Race No. 133 i.e, The Bold Gesture Plate - (About) 1200 metres. Horses rated 00 to 25 (Whips not allowed), run on 19/07/2025 wherein it ran unplaced.

Routine Sample was taken for analysis from the winner b m MEGHANN.

**2<sup>nd</sup> Race: 152. The Camineto Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 (8 Runners).**

SILICON STAR (A.Ramu) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Warren Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey P. Trevor, the rider of CASCAIS reported that his mount was hanging 'in' throughout the race. The horse was subjected to veterinary examination. On examination, it was found to have bleeding from both nostrils. Trainer Mr. Azhar Ali was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Shreyas Singh S, the rider of TEMPERANCE reported that his mount was not galloping fluently after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

It was reported after the race that WHITNEY (L. Alex Rozario) pulled up lame on right hind and sustained clip injury on right hind tendon. Trainer Mr. S. Dominic was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SILICON STAR (A. Ramu) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b f SILICON STAR.

Routine Sample was taken for analysis from the winner b g ROYAL DECCAN.

**3<sup>rd</sup> Race: 153. The Esquire Plate - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (12 Runners).**

GET SET GO (Salman Khan) after jumping out slightly swerved towards the left. In view of its behaviour, Trainer Mr. Pradeep Annaiah was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Hindu Singh, the rider of DIVINE RIGHT reported that his mount was hanging out throughout the race and ran detached. The horse was subjected to veterinary examination. On examination, it was found to have bit injury on left oral commissure. Trainer Mr. Vijay Singh was informed to take remedial measures before accepting with it again.

Jockey Salman Khan, the rider of GET SET GO reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Pradeep Annaiah was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b f ROMPING HOME.

**4<sup>th</sup> Race: 154. The Salazaar Plate - (About) 1200 metres. Horses rated 60 to 85 (11 Runners).**

DUN IT AGAIN (Koshi Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Laxman Singh, the rider of GRIZZLY was fined Rs.1,000/- for shifting 'in' and causing interference to MAZAL TOV (P. Trevor) on his inside passing the 1100 Metres.

Jockey Laxman Singh, the rider of GRIZZLY was severely reprimanded for the inept handling of his mount in presence of Master Trainer Mr. Warren Singh.

Routine Sample was taken for analysis from the winner dk b f EXCELLENT LASS.

**5<sup>th</sup> Race: 155. The Admiral Henry John Rous Trophy - (About) 1400 metres. Horses rated 40 to 65 (6 Runners).**

Permission was granted to Trainer Mr. Rajesh Narredu to withdraw SENSATIONAL (A.A. Vikrant) on veterinary grounds as it was found to have tendinitis on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Vinod Shinde replaced the indisposed Jockey A.R. Pradeep on ELFIN KNIGHT.

POLE STAR (Vivek.G) bolted on the way to the starting gates along with the rider and completed one full round on the inner sand track. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Prasanna Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Vinod Shinde, the rider of ELFIN KNIGHT reported that he had to steady his mount to avoid striking the front runner SIR WINSTON (Neeraj Rawal) passing the 850 Metres.

Jockey P. Trevor, the rider of CIRCLE OF DREAMS was reprimanded for shifting 'in' and inconveniencing ELFIN KNIGHT (Vinod Shinde) on his inside passing the 300 Metres.

It was observed that POWER OF BEAUTY (Antony Raj S.) was lugging 'in' under pressure in the final 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

ASAGIRI (Darshan R.N) was subjected to veterinary examination but no abnormality was reported.

CIRCLE OF DREAMS (P. Trevor) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b c CIRCLE OF DREAMS.

Routine Sample was taken for analysis from the winner b g POWER OF BEAUTY.

**6<sup>th</sup> Race: 156. The Karnataka Mile Championship Cup - (About) 1600 metres. 4 years old and over. (4 Runners).**

MAYNE MAGIC (Antony Raj S.) accidentally stumbled soon after jumping out of the starting gates.

Routine Sample was taken for analysis from the winner dk b g MAYNE MAGIC.

**7<sup>th</sup> Race: 157. The Camineto Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45 (8 Runners).**

MUTUAL TRUST (P. Trevor) while jumping out brushed the right side of starting gates, slowly away and lost considerable ground. In view of its behaviour, Trainer Mr.S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Vivek.G, the rider of CARAT LOVE was fined Rs.5,000/- for shifting 'in' and causing interference to the horses on his inside viz; BOLD ACT (G. Praveen) and TRUE PUNCH (Antony Raj S.) approaching 900 Metres.

Jockey Abhishek Mhatre, the rider of SIRA reported that his mount was hanging out and not galloping fluently throughout the race. The horse was subjected to veterinary examination. On examination, it was found to have sustained superficial injury on right fore coronet and bit injury on left oral commissure. Trainer Mr. M.Eshwer was informed to take appropriate corrective measures before accepting with it again.

It was reported after the race that BOLD ACT (G. Praveen) pulled up lame on right fore. Trainer Mr. S.Narredu was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

JOYFUL SPIRIT (Shreyas Singh S) sustained injury on right hock.

Routine Sample was taken for analysis from the winner b f ELEANORA.

**ADDITONAL REPORT**

**BANGALORE SUMMER MEETING 2025**

**SEVENTEENTH DAY, SATURDAY, 12<sup>TH</sup> JULY 2025**

**6<sup>th</sup> Race: 121. The Coromandel Gromor Bangalore Million - (About) 1400 metres. 3-year-old horses (foaled in 2022) (8 Runners).**

An enquiry was held on 28th July, 2025 by the Stipendiary Stewards for the above race with respect to Jockey Yash Narredu pertaining to his riding on his mount BIG BAY, "In that he has not alert at the start, it is evident that between the 450 Meters and 350 Metres he could have made a move on the inside where there was a gap and ridden out his mount".

Jockey Yash Narredu was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Yash Narredu and after viewing the CCTV decided to charge Jockey Yash Narredu for riding in an Injudicious Manner.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Yash Narredu **for the first two (2) race days of BWM 2025-26** as he had pleaded guilty of the charge under Rule No. 161 (ii) of the BTC Rules of Racing for Injudicious Riding on his mount BIG BAY (he was permitted to ride work) and was informed of his right to appeal.
