# BANGALORE SUMMER MEETING 2025 TWENTYTHIRD DAY, THURSDAY, 31st JULY 2025 RACING INCIDENTS

**(158 - 166)** 

**GOING: Good** 

PENETROMETER READING: 3.1 Cms.

RAILING POSITION: Railing fixed at an average width of 6.0 Meters from

1600 Meters to winning post from its original position.

1<sup>st</sup> Race: 158. The Own Opinion Plate - Div. II - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (9 Runners).

Trainer Mr. Darius R. Byramji was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge PLEDGE (Akshay Kumar) (1st infringement).

Jockey Darshan R.N, the rider of RESPLENDENCE reported that his mount raced very keenly from 1300 Metres till about 800 Metres.

Jockey Suraj Narredu, the rider of UNFORGETTABLE STAR was fined Rs.5,000/- for the excessive use of the whip on his mount during the race (2nd infringement).

It was reported after the race that LAAMIKA (Vivek.G) returned bleeding from both nostrils. Trainer Mr. V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g UNFORGETTABLE STAR.

#### 2<sup>nd</sup> Race: 159. The Sha Tin Plate - (About) 1400 metres. Horses rated 00 to 25 (9 Runners).

RISING FORM (S. Sachin) was extremely fractious and dropped the rider on the way to the starting gates. On immediate examination by the Club's Veterinary Officer, it was found to have sustained injuries on left hind fetlock and the left hind shoe had splayed. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Imtiaz Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SATIN LASS (Tousif Khan) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Dominic was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Antony Raj S., the rider of MEGA SUCCESS was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Jockey D. Patel, the rider of WOMAN AT WAR was reprimanded for taking an unduly long lead during the race.

ICE STORM (Angad) sustained Clip injury on left hind fetlock.

WOMAN AT WAR (D. Patel) sustained clip injury on right hind fetlock.

Routine Sample was taken for analysis from the winner b g MEGA SUCCESS.

3<sup>rd</sup> Race: 160. The Own Opinion Plate - Div. I - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (8 Runners).

Jockey Siddaraju.P, the rider of CASHABLE was fined Rs.1,000/- for shifting 'in' and causing interference to XANTHE (P. Trevor) on his inside passing the 900 Metres.

Jockey Arvind Kumar. N, the rider of DARRINGTON was reprimanded for shifting out and inconveniencing KONKRAH (A. Sandesh) on his inside passing the 300 Metres.

Jockey P. Trevor, the rider of XANTHE was fined Rs.1,000/- for shifting 'in' and tightening SKAGEN (Vivek.G) on his inside in the final 200 Metres.

Routine Sample was taken for analysis from the winner b f XANTHE.

# 4<sup>th</sup> Race: 161. The Baraloy Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).

Jockey Angad, the rider of RANSOMWARE was fined Rs.1,000/- for shifting out and causing interference to CARTER (V.R.Jagadeesh), which in turn passed it onto VIBRANT QUEEN (Antony Raj S.) and DR. COLCHESTER (Vinod Shinde) on his outside soon after the start.

Jockey V.R.Jagadeesh, the rider of CARTER reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have bit injury on left oral commissure. Trainer Mr. Md Sajid Qureshi was informed to take remedial measures before accepting with it again.

Jockey Tousif Khan, the rider of NOBLE CAUSE was fined Rs.1,000/- for shifting out and taking out AMAZING STRIDE (P. Trevor) on his outside approaching 200 Metres.

It was reported after the race that AMAZING STRIDE (P. Trevor) returned bleeding from both nostrils. Trainer Mr. S. Padmanabhan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry was held by the Stipendiary Stewards into the excessive use of whip by Jockey P. Trevor on his mount AMAZING STRIDE (3rd infringement) in the above race, thereby Contravening the B.T.C Calendar Notification under the heading "USE OF WHIP".

#### "In that:

- (a) He use the whip in excess in the above race of Bangalore Summer Meeting 2025, on his mount AMAZING STRIDE, this being the 3rd offence during the season;
- (b) He use the whip in excess in Race No.83 of Bangalore Summer Meeting 2025, on his mount RED BISHOP (1st offence);
- (c) He use the whip in excess in Race No.101 of Bangalore Summer Meeting 2025, on his mount DUBAI SAFARI (2nd offence)".

The Stipendiary Stewards after considering the submissions made by Jockey P. Trevordecided to suspend the Jockeys licence granted to him for the **first two (2)** race days of Bangalore Winter Meeting 2025-26 for contravening Calendar Notification under the heading "USE OF WHIP" on his mount AMAZING STRIDE (he is permitted to ride work) and he was informed of his right to appeal.

Routine Sample was taken for analysis from the winner b g AMAZING STRIDE.

#### 5<sup>th</sup> Race: 162. The Holding Court Plate - (About) 1600 metres. Horses rated 20 to 45 (9 Runners).

FINAL CALL (Ramswarup) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr.S. Padmanabhan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Ramswarup, the rider of FINAL CALL was fined Rs.1,000/- for shifting out and taking out CR SEVEN (Angad) on his outside passing the 900 Metres.

It was observed that GLORIOUS STRIDES (Suraj Narredu) accidentally stumbled passing the 200 Metres.

It was reported after the race that GLORIOUS STRIDES (Suraj Narredu) pulled up lame on left fore. Trainer Mr. S. Narredu was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner gr f WINFIELD.

# 6<sup>th</sup> Race: 163. The B.T.C. Workforce Cup - (About) 1600 metres. Horses rated 40 to 65 (7 Runners).

It was reported by the Club's Veterinary Officer that FOREST FRAGRANCE (A. Sandesh) was consistently kicked on left hind cannon and suspensory ligament by the horse from adjacent stall which had reared up and flipped over. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Vijay Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

GORDON (A.A. Vikrant) reared up, flipped over inside the stalls and was stuck for a considerable period of time, in the process the bridle had come off. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order. In view of its repeated unruly behaviour, Trainer Mr. Rajesh Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least **two Mock Races.** 

Jockey P. Trevor, the rider of LUX AETERNA reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have bit injury on left oral commissure. Trainer Mr. S.S. Attaollahi was informed to take remedial measures before accepting with it again.

INDIAN JACK (Koshi Kumar) sustained superficial clip injuries on both hind pastern.

ALAMGIR (Neeraj Rawal) sustained superficial clip injury on left hind pastern.

Routine Sample was taken for analysis from the winner b f INSPIRE.

# 7<sup>th</sup> Race: 164. The Bangalore Summer Million - (About) 1600 metres. 3-year-old horses(foaled in 2022). (5 Runners).

Routine Sample was taken for analysis from the winner b f MIRACLE STAR.

# 8<sup>th</sup> Race: 165. The Baraloy Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45 (8 Runners).

POSITIVITY (M. Prabhakaran) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.S. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

DR ASH (Salman Khan) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr. G. Y. Rajesh Babu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Antony Raj S., the rider of PERFECT ATTITUDE reported that his mount was hanging 'in' throughout the race. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Arjun Mangalorkar was informed to take appropriate corrective measures before accepting with it again.

Jockey Girish R., the rider of VICTORIARAYA was fined Rs.2,000/- for the improper use of whip on his mount during the race.

Routine Sample was taken for analysis from the winner dk b f FLIGHT OF FANCY.

### 9<sup>th</sup> Race: 166. The Confucious Plate - (About) 1400 metres. Horses rated 40 to 65, 5 years old and over (9 Runners).

DISRUPTOR (Siddaraju.P) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr.Imtiaz Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

At the request of trainer Mr. Umar Shariff. S, endoscopy was performed on BAASHHA (Shreyas Singh S) at 05:30 P.M. and found no abnormality was reported.

Routine Sample was taken for analysis from the winner ch g VYASA.
