RACING INCIDENTS

(167 - 174)

GOING : Good

PENETROMETER READING : 3.4 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 167. The Champion Trainer Cup - (About) 1600 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible)(6 Runners).

PRISTINE GLORY (A. Sandesh) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr. Karthik Ganapathy was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

APHELION (K. Sai Kiran) ran detached in the final 200 Metres. Trainer Mr. Pradeep Annaiah was informed to ensure better performance of his charge in future.

STAR STUDDER (Suraj Narredu) pulled up its left testicle.

Routine Sample was taken for analysis from the winner b c TOLKIEN.

2nd Race: 168. The Sayonara Plate - (About) 1600 metres. Horses rated 00 to 25 (8 Runners).

Routine Sample was taken for analysis from the winner b m SEA DIAMOND.

3rd Race: 169. The Racing Officials Cup - (About) 1400 metres. Horses rated 20 to 45, 6 years old and over (Whips not allowed) (9 Runners).

Permission was granted to Trainer Mr. Pradeep Annaiah to withdraw AUGUSTO (Arvind Kumar. N) on veterinary grounds as it was found to have urticaria. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

PERIDOT (Antony Raj S.) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr. Imtiaz Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey A.R.Pradeep, the rider of SUNDANCE KID reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.K. Purshotham was informed to take appropriate corrective measures before accepting with it again.

Jockey R. Robert, the rider of DOUBLE VISION was reprimanded for shifting 'in' and inconveniencing SUNDANCE KID (A.R.Pradeep) on his inside approaching 250 Metres.

SOUTHERN DYNASTY (Abhishek Mhatre) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g EL ALAMEIN.

4th Race: 170. The Champion Jockey Cup - Div. I - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).

As Jockey Ramswarup was unable to fulfil his riding engagement due to reasons beyond control. Permission was granted to trainer Mr.G. Y. Rajesh Babu to declare Jockey Vishwa. V to ride IL VOLO in place of the declared rider.

BELLAVITA (Y. S. Srinath) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.K. Purshotham was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

STAR SERENADE (Darshan R.N) walked out of the gates and lost many lengths at the start. In view of its behaviour, Trainer Mr.Rajesh Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

THESSALIAN (Darshan N) took a fly jump, thereby the rider was totally unbalanced soon after the start.

CARAT LOVE (Neeraj Rawal) jumped awkwardly outwards.

Jockey P. Trevor, the rider of BASILICA was reprimanded for shifting out and inconveniencing ANZAC PARADE (Abhishek Mhatre) on his outside approaching 450 Metres.

Jockey Abhishek Mhatre, the rider of ANZAC PARADE reported that he accidentally lost his whip passing the 100 Metres.

It was reported after the race that STAR SERENADE (Darshan R.N) returned bleeding from both nostrils. Trainer Mr. Rajesh Narredu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

GOLDEN GLORY (Aleemuddin) sustained clip injury on right hind cannon.

THESSALIAN (Darshan N) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch f BASILICA.

5th Race: 171. The Leading Stud Cup - (About) 1400 metres. Horses rated 80 and above (7 Runners).

Trainer Mr. Arjun Mangalorkar was fined Rs.10,000/- by the Stewards for not declaring his charge NEVER GIVE IN to start after having accepted with it to run in the above race.

Routine Sample was taken for analysis from the winner b g MANDARINO.

6th Race: 172. The Governor's Cup(Grade III) - (About) 2400 metres. 4 years old and over. (6 Runners).

MESCALITO (J. Chinoy) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

RAMIEL (A. Sandesh) reared up as the gates opened.

Jockey Neeraj Rawal, the rider of RISE AND REIGN reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr.Rajesh Narredu was informed to take appropriate corrective measures before accepting with it again.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

7th Race: 173. The Leading Owner Cup - (About) 1200 metres. Horses rated 40 to 65, 6 years old and over (11 Runners).

As Jockey Ramswarup was unable to fulfil his riding engagement due to reasons beyond control. Permission was granted to trainer Mr.Narayana Gowda V. to declare Jockey Asirvatham to ride LAUTERBRUNNEN in place of the declared rider.

Jockey J. Chinoy, the rider of BEZAWADA SULTAN was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Jockey A.R.Pradeep, the rider of MACRON reported that he accidentally lost his whip passing the 300 Metres.

Jockey K. Sai Kiran, the rider of THE STRIKINGLY was reprimanded for riding an indifferent race.

WELLINGTON (P. Trevor) sustained clip injury on left hock.

Routine Sample was taken for analysis from the winner dk b g BEZAWADA SULTAN.

8th Race: 174. The Champion Jockey Cup - Div. II - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).

As Jockey L. Alex Rozario was certified medically unfit to ride. Permission was granted to trainer Mr.S. Dominic to declare Jockey Hindu Singh to ride RAFFLES in place of the declared rider.

Jockey Shreyas Singh S replaced the indisposed Jockey Koshi Kumar on GOLDEN BEAST.

GOLDEN BEAST (Shreyas Singh S) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr.Umar Shariff. S was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

HABIBTI (Antony Raj S.) jumped awkwardly outwards.

Jockey V.R.Jagadeesh, the rider of DAYS DATE reported that his mount raced very keenly, in the process he shifted out and inconvenienced HIGGS BOSON (Angad) between the 950 Metres and 850 Metres.

Jockey Vinod Shinde, the rider of DIVO reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr.S.Shoban Babu was informed to take appropriate corrective measures before accepting with it again.

Jockey Angad, the rider of HIGGS BOSON was reprimanded for riding an indifferent race.

Jockey Vinod Shinde, the rider of DIVO was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

MEHRA (Y. S. Srinath) sustained abrasions on both nostrils.

Routine Sample was taken for analysis from the winner b c SMALL DREAMS.

Permission was granted to trainer Mr. Neil B. Devaney to deputize on behalf of trainer Mr. Prasanna Kumar who was unable to attend the races.

ADDITIONAL REPORT

BANGALORE SUMMER MEETING 2025

SIXTEENTH DAY, SUNDAY, 6TH JULY 2025

Race: 115. The Southern Empire Plate - (About) 1400 metres. Horses rated 20 to 45, 6 years old and over.

The Stipendiary Stewards reported Trainer Mr. Warren Singh for Contravening Rule No. 159 (a) & (b) of the BTC Rules of Racing in respect of his charge THE GOLDEN DREAM and Jockey A.R. Pradeep to the Stewards for Contravening Rule No. 159 (a) & (b) of the B.T.C Rules of Racing on his mount THE GOLDEN DREAM.

The Stewards held an enquiry on 28/07/2025 and examined Trainer Mr. Warren Singh and Spokesperson Mr. Darius R. Byramji for Jockey A.R. Pradeep and Jockey A.R. Pradeep himself.

The Stewards considered the following:

- a) The Minutes of the Preliminary enquiry conducted by the enquiry officers;
- b) Charge sheets issued to Trainer Mr. Warren Singh and Jockey A.R. Pradeep by the Stipendiary Steward;
- c) The Submissions made by Trainer Mr. Warren Singh and Spokesperson Mr. Darius R. Byramji for Jockey A.R. Pradeep during the enquiry;
- d) Stewards viewed various angles of the race with specific reference to the riding of Jockey A.R. Pradeep in the above race;
- e) The Stewards noted that Trainer Mr. Warren Singh had not pleaded guilty to the alleged breach of Contravening Rule No. 159 (a) & (b) of the BTC Rules of Racing as charged by the Stipendiary Steward.
- f) The Stewards noted that Jockey A.R. Pradeep had not pleaded guilty to the alleged breach of Contravening Rule No. 159 (a) & (b) of the BTC Rules of Racing as charged by the Stipendiary Steward.

After deliberations, the Stewards were of the unanimous opinion that Trainer Mr. Warren Singh and Jockey A.R. Pradeep were "**Guilty**" as charged in the matter.

In light of the above, the Stewards decided as under:

- (a) To treat Trainer Mr. Warren Singh as a disqualified person w.e.f **06/08/2025 to 05/08/2026 [Both days inclusive]** for Contravening Rule No. 159 (a) & (b) of the BTC Rules of Racing in respect of his charge THE GOLDEN DREAM.
- (b) To treat Jockey A.R. Pradeep as a disqualified person w.e.f **06/08/2025 to 05/08/2026 [Both days inclusive]** for Contravening Rule No. 159 (a) & (b) of the BTC Rules of Racing on his mount THE GOLDEN DREAM (He is not permitted to ride work).
- (c) They were informed of their right to appeal to the Board of Appeal.
