

BANGALORE WINTER MEETING 2012-2013

RACING INCIDENTS

(1- 9)

Going : Soft

Penetrometer Reading : 5.3 Cms.

(No False Rails)

1st Race: 1. The Inauguration Plate – Div.II-(About) 1100 Metres. Maiden Indian Horses 3 years old only (Terms) (12 Runners).

Trainer Mr. J. Babu Rao was fined Rs.5,000/- for the discrepancy in shoeing in respect of his charge CHE GUEVARA (S. Shiva Kumar) (1st infringement).

MULLIGAN (Santosh Kumar Paswan) jumped awkwardly outwards from the starting gates.

Jockey K. Raja Rao, the rider of MASTERY, was fined Rs.5,000/- for his negligence in galloping his horse till approaching the 400 Metres when his mount had suffered a stifle lock of right hind soon after jumping out of the starting gates. The rider dismounted only after passing the 400 Metres. On immediate veterinary examination by the Club's Veterinary Officer, it was found to have pulled up lame on right hind. Subsequently it was reported that the horse died in the afternoon of the race day.

MULLIGAN (Santosh Kumar Paswan) ran detached from the field. Trainer Mr. Pradeep Annaiah was informed to ensure better performance of his charge in future.

It was observed that TRUST ME BOY (Tauseef Ahmed) suddenly shifted in approaching the 200 Metres. The horse was impounded for veterinary examination and no abnormality was reported. However, trainer Mr. Amit Caddy was informed to take appropriate corrective measures before accepting with it again.

GOL MATOL (Frco F DaSilva) sustained cut injury on right hind pastern.

2nd Race : 2. The COrdon Bleu Plate – (About) 1200 Metres. Horses rated 20 to 45, 4 year old and over (11 Runners).

Permission was granted to trainer Mr. J. Babu Rao to withdraw INDIAN (S. Shiva Kumar) on veterinary grounds as it was found to be suffering from fever. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

RAJA'S PET (A.R. Pradeep) was slowly away and lost few lengths at the start. In view of its behaviour Trainer Mr. Warren Singh was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in one jump out on a starting gate practice day.

Jockey M. Noornabi, the rider of SHADES OF SCARLET, was fined Rs.3,000/- for not making sufficient effort to improve his position between the 400 Metres and 200 Metres.

Jockey A.R. Pradeep, the rider of RAJA'S PET, was fined Rs.1,000/- for shifting out and taking out HATCHET HARRY (M. Kumar) which in turn passed it on to ANOTHER VOICE (M.D. Praveen) rounding the final bend.

Jockey A. Ashok Kumar, the rider of ASTONISHING, was fined Rs.1,000/- for shifting in and causing interference to SUPERIOR EDGE (K. Raja Rao) on his inside passing the 300 Metres.

3rd Race: 3. The Inauguration Plate – Div.I-(About) 1100 Metres. Maiden Indian Horses 3 years old only (Terms) (11 Runners).

Permission was granted to Trainer Mr. Arjun Mangalorkar to withdraw AFFRIKAH on veterinary grounds as it was found to be lame on right hind due to sprained stifle. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

JERUSALEM (Suraj Narredu) was examined at the starting gates by the Club's Veterinary Officer and was found to be lame on right fore. Under the circumstances it was permitted to be withdrawn on veterinary grounds before coming under Starter's orders.

Jockey M. Ravi, the rider of ASSURANCE, was fined Rs.5,000/- for not making sufficient effort on his mount during the race.

Jockey K. Raja Rao, the rider of AIR DISPLAY, was fined Rs.3,000/- for not persevering with his mount during the race.

BALANCE OF NATURE (P. Ramesh) sustained gum injury.

Routine Sample was taken for analysis from the winner b g VOLCANO.

4th Race : 4. The Hassan Plate – Div.II - (About) 1400 Metres. Horses rated 40 to 65, 4 years old and over (12 Runners).

CAT LOGAN (S. Mallikarjun) reared up and flipped over at the starting gates. Under the circumstances it was permitted to be withdrawn before coming under Starter's Order.

HOT STUFF (R. Koch) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. S. Narredu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in one Mock Race on a race day on the race track.

Jockey R. Vaideeshwaran, the rider of ROYAL SPIRIT, was fined Rs.2,000/- for shifting out and causing interference NORTH CAPE (P. Kiran Rai) which in turn passed it on to UNIQUE SHOW (B. Sreekanth) on the far side passing the 250 Metres.

Jockey P. Kiran Rai, the rider of NORTH CAPE, reported that his saddle shifted towards the left rounding the final bend as such he could not offer much assistance to his mount thereafter. After due examination of the equipment Trainer Mr. B. Prithviraj was fined Rs.3,000/- for faulty saddling.

Jockey A.R. Pradeep, the rider of ABRACADABRA, reported that he could not get a clear run in the final stages of the race due to a closely packed field.

Jockey P.S. Chouhan, the rider of BESSIE, was reprimanded for dropping hands before passing the winning post.

Jockey Mudassar Nazar, the rider of ANNA, was fined Rs.2,000/- for his negligence pertaining to weighing in.

ABRACADABRA (A.R. Pradeep) sustained a cut injury on right hind cannon.

ARUN (M. Rajesh Kumar) sustained a cut injury on left hind inner bulb of heel.

5th Race : 5. The Prince Ardent Plate – (About) 1600 Metres. Horses rated 20 to 45 (11 Runners).

BOURBON ROCK (M. Ravi) after jumping out, swerved towards left and did not raise a gallop in the first 100 Metres of the race. In view of its behaviour, Trainer Mr. S. Ganapathy was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in one Mock Race on a race day on the race track.

Routine Sample was taken for analysis from the winner ch f SUPREME.

6th Race: 6. The Kolar Plate - (About) 1200 Metres. Horses rated 40 to 65 (12 Runners).

Trainer Mr. J. Babu Rao was fined Rs.10,000/- for the discrepancy in shoeing in respect of his charge THE SITUATION (M. Rajesh Kumar) (2nd infringement).

STAR PRESENCE (D.Gnaneshwar) stumbled soon after jumping out of the starting gates.

Routine Sample was taken for analysis from the winner b g CARDUCCI.

7th Race: 7. The Rajyotsava Trophy – (Grade III) (About 1400 Metres. Indian Horses 3 years old and over (Terms) (9 Runners).

Permission was granted to trainer Mr. Samar Singh to withdraw LOVELY KISS on veterinary grounds as it was found to be suffering from fever. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey C. Rajendra was fined Rs.2,000/- for not coming in a proper attire to the weighing room for the day's races.

SPRINT STAR (Suraj Narredu) was kept under veterinary observation after the race. After the last race the Club's Veterinary Officer reported that SPRINT STAR suffered from EIPH (Endoscopy). Trainer Mr. S. Narredu was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

INQUISITION (Imran Chisty) sustained a cut injury on right fore cannon.

Compulsory Samples were taken for analysis from the following 1st, 2nd and 3rd placed horses viz:

8th Race: 8. The Kunigal Trophy – (About) 1400 Metres. Horses rated 60 to 85 (14 Runners).

SHOWIN'OFF (P. Trevor) was extremely fractious and refused to be stalled. Under the circumstances it was withdrawn before coming under Starter's Orders.

Jockey M. Prabhakaran, the rider of AZTEC GOLD, was fined Rs.1,000/- for shifting in and causing interference to YOURE STUNNING (Nasir Imam) on his inside passing the 300 Metres.

Jockey Fr'co F DaSilva, the rider of CINNAMON RUSH, was fined Rs.1,000/- for shifting out and causing interference to YOURE STUNNING (Nasir Imam) on his outside passing the 300 Metres.

YOURE STUNNING (Nasir Imam) sustained a cut injury on right hind coronet.

SIX GUN SMITH (Irvan Singh) sustained a cut injury on right hind coronet.

DEEP BLUE SKY (F.K. Shabuddin) sustained a cut injury on right fore cannon.

An enquiry is being held into the interference caused by Jockey P.S. Chouhan, the rider of NICKEL CHROME to the horses on his inside in the above race.

Surprise Sample was taken for analysis from gr g YOURE STUNNING.

9th Race : 9. The Hassan Plate – Div.I - (About) 1400 Metres. Horses rated 40 to 65, 4 years old and over (14 Runners).

Jockey P.S. Chouhan, the rider of ABSOLUT GREY, placed II by the Judge objected against Jockey S. John, the rider of SAVVY CONCEPT placed I for "in the last 200 Metres the winner came out pushed me whereby my horse lost the rhythm as he was carrying 62½ Kg. whereby I lost a certain race". The Stewards held an enquiry immediately after the race and examined the Jockeys concerned. After deliberations, they decided to overrule the objection.
