#### 1st Race: 165. The Lalitmahal Plate - Div.II - (About) 1400 Metres. Horses rated 00 to 25 (12 Runners)

AVARI (Irvan Singh) sustained cut injury on right fore cannon.

BYRONIC (P.S. Chouhan) sustained cut injury on right stifle.

MISTER GREY (Imran Chisty) sustained cut injury on left hock.

Routine Sample was taken for analysis from the winner ch g BYRONIC.

### 2<sup>nd</sup> Race: 166. The Brahmaputra Plate - Div.II - (About) 1200 Metres. Horses rated 20 to 45, 5 years old & over (12 Runners)

It was observed that VISTABELLA (S. John) was hanging in after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Irfan Ghatala was informed to take appropriate corrective measures before accepting with it again.

Jockey Arshad Alam, the rider of GAGAN STAR, was reprimanded for shifting in and inconveniencing SOVIET MELODY (N. Noornabi) on his inside passing the 1000 Metres.

JEYEM'S PRIDE (P. Kiran Rai) sustained a cut injury on left hind cannon.

Routine Sample was taken for analysis from the winner b m VISTABELLA.

### 167. The Lalitmahal Plate - Div.I - (About) 1400 Metres. Horses rated 00 to 25 (12 Runners)

Jockey Ryan Marshall, the rider of DANUBE, reported that his mount was gradually falling back after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. R.R. Byramji was informed to ensure better performance of his charge in future.

Jockey T.S. Jodha, the rider of LIQUID ASSET, reported that his mount was hanging 'in' after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. B. Puttanna was informed to take appropriate corrective measures before accepting with it again.

Jockey T.S. Jodha, the rider of LIQUID ASSET, was fined Rs.1,000/- for the excessive use of the whip on his mount during the race (1st infringement).

SILHOUETTE (Vinod Shinde) sustained cut injury on right hock and left hind cannon.

Routine Sample was taken for analysis from the winner dk b g FANCY NUMBER.

## 4<sup>th</sup> Race: 168. The Forever Elegance Plate – (About) 2000 Metres. Horses rated 20 to 45 (11 Runners)

SMOKEHEAD (P. Kiran Rai) was slowly away and lost few lengths at the start. In view of its behaviour Trainer Mr. J. Babu Rao was informed that he must not accept with it again until its behavioour improved to the satisfaction of the Stipendiary Stewards in one Jump Out on a Starting Gate Practice day.

Jockey Saddam Hussain, the rider of AMAZONAS, reported that his mount was inclined to run out between 1800 Metres and 1700 Metres.

It was observed that VIKTOR (S. John) was hanging in after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Arjun Mangalorkar was informed to take appropriate corrective measures before accepting with it again.

Jockey P. Kiran Rai, the rider of SMOKEHEAD, was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (2<sup>nd</sup> infringement).

MELLONSDELIGHT (A. Ashok Kumar) sustained a bleeding cut injury on left hind cannon.

Routine Sample was taken for analysis from the winner ch c VIKTOR.

## 5<sup>th</sup> Race: 169. The D.P. Sharma Memorial Sprinters Trial Stakes - (About) 1200 Metres. For Indian Horses 4 years old and over at the time of starting (Terms) (6 Runners)

Jockey Suraj Narredu, the rider of JERSEY SHORE, reported that he could not get a clear run in the final stages of the race due to a closely packed fileld.

Jockey Ahsan Qureshi, the rider of CHUL BUL PANDY was reprimanded for coming in and tightening JERSEY SHORE (Suraj Narredu) on his inside before passing the red marker post.

An enquiry is being held into the manner of riding of Jockey L.P. Beuzelin on SPEED SIX in the above race.

Routine Sample was taken for analysis from the winner b g SPEED SIX.

### 6<sup>th</sup> Race: 170. The Murudeshwara Plate - (About) 1400 Metres. Horses rated 40 to 65 (10 Runners)

ICE KINGDOM (G. Adarsh) was extremely fractious, reared up and sat down in the gates for a considerable period of time. Under the circumstances it was permitted to be withdrawn before coming under Starter's orders.

CULLINAN (S. John) was examined at the starting gates by the Club's Veterinary Officer and was found to have sustained cut injuries on both fore cannon. Under the circumstances it was permitted to be withdrawn on veterinary grounds before coming under Starter's orders. Trainer Mr. Arjun Mangalorkar was in formed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

WIND FORCE (P. Kiran Rai) jumped awkwardly inwards and inconvenienced IRISH SONG (K. Raja Rao) on its inside soon after jumping out of the starting gates.

MARK (A. Ashok Kumar) planted, lost many lengths at the start and ran detached thereafter. In view of its behaviour Trainer Mr. B. Puttanna was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in One Mock Race on a race day on the race track.

TONY MONTANA (P. Mani) accidentally stumbled passing the 900 Metres.

Routine Sample was taken for analysis from the winner b g TRIUMPH.

## 7<sup>th</sup> Race: 171. The Hampi Plate - (About) 1200 Metres. Horses rated 40 to 65, 5 years old & over (10 Runners)

Permission was granted to Trainer Mr. J.S. Pillay to withdraw OPTIMUS ZONE on veterinary grounds as it was found to be walking lame on right fore due to sprained tendon. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

As Jockey M. Noornabi, the declared rider of WHISTLEJACKET was certified medically unfit to ride after his ride in the 3<sup>rd</sup> race, permission was granted to Trainer Mr. S. Dominic to substitute Jockey P. Kiran Rai to ride WHISTLEJACKET in place of Jockey M. Noornabi, the declared rider.

STARSTRUCK (S. John) was extremely fractious on the way to the starting gates, dropped the rider and ran riderless. On examination by the Club's Veterinary Officer it was found to have sustained a cut injury on left knee. Under the circumstances it was permitted to be withdrawn on veterinary grounds before coming under Starter's orders. Trainer Mr. Sharat Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey P. Mani, the rider of MARK OF GENIUS, was reprimanded for riding an indifferent race.

It was reported after the race that TRUMAN (M. Ravi) burst its blood vessels. Trainer Mr. Mahmood Khan was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g LIVING LEGEND.

## 8<sup>th</sup> Race: 172. The Brahmaputra Plate - Div.I - (About) 1200 Metres. Horses rated 20 to 45, 5 years old & over (11 Runners)

Permission was granted to trainer Mr. Mahmood Khan to substitute Jockey P Kiran Rai to ride YOU'RE MY LIFE in place to Jockey M Noornabi, the declared rider.

FIORITTA (Dashrat Singh) was extremely fractious in the paddock, reared up and fell on its back and hit its head on the ground while parading. On immediate examination by the Club's veterinary officer it was found to have been shivering and was in a shock. Under the circumstances it was permitted to be withdrawn on veterinary grounds before coming under Starter's orders. Trainer Mr. Faraz Arshad was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Vinod Shinde, the rider of ICEPICK WILLIE reported that he could not get a clear run at the start to the crowding of the field.

Jockey Vinod Shinde, the rider of ICEPICK WILLIE reported that his mount was hanging in after entering the straight. The horse was impounded for veterinary examination and on examination the Club's veterinary reported that it was lame on left hind. Trainer Mr. Irfan Ghatala was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again,

Routine Sample was taken for analysis from the winner b g HATCHET

Permission was granted to Trainers M/s. B. Puttanna, Samar Singh and Hidayat Khan to deputise on behalf of Trainers M/s. J.S. Dhariwal, J.S. Pillay and Warren Singh respectively who were unable to attend the races.
