Going: Good

False Rails: Average width of 4.5 Metres from 1600 Metres to the winning post.

Penetrometer Reading: 3.2 Cms.

1st Race: 190. The Dharmasthala Plate - Div.II - (About) 1200 Metres. Horses rated 20 to 45 (8 Runners)

Permission was granted to Trainer Mr. Pradeep Annaiah to withdraw VICTORY GIRL (P. Mani) on veterinary grounds as it was found to be suffering from fever. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Arshad Alam, the rider of FIRE STORM , reported that his mount accidentally stumbled approaching the 800 Metres thereby he lost his left stirrup which he regained within a few strides.

Jockey Mohd. Feroz, the rider of ABBA, was reprimanded in the presence of Trainer Mr. Arjun Mangalorkar for riding an indifferent race and was informed that a repetition of a similar manner of riding would entail him being reported to the Stewards for severe disciplinary action.

It was reported after the race that SEVEN OF HEARTS (S. Mallikarjun) pulled up lame on right fore and sustained cut injury on left fore cannon. Trainer Mr. Sharat Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

AERO STAR (M. Krishna) sustained cut injury on left hind cannon.

ALWAYS REMEMBERING (Syed Asghar) sustained cut injury on right hock.

Routine Sample was taken for analysis from the winner b f WOODBERG.

2nd Race: 191. The Tiptur Plate - (About) 1600 Metres. Horses rated 00 to 25 (10 Runners)

Jockey A. Ashok Kumar, the rider of NATION'S GLORY, was fined Rs.3,000/- for shifting in and causing interference to LA LANTERNA(B. Mahesh) on his inside which had to be checked by its rider and shift out taking out BERNICIA (R. Vaibhav) and PRIVATE PARTY (Babu Singh) on the far side approaching the 700 Metres.

Jockey Mudassar Nazar, the rider of GLAMOUR BOY, reported that he lost his whip in the final 100 Metres of the race.

It was reported after the race that the left fore shoe of MAGNETIZE (S. John) had apparently come off during the race.

It was observed that under the use of whip MAGNETIZE (S. John) crashed into the rails passing the 50 Metres whereby the rider got totally unbalanced and was dislodged from his mount. An enquiry is being held into the above incident.

It was reported after the race that MAGNETIZE (S. John) pulled up lame on right hind and also sustained cut injury on right hind fetlock. Trainer Mr. Arjun Mangalorkar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

PRIVATE PARTY (Babu Singh) sustained cut injuries on left hind cannon and right hind cannon.

Routine Sample was taken for analysis from the winner ch g EXTRA SPARK.

3rd Race: 192. The Becket Plate Div.II - (About) 1400 Metres. Maiden Indian Horses 3 years old only (11 Runners)

Jockey R. Vaibhav, the rider of OCEAN PARK, reported that he could not get a clear run at the start due to the crowding of the field.

Jockey R. Anand, the rider of DEEPALIKA, was fined Rs.2,000/- for shifting out and bumping SMART CONNECTIONS (Fr'co F DaSilva) which in turn passed it on to CROZIET (P. Mani) on his outside rounding the final bend.

Jockey Ryan Marshall, the rider of PASSING FULCRUM, reported that his mount was running green throughout the race.

CROZIET (P. Mani) sustained cut injuries on right hind fetlock.

SECRET DIMENSION (San. Kumar Paswan) sustained cut injury on left fore cannon.

Routine Sample was taken for analysis from the winner b g BAZINGA.

4th Race: 193. The S. Rangarajan Memorial Cup- (About) 1200 Metres. For Horses rated 40 t 65 (12 Runners)

As Jockey S. John, the declared rider of SMOKEY SID was certified medically unfit to ride after his fall in the 2nd race, permission was granted to Trainer Mr. Arjun Mangalorkar to substitute Jockey Ryan Marshall to ride SMOKEY SID in place of Jockey S. John, the declared rider.

Jockey Ryan Marshall, the rider of SMOKEY SID, was fined Rs.2,000/-for coming in and causing interference to VIGOROUS (Arshad Alam) on his inside approaching the 250 Metres.

Jockey Ryan Marshall, the rider of SMOKEY SID, was reprimanded for dropping hands before passing the winning post.

NIBBLEY (Mudassar Nazar) sustained a cut injury on right hind cannon.

Routine Sample was taken for analysis from the winner ch c ACCURACY

5th Race: 194. The Hosmat Hospital Bangalore Winter Million (Grade III) - (About) 1200 Metres. 3 year old Indian Horses (Foaled in 2011) (6 Runners)

Trainer Mr. Dallas Todywala was fined Rs.10,000/- by the Stewards for failing to declare his charge GRAND GIBRALTAR to start for this race after having accepted with it.

Permission was granted to Trainer Mr. Sharat Kumar to substitute Jockey T.S. Jodha to ride EMPEROR CRUISE in place of Jockey S. John, the declared rider.

JERSEY BRIDE (J.H. Christopher) accidentally stumbled passing the 800 Metres.

Jockey Suraj Narredu, the rider of NURAY, reported that his mount was hanging out after entering the straight. The horse was impounded for veterinary examination and on examination the Club's Veterinary Officer reported that it had sharp molars on both sides. Hence Trainer Mr. G. Nityanand (deputizing for Trainer Mr. Neil Darashah) was informed that Mr. Neil Darashah was fined Rs.3,000/for his negligence (1st infringement).

SAYYONEE (Irvan Singh) sustained a cut injury on left fore cannon.

Routine Sample was taken for analysis from the winner b g NATIVE INDIAN.

7th Race: 196. The Dharmasthala Plate - Div.I - (About) 1200 Metres. Horses rated 20 to 45 (8 Runners)

Permission was granted to Trainer Mr.G.Nityanand to deputise on behalf of Trainer Mr.Neil Darashah for the above race in respect of his charge b f SPIRIT.

Permission was granted to Trainer Mr. Irfan Ghatala to substitute Jockey Suraj Narredu to ride ACE LEXINGTON in place of Jockey S. John, the declared rider.

ACE LEXINGTON (Suraj Narredu) jumped awkwardly outwards and inconvenienced SUN GLOW (Akshaya Sundaram) on its outside soon after jumping out of the starting gates.

SPIRIT (V.R. Jagadeesh) planted, lost many lengths at the start and ran detached thereafter. In view of its behaviour Trainer Mr. G. Nityanand (deputizing for Trainer Mr. Neil Darashah) was informed

that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in one Mock Race on a race day on the race track.

Jockey K. Raja Rao, the rider of KINGSTON TOWN, was fined Rs.3,000/- for the inept handling of his mount during the race.

Routine Sample was taken for analysis from the winner b g ACE LEXINGTON.

8th Race: 197. The Becket Plate Div.I - (About) 1400 Metres. Maiden Indian Horses 3 years old only (11 Runners)

Permission was granted to Trainer Mr. Arjun Mangalorkar to substitute Jockey Ryan Marshall to ride BIG TICKET in place of Jockey S. John, the declared rider.

COOL ICEMINT (B. Mahesh) ran detached from the field. Trainer Mr. Sharat Kumar was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b c STAR OF DESTINY.

169. The D.P. Sharma Memorial Sprinters Trial Stakes - (About) 1200 Metres. Indian Horses 4 years old and over at the time of starting.

The Stipendiary Stewards reported Jockey L.P Beauzelin , the rider of SPEED SIX to the Stewards for Careless Riding [Rule No. 161(i) of the BTC Rules of Racing] in that "for coming in approaching the 1100 Metres and causing severe interference to SHIVALIK STAR (S. John) on your inside, which in turn passed it on to ABSOLUTE MAJORITY (P.S. Chouhan) along the rails, which collided against the false rails and had to be checked by its respective rider, as a result ESTEBAN (Dashrat Singh) travelling behind the latter also had to be checked by its rider". The Stewards held an enquiry on 15th February, 2014 and examined Jockey L.P. Beauzelin. After deliberations, the Stewards decided to suspend the Jockey's licence granted to Jockey L.P. Beauzelin from 7-3-2014 to 8-3-2014 (both days inclusive) for Careless Riding [Rule No. 161(i) of the BTC Rules of Racing] on his mount SPEED SIX in the above race (permitted to ride work).
