Jockey J.H. Christopher, the rider of TO THE FUTURE, was reprimanded for shifting in and inconveniencing MANDARIN (Fr'co F DaSilva) on his inside approaching the 200 Metres.

Jockey A. Ashok Kumar, the rider of ZULU FANTASY, reported that his mount was running green throughout the race.

Jockey Fr'co DaSilva, the rider of MANDARIN, reported that his mount was running green throughout the race.

Jockey J.H. Christopher, the rider of TO THE FUTURE, was reprimended for dropping hands before passing the winning post.

Routine Sample was taken for analysis from the winner b f EVALINA.

## 2<sup>nd</sup> Race: 174. The Chamundi Hill Plate – Div.II - (About) 1200 Metres. Horses rated 20 to 45 (12 Runners).

ROCKA STAR (B. Harish) after jumping out, swerved towards right, refused to raise a fluent gallop and ran detached thereafter. In view of its behaviour, trainer Mr. S. Britto (deputizing for Trainer Mr. S. Dominic) was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in one Mock Race on a race day on the race track.

SUMMER GOLD (K. Raja Rao) stood for a while at the gates and after jumping out, swerved towards right, refused to raise a fluent gallop for some time and ran detached thereafter. In view of its behaviour, trainer Mr. Amit Caddy was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in one Mock Race on a race day on the race track.

Jockey Arshad Alam, the rider of RAAGA, was reprimanded for shifting in and inconveniencing BEST CRUISE (S. Mallikarjun) on his inside approaching the 1000 Metres.

Jockey P. Mani, the rider of OPTIMISTIC, was reprimanded for shifting out and inconveniencing ORIENTAL IMAGE (T.S. Jodha) on his outside approaching the 1000 Metres.

Jockey T.S. Jodha, the rider of ORIENTAL IMAGE, was reprimanded for travelling wide between the 800 Metres and 600 Metres for no apparent reason.

OPTIMISTIC (P.Mani) accidentally stumbled approaching the 600 Metres.

Jockey S. John, the rider of WOODSTREAM, was fined Rs.5,000/- for his over confidence in completely easing his mount in the final stages of the race when the  $2^{nd}$  placed horse was fast catching up. He was further cautioned to desist from repeating this practice in future.

OPTIMISTIC (P. Mani) sustained a cut injury on right hind pastern.

Routine Sample was taken for analysis from the winner b g WOODSTREAM.

## 3<sup>rd</sup> Race: 175. The Ilkal Plate - (About) 1600 Metres. Horses rated 40 to 65, 5 years old and over (11 Runners)

Jockey G. Adarsh, the rider of WIND FORCE, was reprimanded for shifting in and inconveniencing WIND TUNNEL (M. Krishna) on his inside approaching the 700 Metres.

Jockey G. Adarsh, the rider of WIND FORCE, was fined Rs.1,000/- for shifting in and causing interference to I SAY (Ryan Marshall) on his inside passing the 500 Metres.

Jockey M.A. Roushan, the rider of ROSHAN STAR, reported that his mount was hanging out throughout the race. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Samar Singh was informed to take appropriate corrective measures before accepting with it again.

Jockey B. Mahesh, the rider of MAGNITUDE STAR, was fined Rs.1,000/- for the excessive use of whip on his mount during the race  $(1^{st}$  infringement).

Jockey M. Krishna, the rider of WIND TUNNEL, was reprimanded for dropping hands before passing the winning post.

WIND FORCE (G. Adarsh) sustained a cut injury on right fore pastern.

Routine Sample was taken for analysis from the winner b g MAGNITUDE STAR.

## 4<sup>th</sup> Race: 176. The February Plate - Div.I - (About) 1200 Metres. Maiden Indian Horses 3 years old only (12 Runners)

Jockey M.A. Roushan, the rider of REVA, reported that his mount was inclined to run out during the race. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Samar Singh was informed to take appropriate corrective measures before accepting with it again.

Jockey V.R. Jagadeesh, the rider of WINDYANNA, reported that his mount was running green throughout the race.

Routine Sample was taken for analysis from the winner b g EMPEROR CRUISE.

## 5<sup>th</sup> Race: 177. The Smt. Saraswati Sajnani Memorial Trophy (About) 1200 Metres. Horses rated 40 to 65 (12 Runners).

Jockey B. Mahesh, the rider of COOL BABY, reported that his left stirrup iron fell from the stirrup leather soon after jumping out of the starting gates as such he could not offer any assistance to his mount thereafter and he had to dismount before passing the winning post. An enquiry is being held into this incident.

CAPITALIZE (S. John) accidentally stumbled passing the 800 Metres.

Jockey S. John, the rider of CAPITALIZE, reported that he could not get a clear run passing 200 Metres due to a closely packed field.

Jockey P Ramesh, the rider of MEGHALAYA, was reprimanded for riding an indifferent race in the presence of trainer Mr. S. Britto (deputizing for trainer Mr. S. Dominic). He was informed that a repetition of similar manner of riding would entail him being reported to the Stewards for appropriate action.

Routine Sample was taken for analysis from the winner dk b f SALZBURG.

## 6<sup>th</sup> Race: 178. The Kunigal Stud Stayers Trial Stakes - (About) 2400 Metres. Indian Horses 4 years old and over at the time of starting (5 Runners)

WIND STREAM (Ryan Marshall) sustained a cut injury on left hind cannon.

Routine Sample was taken for analysis from the winner ch h APPLEJACK.

## 7<sup>th</sup> Race: 179. The Hurricane Stud Plate - (About) 1200 Metres. Horses rated 60 and above, 5 years old and over (11 Runners)

Permission was granted to Trainer Mr. Prasanna Kumar to withdraw SCENIC BLAST on veterinary grounds as it was found to be lame on left fore due to sprained shoulder. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

VOLCANO (R. Vaibhav) was inclined to run out thereby inconvenienced DIVINE DELIVERANCE (Ryan Marshall) and CLEVER TRICK (Imran Chisty) on its outside passing the 800 Metres.

It was reported after the race that VOLCANO (R. Vaibhav) had burst it blood vessels (endoscopy Grade III) at 6.15 p.m. Trainer Mr. S. Inayathulla was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry is being held into the manner of riding of Jockey Y.S. Srinath on his mount WILL STAR in the above race.

VOLCANO (R. Vaibhav) sustained a cut injury on right hind cannon.

Surprise Sample was taken for analysis from b m RICH CELEBRATION.

Routine Sample was taken for analysis from the winner b g WILL STAR.

### 8<sup>th</sup> Race: 180. The Gaganachukki Plate - (About) 1400 Metres. Horses rated 20 to 45, 5 years old and over (12 Runners)

Jockey Arshad Alam, the rider of KING OF HEROES, was fined Rs.2,000/- for his negligence for not wearing his goggles during the race.

ACTIVE GREY (G. Adarsh) sustained a cut injury on left hind fetlock.

Routine Sample was taken for analysis from the winner b g KING OF HEROES.

### 9<sup>th</sup> Race: 181. The Chamundi Hill Plate - Div.I - (About) 1200 Metres. Horses rated 20 to 45 (11 Runners)

RUBI REY (K. Raja Rao) planted and lost many lengths at the start. In view of its behaviour Trainer Mr. Amit Caddy was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in one Mock Race on a race day on the race track.

SAPHIRA (B. Nayak) jumped awkwardly inwards and inconvenienced JEWEL LADY (G. Adarsh) on its inside which in turn passed it on to SEVEN OF HEARTS (S. Mallikarjun) soon after jump;ing out of the starting gates.

Jockey S. Mallikarjun, the rider of SEVEN OF HEARTS, was reprimanded for travelling wide rounding the final bend for no apparent reason.

Jockey J.H. Anil, the rider of MY FAVOURITE VOICE, was reprimanded for travelling wide rounding the final bend for no apparent reason.

The Stewards also considered the enquiry report of the Stipendiary Stewards along with the copy of the evidence tendered by Trainer Mr. Neil Darashah and his relevant employees during the enquiry by the Stipendiary Stewards.

They examined Mr. Sanjay Reddy, spokesman for Trainer Mr. Neil Darashah and the Trainer himself.

After due deliberations, they decided to suspend the Trainer's Licence granted to Trainer Mr. Neil Darashah from 15-2-2014 to 31-3-2014 (both days inclusive) and should the Trainer's Licence be granted to him under BTC Rules of Racing for the year 2014-15, the same shall remain suspended from 15-5-2014 to 30-9-2014 (both days inclusive); and further fine him a sum of Rs.15,000/- (Rupees Fifteen Thousand only) for infringement of Medication Rules (in respect of his charge b c TRIUMPHANT in the above race) as contained in BTC Calendar Notification under the heading "Medication and treatment of horses in Training and Racing and Anti-Doping Control" reading as follows:

"The trainer is always responsible for the protection and security of the horse in his care. The trainers are warned that they will be held responsible if an examination of a horse, results in the finding of any prohibited substances".

Thus you have contravened Rule No.114(b)(iii) of the BTC Rules of Racing, reading as follows:

Rule No.114(b) – In addition to or in lieu of any other penalties or punishments as may be laid down under these Rules of Racing, a Trainer may be fined, suspended for disqualified by the Stewards:-

(iii) If he found intoxicated, use profane, indecent language or use threatening, abusive or insulting words.

The Stewards considered the above Charge Sheet and examined Trainer Mr. Neil Darashah who pleaded guilty in respect of the charge levelled against him and also tendered his unqualified apology to the Stewards for his behaviour.

## 114. The Juvenile Sprinters' Million (Grade III) - (About) 1200 Metres. For 3 year old Indian horses (foaled in 2010)

The Stipendiary Stewards reported Trainer Mr. Neil Darashah for the misconduct and the utterances by him towards the official Starter of the Club soon after the above race at the weighing room thereby contravening Rule No.114(b)(ii) & (iii) of the BTC Rules of Racing in connection with the withdrawal of his charge WHISPERING GALLARY from the said race due to its extremely fractious behaviour at the starting gates. The Stewards held an enquiry on 18<sup>th</sup> July 2013. They interviewed the official Starter Mr. K.S. Shanmukhaswamy. The Stewards examined Mr. Darius Byramji, spokesman for Trainer Mr. Neil Darashah and Mr. Neil Darashah himself.

After deliberations and in view of the unconditional and unqualified apology tendered by Trainer Mr. Neil Darashah for his misconduct, the Stewards decided to severely reprimand him for his misconduct towards the official Starter of the Club soon after the above race at the weighing room thereby contravening Rule No.114(b)(ii) of the BTC Rules of Racing and further to punish him with a fine of Rs.25,000/- (Rupees twentyfive thousand only) as a

suspended sentence and that the sentence shall be invoked immediately in the event of repetition of similar breach of Rules of Racing of Bangalore Turf Club Ltd., by Trainer Mr. Neil Darashah during the period from 19-7-2013 to 31-3-2015 (both days inclusive)".

In view of the repeat breach of the said Rules by Trainer Mr. Neil Darashah, the Stewards after due deliberations, decided to invoke the above said sentence and fine him a sum of Rs.25,000/- (Rupees twentyfive thousand only) in terms of the earlier Order of the Stewards and fine him a further sum of Rs.25,000/- (Rupees twentyfive thousand only) for the said breach of rule as mentioned in the Charge Sheet No.748 dated 19-1-2014.

The Stipendiary Stewards reported Trainer Mr. J. Babu Rao to the Stewards for the inconsistent running and the improved performance of his charge b m DANCE WITH ME (P. Kiran Rai) the winner of the above race as compared to its previous run in Race No.122, The Kitty Bank Plate (about) 1400 Metres, Horses rated 20 to 45, 5 years old and over at the time of starting, run on Saturday, 4<sup>th</sup> January 2014 when ridden by the same Jockey it ran unplaced thereby contravening Rule No.114(b)(i) of the BTC Rules of Racing.

The Stewards held an enquiry on 27-1-2014 and examined Trainer Mr. J. Babu Rao. After deliberations, the Stewards decided to suspend the Trainer's Licence granted to Trainer Mr. J. Babu Rao from 10-2-2014 to 9-3-2014 (both days inclusive) and fine him a sum of Rs.10,000/- for the inconsistent running and the improved performance of his charge b m DANCE WITH ME (P. Kiran Rai) the winner of the above race as compared to its previous run in Race No.122, The Kitty Bank Plate (about) 1400 Metres, Horses rated 20 to 45, 5 years old and over at the time of starting, run on Saturday, 4<sup>th</sup> January 2014 when ridden by the same Jockey it ran unplaced thereby contravening Rule No.114(b)(i) of the BTC Rules of Racing. He was further cautioned by the Stewards that a repetition of similar breach of the Rules of Racing would be dealt with very severely.

### EIGHTEENTH DAY, SATURDAY, 25th JANUARY 2014

### 154. The Vibrant Plate - (About) 1100 Metres. Horses rated 20 to 45

The Stipendiary Stewards reported Jockey Saddam Hussain, the rider of ANMOL HIRA to the Stewards for Dangerous Riding [Rule No. 161(i) of the BTC Rules of Racing] in that he cut across sharply within 100 Metres of the start causing interference to MAGIC WAVE (G.Y. Rajesh Babu) on his inside and later to SHINNECOCK HILLS (S. John) which in turn passed it on to SCUFFLE (Indrajeet Singh) along the rails just passing 1000 Metres. The Stewards held an enquiry on 31<sup>st</sup> January, 2014 and examined Jockey Saddam Hussain. After deliberations, the Stewards decided to suspend the Jockey's licence granted to Jockey Saddam Hussain from 11-2-2014 to 7-3-2014 (both days inclusive) for Dangerous Riding [Rule No. 161(i) of the BTC Rules of Racing] on his mount ANMOL HIRA in the above race (permitted to ride work).
