Surprise Sample was taken for analysis from b c ROCK WITH US.

Routine Sample was taken for analysis from the winner dk b f CATTLEYA.

**2<sup>nd</sup> Race: 215. The Ramanagar Plate - (About) 1200 Metres. Horses rated 00 to 25 (12 Runners)**

Jockey Noornabi, the rider of ZIZZI was fined Rs.2,000/- for losing position during the early stages of the race for no apparent reason.

Routine Sample was taken for analysis from the winner b f SECRET TOUCH.

**3<sup>rd</sup> Race: 216. The Bhagamandala Plate - (About) 2000 Metres. Horses rated 40 to 65 (7 Runners).**

Jockey A. Vishwanath, the rider of ROSHAN STAR, reported that his mount was hanging out after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Samar Singh was informed to take appropriate corrective measures before accepting with it again.

Jockey R. Vaibhav, the rider of ARTIC ATTRACTION, reported that his mount was hanging out after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Arjun Mangalokar (deputizing for Trainer Mr. S.S. Attaollahi) was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b g SPANISH CANNON.

**4<sup>th</sup> Race: 217. The Bugs Bunny Trophy - (About) 1200 Metres. For Indian Horses 3 years old only (10 Runners).**

HIDDEN STAR (A.R. Pradeep) sustained a cut injury on right hind pastern.

FLAME'S FURY (G. Adarsh) sustained a cut injury on right hind pastern.

Routine Sample was taken for analysis from the winner b f RED RED ROSE.

**5<sup>th</sup> Race: 218. The Devarayanadurga Plate - Div.I - (About) 1400 Metres. Horses rated 20 to 45 (12 Runners)**

Jockey B. Mahesh, the rider of RAKSHITHA, reported that his mount suddenly stopped galloping passing 200 Metres and ran detached thereafter. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Sharat Kumar was informed to ensure better performance of his charge in future.

Jockey Akshaya Sundaram, the rider of RED ADMIRAL, was fined Rs.2,000/- for not persevering with his mount during the race.

Jockey A. Vishwanath, the rider of DOFANTASY, was fined Rs.2,000/- for not persevering with his mount during the race.

Jockey M. Noornabi, the rider of LOVE IS LIFE, was fined Rs.2,000/- for not persevering with his mount during the race.

Routine Sample was taken for analysis from the winner b g ROYAL REIN.

**6<sup>th</sup> Race: 219. The Kanteerava Cup - (About) 1400 Metres. For horses rated 60 and above, 5 years old and over (11 Runners)**

Permission was granted to Trainer Mr. Sharat Kumar to withdraw COOL APPROACH (Mudassar Nazar) on veterinary grounds as it was found to be suffering from fever. He was informed that he must produce a Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey P. Kiran Rai, the rider of ETHOPHIAN, was reprimanded for shifting in and inconveniencing VALAHAK (Anjar Alam) on his inside passing the 900 Metres.

Jockey Anjar Alam, the rider of VALAHAK, was reprimanded for shifting out and inconveniencing NICKEL CHROME (M. Noornabi) on his outside passing the 300 Metres.

Jockey P. Kiran Rai, the rider of ETHOPHIAN, reported that he lost his whip approaching the 200 Metres.

Jockey, A. Ashok Kumar, the rider of ONE TIME MAGIC, was fined Rs.2,000/- for not persevering with his mount during the race.

It was reported after the race that SPIRITUAL STAR (Vinod Shinde) burst its blood vessels during the race. Trainer Mr. Faraz Arshad was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

APOLLO KING (D. Gnaneshwar) sustained abrasion on right abdomen.



ONE TIME MAGIC (A. Ashok Kumar) sustained cut injury on left fore cannon.

Routine Sample was taken for analysis from the winner dk b g ETHOPHIAN.

**7<sup>th</sup> Race: 220. The Gadag Plate - (About) 1200 Metres. Horses rated 20 to 45, 6 years old and over (11 Runners)**

GAME DANCER (B. Mahesh) was examined by the Club's Veterinary Officer at the starting gates and was found to have sustained bleeding cut injury on right fore cannon. Under the circumstances it was permitted to be withdrawn on veterinary grounds before coming under Starter's orders. Trainer Mr. Warren Singh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that THE GUARDIAN (J.H. Christopher) burst its blood vessels during the race. Trainer Mr. Britto was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry is being held into the excessive use of the whip by Jockey Mudassar Nazar on his mount BLUE STAR in the above race (3<sup>rd</sup> infringement).

Routine Sample was taken for analysis from the winner b g SARATOGA SPRING.

**8<sup>th</sup> Race: 221. The Devarayanadurga Plate - Div.II - (About) 1400 Metres. Horses rated 20 to 45 (12 Runners)**

Jockey S. Babu, the rider of LET SET GO, reported that he could not get a clear run soon after jumping out of the starting gates due to the crowding of the field.

Jockey K. Chethana, the rider of STAR KINGDOM, was reprimanded for travelling wide from 900 Metres till rounding the final bend for no apparent reason.

It was reported after the race that MUSICAL ROMANCE (Shanth Kumar) burst its blood vessels during the race. Trainer Mr. Warren Singh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Mohammed Shoab, the rider of CHERRY HINTON, was fined Rs.2,000/- for his negligence pertaining to Weighing In.

Jockey B. Mahesh, the rider of SEVEN OF HEARTS, was fined Rs.2,000/- for his negligence pertaining to Weighing In.

Routine Sample was taken for analysis from the winner dk b g CARDIGAN BAY.

It was observed that FLYING BULLET (P. Kiran Rai) was running green during the race.

Routine Sample was taken for analysis from the winner b f ATMOS.

Permission was granted to Trainers M/s. Inayathulla and Arjun Mangalorkar to deputise on behalf of Trainers M/s. Mahmood Khan and S.S. Attaollahi respectively who were unable to attend the races.

### **111. The Raichur Plate (About) 1400 Metres. Horses rated 40 to 65**

The Board of Appeal at its meeting held on Wednesday, 26<sup>th</sup> February 2014, considered the appeal dated 11<sup>th</sup> January 2014 filed by Jockey F.K. Shabuddin against the decision of the Stewards of the Bangalore Turf Club Ltd., in declaring him a disqualified person under the B.T.C Rules of Racing from 1-2-2014 to 30-9-2014 (both days inclusive) for contravention of Rule No.159(b) of the B.T.C Rules of Racing on his mount ACCURACY in the above race.

The Board noted that the punishment imposed on Jockey F.K. Shabuddin had been stayed by it until his appeal was heard and disposed of by the Board.

In this connection, the Board considered the following:

- (a) The copy of the Minutes of the Meeting of the Stewards of the Bangalore Turf Club Ltd., dated 9<sup>th</sup> January 2014;
- (b) The written grounds of appeal dated 7-2-2014 furnished by Jockey F.K. Shabuddin;

The Board examined Mr. Y.S. Gautam, Spokesman for Jockey F.K. Shabuddin and Jockey F.K. Shabuddin himself. After deliberations, the Board decided to:

- (i) Reject the appeal filed by Jockey F.K. Shabuddin;
- (ii) Consequently to declare Jockey F.K. Shabuddin a disqualified person under BTC Rules of Racing from 1-3-2014 to 31-10-2014 (both days inclusive) for contravention of Rule No.159(b) of the B.T.C Rules of Racing on his mount ACCURACY in the above race.
- (iii) To forfeit the deposit paid by Jockey F.K. Shabuddin towards the Appeal Fee.

The Board of Appeal at its meeting held on Wednesday, 26<sup>th</sup> February 2014, considered the appeal dated 25<sup>th</sup> January 2014 filed by Trainer Mr. M.A. Tharun Thimmaiah against the decision of the Stewards of the Bangalore Turf Club Ltd., in declaring him a disqualified person under the B.T.C Rules of Racing from 10-2-2014 to 30-9-2014 (both days inclusive) for indulging in improper practice and conduct unbecoming of a licensed professional in the performance of his duties - vide Rule No.114(b)(i) and Rule No.202(i)(xiv) & (xvi) of the B.T.C Rules of Racing and BTC Racing Calendar Notification under the heading "Trainers Licences".

The Board noted that the punishment imposed on Trainer Mr. M. A. Tharun Thimmaiah had been stayed by it until his appeal was heard and disposed of by the Board.

In this connection, the Board considered the following:

- (a) The copy of the Minutes of the Meeting of the Stewards of the Bangalore Turf Club Ltd., dated 9<sup>th</sup> January 2014 and 24<sup>th</sup> January 2014;
- (b) The written grounds of appeal dated 21-2-2014 and 26-2-2014 filed by Trainer Mr. M. A. Tharun Thimmaiah;

The Board examined Mr. M. A. Tharun Thimmaiah. After deliberations, the Board decided to:

- (i) Reject the appeal filed by Trainer Mr. M. A. Tharun Thimmaiah;
- (ii) Consequently to declare Trainer Mr. M. A. Tharun Thimmaiah a disqualified person under BTC Rules of Racing from 3-3-2014 to 22-10-2014 (both days inclusive) for indulging in improper practice and conduct unbecoming of a licensed professional in the performance of his duties - vide Rule No.114(b)(i) and Rule No.202(i)(xiv) & (xvi) of the B.T.C Rules of Racing and BTC Racing Calendar Notification under the heading "Trainers Licences".
- (iii) To forfeit the deposit paid by Trainer Mr. M. A. Tharun Thammaiah towards the Appeal Fee.

### **110. The Horanudu Plate Div.I (About) 1200 Metres. Horses rated 20 to 45, 4 years old and over.**

The Board of Appeal at its meeting held on Wednesday, 26<sup>th</sup> February 2014, considered the appeal dated 26<sup>th</sup> January 2014 filed by Trainer Mr. Irfan Ghatala against the decision of the Stewards of the Bangalore Turf Club Ltd., in declaring him a disqualified person under the B.T.C Rules of Racing from 10-2-2014 to 31-3-2015 (both days inclusive) for indulging in improper and fraudulent practice and conduct unbecoming of a licensed professional in the performance of his duties - vide Rule No.114(b)(i) and Rule No.202(i)(xiv) & (xvi) of the B.T.C Rules of Racing and BTC Racing Calendar Notification under the heading "Trainers Licences".

The Board noted that the punishment imposed on Trainer Mr. Irfan Ghatala had been stayed by it until his appeal was heard and disposed of by the Board.

In this connection, the Board considered the following:

- (a) The copy of the Minutes of the Meeting of the Stewards of the Bangalore Turf Club Ltd., dated 9<sup>th</sup> January 2014 & 24<sup>th</sup> January 2014; and
- (b) The written grounds of appeal dated 22<sup>nd</sup> February 2014 and undated written grounds of appeal submitted at the Meeting by Trainer Mr. Irfan Ghatala;

The Board examined Mr. Fazal Ur Rahaman, Spokesman for Trainer Mr. Irfan Ghatala and Trainer Mr. Irfan Ghatala himself. After deliberations, the Board decided to:

- (i) Reject the appeal filed by Trainer Mr. Irfan Ghatala;
- (ii) Consequently to declare Trainer Mr. Irfan Ghatala a disqualified person under BTC Rules of Racing from 3-3-2014 to 22-4-2015 (both days inclusive) for indulging in improper and fraudulent practice and conduct unbecoming of a licensed professional in the performance of his duties - vide Rule No.114(b)(i) and Rule No.202(i)(xiv) & (xvi) of the B.T.C Rules of Racing and BTC Racing Calendar Notification under the heading "Trainers Licences".
- (iii) To forfeit the deposit paid by Trainer Mr. Irfan Ghatala towards the Appeal Fee.

## ORDER OF THE BOARD OF APPEAL

**MYSORE RACES 2013**  
**FOURTH DAY, FRIDAY, 30<sup>TH</sup> AUGUST 2013**

### **26. The K. Thammanna Gowda Memorial Trophy - Div.II - (About) 1200 Metres.** **Horses rated 40 to 65.**

The Board of Appeal at its meeting held on 26th February 2014 considered the appeal dated 30<sup>th</sup> January 2014 filed by Trainer Mr. Neil Darashah against the decision of the Stewards of the Bangalore Turf Club Ltd., in suspending his Trainer's Licence under the BTC Rules of Racing from 15-2-2014 to 31-3-2014 (both days inclusive) and should the Trainer's Licence be granted to him under BTC Rules of Racing for the year 2014-15, the same shall remain suspended from 15-5-2014 to 30-9-2014 (both days inclusive); and further fine him a sum of Rs.15,000/- (Rupees Fifteen Thousand only) for infringement of Medication Rules (in respect of his charge b c TRIUMPHANT in the above race) as contained in the BTC Calendar Notification under the heading "Medication and treatment of horses in Training and Racing and Anti-Doping Control".

The Board noted that the punishment imposed on Trainer Mr. Neil Darashah had been stayed by it until his appeal was heard and disposed of by the Board.

In this connection, the Board considered the following:

- (a) The copy of the Minutes of the Meeting of the Stewards of the Bangalore Turf Club Ltd., dated 27<sup>th</sup> January 2014 ; and
- (b) The written grounds of appeal dated 21-2-2014 submitted by Trainer Mr. Neil Darashah;

The Board examined Mr. Sarosh Mody, Spokesman for Trainer Mr. Neil Darashah and Trainer Mr. Neil Darashah himself. After deliberations, the Board decided to:

- (i) partially allow the appeal filed by Trainer Mr. Neil Darashah;
- (ii) to modify the period of punishment in that his Trainer's licence shall be suspended from 3-3-2014 to 31-3-2014 (both days inclusive) and should the Trainer's licence be granted to him under the BTC Rules of Racing for the year 2014-15, the same shall remain suspended from 15-5-2014 to 16-6-2014 (both days inclusive) and to retain the fine of Rs.15,000/- (Rupees Fifteen Thousand only) imposed by the Stewards on him for infringement of Medication Rules (in respect of his charge b c TRIUMPHANT in the above race) as contained in the BTC Calendar Notification under the heading "Medication and treatment of horses in Training and Racing and Anti-Doping Control" reading as follows:

"The trainer is always responsible for the protection and security of the horse in his care. The trainers are warned that they will be held responsible if an examination of a horse, results in the finding of any prohibited substances".

- (iii) To forfeit the deposit paid by Trainer Mr. Neil Darashah towards the Appeal Fee.
