GOING: Good

RAILING POSITION: Railing fixed at average width of 3.5 Meters from 1600 Meters to

winning post from its original position.

1st Race: 118. The Ullal Beach Plate - (About) 1400 metres. Horses rated 00 to 20 (12 Runners).

Jockey Vinod Shinde replaced the indisposed Jockey Chetan Kalay.S on CLASSIC SPEED.

Jockey Ashok Kumar A., the rider of GOLDEN OPINION reported that his mount was not galloping fluently throughout the race, whereby it ran detached. The horse was impounded for veterinary examination. On examination, it was found to be trotting lame on right fore. Trainer Mr. S. Ganapathy was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Darshan R.N, the rider of TRACK STRIKER reported that his mount was wobbling passing the 300 Metres. The horse was impounded for veterinary examination but no abnormality was reported.

Jockey K. Nazil, the rider of SECURING SMILES reported that he accidentally lost his whip passing the 50 Metres.

TURF PROSPECTOR (P. Trevor) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch g FIERCE FIGHTER.

2nd Race: 119. The Raichur Plate - Div. II - (About) 1600 metres. Horses rated 15 to 35 (11 Runners).

LEE AND GRANT (Vinod Shinde) jumped awkwardly outwards and inconvenienced IDO WHAT I DO (Prashant P.Dhebe) soon after the start.

IDO WHAT I DO (Prashant P.Dhebe) took a fly jump.

Jockey Rayan Ahmed R., the rider of ALEEF was reprimanded for shifting out and inconveniencing IDO WHAT I DO (Prashant P.Dhebe) on his outside passing the 1400 Metres.

It was observed that Jockey A.Imran Khan, the rider of THREE WISHES had to steady his mount to avoid striking the front runner thereby shifted out and bumped LEE AND GRANT (Vinod Shinde), which in turn passed it onto IDO WHAT I DO (Prashant P.Dhebe) passing the 1200 Metres.

Jockey A.Imran Khan, the rider of THREE WISHES reported that his mount was hanging out despite his best efforts thereby taking out LEE AND GRANT (Vinod Shinde) passing the 700 Metres.

Routine Sample was taken for analysis from the winner gr g PRINCE CHARMO.

3rd Race: 120. The Premium Spirit Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35, 5 years old and over (10 Runners).

Permission was granted to Trainer Mr. Prithviraj B. to withdraw DEPTH CHARGE (Manish R) on veterinary grounds as it was found to be lame on left fore. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

VASUKI (Adarsh G.) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. M. P. Mahaesh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Arshad Alam, the rider of LOVE FOR LIFE was reprimanded for shifting 'in' and inconveniencing GOOD WORD (T. S. Jodha) on his inside passing the 1100 Metres.

It was reported after the race that HUNTERS MOON (Darshan R.N) burst its blood vessels. Trainer Mr. Neil B Devaney was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

GOOD WORD (T. S. Jodha) sustained bleeding injuries on inside and back side of left knee.

Routine Sample was taken for analysis from the winner b g AS GOOD AS IT GETS.

4th Race: 121. The Kumararajah M.A.M.Muthiah Trophy - (About) 1600 metres. Horses rated 30 to 50 (10 Runners).

As Jockey Neeraj Rawal could not arrive in time to fulfill his riding engagement (missed the flight). Permission was granted to trainer Mr. Arjun Mangalorkar to declare Jockey S. Zervan to ride CIEL ETOILE in the place of declared rider.

Jockey S. Zervan, the rider of CIEL ETOILE reported that he lost his right rein passing the 250 Metres which regained within a few strides.

Jockey S. Zervan, the rider of CIEL ETOILE was fined Rs.3,000/- for shifting 'in' and causing interference to SHESMYSCRIPT (A. Sandesh) on his inside, which in turn passed it onto KING OF THE WIND (Imran Chisty) in the final 20 Metres of the race.

It was reported after the race that LIGHTNING ATTACK (Prashant P.Dhebe) pulled up lame on left fore. Trainer Mr.V. Lokanath was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f CIEL ETOILE.

5th Race: 122. The Ravi Aggarwal Memorial Bangalore Winter Million(Grade III) - (About) 1200 metres. 3-year-old horses(Foaled in 2016). (6 Runners).

As Jockey Neeraj Rawal could not arrive in time to fulfill his riding engagement (missed the flight). Permission was granted to trainer Mr. Arjun Mangalorkar to declare Jockey A. Sandesh to ride KIRKWOOD in the place of declared rider.

It was observed that ANJEZE (P. Trevor) accidentally stumbled soon after the start.

Jockey K. Sai Kiran, the rider of SIR PIGGOT reported that his mount was not galloping fluently throughout the race. The horse was impounded for veterinary examination but no abnormality was reported.

Jockey P. Trevor, the rider of ANJEZE was reprimanded for shifting 'in' and inconveniencing DESERT ROSE (Imran Chisty) on his inside in the final 50 Metres.

6th Race: 123. The Bangalore Race Course 156th year Commemoration Trophy - (About) 1600 metres. 4 years old and over at the time of starting. (6 Runners).

Routine Sample was taken for analysis from the winner b r NAAZAAN.

7th Race: 124. The Premium Spirit Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35, 5 years old and over (12 Runners).

FANTASTIC APP (P. S. Chouhan) jumped awkwardly outwards and inconvenienced HABANERO (P. Trevor) soon after the start.

GOLD MIST (Suraj Narredu) jumped awkwardly outwards and inconvenienced GRANADA (K. Sai Kiran) soon after the start.

Jockey Antony Raj S., the rider of STREAK AHEAD was fined Rs.3,000/- for coming 'in' and tightening the horses on his inside GOLD MIST (Suraj Narredu), INKY BLACK (Shamaz Shareef) and BOLD MOVE (Akshay Kumar), whereby FANTASTIC APP (P. S. Chouhan) which was travelling directly behind had to be checked by its rider passing the 1100 Metres.

Jockey P. Trevor, the rider of HABANERO was reprimanded for shifting 'in' and inconveniencing BOLD MOVE (Akshay Kumar) on his inside passing the 1000 Metres.

Jockey P. Trevor, the rider of HABANERO reported that he stopped riding in the last 150 Metres due to the kick back of the track and his goggle was full of mud.

Trainer Mr. Mahmood Khan was fined Rs.5,000/- permitting Jockey K. Sai Kiran, the rider of GRANADA not to carry whip when permission was not granted.

Routine Sample was taken for analysis from the winner ch m GOLD MIST.

8th Race: 125. The Raichur Plate - Div. I - (About) 1600 metres. Horses rated 15 to 35 (10 Runners).

FIORENZO (Anjar Alam) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Irfan Ghatala was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey P. Trevor, the rider of CONSTANTINOPLE reported that his mount was changing its legs in the straight and the horse was impounded for veterinary examination. On examination, it was found to be trotting lame on right fore. Trainer Mr. S.S.

Attaollahi was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Nazerul Alam, the rider of GAME OF THRONES reported that his mount was not galloping fluently in the final 150 Metres and the horse was impounded for veterinary examination. On examination, it was found to be trotting lame on right fore. Trainer Mr.Azhar Ali was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b g MARCO POLO.

Permission was granted to trainers Mr. Parvathi Byramji to deputise on behalf of trainers Mr. Darius R. Byrmji who was unable to attend the races.
