RACING INCIDENTS
(126-134)

GOING: Good

PENETROMETER READING: 3.5 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 126. The Totalizator Cup - Div. II - (About) 1200 metres. Horses rated 15 to 35 (10 Runners).

Jockey A. Ramu replaced the indisposed Jockey Harish.B on LEGEND IS BACK.

LEGEND IS BACK (A.Ramu) was extremely fractious at the start and refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under starter's order.

Jockey Md.Akram, the rider of NO OPINION was fined Rs.1,000/- for coming 'in' and causing interference to TIGER RETURNS (Arshad Alam) on his inside approaching 900 Metres.

Jockey M. Prabhakaran, the rider of NERVA was reprimanded for shifting out and inconveniencing JE NE SAIS QUOI (Irvan Singh) on his outside passing the 800 Metres.

It was reported after the race that JERSEY STORM (Imran Chisty) had apparently lost its left fore shoe during the race.

Routine Sample was taken for analysis from the winner b f SANTAMARIJA FESTA.

2nd Race: 127. The Saddle Up Cup - (About) 1200 metres. Horses rated 00 to 20 (14 Runners).

COUNTRY'S PEARL (Irvan Singh) jumped awkwardly outwards and inconvenienced DESERT GOLD (Akshay Kumar) soon after the start.

Jockey Shamaz Shareef, the rider of KRUGER PARK reported that his mount was drifting out under pressure in the final 200 Metres.

Jockey Ajay Kumar R, the rider of BOLD RUNNER was fined Rs.5,000/- for the undesirable practice of changing the body protector after weighting out.

KRUGER PARK (Shamaz Shareef) sustained bleeding wound on left fore cannon.

Routine Sample was taken for analysis from the winner b g PERFECTGOLDENERA.

3rd Race: 128. The Kempe Gowda Cup - (About) 1600 metres. Horses rated 60 and above (7 Runners).

PINYADA (T. S. Jodha) planted and lost many lengths at the start. In view of its

behaviour, Trainer Mr. S. Inayathulla was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race and also one Gate Practice.

SUPER SMART (Neeraj Rawal) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch g COURAGE.

4th Race: 129. The Mysore Race Club Trophy - (About) 1200 metres. Maiden Horses 3 years old only. (14 Runners).

Jockey Imran Chisty, the rider of INVICTA was fined Rs.3,000 /- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b f INDIAN EMPRESS.

5th Race: 130. The T.B.Hanumantharaj Memorial Trophy - Div. I - (About) 1400 metres. Horses rated 30 to 50, 5 years old and over (12 Runners).

ULTIMATE MAGIC (T. S. Jodha) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr.S. Dominic was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race and also one Gate Practice.

Jockey Suraj Narredu, the rider of INTERESTING was fined Rs.2,000/- for coming 'in' and causing interference to LAWRENCE OF ARABIA (David Allan) on his inside passing the 250 Metres and for again shifting 'in' and causing interference to RAW GOLD (Vivek) on his inside in the final 75 Metres of the race.

It was observed that Jockey Raghu K, the rider of DEEPALIKA could not get a clear run in the final 50 Metres due to a closely packed field.

Routine Sample was taken for analysis from the winner b g OPTIMISTICAPPROACH.

6th Race: 131. The Totalizator Cup - Div. I - (About) 1200 metres. Horses rated 15 to 35 (10 Runners).

Permission was granted to Trainer Mr. Imtiaz Khan to withdraw NAWABZAADI (Arshad Alam) on veterinary grounds as it was found to have severe keratoconjunctivitis and oedema of cornea on right eye. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Robbie Downey, the rider of ARMIN was fined Rs.3,000/- for allowing his mount to shift 'in' and causing interference to the horses on his inside viz; TINDERELLA (T. S. Jodha) and PINK SMILE (H. G. Rathod) soon after the start.

Jockey Robbie Downey, the rider of ARMIN was fined Rs.2,000/- for shifting 'in' and bumping KIMERA (Y. S. Srinath) on his inside passing the 1000 Metres.

Jockey Manish R, the rider of LOVELY SIERRA reported that his mount was hanging out in the straight, thereby inconveniencing ARMIN (Robbie Downey) rounding the final bend. The horse was impounded for veterinary examination but no abnormality was reported. Trainer Mr. Samar Singh was informed to take appropriate corrective measures before accepting with it again.

Jockey Naveen M., the rider of ANNALEASE reported that he accidentally lost his whip approaching 150 Metres.

ARMIN (Robbie Downey) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g PRODIGAL.

7th Race: 132. The Catalyst Properties Bangalore Derby(Grade I) - (About) 2400 metres. 4-year-old Indian Horses (Foaled in 2015) (13 Runners).

Jockey Y.S. Srinath, the rider of MULTIFACETED was reprimanded for shifting 'in' and inconveniencing THE INVADER (P. Trevor) on his inside passing the 1400 Metres.

Jockey Arshad Alam, the rider of NEW MOON was fined Rs.1,000/- for shifting out and causing interference to MULTIFACETED (Y. S. Srinath) on his outside passing the 400 Metres, whereby VELOCIDAD (P.S.Chouhan) which was travelling directly behind had to be checked by its rider.

8th Race: 133. The Indian Republic Trophy - (About) 1200 metres. Horses rated 45 to 65 (13 Runners).

ARECA LEGEND (Imran Chisty) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Prasanna Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Manish R, the rider of MINIVER ROSE was fined Rs.1,000/- for coming 'in' and cutting across the field thereby the riders of CASTAWAY (P. Trevor) and PANAMA (Neeraj Rawal) on his inside had to steady their respective mounts passing the 1100 Metres.

Jockey A. Sandesh, the rider of CHARMED LIFE was fined Rs.1,000/- for shifting 'in' and causing interference to CASTAWAY (P. Trevor) on his inside passing the 400 Metres.

It was reported after the race that DAISY DUKE (Anjar Alam) pulled up lame on right fore. Trainer Mr.Irfan Ghatala was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g AEISIR.

9th Race: 134. The T.B.Hanumantharaj Memorial Trophy - Div. II - (About) 1400 metres. Horses rated 30 to 50, 5 years old and over (11 Runners).

Jockey Arshad Alam, the rider of NINON had to steady his mount to avoid striking the front runner passing the 800 Metres.

Jockey P. S. Chouhan, the rider of SPIRIT OF LONDON had to steady his mount to avoid striking the front runner passing the 800 Metres.

It was reported after the race that BLUEJACK (T. S. Jodha) trotting lame on right fore. Trainer Mr.F. Sirajuddin was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b r SPIRIT OF LONDON.

Permission was granted to trainers M/s. S.S. Attaollahi and S. Narredu to deputise on behalf of trainers M/s. P. Shroff and Rajesh Narredu who were unable to attend the races.

TWELFTH DAY , FRIDAY , 28TH DECEMBER 2018

Race: 81. The Native Chieftan Plate - (About) 1400 metres. Horses rated 15 to 35, 4 years old and over (Whips not allowed).

An enquiry was held on 21st January, 2019 by the Stipendiary Steward into running and riding of INCITATUS, trained by Prithviraj B. and ridden by Jockey Md.Akram in the above race. After due enquiry, Jockey Md. Akram was fined Rs.5,000/- for not sufficiently persevering with his mount in the final 150 Metres.

THIRTEENTH DAY , SATURDAY , 29TH DECEMBER 2018

Race: 89. The Bellary Plate - Div. II - (About) 1400 metres. Horses rated 15 to 35, 5 years old and over.

An enquiry was held on 21st January, 2019 by the Stipendiary Steward into the improper practice by Jockey Inrajeet Singh who rode GUMPTION in the above race where he tried

to complete the course when the horse came to standstill at about 150 Metres and pulled up after the winning post, was found to have blood from both nostrils, collapsed and died thereafter.

The Jockey stated that his horse slowed down from the 300 Metres but he could not find anything abnormal as such he decided to get off his mount passed the winning post before he dismounted. While noting his explanations he was severely cautioned as to his future riding.

SIXTEENTH DAY , SATURDAY , 19TH JANUARY, 2019

Race: 114. The Dr.C.Vittal Memorial Trophy - Div. I - (About) 1200 metres. Horses rated 30 to 50.

An enquiry was held on 21st January, 2019 by the Stipendiary Stewards for the above race into the interference caused by Jockey K. Sai Kiran on his mount AINE in that he shifted out caused severe interference to WINGS OF DESIRE (P. Trevor) on his outside, which in turn passed it onto GRAND EMPIRE (Ashok Kumar .A) passing the 1100 Metres.

Jockey K. Sai Kiran was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey K. Sai Kiran and after viewing the CCTV decided to charge Jockey K. Sai Kiran for careless riding.

The Stipendiary Stewards thereafter suspended Jockey K. Sai Kiran with effect from 31st January, 2019 to 8th February, 2019 (both days inclusive) as he had pleaded guilty of the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount AINE (he is permitted to ride work) and was informed of his right to appeal.
