## BANGALORE WINTER MEETING 2018-2019 FOURTH DAY, SATURDAY, 17<sup>™</sup> NOVEMBER 2018

### RACING INCIDENTS (22-29)

**GOING: GOOD** 

**PENETROMETER READING: 3.4 Cms.** 

RAILING POSITION: Railing fixed at average width of 7.5 Meters

from 1600 Meters to winning post from its original position.

### <u>1<sup>st</sup> Race: 22. The Huthari Festival Plate - (About) 1400 metres.</u> Horses rated 00 to 20 (10 Runners).

Permission was granted to Trainer Mr. Dheeraj.V to withdraw DAUPHINE (R.Praveen Shinde) on veterinary grounds as it was found to be trotting lame on left hind. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

REGAL REALM (A.Imran Khan) was extremely fractious at the start and refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under starter's order.

PARTING SHOT (Rajesh N) after jumping out, stumbled, totally unbalancing the rider, dislodging him and ran riderless thereafter. Subsequently, the Jockey was declared medically unfit to ride for the day.

Jockey M. Prabhakaran, the rider of DANCING PRINCESS reported that his mount was hanging 'in' after entering the straight. Trainer Mr. Praveen Jesu was informed to take appropriate corrective measures before accepting with it again.

Jockey P. Mani, the rider of AMAZING ANGEL was reprimanded for travelling wide rounding the final bend for no apparent reason.

Trainer Mr. Samar Singh was questioned regarding the reversal of form in respect of his charge LOVELY SIERRA as compared to its previous run in Race No. 8 i.e., The B.A.R.I Plate about 1200 Metres, Horses rated 00 to 20 run on 3<sup>rd</sup> November, 2018 where it ran unplaced. The trainer stated that the horse was inclined to run out in its previous outings. Therefore, he removed the blinkers and added the side cheek pieces along with the basket bit which had definitely helped his charge and this was the second run after he took over this horse from trainer Mr. Neil Darashah. His explanations were noted for future reference.

Routine Sample was taken for analysis from the winner ch f LOVELY SIERRA.

## 2<sup>nd</sup> Race: 23. The Bramhagiri Plate - Div. II - (About) 1400 metres. Horses rated 15 to 35 (10 Runners).

Permission was granted to Trainer Mrs. Parvati Byramji to withdraw MAYURANA (S. Zervan) on veterinary grounds as it was found to be injured on poll region. She was informed that she must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

HAVE A NICE DAY (D. Patel) was extremely fractious in the stalls and injured itself. On examination by the Club's Veterinary Officer it was found to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.F. Sirajuddin was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

GIRL WITH PEARL (Md.Akram) was slowly away, lost few lengths and ran detached thereafter. In view of its behaviour, Trainer Mr. Mahmood Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

STAR MAN (P. Mani) was slightly slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Dheeraj.V (deputizing on behalf of trainer Mr. Nityanand.G) was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that AESOP (Mudassar Nazar) stopped galloping in the final 200 Metres. The horse was impounded for veterinary examination. On examination it was found to have burst its blood vessels (Endoscopy Grade - III). Trainer Mr. Arjun Manglorkar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey S. Selvaraj, the rider of MEMORITER was reprimanded for riding an indifferent race.

It was observed that CAMILA (Arshad Alam) was inclined to run out in the final 100 Metres of the race.

Routine Sample was taken for analysis from the winner b c KASHKHA.

## 3<sup>rd</sup> Race: 24. The Kokkarebellur Plate - (About) 1400 metres. Maiden Horses 3 years old only. (12 Runners).

Jockey Surya. P replaced the indisposed Jockey Rajesh. N on BELLA DESTINY.

JON SNOW (Anjar Alam) jumped awkwardly inwards and inconvenienced JERSEY STORM (Prashant P.Dhebe) on his inside soon after the start.

Jockey A. Sandesh, the rider of KING CREOLE reported that his mount was running green throughout the race.

Jockey Prashant P.Dhebe, the rider of JERSEY STORM reported that his mount was running green throughout the race.

Jockey Arshad Alam, the rider of LE MARC reported that his mount was running green in the straight.

ADVENTURER (Ryan Marshall) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g TREASURE DELIGHT.

## 4<sup>th</sup> Race: 25. The Bangarpet Plate - (About) 1200 metres. Horses rated 45 to 65 (12 Runners).

Jockey Surya. P replaced the indisposed Jockey Rajesh. N on EWANDOR.

TURF MAGIC (A.Imran Khan) jumped awkwardly inwards and inconvenienced HUKUM (S. Zervan) which in turn passed it onto MINT (Manish R) at the start.

Jockey Arshad Alam, the rider of ARECA LEGEND was reprimanded for shifting 'in' and inconveniencing EWANDOR (Surya.P) and ALBERETTA (Shamaz Shareef) on his inside soon after the start.

Jockey Arshad Alam, the rider of ARECA LEGEND was fined Rs.3,000/- for shifting 'in' and tightening MINIVER ROSE (Md.Akram) on his inside passing the 950 Metres, whereby HAEDI'S FOLLY (Y. S. Srinath) which was travelling directly behind also had to be steadied by its rider.

Jockey Manish R, the rider of MINT was fined Rs. 1,000/- for shifting 'in' and causing interference to FAIR WARNING (Antony Raj S.) on his inside approaching 900 Metres.

Jockey A.Imran Khan, the rider of TURF MAGIC was reprimanded for shifting out and inconveniencing HUKUM (S. Zervan) on his outside passing the 300 Metres.

It was reported after the race that TURF MAGIC (A.Imran Khan) burst its blood vessels. Trainer Mr.S. Ganapathy was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f QUEEN LATIFA.

## 5<sup>th</sup> Race: 26. The Chickmagalur Nirvanappa Shetty Nanjamma TMP Cup - (About) 1600 metres. Horses rated 30 to 50 (12 Runners).

Jockey P. Ramesh replaced the indisposed Jockey Ahsan Qureshi on LYCURGUS.

NITROMAX (K. Sai Kiran) reared up as the gates opened, totally unbalancing the rider and dislodging him from his mount within the first 50 Metres and the horse ran riderless thereafter. Subsequently, the Jockey was declared medically unfit to ride for the day.

Jockey S. Zervan, the rider of SUPERNORMAL was fined Rs.5,000/- for riding an incompetent manner whereby he travelled wide from 1400 Metres till about the 600 Metres for no apparent reason.

Jockey S. Zervan, the rider of SUPERNORMAL was fined Rs.2,000/- for coming 'in' and causing interference to the horses on his inside viz; DEL PORTO (Surya P.) and MIDNIGHT SKY (Adarsh G.) approaching 250 Metres.

NITROMAX (K. Sai Kiran) sustained bleeding injury on right fore cannon.

THE INVADER (P. Trevor) sustained clipped injury on right hind outer bulb of heel.

Routine Sample was taken for analysis from the winner b g KING OF THE WIND.

# 6<sup>th</sup> Race: 27. The Karnataka Police Trophy - (About) 1600 metres. Horses rated 60 and above (8 Runners).

SNOWDON (Neeraj Rawal) was extremely fractious in the stalls and lost few lengths at the start.

Routine Sample was taken for analysis from the winner b c PSYCHIC FORCE.

## 7th Race: 28. The Altenburg Plate - (About) 1100 metres. Horses rated 15 to 35, 4 years old and over (11 Runners).

Jockey Arshad Alam replaced the indisposed Jockey K. Sai Kiran on INDIAN LEAGUE.

FANTASTIC APP (S. Zervan) was extremely fractious in the stalls and injured the rider. Under the circumstances, it was permitted to be withdrawn before coming under starter's order.

Jockey Rajesh Kumar M, the rider of AMALFI COAST was fined Rs.3,000/- for repeatedly checking his mount thereby loosing position from the start till about 900 Metres.

Jockey Arshad Alam, the rider of INDIAN LEAGUE reported that his mount was not galloping fluently throughout the race, thereby ran detached. The horse was impounded for veterinary examination but no abnormality was reported. Trainer Mr. M. Rajendra Singh was informed to ensure better performance of his charge in future.

An enquiry is being held into running and riding of SMILE OF PEACE, trained by F. Sirajuddin and ridden by T. S. Jodha in the above race.

Routine Sample was taken for analysis from the winner ch f PRINCESS PRIDE.

# 8<sup>th</sup> Race: 29. The Bramhagiri Plate - Div. I - (About) 1400 metres. Horses rated 15 to 35 (11 Runners).

Permission was granted to Trainer Mr.Mahmood Khan to withdraw ALEEF (Sunil Samson) on veterinary grounds as it was found to be lame on left fore due to capped elbow. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Surya. P replaced the indisposed Jockey Rajesh. N on LOOK OUT.

Jockey Prashant P. Dhebe replaced the indisposed Jockey K. Sai Kiran on MARCO POLO.

It was reported after the race that AIR OF DISTINCTION (Ashok Kumar A.) burst its blood vessels. Trainer Mr.S. Ganapathy was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that FIRING LINE (K. Raja Rao) was trotting lame on left fore. Trainer Mr. Samar Singh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that FULL BLOOM (Nazerul Alam) had apparently lost its right hind shoe during the race.

An enquiry is being held into running and riding of LIKEAKNIFE, trained by S. Inayathulla and ridden by Rajesh Kumar M in the above race.

Routine Sample was taken for analysis from the winner b f FULL BLOOM.

### BANGALORE WINTER MEETING 2018-19 SECOND DAY, SATURDAY, 3<sup>RD</sup> NOVEMBER 2018

#### Race: 8. The B.A.R.I Plate - (About) 1200 metres. Horses rated 00 to 20.

The Stipendiary Stewards reported Trainer Mr. M.P. Mahaesh to the Stewards for contravention of Rule No. 114 (b) (i) for his negligence in discharge of duties as a trainer and a licensed professional under the BTC Rules of Racing (thereby violating - alleged breach of rules) in that on examination of the shoes on ROCKET PUNCH in the above race it was found that the total weight of the shoes was 978.2 gms which was in excess of the prescribed limit of 600 gms as per the BTC Racing Calendar under the heading "SHOEING".

The Stewards held an enquiry on 12<sup>th</sup> November, 2018 and examined trainer Mr. M.P. Mahaesh.

After deliberations, the Stewards decided to fine him a sum of Rs.10,000/-for contravention of Rule No. 114 (b)(i) for negligence pertaining to duties as a trainer in respect of his charge ROCKET PUNCH ( $1^{st}$  infringement) in the above race.

## Race: 9. The Master Key Plate - (About) 1400 metres. Horses rated 15 to 35.

The Stipendiary Stewards reported Jockey Surya.P, the rider of GOLD MIST, to the Stewards for contravention of Rule No.159 (b) of the BTC Rules of Racing, the charge being that in the above race Jockey Surya.P did not take all reasonable and permissible measures throughout the race to ensure that

his horse was given full opportunity to win or to obtain the best possible place in the field.

The Stewards held an enquiry on Monday, 12<sup>th</sup> November, 2018, and examined trainer Mr. Dheeraj.V and Jockey Surya.P.

After deliberations, they decided to :-

- (a) note the explanation tendered by Trainer Mr. Dheeraj.V & severely cautioned him as to the selection of riders on his charge in future and;
- (b) withdraw the Jockey's Licence granted to Jockey Surya.P with effect from 22<sup>nd</sup> November, 2018 to 21<sup>st</sup> February, 2019 (both days inclusive), and treat him as a disqualified person during the above period for contravention of Rule No.159 (b) of the BTC Rules of Racing in that as the rider of GOLD MIST he did not take all reasonable and permissible measures throughout the race to ensure that, his horse is given full opportunity to win or to obtain the best possible place in the field and;
- (c) not to permit him to ride track work during the period of disqualification.
- (d) he was also informed of his right to appeal.

### Race: 11. The Air Force Trophy - (About) 1400 metres. Horses rated 45 to 65.

The Stipendiary Stewards reported Trainer Mr. M.P. Mahaesh to the Stewards for contravention Rule No. 114 (b) (i) for his negligence in discharge of duties as a trainer and a licensed professional under the BTC Rules of Racing (thereby violating - alleged breach of rules) in that on examination of the shoes on GOOD TIME INDEED in the above race it was found that the total weight of the shoes was 863 gms which was in excess of the prescribed limit of 600 gms as per the BTC Racing Calendar under the heading "SHOEING".

The Stewards held an enquiry on 12<sup>th</sup> November, 2018 and examined trainer Mr. M.P. Mahaesh.

After deliberations, the Stewards decided to fine him a sum of Rs.15,000/for contravention of Rule No. 114 (b)(i) for negligence pertaining to duties
as a trainer in respect of his charge GOOD TIME INDEED (2<sup>nd</sup> infringement)
in the above race.

#### THIRD DAY, FRIDAY, 9<sup>™</sup> NOVEMBER 2018

# Race: 14. The Lalitmahal Plate - (About) 1100 metres. Horses rated 00 to 20, 4 years old and over (Whips not allowed).

An enquiry was held on 12<sup>th</sup> November, 2018 by the Stipendiary Stewards for the above race in respect of Jockey R. Manjunath pertaining to his riding on his mount PROUDWISH, in that he failed to improve his position from 1000 Metres after having been positioned last and rounding the final bend

and getting into the straight he lacked vigour and enterprise in his riding and failed to ride out his horse vigorously despite his horse was responding.

Jockey R. Manjunath was interviewed by the Stipendiary Stewards. The Stipendiary Stewards, after considering the submissions made by Jockey R. Manjunath and trainer Mr. Pradeep Annaiah after viewing the CCTV replay of the race decided to charge Jockey R. Manjunath for Unsatisfactory Riding, Rule No. 161 (ii) of the BTC Rules of Racing.

The Stipendiary Stewards thereafter suspended Jockey R. Manjunath with effect from 23<sup>rd</sup> November, 2018 to 30<sup>th</sup> November, 2018 (both days inclusive) for Unsatisfactory Riding Rule No. 161 (ii) of the BTC Rules of Racing on his mount PROUDWISH (he is permitted to ride work and was informed of his right to appeal).
