## **RAILING POSITION : Railing fixed at average width of 8 Meters from 1600 Meters to winning post from its original position.**

## <u>1<sup>st</sup> Race: 30. The Beginners Plate - (About) 1100 metres. Maiden</u> Horses 2 years old only. (8 Runners).

Permission was granted to Trainer Mr. S. Narredu to withdraw AIR FORCE ONE (Rayan Ahmed R.) on veterinary grounds as it was found to be lame on left hind. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Nazerul Alam, the rider of HERE AND NOW was fined Rs.1,000/- for coming 'in' and causing interference to the horses on his inside viz; WOODY (K. Sai Kiran) ,KARADENIZ (Irvan Singh) and ESTELLA (Arshad Alam) passing the 950 Metres.

SIR PIGGOT (Y.S. Srinath) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f ANJEZE.

## <u>2<sup>nd</sup> Race: 31. The Belur Plate - (About) 1600 metres. Horses rated 00</u> to 20 (8 Runners).

Permission was granted to Trainer Mr.Sharat Kumar to withdraw DREAMS UNITED (K. Nazil) on veterinary grounds as it was found to be suffering from fever. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

NOBLE SPLENDOR (A.Imran Khan) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Faraz Arshad was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that WINX (Vinod Shinde) accidentally stumbled passing the 800 Metres.

Jockey Jan'dhan Paswan, the rider of ROMANTIC HAVEN reported that he accidentally lost his whip passing the 300 Metres.

It was observed that STRIKING GREY (Adarsh G.) was inclined to run out in the final 150 Metres of the race. The horse was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner gr g STRIKING GREY.

After the conclusion of the above race the Jockeys reported that the ground was slippery and a lot of kickback between the 900 Metres to 600 Metres.

# <u>3<sup>rd</sup> Race: 32. The Bidar Plate - (About) 1600 metres. Horses rated 30 to 50, 4 years old and over (7 Runners).</u>

Permission was granted to Trainer Mr.R.V.Manohar to withdraw SHAMSADAS GIRL (A.R.Pradeep) on veterinary grounds as it was found to be lame on right fore. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Mohd Asif Khan, the rider of ULTIMATE MAGIC reported that he accidently lost his whip approaching 300 Meters.

It was reported after the race that HUEMAC (Antony Raj S.) burst its blood vessels. Trainer Mr.Neil B Devaney was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr. S. Narredu was questioned regarding the relatively improved performance of his charge AUSTRALIS (P. Trevor). The trainer stated that:

(a) His charge was performing poorly over 1200 Metres and was slowly away and sluggish in its previous starts at Mysore;

(b) As such he had applied a pair of blinkers on his charge for the first time;

(c) His charge had performed very well in the Mock Race over a distance of 1600 Metres with the said equipment;

(d) He had fancied his horse to win as it was running in a relatively poor company.

His explanations were noted for future reference.

Routine Sample was taken for analysis from the winner b f AUSTRALIS.

## <u>4<sup>th</sup> Race: 33. The Manipal Plate - Div. I - (About) 1100 metres.</u> Horses rated 15 to 35 (12 Runners).

Jockey Arshad Alam, the rider of TIO RICO was fined Rs.3,000/- for shifting 'in' and causing interference to BAROG (H. G. Rathod) passing the 1000 Metres and for further shifting 'in' and causing interference to AINE (Tauseef Ahmed) on his inside approaching 950 Metres.

It was observed that PRINCEAZEEM (Shamaz Shareef) accidentally slipped from its right hind passing the 600 Metres.

Jockey Antony Raj S., the rider of SPIRITOUS was fined Rs.1,000/- for shifting out and causing interference to SUN POWER (P. Trevor) on his outside approaching 500 Metres.

SPIRITOUS (Antony Raj S.) sustained bleeding injury on left hind cannon.

Routine Sample was taken for analysis from the winner b f SPIRITOUS.

## <u>5<sup>th</sup> Race: 34. The Garden City Trophy - (About) 1400 metres. Horses</u> rated 45 to 65, 4 years old and over (11 Runners).

PSYCHIC WARRIOR (Y. S. Srinath) was extremely fractious, reared up whereby its right hind got stuck in the gates for a considerable period of time. On immediate examination by the Club's Veterinary Officer it was found to have sustained clipped bleeding injury on upper forth cannon. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Darius R. Byramji was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

KHAYYAM (Prashant P.Dhebe) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr.S. Inayathulla was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races and if it continued to behave in a similar manner during the race it would be banned to race under BTC Rules of Racing.

Jockey Ahsan Qureshi, the rider of DR LOGAN was fined Rs.1,000/- for coming 'in' and causing interference to TZAR (Rayan Ahmed R.) on his inside passing the 300 Metres.

Jockey Anjar Alam, the rider of ZAFRAN was fined Rs. 1,000/- for allowing his mount to drift out under the use of whip in the final 200 Metres.

Jockey Ahsan Qureshi, the rider of DR LOGAN was fined Rs.2,000/- for exulting before passing the winning post.

AFRICAN EMPEROR (Mohd. Asif Khan) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g DR LOGAN.

## <u>6<sup>th</sup> Race: 35. The Hyderabad Silver Vase - (About) 1200 metres.</u> Horses rated 75 and above (8 Runners).

It was observed that BATTALION (Prashant P.Dhebe) slipped from both fore legs thereby totally unbalancing and dislodging the rider passing the 850 Metres.

Jockey Harish. B, the rider of SIDE WINDER was fined Rs.3,000/- for coming 'in' and tightening RAFA (Arshad Alam) which in turn passed it onto BATTALION (Prashant P. Dhebe) on his inside passing the 900 Metres.

Jockey Arshad Alam, the rider of RAFA reported that his mount stopped galloping in the final 200 Meters of the race. The horse was impounded for veterinary examination. On examination it was found to have burst its blood vessels (Endoscopy - Grade IV). Trainer Mr.S. Dominic was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g SMILE STONE.

### DUE TO HEAVY RAIN RENDERING THE RACE TRACK NOT CONDUSIVE FOR RACING, THE STEWARDS OF THE BANGALORE TURF CLUB DECIDED TO CANCEL THE REMAINDER OF RACES.

## 7<sup>th</sup> Race: 36. The Manipal Plate - Div. II - (About) 1100 metres. Horses rated 15 to 35 (12 Runners).

## **CONFISCATED ITEMS FROM TRAINER MR. G. SANDHU'S STABLE**

The Stewards of the Bangalore Turf Club Ltd. at their meeting held on Friday, 16<sup>th</sup> November, 2018 considered the Charge Sheet No.657 dated 10th November, 2018 issued to Trainer Mr. G. Sandhu reading as follows:

## <u>"Charge Sheet No. 657</u>

[Allegation of a breach of the B.T.C. Rules of Racing]

The B.T.C. Stipendiary Stewards allege that the above named Defendant committed a breach of:

B.T.C. Rule/s 114 (b) (i) read with 202 (x) (b) of the B.T.C. Rules of Racing (thereby violating - alleged breach of rules)

(Outline description of allegation of breach)

In that on inspection of your stable;

The following items were confiscated which were under your charge / position viz; PLACEBO, PRE-FILLED SYRINGE (without wrapper), QUARTER PRE-FILLED SYRINGE (with wrapper), SMALL BOTTLE CONTAINING POWDER (with Chinese wrapper) and STOMACH TUBE.

Calendar Notification under heading "TRACHEOTOMY"-

The Stewards of the BTC give notice to Owners and Trainers that they forbid the tubing of horses on the day on which it is to run in a race. Trainers are required to notify the Club the names of horses under their training that have been tubed.

# Rule No. 114 (b) (i) read with Rule No. 202 (x) (b) of BTC Rules of Racing reading as under :-

## Rule No. 114(b) (i)

(b) In addition to or in lieu of any other penalties or punishments as may be laid down under these Rules of Racing, a Trainer may be fined, suspended or disqualified by the Stewards :-

(i) If his conduct or negligence or neglect in the performance of his duties as a licenced professional has led or could have led to a breach of the Rules of Racing;

## Rule No. 202 (x) (b)

202. The Stewards and/or the Stewards of the Club shall fine and/or punish and/or warn off and/or exclude and/or eject and/or disqualify and/or suspend or withdraw Licences, for any reason or reasons, from any race course or place where these Rules are in force, any of the following persons viz.: (x) (b) Any person who uses or has in his possession, any electric or electronic apparatus or any improper contrivance capable of affecting the performance of a horse in a race or training gallop.

# **1.** The Stewards examined trainer Mr. G. Sandhu and Dr. Jha, Private Veterinarian Practitioner at BTC.

# 2. The Stewards also considered the past offences by Trainer Mr. G. Sandhu under BTC Rules of Racing as detailed below:

### **"RECORD OF TRAINER SANDHU G.**

#### **MYSORE RACES 1999**

#### 13-8-1999 14. The Mount Everest Plate-(About) 1400 Metres.

Trainer Mr. G.Sandhu was fined Rs.500/- for making an error in the Starting declaration in respect of his charge MOVING CLOUD(S.Guruprasad) as regards shoeing.

#### 17-9-1999 80. The Weight In Gold Plate-(About) 1400 Metres.

Trainer Mr. G. Sandhu and Jockey Ryan Marshall were questioned regarding the running and riding of FAMILY HONOUR. Trainer Mr. G.Sandhu stated that (a) based on the previous pattern of running of this horse he had specifically instructed the rider to ride it in check till entering the straight (b) not to show daylight early (c) to ride out hands and heels in the straight (d) he was satisfied with the riding of Jockey Ryan Marshall on his charge and (e) similar riding instructions will be given to the riders riding this horse in future also. Jockey Ryan Marshall corroborating the statement of the trainer regarding the riding instructions added that he implicitly followed the instructions and could finish only 4th. While noting the explanations of Trainer for future reference, Jockey Ryan Marshall was informed that although he had to follow the riding instructions of the Trainer, he should use his own judgement depending on the pace of the race and the manner in which the race was run as in this case he allowed the other runners to take a sizeable lead which he could not compound at the end and that he was being given the benefit of a grave doubt at this instance and his riding would be closely monitored in future.

#### MYSORE SUMMER RACES 2000

#### 21-6-2000 16. The Beloved Prince Palte-(About) 1600 Metres.

Traienr Mr. G.Sandhu and Jockey Hanumant Singh were questioned regarding the running and riding of TABREEZ especially as to the reason for the rider taking an unduly long lead whereby it packed up in the straight. The Trainer stated that the horse was always ridden as a front runner as it was difficult to control it especially over a distance of 1600 Metres where the initial pace of the other runners was slow. Therefore, he had instructed the rider to take a good jump and ride it in front. He further stated that similar instruction would be given to the riders in future also. The rider corroborating the statement of the trainer added that he rode as per his riding instructions. Their explanations were noted for future reference.

#### 6th Race:52. The Republican Plate-Div.I-(About) 1200 Metres

Trainer Mr. G.Sandhu was fined Rs.5,000/- for the inconsistent pattern of running of his charge b g TABREEZ (S.Guruprasad) the winner of this race as compared to its previous runs in Race Nos.44 and 16 of the Mysore Summer Races 2000.

#### **MYSORE RACES 2000**

#### 31-8-200031. The Reliance Gold Trophy-Div.II-(About)1400 Mtrs.

Trainer Mr. G. Sandhu was fined Rs.500/- for making an error in the starting declaration in respect of his charge SNORTER (R.Devraj) as regards shoeing.

#### 8-9-2000: 53. The Rock Haven Plate-(About) 1400 Metres.

Trainer Mr. G.Sandhu was fined Rs.500/- for failing to use tongue strap on his charge TEQUILA RIDE (Ryan Marshall) for the use of which prior permission had been obtained. Subsequently tongue strap was put on TEQUILA RIDE before the start of the race.

#### MYSORE WINTER RACES 2000-2001

#### 3-1-2001 48. The Taj Mahal Plate-(About) 1200 Metres.

Trainer Mr. G.Sandhu and Jockey M.Shafiq were questioned regarding the running and riding of SNORTER. The Trainer state that (a) the horse in its last run after coming up well in the

straight did not accelerate to collar the winner, (b) the Jockey who rode last time advised me that it was not holding the bit and

therefore I used an Australian Nose Band today, (c) in my opinion it runs well if ridden in check, (d) therefore I instructed the rider to preserve it as much as possible and ride out in the last 300 Metres, (e) the rider fully followed my instructions but it did not improve well even after being ridden out in the last 300 Metres and (f) I am satisfied with the manner in which it was ridden by Jockey M.Shafiq. The rider corroborating the statement of the trainer added that when he rode out fully in the last 300 Metres the horse was running there and there only and did not respond well. Their explanations were noted for future reference.

#### MYSORE RACES 2001

#### 24-8-2001 30.The Nanoli Stud Million (Grade III)(About) 1400 Mtrs

Trainer Mr. G.Sandhu was fined Rs.2,000/- for failing to declare his charge ALEKTRYON to start for this race after having accepted with it.

#### ADDITIONAL REPORT MYSORE WINTER RACES 2001-2002 FIRST DAY, MONDAY, 12TH NOVEMBER, 2001

Trainer Mr. G. Sandhu was fined Rs.10,000/- by the Stewards for the contravention of Steward's instructions pertaining to the use of Mobile Phone in Mysore Race Club premises.

#### 11-2-2002: 73. The Vani Vilas Sagar Plate-(About) 1400 Metres.

Trainer Mr. G.Sandhu was fined Rs.500/- for failing to produce the declared colours at the scales in respect of his charge ROYALE INCARNATE.

#### 18-2-2002: 79. The Kalinadi Plate-(About) 1600 Metres.

Trainer Mr. G. Sandhu was fined Rs.500/- for failing to produce the declared colours at the scales in respect of his charge ROYALE INCARNATE (Imran Chisty). Subsequently `all black' emergency colours were permitted to be used.

#### 20-6-2002 19. The Sargur Stakes-(About) 1400 Metres.

Trainer Mr. G. Sandhu was fined Rs.500/- for making an error in the starting declaration in respect of his charge ROYALE INCARNATE (Ryan Marshall) as regards shoeing.

#### 10-12-2002: 26. The Pattadakal Plate-(About) 1200 Metres.

Trainer Mr. G. Sandhu was fined Rs.500/- for making an error in the starting declaration in respect of his charge LAPLANDER (P.Kumar) as regards shoeing.

#### 23-12-2002: 37. The Bijapur Plate-Div.I-(About) 1200 Metres.

Trainer Mr. G. Sandhu was fined Rs.500/- for making an error in the starting declaration in respect of his charge LAPLANDER (Vivek) as regards shoeing.

#### 10-3-2003: 102. The Itarsi Plate-Div.I-(About) 1200 Metres.

Trainer Mr. G. Sandhu was fined Rs.500/- for failing to use Blinkers on his charge ROSNOVSKI (P.Kumar) for the use of which permission had already been obtained. Subsequently Blinkers were put on ROSNOVSKI before leaving the paddock.

#### 17-11-2003: 7. The Sharavathi Plate-Div.II-(About) 1200 Metres

Trainer Mr. G. Sandhu was fined Rs.500/- for making an error in the starting declaration in respect of his charge RONSON (Afsar Khan) as regards shoeing.

### ADDTIONAL REPORT MYSORE WINTER RACES 2003-04 Sixth Day, Monday, 15th December, 2003

## 1st Race: 33. The Karkala Plate - (About) 1200 Metres (9 Runners) Horses rated 15 and below, 6, 7 and 8 years old, 4 and 5 years old rated below 0 eligible.

The Stewards ordered and held an enquiry after the last race on Monday, 12th January 2004 into the running and riding of PRESTIGIOUS BABY in the above race trained by Mr. G. Sandhu and ridden by Jockey Harish. After deliberations, the Stewards decided to (a) suspend Jockey Harish from riding in races from 22-1-2004 to 26-1-2004 (both days inclusive) for injudicious handling of his mount PRESTIGIOUS BABY in the above race; and (b) caution trainer Mr. G. Sandhu as to the future runnig of his charges in races.

#### STIPENDIARY STEWARDS, PUBLISHED BY ORDER OF THE STEWARDS.

#### 19-1-2004 68. The Kovalam Plate - (About) 1100 Metres.

Jockey M Reuben, the rider of SMALL SOLDIER, reported that his saddle shifted towards the left approximately 100 Metres after the start and that he was unable to offer proper assistance to his mount thereafter. Trainer Mr. G. Sandhu was fined Rs.1,000/- for faulty saddling of his charge.

#### 23-2-2004: 98.The Simhaghad Plate-Div.II-(About) 1100 Metres.

Trainer Mr. G. Sandhu was fined Rs.2,000/- for failing to produce the Fitness Certificate in respect of his charge ROSNOVSKI when he had been specifically instructed to do so after its run in Race No.16 of the Mysore Winter Races 2003-04.

#### 22-3-2004: 128. The Shanthinikethan Plate - (About) 1200 Metres.

Trainer Mr. G. Sandhu was fined Rs.500/- for making an error in the starting declaration in respect of his charge WOOL U GOOLI (B.L. Paswan) as regards shoeing.

#### 9-6-2004: 22. The Malavalli Plate-Div.II-(About) 1400 Metres.

Trainer Mr. G. Sandhu was fined Rs.500/- for failing to produce the declared colours at the scales in respect of his charge CHILL PILL (M. Suresh). Subsequently `all black' emergency colours were permitted to be used.

## 9-6-2004: 25.The J.K.Van Ingen Memorial Gold Cup - (About) 1600 Metres.

Trainer Mr. G. Sandhu was fined Rs.500/- for making an error in the starting declaration in respect of his charge ROYALE INCARNATE (M. Suresh) as regards shoeing.

#### 30-6-2004:46. The Kokkare Belluru Plate - Div.II - (About) 1400 Metres.

Trainer Mr. G. Sandhu was fined Rs.2,000/- for faulty saddling of his charge BRAVE BEAUTY.

## **30-6-2004: 50.** The Hyderabad Race Club Gold Trophy - (About) 1400 Metres.

Trainer Mr. G. Sandhu was fined Rs.500/- for failing to produce the declared colours at the scales in respect of his charge AVALEUR (M.Suresh). Subsequently `all black' emergency colours were permitted to be used.

Trainer Mr. G. Sandhu was fined Rs.5,000/- for unsatisfactory running of his charge AVALEUR.

#### 7-7-2004: 54. The Kapila Plate-Div.II-(About) 1200 Metres.

Trainer Mr. G. Sadhu was fined Rs.500/- for failing to produce the declared colours at the scales in respect of his charge STAR TRUSTEE (M. Suresh). Subsequently `all black' emergency colours were permitted to be used.

## 7-7-2004: 58. The Royal Western India Turf Club Ltd., Trophy (About) 1100 Metres.

Trainer Mr. G. Sandhu was fined Rs.500/- for failing to produce the declared colours at the scales in respect of his charge WHOSEFATHERWATGOES(B. Prithviraj). Subsequently `all black' emergency colours were permitted to be used.

#### 14-7-2004:65. The Red Rufus Plate-Div.I-(About) 1100 Metres.

Trainer Mr. G. Sandhu was fined Rs.2,000/- for failing to produce the Fitness Certificate from the Club's Veterinary Officer in respect of his charge GOLDEN THRONE when he had been specifically instructed to do so after its run in Race No.39 of Mysore Summer Races 2004.

## 21-7-2004: 71. The S.V.Subramaniam Memorial Gold Cup - Div.II (About) 1400 Metres.

The Stipendiary Stewards reported Trainer Mr. G. Sandhu to the Stewards for his negligence in the discharge of his duties as a trainer as regards saddling of his charge BRAVE BEAUTY (M. Suresh), in that approaching the 1200 Metres it was observed that the saddle had shifted back alarmingly whereby the rider could

not offer any assistance to his mount - this despite an earlier punishment meted out to him pertaining to a similar incident concerning the same horse in Race No.46 of the Mysore Summer Races 2004. The Stewards held an enquiry after the last race and interviewed Mr. G. Sandhu. After deliberations, they decided to fine a sum of Rs.10,000/- for the faulty saddling of his charge BRAVE BEAUTY in the above race (Rule No.114(a)(i) and Calendar Notification under the heading "Saddling of Horses").

#### 26-8-2004: 21.The Srirangapattana Plate - Div.II - (About) 1200 Metres.

The Stipendiary Stewards reported Jockey M Suresh to the Steward for unsatisfactory riding (Rule 161(ii)) on his mount STAR TRUSTEE, in the above race. The Stewards held an enquiry after the last race and interviewed Jockey M Suresh and Trainer, Mr. G. Sandhu. After deliberations, they decided to (a) suspend Jockey M .Suresh from riding in races from 5-9-2004 to 24-9-2004 (both days inclusive) for unsatisfactory riding (Rule 161(ii)) on his mount STAR TRUSTEE in the above race (permitted to ride work) and (b) fine Trainer, Mr. G Sandhu, Rs.5,000/- for the unsatisfactory running of his charge, STAR TRUSTE, in the above race.

#### 9-9-2004: 37. The Topmost Plate - Div.II-(About) 1200 Metres.

Trainer Mr. G. Sandhu was fined Rs.5,000/- for declaring Jockey M. Suresh to ride his charge ROSNOVSKI in this race when the rider's Jockey's licence was under suspension and Jockey M. Suresh was fined Rs.5,000/- for accepting to ride ROSNOVSKI when his Jockey's licence was under suspension. Hence ROSNOVSKI was permitted to be withdrawn.

#### 29-9-2004 92. The Bhadravathi Plate - (About) 1200 Metres.

Trainer Mr. G. Sandhu was fined Rs.500/- for failing to produce the declared colours at the scales in respect of his charge FIRE'S DEW (B. Prithviraj). Subsequently `all black' emergency colours were permitted to be used.

#### 14-10-2004: 115. The Sowcar T.Thimmappa Memorial Cup-Div.II-(About) 1200 Metres.

Trainer Mr. G. Sandhu was fined Rs.2,000/- by the Stewards for failing to declare his charge FIRE'S DEW to start for this race after having accepted with it.

## 14-10-2004: 117. The Sowcar T.Thimmappa Memorial Cup-Div.I - (About) 1200 Metres.
