## RACING INCIDENTS (38-44)

**GOING: GOOD** 

PENETROMETER READING: 3.5 Cms

RAILING POSITION: Railing fixed at average width of 3.5 Meters from 1600 Meters to

winning post from its original position.

### 1<sup>st</sup> Race: 38. The Hebbe Falls Plate - (About) 1100 metres. Horses rated 00 to 20 (12 Runners).

ROCKET PUNCH (Irvan Singh) took a fly jump.

Jockey Antony Raj S., the rider of FANTASTIC APP was fined Rs.1,000/- for shifting out and causing interference to the horses on his outside viz; PERFECTGOLDENERA (Naveen.M) and GREY HOUND (Darshan R.N) soon after the start.

Jockey Rajesh Kumar M, the rider of KANTHAKA was fined Rs.2,000/- for coming 'in' and causing interference to TORONTO (Arshad Alam) on his inside passing the 900 Metres.

GREY HOUND (Darshan R.N) was impounded for veterinary examination but no abnormality was reported (non co-operative for endoscopy).

Routine Sample was taken for analysis from the winner b f FANTASTIC APP.

### 2<sup>nd</sup> Race: 39. The Horanadu Plate - (About) 1600 metres. Horses rated 15 to 35, 4 years old and over (12 Runners).

CADILLAC SKY (Raghu K) after jumping out, veered out and did not raise a fluent gallop for the first 200 Metres. In view of its behaviour, Trainer Mr.Rajesh Narredu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SCARLET PRINCESS (Shamaz Shareef) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Sharat Kumar was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

CADILLAC SKY (Raghu K) accidentally brushed running rails passing the 1000 Metres.

GUMPTION (Manish R) was impounded for veterinary examination. On examination it was found to have sharp molars on both sides. Hence, Trainer Mr. Neil B Devaney was fined Rs. 3,000/- for his negligence (1st infringement).

DECLARATIONOFLOVE (Ryan Marshall) was impounded for veterinary examination but no abnormality was reported (non co-operative for endoscopy).

Routine Sample was taken for analysis from the winner ch c CASEY.

# 3<sup>rd</sup> Race: 40. The Kodagu Plate - Div. I - (About) 1400 metres. Horses rated 30 to 50, 4 years old and over (11 Runners).

RECZAI (Naveen M.) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was

permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Sharat Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

DEEPALIKA (A.R.Pradeep) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Pradeep Annaiah was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey P. Trevor, the rider of TOUCH OF CLASS reported that his mount was trying to run out between the 900 Metres and 600 Metres. The horse was impounded for veterinary examination but no abnormality was reported.

Jockey Nazerul Alam, the rider of ROYAL REIN was reprimanded for travelling wide rounding the final bend for no apparent reason.

Jockey Anjar Alam, the rider of REFERENCE was fined Rs.1,000/- for shifting 'in' and causing interference to EMIDIO (Harish B.) on his inside in the final 50 Metres of the race.

Jockey R. Praveen Shinde, the rider of DEL PORTO was reprimanded for dropping hands before passing the winning post.

An enquiry is being held into the improper practice of Jockey A.R. Pradeep, the rider of DEEPALIKA where he hit the horse with his hand on the head after passing the winning post.

PIPER REGINA (Irvan Singh) sustained bleeding injury on right fore cannon.

Routine Sample was taken for analysis from the winner b f ALLSETTOGO.

### 4<sup>th</sup> Race: 41. The Hoysala Salver - (About) 1600 metres. Horses rated 45 to 65 (9 Runners).

Permission was granted to Trainer Mr.Arjun Mangalorkar to withdraw MYSTIC MUSIC (Mudassar Nazar) on veterinary grounds as it was found to be suffering from colic. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr.S. Narredu was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge MR HANDSOME (1st infringement).

An enquiry is being held into the running and riding of ANGELINO, trained by S.S. Attaollahi and ridden by A. Sandesh in the above race.

Surprise sample was taken for analysis from b c ANGELINO.

Routine Sample was taken for analysis from the winner dk b g MR HANDSOME.

#### 5<sup>th</sup> Race: 42. The Bangalore Turf Club Trophy (Grade III) - (About) 1200 metres. 3 years old and over. (6 Runners).

Jockey Manish R, the rider of LIMATO was reprimanded for shifting 'in' and inconveniencing the horses on his inside viz; SOUTH BELL (H. G. Rathod) which in turn passed it onto GIFTED (Irvan Singh) passing the 950 Metres.

It was reported after the race that LIMATO (Manish R) burst its blood vessels. Trainer Mr.Prithviraj B. was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry is being held into the conduct of Jockey Y.S. Srinath, the rider of FIERCE FIGHTER in the above race.

Routine Sample was taken for analysis from the winner b g NOSTRADAMUS.

#### 7th Race: 44. The Kodagu Plate - Div. II - (About) 1400 metres. Horses rated 30 to 50, 4 years old and over (11 Runners).

STARRY WIND (Irvan Singh) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Darius R. Byramji was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

POWERSCOURT (Mudassar Nazar) sustained bleeding injury on left fore cannon.

SANTORINI SECRET (Rayan Ahmed R.) was impounded for veterinary examination but no abnormality was reported (non co-operative for endoscopy).
