# RACING INCIDENTS (45-52)

**GOING: GOOD** 

PENETROMETER READING: 3.0 Cms

RAILING POSITION: Railing fixed at its original position.

### 1<sup>st</sup> Race: 45. The Mount Joy Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35 (14 Runners).

DESERT ANGEL (T. S. Jodha) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.S. Dominic was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

CONSTANTINOPLE (P. Trevor) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S.S. Attaollahi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

HAPPY DANCING (Naveen M.) jumped awkwardly outwards and inconvenienced QUEEN ISABELLA (Nazerul Alam) soon after the start.

It was observed that SMILE OF COURAGE (Sunil Samson) was trying to run out between 900 Metres and 700 Metres. The horse was impounded for veterinary examination but no abnormality was reported.

Jockey Naveen M., the rider of HAPPY DANCING was reprimanded for travelling wide from the 800 Metres till about rounding the final bend for no apparent reason.

Jockey Rajesh Kumar M, the rider of SO I THINK was fined Rs. 1,000/- for coming 'in' and causing interference to PARADISO (A. Velu) on his inside passing the 300 Metres.

Jockey Jan'dhan Paswan, the rider of SEABORN reported that his mount was not galloping fluently throughout the race. The horse was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade - III). Trainer Mr. Sriram Komandur was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that QUEEN ISABELLA (Nazerul Alam) burst its blood vessels. Trainer Mr. Neil Darashah was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b g BENEDICTION.

## 2<sup>nd</sup> Race: 46. The Dharmasthala Plate - Div. II - (About) 1400 metres. Horses rated 15 to 35 (13 Runners).

Trainer Mr. S. Dominic was fined Rs. 10,000/- for having accepted his charge HABANERO, when it was under treatment. Subsequently, permission was granted to him to withdraw it from the above race.

BAIRAVA (A.R.Pradeep) ran detached from the field. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Pradeep Annaiah was informed to ensure better performance of his charge in future.

Jockey Arshad Alam, the rider of SAHARA reported that his mount got keen in the initial stages of the race for the first 400 Metres despite his best efforts to settle the horse. Trainer Mr. Neil Darashah was informed to take appropriate corrective measures before accepting with it again.

LOFTY THOUGHTS (Y. S. Srinath) sustained clipped injury on right fore outer bulb of heel.

Routine Sample was taken for analysis from the winner b g LOFTY THOUGHTS.

# 3<sup>rd</sup> Race: 47. The Mount Joy Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35 (13 Runners).

Permission was granted to Trainer Mr.Prithviraj B. to withdraw DON DELA VEGA (Manish R) on veterinary grounds as it was found to be lame on left fore. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

AMAZING SKILL (A. Velu) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.S. Narredu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

At the behest of the Stipendiary Stewards, the Stewards held an enquiry into the start of the race with specific reference to KUDLA PUNCH (Drawn 14). The Stewards examined the Jockey, Starter and the Stipendiary Stewards. Subsequently, the Stewards decided to declare Horse No.7 KUDLA PUNCH as a non starter and all bets related to this horse was refunded.

Jockey Tauseef Ahmed, the rider of VERNESCO reported that his mount was hanging 'in' in the last 300 Metres. The horse was impounded for veterinary examination. On examination it was found to be lame on left fore. Trainer Mr. Azhar Ali was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch f SPANISH BEAUTY.

## 4<sup>th</sup> Race: 48. The S.Rangarajan Memorial Trophy - Div. I - (About) 1200 metres. Horses rated 30 to 50 (13 Runners).

Permission was granted to Trainer Mr. Mahmood Khan to withdraw TRIGGAR on veterinary grounds as it was found to be trotting lame on right hind and also sustained bleeding injury on right knee, right hock and right hind fetlock. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

BEOND REACH (K. Sai Kiran) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. K.P.G Appu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Rajesh Kumar M, the rider of PRINCESS HOLLY reported that his mount was inclined to run out from 800 Metres till about 300 Metres. The horse was impounded for veterinary examination but no abnormality was reported.

Jockey P. Trevor, the rider of CASTAWAY was fined Rs. 2,000/- for shifting out and

taking out GRECIAN LIGHT (Anjar Alam) and FLORENCIA (K. Nazil), which in turn passed it onto VARCASVA (A. Sandesh) on his outside rounding the final bend.

Jockey A. Sandesh, the rider of VARCASVA reported that his horse was making a roaring noise. The horse was impounded for veterinary examination. On examination, it was found to have (ILH paralysis – on endoscopy) on left side cord. Trainer Mr. Neil B Devaney was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that EXPERT (M. Ravi) burst its blood vessels. Trainer Mr.Pradeep Annaiah was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f CASTAWAY.

## 5<sup>th</sup> Race: 49. The Bold Majesty Plate - (About) 1400 metres. Horses rated 60 and above (11 Runners).

SEDULOUS (Naveen M.) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Neil B Devaney was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

AUTOMATIC (Ahsan Qureshi) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Hidayat Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey P. Trevor, the rider of FIRE GLOW reported that his mount was hanging 'in' after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. Trainer Mr.Neil Darashah was informed to take appropriate corrective measures before accepting with it again.

Jockey K. Sai Kiran, the rider of BUSCADERO reported that his mount was hanging 'in' after entering the straight. The horse was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade -III). Trainer Mr. Azhar Ali was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that CLASSICAL DANCER (S. Zervan) could not get a clear run between 175 Metres and 150 Metres due to a closely packed field.

Jockey Ahsan Qureshi, the rider of AUTOMATIC was fined Rs.5,000/- for exulting after passing the winning post, thereby causing severe interference to the horses on his inside viz; FIRE GLOW (P. Trevor) and TURF STAR (K. Nazil).

Routine Sample was taken for analysis from the winner dk b g AUTOMATIC.

## 6<sup>th</sup> Race: 50. The Bangalore 1000 Guineas (Grade II) - (About) 1600 metres. 3-year-old Indian Fillies (foaled in 2015) (8 Runners).

Jockey A.Imran Khan, the rider of ORENDA was reprimanded for shifting 'in' and inconveniencing the horses on his inside viz; SHESMYSCRIPT (A. Sandesh) and HAMMERSMITH (P. Trevor) passing the 1500 Metres.

HARMONIA (Y. S. Srinath) ran detached from the field. Trainer Mr. Pradeep Annaiah was informed to ensure better performance of his charge in future.

LASSILO (Rajesh N) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Sandhu G. was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

LASSILO (Rajesh N) was impounded for veterinary examination. On examination it was found to have burst its blood vessels (Endoscopy Grade - IV). Trainer Mr. Sandhu G. was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry is being held into the running and riding of BAZINGA, trained by S. Inayathulla and ridden by Jockey Rajesh Kumar .M in the above race.

Routine Sample was taken for analysis from the winner b f AKITA PRO.

## 8<sup>th</sup> Race: 52. The S.Rangarajan Memorial Trophy - Div. II - (About) 1200 metres. Horses rated 30 to 50 (14 Runners).

LIGHTNING ATTACK (Adarsh G.) reared up as the gates opened and lost many lengths at the start. In view of its behaviour, Trainer Mr.V. Lokanath was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

DONNA ROSSA (K. Nazil) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Sandhu. G was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was reported after the race that WAR HERO (P. Trevor) burst its blood vessels. Trainer Mr.Neil Darashah was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

VENUS BAY (S. Zervan) was impounded for veterinary examination but no abnormality was reported.

MAYBE FOREVER (A.R. Pradeep) was impounded for veterinary examination but no abnormality was reported.
