**RACING INCIDENTS**  
**(61-66)**

**GOING : GOOD**

**PENETROMETER READING: 3.5 Cms**

**RAILING POSITION: Railing fixed at average width of 2.5 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 61. The Chamundi Hills Cup - Div. II - (About) 1400 metres. Horses rated 15 to 35 (11 Runners).**

Permission was granted to Trainer Mr. Azhar Ali to withdraw SHIVALIK KISS (Darshan R.N) on veterinary grounds as it was found to be lame on left fore. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr. S.S. Attaollahi was fined Rs. 5,000/- for not obtaining prior permission for the use of tongue strap on his charge AMBROSIO (P. Trevor). Subsequently, permission was granted to him to use tongue strap before horses left the paddock.

It was observed that TIGER RETURNS (Rajesh N) threw its head up in the air while jumping out of the starting gates.

RAVISHING SNOW (Tauseef Ahmed) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. F. Sirajuddin was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SMILE OF JOY (T. S. Jodha) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Dominic was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Harish B., the rider of SILENT RULER was fined Rs. 1,000/- for coming 'in' and causing interference to LE MARC (Arshad Alam) on his inside passing the 300 Metres.

RAVISHING SNOW (Tauseef Ahmed) was impounded for veterinary examination. On examination, it was found to be trotting lame on left fore due to wound inside mid third cannon. Trainer Mr. F. Sirajuddin was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Arshad Alam, the rider of LE MARC reported that his mount was galloping in patches after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g AMBROSIO.

**2<sup>nd</sup> Race: 62. The Red Baron Plate - (About) 1400 metres. Horses rated 30 to 50 (12 Runners).**

Jockey Y. S. Srinath, the rider of AEOLUS was severely reprimanded for shifting 'in' and inconveniencing the horses on his inside viz; RECZAI (Naveen M.), PRINCEAZEEM (T. S. Jodha) and GERONTOCRAT (Imran Chisty) soon after the start.

Jockey Y. S. Srinath, the rider of AEOLUS was reprimanded for shifting 'in' and inconveniencing STANLEY (Sunil Samson) on his inside passing the 700 Metres.

Jockey A.Imran Khan, the rider of DECISIVE was reprimanded for dropping hands before passing the winning post.

Jockey Ryan Marshall, the rider of HUKUM was reprimanded for dropping hands before passing the winning post.

It was reported after the race that PRINCEAZEEM (T. S. Jodha) had apparently lost its left fore shoe during the race.

AEOLUS (Y. S. Srinath) was impounded for veterinary examination. On examination, it was found to have pulled up its left testicle.

Routine Sample was taken for analysis from the winner b c GERONTOCRAT.

**3<sup>rd</sup> Race: 63. The Krishna Raja Sagar Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35, 4 years old and over (10 Runners).**

TEA WID ME (D. Patel) jumped awkwardly outwards and inconvenienced COLOUR OF GOLD (H. G. Rathod) on its outside soon after jumping out of the starting gates.

It was observed that AMALFI COAST (Kiran Rai P) was forced to travel wide from 1000 Metres to 700 Metres.

It was observed that AMAZONITE (Shamaz Shareef) had to steady his mount passing the 900 Metres.

Jockey Rajesh N, the rider of SILKEN STRIKER was fined Rs.2,000/- for exulting before passing the winning post.

It was reported after the race that FINE BARRISTOR (K. Raja Rao) pulled up lame on left fore. Trainer Mr. Mahmood Khan was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g SILKEN STRIKER.

**4<sup>th</sup> Race: 64. The Chamundi Hills Cup - Div. I - (About) 1400 metres. Horses rated 15 to 35 (12 Runners).**

FIORENZO (Anjar Alam) jumped awkwardly outwards onto ASHOKA THE GREAT (Rajesh N), which in turn passed it onto CIEL ETOILE (A. Sandesh) soon after the start.

HOLY TRINITY (Y. S. Srinath) jumped awkwardly inwards and inconvenienced CIEL ETOILE (A. Sandesh) soon after the start.

It was observed that the towel used to wipe the sweat on HOLY TRINITY was stuck in the left boot of the Jockey which came off passing the 1100 Metres. Jockey Y. S. Srinath was cautioned to be more careful in future.

LIKEAKNIFE (Rajesh Kumar M) ran detached from the field. The horse was impounded for veterinary examination. On examination, it was found to be lame on right fore and also sustained deep bleeding clipped injury on right fore bulb of heel. Trainer Mr. Narayana Gowda V. was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g MOHICAN.

**5<sup>th</sup> Race: 65. The Linganamakki Plate - (About) 1400 metres. Horses rated 00 to 20, 4 years old and over (12 Runners).**

Jockey M. Prabhakaran, the rider of DANCING PRINCESS was fined Rs.1,000/- for shifting 'in' and causing interference to INKY BLACK (Arshad Alam) on his inside passing the 1000 Metres.

It was observed that MAGNIFICENT MARY (Sunil Samson) accidentally stumbled approaching 600 Metres, dislodging the rider. On examination, it was found to have fractured both fore radius bones. Hence, it was euthanized.

Jockey IndraJeet Singh, the rider of HAPPY HOURS reported that he accidentally lost his whip approaching 200 Meters.

It was reported after the race that EMANCIPATION (Irvan Singh) pulled up lame on left fore. Trainer Mr. M. Rajendra Singh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ABLE MASTER (Darshan R.N) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g PARTING SHOT.

**6<sup>th</sup> Race: 66. The Krishna Raja Sagar Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35, 4 years old and over (11 Runners).**

Jockey Nazerul Alam replaced the indisposed Jockey Sunil Samson on GALINO.

AGNAR (Tauseef Ahmed) after jumping out swerved towards the left and lost many lengths. In view of its behaviour, Trainer Mr. Pradeep Annaiah was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

It was reported after the race that KUDLA PUNCH (Naveen M.) burst its blood vessels. Trainer Mr. Sharat Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that CAPSTONE (M. Prabhakaran) burst its blood vessels. Trainer Mr. Kishan Thomas was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

OWN SCRIPT (P. Mani) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b m KUDLA PUNCH.
