RACING INCIDENTS
(67-72)

GOING : GOOD

PENETROMETER READING: 3.0 Cms

RAILING POSITION: Railing fixed at its original position.

1st Race: 67. The Novice Plate - (About) 1200 metres. Maiden Horses 2 years old only. (11 Runners).

Jockey Rayan Ahmed .R replaced the indisposed Jockey Sunil Samson on SIR PIGGOT.

Jockey A.Imran Khan, the rider of SOUTHERN RULER reported that his right rein snapped rounding the final bend and thereafter his mount raced on sand track. On examination of the equipment, it was found to be in a good condition. As the incident was accidental no action was taken beyond noting the incident.

Jockey Rayan Ahmed R., the rider of SIR PIGGOT reported that he accidentally lost his whip passing the 300 Meters.

Jockey T. S. Jodha, the rider of SILENT GUARDIAN reported that his mount was inclined to run out in the last 200 Metres.

Routine Sample was taken for analysis from the winner b c MALWA.

2nd Race: 68. The Beloved Prince Plate - (About) 1100 metres. Horses rated 15 to 35, 4 years old and over (13 Runners).

Permission was granted to Trainer Mr.Prithviraj B. to withdraw DEPTH CHARGE (Manish R) on veterinary grounds as it was found to be lame on left fore. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr. Pradeep Annaiah was fined Rs.10,000/- for the inconsistent running of his charge AINE (A.Imran Khan) as compared to its previous run in Race No. 33 i.e., The Manipal Plate - Div. I - (About) 1100 metres. Horses rated 15 to 35 run on 23rd November, 2018 where it ran unplaced.

Jockey Irvan Singh, the rider of SMILE OF COURAGE was reprimanded for coming 'in' and inconveniencing AINE (A.Imran Khan) on his inside passing the 975 Metres.

Jockey Shamaz Shareef, the rider of GOOD WORD was fined Rs.1,000/- for coming 'in' and causing interference to SO I THINK (Rajesh Kumar M) on his inside approaching 900 Metres.

It was observed that HAPPY DANCING (H. G. Rathod) could not get a clear run in the final 200 Metres of the race.

It was reported after the race that MAJESTIC HEROINE (Harish B.) pulled up lame on right fore. Trainer Mr. Azhar Ali was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SMILE OF COURAGE (Irvan Singh) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch f AINE.

3rd Race: 69. The S.V.Subramaniam Memorial Trophy - (About) 1600 metres. Horses rated 30 to 50, 4 years old and over (12 Runners).

CASEY (Y. S. Srinath) took a fly jump.

NITROMAX (Arshad Alam) took a fly jump.

HANKO (Imran Chisty) ran detached in the final 300 Metres. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Sandhu G. was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b c DONT DILLY DALLY.

4th Race: 70. The Manjri Stud Bangalore 2000 Guineas(Grade II) - (About) 1600 metres. 3-year-old Indian Horses (foaled in 2015) (9 Runners).

Jockey Yash Narredu, the rider of SEA QUEST was fined Rs.2,000/- for coming 'in' and tightening the horses on his inside viz; KNOTTY ASH (Imran Chisty) and PSYCHIC FORCE (Y. S. Srinath) passing the 1500 Metres.

SEA QUEST (Yash Narredu) ran detached after rounding the final bend. The horse was impounded for veterinary examination. On examination, it was found to be lame on left fore. Trainer Mr. M. Narredu was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SALVADOR DALI (David Allan) sustained superficial injury on right fore cannon.

AIR COMMAND (Neeraj Rawal) sustained bleeding wound on right side ventral mandible.

KNOTTY ASH (Imran Chisty) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b c KNOTTY ASH.

Compulsory samples were taken for analysis from the following I,II & III placed horses viz:

5th Race: 71. The Kunigal Stud Plate - (About) 1200 metres. Horses rated 45 to 65, 4 years old and over (13 Runners).

TORSORO (Rajesh N) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Sandhu G. was informed

that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that AEISIR (Suraj Narredu) was hanging 'in' despite the best efforts of the Jockey to keep it on a straight course, whereby it shifted 'in' and caused interference to LOUISIANA (P. Trevor) on its inside approaching 1000 Metres.

It was observed that SHAN BEN AARI (Rajesh Kumar M) pulled up lame passing the 700 Metres. The horse was impounded for veterinary examination. On examination, it was found to be lame on right fore. Trainer Mr. Narayana Gowda V. was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b g LOUISIANA.

6th Race: 72. The Amathos Plate - (About) 1200 metres. Horses rated 15 to 35 (14 Runners).

Jockey Rayan Ahmed .R replaced the indisposed Jockey Tauseef Ahmed on IRON FIST.

Jockey Harish.B replaced the indisposed Jockey Ganesh.N on PERFECTGOLDNERA.

ANDRA KING (Suraj Narredu) jumped awkwardly outwards and inconvenienced MULTIFACETED (Y. S. Srinath) soon after the start.

HIMACHALI (A. Sandesh) reared up as the gates opened and lost few lengths at the start. In view of its behaviour, Trainer Mr. Neil B Devaney was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner b c MULTIFACETED.

Permission was granted to trainers M/s. Neil B. Devaney, G. Nityanand and Vishal Gaikwad to deputise on behalf of trainers M/s. S.S. Attaollahi, S. Padmanabhan and P. Shroff who were unable to attend the races.
