RACING INCIDENTS (73-79)

GOING: GOOD

PENETROMETER READING: 3.0 Cms

RAILING POSITION: Railing fixed at average width of 5.5 Meters from 1600 Meters to

winning post from its original position.

1st Race: 73. The Agumbe Plate - (About) 1200 metres. Horses rated 00 to 20 (12 Runners).

HUNTERS MOON (Antony Raj S.) after jumping out bumped FIERCE FIGHTER (P. Trevor), which in turn passed it onto ANOTHER RAINBOW (Rayan Ahmed R.) soon after the start.

PREMIER PREMISES (K. Sai Kiran) jumped awkwardly inwards and inconvenienced FIERCE FIGHTER (P. Trevor) on its inside soon after the start.

It was observed that PHOENIX REACHED (T. S. Jodha) accidentally stumbled passing the 1000 Metres.

Jockey A.R.Pradeep, the rider of DARAHASINI was reprimanded for travelling wide from 600 Metres till about rounding the final bend for no apparent reason.

Jockey Md.Akram, the rider of DALLAS was fined Rs.2,000/- for not sufficiently persevering on his mount during the race.

Jockey Imran Chisty, the rider of KANTHAKA was reprimanded for not wearing his goggles during the race.

KANTHAKA (Imran Chisty) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade - IV). Trainer Mr. Narayana Gowda V. was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b r ANOTHER RAINBOW.

2nd Race: 74. The Kolar Plate - Div. II - (About) 1600 metres. Horses rated 15 to 35 (11 Runners).

Trainer Mr. Sandhu G. was fined Rs.5,000/- for not obtaining a prior permission for the use of Side Cheek Pieces on his charge MAYNE DIMENSION. Subsequently, permission was granted to him to use Side Cheek Pieces before horses left the paddock.

As Jockey Ahsan Qureshi was unable to arrive to fulfill his riding engagement (as his father was ill). Permission was granted to trainer Mr. S. Padmanabhan to declare Jockey Ryan Marshall to ride TEQUILA TORNADO in the place of declared rider.

MAYNE DIMENSION (Rajesh .N) walked out of the gates and lost many lengths at the start. In view of its behaviour, Trainer Mr. Sandhu G. was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

MERITORIOUS (Darshan R.N) jumped out awkwardly, lost many lengths and did not raise a fluent gallop for the first 100 Metres. In view of its behaviour, Trainer Mr. S.

Ganapathy was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

PRINCE CHARMO (Jan'dhan Paswan) was slightly slowly away.

Jockey Imran Chisty, the rider of JERSEY STORM reported that his mount was running green throughout the race.

Jockey Manish R, the rider of IDO WHAT I DO was reprimanded for riding an indifferent race.

CAPRILE (P. Trevor) sustained bleeding cut injury on left hind cannon.

JERSEY STORM (Imran Chisty) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch g MARIACHI.

3rd Race: 75. The O.M.Lingappa Silver Bar Trophy - (About) 1600 metres. Horses rated 30 to 50 (11 Runners).

It was observed that the saddle on MIDNIGHT SKY (Darshan R.N) had shifted forward passing the 1400 Metres as such the Jockey could not offer any assistance on his mount thereafter. After due examination of the equipment, Trainer Mr. V. Lokanath was fined Rs.3,000/- for faulty saddling of his charge.

Jockey A.Imran Khan, the rider of PLAY SAFE was fined Rs.1,000/- for the improper use of whip on his mount during the race.

Jockey Arshad Alam, the rider of MASADA reported that his mount was hanging 'in' after entering the straight. The horse was impounded for veterinary examination. On examination, it was found to have raw wound on left commissure of mouth. However, Trainer Mr. Imtiaz Khan was informed to take appropriate corrective measures before accepting with it again.

MIDNIGHT SKY (Darshan R.N) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g MYSTIC FLAME.

4th Race: 76. The Gumbaz Plate - Div. II - (About) 1100 metres. Horses rated 15 to 35 (9 Runners).

ODYSSEY (Naveen M.) was extremely fractious at the start and refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under starter's order.

UNBROKEN (Rayan Ahmed R.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Hidayat Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Rayan Ahmed R., the rider of UNBROKEN reported that his mount was running green throughout the race.

Jockey Md.Akram, the rider of GLOBAL RULER was fined Rs.1,000/- for shifting out and taking out SIMPLY MAGICAL (Shamaz Shareef) between the 700 Metres and 600 Metres.

BRIGHTSIDE OF LIFE (K. Sai Kiran) was impounded for veterinary examination. On examination, it was found to be trotting lame on left fore. Trainer Mr. Pradeep Annaiah was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g STARS IN HIS EYES.

5th Race: 77. The Dr.M.A.M.Ramaswamy Memorial Trophy - (About) 1600 metres. Horses rated 75 and above (12 Runners).

As Jockey Ahsan Qureshi was unable to arrive to fulfill his riding engagement (as his father was ill). Permission was granted to trainer S. Padmanabhan to declare Jockey Ryan Marshall to ride BARACCHUS in the place of declared rider.

PINYADA (Nazerul Alam) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.S. Inayathulla was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

BARACCHUS (Ryan Marshall) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.S. Padmanabhan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey T. S. Jodha, the rider of FIRE GLOW was reprimanded for shifting 'in' and inconveniencing STAR CARNATION (A.Imran Khan), which in turn passed it onto AUTOMATIC (Suraj Narredu) on his inside passing the 1400 Metres.

It was observed that BARACCHUS (Ryan Marshall) accidentally stumbled approaching 900 Metres.

Jockey Suraj Narredu, the rider of AUTOMATIC was fined Rs.1,000/- for shifting out and causing interference to RUM RUNNER (Imran Chisty) on his outside approaching 400 Metres.

Jockey Ryan Marshall, the rider of BARACCHUS was questioned regarding dropping of hands in the final 400 Metres. Jockey stated that as he got into the horse and pushed, it started choking and refused to gallop. The horse was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g AUTOMATIC.

6th Race: 78. The Gumbaz Plate - Div. I - (About) 1100 metres. Horses rated 15 to 35 (9 Runners).

Permission was granted to Trainer Mr. Neil Darashah to withdraw MERCURY (P. Trevor) on veterinary grounds as it was found to be lame on right fore. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr. Azhar Ali was fined Rs.10,000/- for having accepted his charge SHIVALIK SHOW (Tauseef Ahmed), when it was under medication. Subsequently, permission was granted to him to withdraw the horse from the above race.

Jockey Naveen M., the rider of FIRST STEP reported that he lost his whip in the starting gates.

Jockey Suraj Narredu, the rider of CHARMED LIFE reported that he accidently lost his whip passing the 200 Meters.

Routine Sample was taken for analysis from the winner b f CHARMED LIFE.

7th Race: 79. The Kolar Plate - Div. I - (About) 1600 metres. Horses rated 15 to 35 (11 Runners).

Permission was granted to Trainer Mr. Dheeraj.V to withdraw GOLD MIST (R.Praveen Shinde) on veterinary grounds as it was found to be suffering from colic. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

BAIRAVA (M. D. Praveen) ran detached from the field. Trainer Mr. Pradeep Annaiah stated that as informed earlier, he would retire the horse.

Routine Sample was taken for analysis from the winner b g SPIRIT BRUCE.

Permission was granted to trainers Mr. Darius R. Byramji to deputise on behalf of trainers Mr. Parvathi Byramji who was unable to attend the races.
