RACING INCIDENTS (80-87)

GOING: GOOD

PENETROMETER READING: 3.4 Cms.

RAILING POSITION: Railing fixed at average width of 3 Meters from 1600 Meters to winning post from its original position.

<u>1st Race: 80. The Amber Regent Plate - Div. II - (About) 1200 metres.</u> Horses rated 15 to 35 (11 Runners).

Permission was granted to Trainer Mr. Prithviraj B. to withdraw SECRETSUPERSTAR on veterinary grounds as it was found to be lame on right fore. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey H. G. Rathod, the rider of PERFECTASTHER reported that his mount was inclined to run out between the 900 Metres and 800 Metres. Trainer Mr. Sharat Kumar was informed to take appropriate corrective measures before accepting with it again.

Jockey Irvan Singh, the rider of COUNTRY'S STAR reported that his mount was hanging 'in' from the 800 Metres. The horse was impounded for veterinary examination. On examination, it was found to have sharp molars on right side and trotting lame on left fore. However, Trainer Mr. Faraz Arshad was fined Rs.3,000/- for his negligence (1st infringement) and was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that Jockey David Allan, the rider of ROYAL RESOLUTION had to check his mount between the 500 Metres to 450 Metres due to the crowding of the field.

It was observed that Jockey Tauseef Ahmed, the rider of ANAKIN had to steady his mount to avoid striking the front runner PICCOLA (K. Sai Kiran) passing the 300 Metres.

Jockey Mudassar Nazar, the rider of SIMONE was reprimanded for shifting 'in' and inconveniencing PICCOLA (K. Sai Kiran) on his inside approaching 200 Metres.

Jockey Tauseef Ahmed, the rider of ANAKIN was fined Rs.3,000/- for not making sufficient effort on his mount during the race.

It was reported after the race that PICCOLA (K. Sai Kiran) burst its blood vessels. Trainer Mr. Neil B Devaney was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SHAKTIMAN (Manish R) sustained bleeding injury on right fore cannon.

Routine Sample was taken for analysis from the winner ch f SAHARA.

2nd Race: 81. The Native Chieftan Plate - (About) 1400 metres. Horses rated 15 to 35, 4 years old and over (Whips not allowed) (12 Runners).

DREAMS UNITED (Vijay Kumar) jumped awkwardly inwards.

Jockey Manish R, the rider of ALL BY MYSELF reported that his mount was hanging out after passing the 600 Metres. The horse was impounded for veterinary examination. On examination, it was found to be lame on right fore. Trainer Mr. K.P.G Appu was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey K. Sai Kiran, the rider of KINGOFHEARTS was fined Rs.1,000/- for hitting the horse with his hands during the race.

Jockey D. Patel, the rider of TEA WID ME was reprimanded for dropping hands before passing the winning post.

An enquiry is being held into running and riding of INCITATUS, trained by Prithviraj B. and ridden by Jockey Md.Akram in the above race.

Routine Sample was taken for analysis from the winner b g ULTIMATE POWER.

<u>3rd Race: 82. The Mekedatu Plate - (About) 1200 metres. Horses rated 60 and above (8 Runners).</u>

TURF STAR (K. Sai Kiran) buckled soon after jumping out of the starting gates, thereby inconvenienced SIDE WINDER (Harish B.) on its inside.

Routine Sample was taken for analysis from the winner b g SAINT PETERSBURG.

4th Race: 83. The G.Krishnappa Memorial Trophy - Div. I - (About) 1200 metres. Horses rated 30 to 50 (12 Runners).

Jockey Darshan R.N, the rider of ULTIMATE SPEED was reprimanded for shifting out and taking out MAHANATI (K. Sai Kiran) on his outside passing the 800 Metres.

Jockey Kiran Rai P, the rider of PRINCESS HOLLY was reprimanded for travelling wide after entering the straight for no apparent reason.

Jockey Arshad Alam, the rider of ALPHA reported that his mount was hanging out in the final 300 Metres. The horse was impounded for veterinary examination but no abnormality was reported. Trainer Mr.Neil Darashah was informed to take appropriate corrective measures before accepting with it again.

CHEMICAL ROMANCE (Shamaz Shareef) ran detached from the field. Trainer Mr. Nityanand G. was informed to ensure better performance of his charge in future.

Jockey Imran Chisty, the rider of YERWAZAN, placed 2nd by the judge objected against Jockey Anjar Alam, the rider of DAISY DUKE placed 1st for "In the last 75 Meters the winner shifted 'in' sharply where I had to stop riding, pull him out which cost me a certain race.". The Stewards held an enquiry immediately after the race and interviewed the Jockeys concerned. After deliberations, they decided to overrule the objection.

Jockey Anjar Alam, the rider of DAISY DUKE was fined Rs.2,000/- for coming 'in' and tightening YERWAZAN (Imran Chisty) on his inside in the final 75 Metres.

It was reported after the race that YERWAZAN (Imran Chisty) pulled up lame on right fore. Trainer Mr. Prasanna Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m DAISY DUKE.

5th Race: 84. The Manasa Sarovara Trophy - (About) 1800 metres. Horses rated 45 to 65 (9 Runners).

Permission was granted to Trainer Mr. Prasanna Kumar to withdraw KING OF THE WIND (P. Trevor) on veterinary grounds as it was found to be lame on left hind. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

LYCURGUS (Harish B.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Prithviraj B. was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Arshad Alam, the rider of NITROMAX reported that he could not get a clear run at the start due to the crowding of the field.

It was observed that MYSTIC MUSIC (Mudassar Nazar) was inclined to run out after entering the straight. The horse was impounded for veterinary examination. On examination, it was found to have pulled up lame on right fore. Trainer Mr.Arjun Mangalorkar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g SET TO WIN.

6th Race: 85. The G.Krishnappa Memorial Trophy - Div. II - (About) 1200 metres. Horses rated 30 to 50 (12 Runners).

TARINI (A. Velu) after jumping out swerved towards the left, dislodging the rider and ran riderless thereafter. In view of its behaviour, Trainer Mr.S. Narredu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey David Allan, the rider of MOST WELCOME reported that he could not get a clear run passing the 500 Metres.

Jockey Darshan R.N, the rider of WAR ENVOY reported that he could not get a clear run in the last 100 Metres.

Routine Sample was taken for analysis from the winner b f VENUS BAY.

7th Race: 86. The Amber Regent Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35 (11 Runners).

Trainer Mr. Azhar Ali was fined Rs.3,000/- for the late submission of scratching form in respect of his charge SHIVALIK KISS for the above race.

Permission was granted to Trainer Mr.Azhar Ali to withdraw VERNESCO on veterinary grounds as it was found to be lame on left fore. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

RED INDIAN (Irvan Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mrs. Parvati Byramji was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner b f ANGELS KISS.

Permission was granted to trainers Mr. Hidayat Khan to deputise on behalf of trainers Mr. S. Inayathulla who was unable to attend the races.
