

**BANGALORE WINTER MEETING 2018-2019**

**RACING INCIDENTS**  
**(87-94)**

**GOING : SOFT**

**PENETROMETER READING: 4.6 Cms.**

**RAILING POSITION: Railing fixed at its original position.**

**1<sup>st</sup> Race: 87. The Infants Plate - (About) 1100 metres. Maiden Horses 2 years old only. (11 Runners).**

Jockey Suraj Narredu, the rider of STAR APPEARANCE was fined Rs.1,000/- for coming 'in' and tightening the horses on his inside viz; MUSTERION (A.Imran Khan) and DESERT EMPIRE (David Allan) soon after the start.

Jockey A.Imran Khan, the rider of MUSTERION was reprimanded for coming 'in' and inconveniencing the horses on his inside viz; CRACK OF DAWN (A. Sandesh) and WOODY (A.R. Pradeep) passing the 300 Metres.

STAR APPEARANCE (Suraj Narredu) sustained superficial injury on right hind fetlock.

SPEEDSTER (Darshan R.N) sustained bleeding injury on left fore.

Routine Sample was taken for analysis from the winner b f STAR APPEARANCE.

**2<sup>nd</sup> Race: 88. The Mudabidri Plate - (About) 1600 metres. Horses rated 00 to 20 (12 Runners).**

Jockey Darshan R.N. was fined Rs.2000/- for not drawing the declared weight on the scales. Subsequently, permission was granted to Trainer Mr. Imtiaz Khan to declare Jockey Harish B. to ride PERFECT PRINCE in place of the declared rider.

Jockey K. Sai Kiran, the rider of NATALIE was fined Rs.10,000/- for coming 'in' sharply and caused severe interference to the horses on his inside viz; KINGS KID (Suraj Narredu) and GOLDEN OPINION (Ashok Kumar A.) approaching 1400 Metres.

Jockey T. S. Jodha, the rider of EXTREMELYDANGEROUS reported that his mount was lugging out under pressure in the final 200 Metres.

Jockey Naveen M., the rider of SECURING SMILES was fined Rs.2,000/- for not sufficiently persevering with his mount in the final 200 Metres.

It was reported after the race that ALL SAID AND DONE (Adarsh G.) had apparently lost its right fore shoe during the race.

Trainer Mr. Nityanand G. was questioned regarding the poor performance of his charge DONTBREAKTHERULES (Arshad Alam). The trainer stated that:

(a) he had instructed the rider to ride from 3<sup>rd</sup> – 4<sup>th</sup> position and do his best in the straight;

(b) His charge had run a close 5th in Race No.2 in a higher class as such he choose to run it over a mile in a lower class i.e., 00 to 20.

(c) The rider rode as per his instructions but it appeared to him as the horse was drifting out under pressure in the final 200 Metres.

(d) The Jockey corroborated the statement of the trainer and added that his mount was inclined to run out from 1000 Metres.

Their explanations were noted for future reference.

Routine Sample was taken for analysis from the winner b m EXTREMELYDANGEROUS.

**3<sup>rd</sup> Race: 89. The Bellary Plate - Div. II - (About) 1400 metres. Horses rated 15 to 35, 5 years old and over (11 Runners).**

Jockey Mudassar Nazar, the rider of FIND reported that he lost his left stirrup soon after jumping out of the starting gates, which he regained passing the 1000 Metres.

Jockey A.R.Pradeep, the rider of MASTERS GLORY was reprimanded for travelling wide between the 500 Metres and 400 Metres for no apparent reason.

Jockey Kiran Rai P, the rider of BAZINGA was reprimanded for travelling wide between the 500 Metres and 400 Metres for no apparent reason.

Jockey A.R.Pradeep, the rider of MASTERS GLORY reported that he accidentally lost his whip passing the 200 Metres.

It was observed that GUMPTION (IndraJeet Singh) pulled up after the winning post and was found to have blood from both nostrils, collapsed and died. An enquiry is being held into the incident.

Routine Sample was taken for analysis from the winner b m FOTOGENIC.

**4<sup>th</sup> Race: 90. The Lal Bagh Trophy - (About) 1600 metres. Horses rated 60 and above (11 Runners).**

Jockey P. Trevor, the rider of ST PAULI GIRL reported that his mount was slightly slowly away as such he could not obtain the desired forward position as instructed by his trainer.

Routine Sample was taken for analysis from the winner b g SAGRADA.

**5<sup>th</sup> Race: 91. The Gustav Hermann Krumbiegel Cup - (About) 1400 metres. Horses rated 45 to 65 (11 Runners).**

Jockey Suraj Narredu, the rider of QUEEN LATIFA reported that his mount stumbled twice passing the 1200 Metres and he was totally unbalanced, as such he eased his mount, pulled up passing the 500 Metres and did not complete the course. The horse was impounded for veterinary examination but no abnormality was reported.

Jockey Tauseef Ahmed, the rider of IDEALIST reported that his mount accidentally stumbled approaching 700 Metres and also passing the 400 Metres. The horse was impounded for veterinary examination but no abnormality was reported.

It was observed that WHITE GOLD (Harish B.) pulled up approaching 300 Metres, dislodging the rider and did not complete the course. On immediate examination, it was found to have blood from both nostrils, collapsed and died.

Routine Sample was taken for analysis from the winner b f ALLSETTOGO.

**6<sup>th</sup> Race: 92. The Chief Minister's Trophy - (About) 2000 metres. 3 years old and over. (4 Runners).**

Routine Sample was taken for analysis from the winner b m WATCHMYSCRIPT.

**7<sup>th</sup> Race: 93. The Mandya Plate - (About) 1400 metres. Horses rated 30 to 50, 4 years old and over (11 Runners).**

BEOND REACH (K. Sai Kiran) was extremely fractious at the start and refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under starter's order.

REFERENCE (D'nuSingh Deora) after jumping out did not raise a fluent gallop for the first 100 Metres. In view of its behaviour, Trainer Mr. R. V. Manohar was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

TOUCH OF CLASS (Akshay Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. M. Rajendra Singh was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey D'nuSingh Deora, the rider of REFERENCE reported that his mount was not galloping fluently throughout the race. The horse was impounded for veterinary examination. On examination, it was found to have sustained clipped injury on right fore bulb of heel.

Jockey Akshay Kumar, the rider of TOUCH OF CLASS reported that his mount was hanging 'in' after entering the straight, as such he inconvenienced CALL ME MAYBE (Darshan R.N) passing the 300 Metres. The horse was impounded for veterinary examination. On examination, it was found to be trotting lame on left fore. Trainer Mr. M. Rajendra Singh was informed to take appropriate corrective measures before accepting with it again and was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Akshay Kumar, the rider of TOUCH OF CLASS was reprimanded for shifting 'in' and inconveniencing LOFTY THOUGHTS (Y. S. Srinath) on his inside rounding the final bend.

POWERSCOURT (Rayan Ahmed R.) sustained superficial injury on left fore knee.

It was reported after the race that LOFTY THOUGHTS (Y. S. Srinath) trotting lame on left fore. Trainer Mr.Prasanna Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g LOFTY THOUGHTS.

**8<sup>th</sup> Race: 94. The Bellary Plate - Div. I - (About) 1400 metres. Horses rated 15 to 35, 5 years old and over (10 Runners).**

Jockey Anjar Alam, the rider of FIORENZO reported that his mount was not galloping fluently from the 1000 Metres till about 600 Metres. The horse was impounded for veterinary examination. On examination, it was found to be lame on right fore. Trainer Mr. Irfan Ghatala was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey M. Prabhakaran, the rider of MISCHIEF FLYER reported that he accidentally lost his whip passing the 200 Metres.

Jockey T. S. Jodha, the rider of PRINCEAZEEM was reprimanded for shifting 'in' and inconveniencing AS GOOD AS IT GETS (A.R.Pradeep) on his inside passing the 200 Metres.

Jockey T. S. Jodha, the rider of PRINCEAZEEM reported that the left fore shoe had come off during the race.

Routine Sample was taken for analysis from the winner b r NOBLE SAPPHIRE.
