**RACING INCIDENTS**  
**(161-169)**

**GOING: Good**

**PENETROMETER READING: 3.3 Cms.**

**RAILING POSITION: Railing fixed at its original position.**

**1<sup>st</sup> Race: 161. The Flashing Star Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35, 5 years old and over (12 Runners).**

MAGNITUDE QUEEN (Prashant P.Dhebe) took a fly jump.

Jockey Darshan R.N, the rider of DESERT GOLD was reprimanded for shifting out and inconveniencing the horses on his outside viz; ZEDCLASS (Mohd Asif Khan) and TEA WID ME (Arshad Alam) passing the 350 Metres.

It was reported after the race that NOBLE SPLENDOR (Irvan Singh) pulled up lame on left fore. Trainer Mr. Faraz Arshad was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

DUTY CALL (P. Trevor) was impounded for veterinary examination. On examination, it was found to have pulled up lame on right fore. Trainer Mr. Praveen Jesu was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from gr g DUTY CALL.

Routine Sample was taken for analysis from the winner b g BOLD MOVE.

**2<sup>nd</sup> Race: 162. The Gaganachukki Plate - (About) 2000 metres. Horses rated 15 to 35 (11 Runners).**

Jockey Manish R replaced the indisposed Jockey Naveen. M on ANNALEASE.

Jockey Prashant P.Dhebe replaced the indisposed Jockey Imran Chisty on FIERCE FIGHTER.

ANNALEASE (Manish .R) was extremely fractious at the start and refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under starter's order.

ALEEF (Rayan Ahmed R.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Mahmood Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that VAIL (Antony Raj S.) jumped awkwardly inwards and inconvenienced THREE WISHES (Darshan R.N) on its inside soon after the start.

Jockey Prashant P.Dhebe, the rider of FIERCE FIGHTER was reprimanded for shifting out and inconveniencing THREE WISHES (Darshan R.N) on his outside passing the 1800 Metres.

It was observed that PROUDPRINCE (Tauseef Ahmed) was hanging out in the final 250 Metres. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Pradeep Annaiah was informed to take appropriate corrective measures before accepting with it again.

FIERCE FIGHTER (Prashant P.Dhebe) ran detached from the field. Trainer Mr. Faraz Arshad was informed to ensure better performance of his charge in future.

SMILE OF JOY (T. S. Jodha) ran detached from the field. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. S. Dominic was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b c KASHKHA.

**3<sup>rd</sup> Race: 163. The Haveri Plate - Div. II - (About) 1400 metres. Horses rated 30 to 50, 5 years old and over (12 Runners).**

Permission was granted to Trainer Mr. Dheeraj.V to withdraw EMIDIO on veterinary grounds as it was found to be suffering from colic. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey A. Ramu replaced the indisposed Jockey Naveen. M on SUMMER DAWN.

Jockey Raghu K, the rider of SECRET DIMENSION was fined Rs.1,000/- for shifting 'in' and causing interference to ROYAL REIN (Mohd Asif Khan) on his inside passing the 800 Metres.

Jockey Darshan R.N, the rider of ULTIMATE POWER was fined Rs.1,000/- for shifting 'in' and causing interference to AMAZONITE (Shamaz Shareef) on his inside in the final 150 Metres.

SHAMSADAS GIRL (K. Sai Kiran) ran detached from the field. The horse was impounded for veterinary examination. On examination, it was found to have burst its blood vessels. Trainer Mr. R. V. Manohar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that CALL ME MAYBE (T. S. Jodha) pulled up lame on right fore. Trainer Mr.Imtiaz Khan was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry is being held into the running and riding of HELENKA, trained by Mr. F. Sirajuddin and ridden by Jockey Arshad Alam in the above race.

Routine Sample was taken for analysis from the winner b m CALL ME MAYBE.

**4<sup>th</sup> Race: 164. The Black Caviar Stakes - (About) 1200 metres. Madien Horses 3 years old only. (9 Runners).**

Jockey P. Trevor replaced the indisposed Jockey Imran Chisty on DEBONAIR.

OLYMPUS MONS (Y. S. Srinath) after jumping out, swerved towards the left and lost few lengths at the start. In view of its behaviour, Trainer Mr. S.S. Attaollahi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner dk b c IMPAVID.

**5<sup>th</sup> Race: 165. The Srikantadatta Narasimharaja Wadiyar Memorial Trophy - (About) 1400 metres. Horses rated 75 and above (12 Runners).**

BARACCHUS (David Allan) planted, lost many lengths at the start and ran detached thereafter. In view of its behaviour, Trainer Mr.S. Padmanabhan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

TOROROSSO (A. Sandesh) took a fly jump.

Jockey P. Trevor, the rider of SAINT PETERSBURG reported that his mount stopped galloping in the final 400 Metres. The horse was impounded for veterinary examination but no abnormality was reported.

Jockey T. S. Jodha, the rider of FIRE GLOW was reprimanded for shifting 'in' and inconveniencing AUTOMATIC (Shamaz Shareef) on his inside in the final 150 Metres.

It was reported after the race that THE LIEUTENANT (Arshad Alam) pulled up lame on right fore. Trainer Mr.K.P.G Appu was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that MANSUETUDE (Akshay Kumar (Hyd)) pulled up lame on right fore. Trainer Mr. Prasanna Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch g STAR CARNATION.

**6<sup>th</sup> Race: 166. The Bangalore Juvenile Million (Grade III) - (About) 1400 metres. 3 years old only (foaled in 2016). (5 Runners).**

Compulsory samples were taken for analysis from the following I, II & III placed horses viz:

**7<sup>th</sup> Race: 167. The Galloping Acres Stud Plate - (About) 1200 metres. Horses rated 45 to 65 (12 Runners).**

Jockey R. Praveen Shinde replaced the indisposed Jockey Rajesh. N on AARON THE BARON.

Jockey T. S. Jodha replaced the indisposed Jockey Imran Chisty on PANAMA.

NAVELROCK (Arshad Alam) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. F. Sirajuddin was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

GOOD TIME INDEED (Prashant P.Dhebe) jumped awkwardly inwards and inconvenienced TURF MAGIC (Ashok Kumar A.) on its inside soon after the start.

Jockey Darshan R.N, the rider of BLUE BLAZER was fined Rs.3,000/- for coming 'in' and causing interference to ANGELS KISS (Antony Raj S.) on his inside approaching 700 Metres.

Jockey P. Trevor, the rider of CASTAWAY reported that his mount slipped from its hind passing the 600 Metres as such he could not offer much assistance thereafter.

Jockey Akshay Kumar was questioned regarding the riding of VENUS BAY in the above race. He stated that the horse did not show initial speed, rounding the bend it did not gallop fluently and also it was lugging 'in' under pressure. His explanations were noted for future reference. However, he was severely cautioned to report any incident that happens during the race.

ANGELS KISS (Antony Raj S.) sustained superficial injury on right fore pastern.

Routine Sample was taken for analysis from the winner b h BLUE BLAZER.

**8<sup>th</sup> Race: 168. The Flashing Star Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35, 5 years old and over (12 Runners).**

IRON MAN (Antony Raj S.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Samar Singh was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

LOVE FOR LIFE (Arshad Alam) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. K.P.G Appu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SO MI DAR (Kiran Rai P) planted and did not take any practical part in the race. Trainer Mr. Prithviraj B. was advice to retire the horse and he accepted the same due to its bad behaviour at the gates.

It was observed that Jockey A.Imran Khan, the rider of BLARNEY STONE had to steady his mount between the 1000 Metres and 950 Metres due to the crowding of the field.

Jockey A.Imran Khan, the rider of BLARNEY STONE was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Jockey Mohd Asif Khan, the rider of HABANERO reported that his mount was hanging 'in' after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. Trainer Mr.S. Dominic was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b m SAN BERNARDINO.

**9<sup>th</sup> Race: 169. The Haveri Plate - Div. I - (About) 1400 metres. Horses rated 30 to 50, 5 years old and over (12 Runners).**

Jockey Darshan R.N replaced the indisposed Jockey Naveen. M on RECZAI.

Jockey A.Imran Khan replaced the indisposed Jockey Imran Chisty on ALBERETTA.

Jockey R. Praveen Shinde, the rider of WILD WILD ANGELS reported that he accidentally lost his whip passing the 250 Meters.

An enquiry was held into the interference caused by Jockey Chetan Kalay.S on his mount BROOKLYN SUPREME in that he continuously came 'in' soon after the start and caused severe interference to LAWRENCE OF ARABIA (A. Sandesh), which in turn passed it onto RAW GOLD (Vivek) whereby Jockey Vivek had to check his mount and fall back passing the 1300 Metres. Thereafter for again shifted 'in' and tightened the horses on his inside viz; LAWRENCE OF ARABIA (A. Sandesh) and WILD WILD ANGELS ( R. Praveen Shinde) passing the 1200 Metres.

Jockey Chetan Kalay.S was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey Chetan Kalay.S and after viewing the CCTV decided to charge Jockey Chetan Kalay.S for careless riding.

The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to Chetan Kalay.S with effect from 4<sup>th</sup> March, 2019 to 22<sup>nd</sup> March, 2019 (both days inclusive) and fined a sum of Rs.10,000/- as he had pleaded guilty of the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount BROOKLYN SUPREME (he is permitted to ride work and informed of his right to appeal).

REFERENCE (Arshad Alam) was impounded for veterinary examination. On examination, it was found to have pulled up lame on left hind. Trainer Mr. R. V. Manohar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

RECZAI (Darshan R.N) was impounded for veterinary examination. On examination, it was found to have sustained injuries on right fore shoulder and both hocks.

BROOKLYN SUPREME (Chetan Kalay S.) was impounded for veterinary examination but no abnormality was reported.

LAWRENCE OF ARABIA (A. Sandesh) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b m RECZAI.

Routine Sample was taken for analysis from the winner ch m PIPER REGINA.

**BANGALORE WINTER MEETING 2018-2019**  
**TWENTYSECOND DAY , THURSDAY , 14<sup>TH</sup> FEBRUARY, 2019**

**Race: 160. The Charmudi Plate - (About) 1600 metres. Horses rated 00 to 20, 5 years old and over.**

The Stipendiary Stewards reported Jockey K. Sai Kiran, the rider of KINGS KID to the Stewards on 22<sup>nd</sup> February, 2019. In that "he whipped his mount 16 times from 500 Metres till the winning post, which is much more than the prescribed limit of 8 times, thereby violating (alleged breach of rules) BTC Racing Calendar under the heading "**USE OF WHIP**" as such the offence was considered as improper riding".

The Stewards examined Jockey K. Sai Kiran and viewed the CCTV Replay of the above race. After deliberations, they decided to:

- (a) Suspend the Jockey's Licence granted to him with effect from 4<sup>th</sup> March, 2019 to 22<sup>nd</sup> March, 2019 (both days inclusive) and fined a sum of Rs.10,000/- for the improper riding and contravening the Calendar Notification under the heading "Use of Whip" on his mount KINGS KID (permitted to ride work).
- (b) He was informed of his right to appeal.
