# RACING INCIDENTS (141-146)

**GOING: Good** 

**PENETROMETER READING: 3.3 Cms.** 

**RAILING POSITION: Railing fixed at average width of 6 Meters from 1600 Meters to winning post from its original position.** 

#### <u>1<sup>st</sup> Race: 141. The Ardent Knight Plate - (About) 1200 metres.</u> Maiden Horses 3 years old only. (9 Runners).

Jockey Akshay Kumar (Hyd), the rider of ROMA VICTOR was reprimanded for shifting out and inconveniencing PHILHARMONIC (P. Trevor) on his outside passing the 500 Metres.

Routine Sample was taken for analysis from the winner b c ROMA VICTOR.

#### <u>2<sup>nd</sup></u> Race: 142. The Classic Story Plate - (About) 1100 metres. Horses rated 15 to 35, 5 years old and over (11 Runners).

Permission was granted to Trainer Mr. Irfan Ghatala to withdraw BOLD MOVE (Anjar Alam) on veterinary grounds as it was found to have infected right capped elbow. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Suraj Narredu replaced the indisposed Jockey S. John on STREAK AHEAD.

Trainer Mr. S. Dominic was fined Rs.1,000/- for late submission of form with respect to being led to starting gate for his charge SMILE OF PEACE.

FANTASTIC APP (Naveen M.) jumped out awkwardly.

Jockey Naveen M., the rider of FANTASTIC APP was reprimanded for shifting 'in' and inconveniencing ALVAREZ (R.Ajinkya) on his inside approaching 750 Metres.

Trainer Mr. Arjun Mangalorkar and Jockey Suraj Narredu were questioned regarding the running and riding of STREAK AHEAD in the above race. The trainer was also questioned regarding the increase in weight of the horse by 12 kgs in comparison to its previous run. The trainer stated that he could not offer much explanation regarding the run of the horse except that he felt the horse had moved up with penalties for running second and with regards to the increase in weight he stated that he was unaware of the increase as he was saddling the horse but he would look into this aspect after the races. He was informed to submit the feed and work register of the horse. Jockey stated that the horse packed up in the final 50 Metres of the race despite his best efforts. The horse was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade

– IV). Trainer was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

GIRL WITH PEARL (Vinod Shinde) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b m STREAK AHEAD.

Routine Sample was taken for analysis from the winner b g BOLD RUNNER.

#### <u>3<sup>rd</sup> Race: 143. The Shivanasamudra Cup - (About) 1200 metres.</u> Horses rated 30 to 50 (11 Runners).

Permission was granted to Trainer Mr. F. Sirajuddin to withdraw HAJIRA (Imran Chisty) on veterinary grounds as it was found to be lame on right fore. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

DECISIVE (T. S. Jodha) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Faraz Arshad was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

TURF JAGUAR (G. Amit) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. R. V. Manohar was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Rayan Ahmed R., the rider of GANDHARVA reported that his mount was drifting out under pressure in the final 400 Metres despite his best efforts. The horse was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g BENEDICTION.

#### <u>4<sup>th</sup> Race: 144. The Daria Daulat Cup - (About) 2000 metres. Horses</u> rated 60 and above (7 Runners).

Jockey D'nuSingh Deora, the rider of BUSCADERO was reprimanded for shifting 'in' and inconveniencing STAR CRACKER (A.Imran Khan) on his inside approaching 1600 Metres.

At the request of the trainer Mr. Azhar Ali b.g. BUSCADERO was examined the horse and found to have burst its blood vessels (Endoscopy - Grade III). He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

AURIGA (Imran Chisty) sustained bleeding injury on right fore pastern.

Routine Sample was taken for analysis from the winner gr m NANHIPARI.

## 5<sup>th</sup> Race: 145. The Davangere Plate - (About) 1200 metres. Horses rated 15 to 35 (12 Runners).

Jockey Irvan Singh replaced the indisposed Jockey A.R. Pradeep on NO OPINION.

Jockey R. Praveen Shinde, the rider of COOL SPRINGS was fined Rs.2,000/for shifting 'in' and causing interference to PRINCEAZEEM (T. S. Jodha) on his inside passing the 1000 Metres.

GREAT CELEBRATION (Tauseef Ahmed) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch f SECRETSUPERSTAR.

#### <u>6<sup>th</sup> Race: 146. The Yedamuri Falls Plate - (About) 1400 metres.</u> Horses rated 00 to 20 (Whips not allowed) (9 Runners).

Trainer Mr. Kishan Thomas was fined Rs.10,000/- for having accepted his charge ASSERTIVE PRINCE to run in the above race and not finding a suitable Jockey to ride. Subsequently, permission was granted to him to withdraw it from the above race.

GALINO (Ajay Kumar R) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Mahmood Khan was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

JERSEY STORM (R Manjunath) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. K.P.G Appu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner ch g IDO WHAT I DO.

Permission was granted to trainers Mr. Irfan Ghatala to deputise on behalf of trainers Mr. S.S. Attaollahi who was unable to attend the races.
