RACING INCIDENTS
(147-153)

GOING: Good

PENETROMETER READING: 3.1 Cms.

RAILING POSITION: Railing fixed at average width of 6 Meters from 1600 Meters to winning post from its original position.

1st Race: 147. The Somanathapura Plate - Div. II - (About) 1100 metres. Horses rated 00 to 20 (11 Runners).

NAAYAAB (T. S. Jodha) took a fly jump.

ZAFRINA (Md.Akram) reared up while jumping out and lost few lengths at the start. In view of its behaviour, Trainer Mr.K.P.G Appu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that Jockey Antony Raj S., the rider of FUTURE BRIGHT had to steady his mount between the 900 Metres till about 800 Metres due to crowding of the field.

Jockey Rajesh Kumar M, the rider of SCORCHING was reprimanded for travelling wide between the 600 Metres till about 400 Metres for no apparent reason.

It was reported after the race that COUNTRY'S PEARL (Akshay Kumar) burst its blood vessels. Trainer Mr. Faraz Arshad was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ZEDCLASS (Vivek) was impounded for veterinary examination. On examination, it was found to have sharp molars. Trainer Mr. S. Inayathulla was fined Rs.3,000/- for his negligence (1st infringement).

Routine Sample was taken for analysis from the winner b m ISLAND PEARL.

2nd Race: 148. The Royal Russian Plate - (About) 1400 metres. Horses rated 15 to 35, 5 years old and over (11 Runners).

Jockey Irvan Singh replaced the indisposed Jockey A.R. Pradeep on AS GOOD AS IT GETS.

PARTING SHOT (S.K.Paswan) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.F. Sirajuddin was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Harish B., the rider of LIMATO was fined Rs.1,000/- for shifting out and taking out AS GOOD AS IT GETS (Irvan Singh) on his outside passing the 1200 Metres.

Jockey Darshan R.N, the rider of ZALA PRINCESS reported that his mount was not galloping fluently throughout the race.

It was reported after the race that ALL BY MYSELF (Antony Raj S.) pulled up lame on right fore. Trainer Mr. K.P.G Appu was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr. Sharat Kumar and Jockey P. Trevor questioned regarding the running and riding of COLOUR OF GOLD in the above race. The Jockey stated that she was galloping in patches and may need blinkers. The trainer corroborated the statement of the Jockey and said she is a 9 year old and this is her last run. An enquiry is being held into the running and riding of COLOUR OF GOLD, trained by Sharat Kumar and ridden by Jockey P. Trevor in the above race.

Routine Sample was taken for analysis from the winner b g LIMATO.

3rd Race: 149. The Amazing Grey Plate - (About) 1200 metres. Horses rated 30 to 50, 5 years old and over (Whips not allowed) (12 Runners).

Jockey Kiran Rai P replaced the indisposed Jockey A.R. Pradeep on MORRANE GABRIELLA.

It was observed that Jockey Akshay Kumar (Hyd), the rider of AMAZONITE had to be checked passing the 1000 Metres due to a closely packed field.

It was observed that Jockey G. Amit, the rider of SHAMSADAS GIRL had to be checked passing the 1000 Metres due to a closely packed field.

It was observed that Jockey Antony Raj S., the rider of POWERSCOURT had to be checked to avoid striking the front runner A HEARTTOREMEMBER (Shamaz Shareef) passing the 1000 Metres.

ULTIMATE POWER (Darshan R.N) sustained bleeding injury on right hind pastern.

SHAMSADAS GIRL (G. Amit) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch m TARINI.

4th Race: 150. The F.K.Irani Memorial Trophy - (About) 1400 metres. Horses rated 45 to 65 (12 Runners).

Jockey Irvan Singh replaced the indisposed Jockey A.R. Pradeep on LOZEN.

Jockey Imran Chisty, the rider of ARECA LEGEND reported that his mount was hanging 'in' after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. Trainer Mr. Prasanna Kumar was informed to take appropriate corrective measures before accepting with it again.

Jockey Yash Narredu, the rider of GYPSY reported that he could not get a clear view between the 900 Metres till about 700 Metres due to the severe kick back of the track.

POSEIDON (Darshan R.N) was impounded for veterinary examination but no abnormality was reported.

LOZEN (Irvan Singh) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner gr f SAKURA.

5th Race: 151. The D.P.Sharma Memorial Sprinters Trial Stakes (Grade III) - (About) 1200 metres. 4 years old and over at the time of starting. (6 Runners).

Compulsory samples were taken for analysis from the following I,II & III placed horses viz;

b h MAURITANIA I

b g TUTANKHAMUN II

ch g STAR CARNATION III

6th Race: 152. The Planetarium Plate - (About) 1600 metres. Horses rated 15 to 35, 6 years old and over (12 Runners).

TURF TACTICS (P. Mani) after jumping out swerved towards the right and lost considerable ground. In view of its behaviour, Trainer Mr.Samar Singh was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

An enquiry is being held into the running and riding of SUMMER DAWN, trained by Sharat Kumar and ridden by Jockey P. Trevor in the above race.

SUMMER DAWN (P. Trevor) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b g SUMMER DAWN.

Routine Sample was taken for analysis from the winner b m AMAZING SKILL.

7th Race: 153. The Somanathapura Plate - Div. I - (About) 1100 metres. Horses rated 00 to 20 (9 Runners).

HAVE A NICE DAY (Antony Raj S.) was extremely fractious, reared up and flipped over in the starting gates. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

Jockey Anjar Alam, the rider of SAVISA reported that his mount accidentally stumbled passing the 600 Metres.

Jockey H. G. Rathod, the rider of IRISH PRINCE reported that he lost his left stirrup soon after jumping out of the starting gates which he regained within a few strides.

SO I THINK (Rajesh Kumar M) was impounded for veterinary examination but no abnormality was reported.

PREMIER PREMISES (Imran Chisty) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b m DESERT GOLD.

Permission was granted to trainers M/s. Neil B. Devaney and Mahmood Khan to deputise on behalf of trainers M/s. Arjun Manglorkar and Neil Darshah who were unable to attend the races.
