## **RAILING POSITION :** Railing fixed at average width of 6 Meters from 1600 Meters to winning post from its original position.

#### <u>1<sup>st</sup> Race: 179. The Karwar Plate - Div. II - (About) 1100 metres.</u> Horses rated 00 to 20 (9 Runners).

Trainer Mr. Azhar Ali was fined Rs.10,000/- for having accepted his charge AQUA BLESSING when it was under B.T.F. BAN. Subsequently, permission was granted to him to withdraw the horse from the above race.

Permission was granted to Trainer Mr. M. P. Mahaesh to withdraw ROCKET PUNCH (P. S. Chouhan) on veterinary grounds as it was found to be lame on left hind. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

FUTURE BRIGHT (Arshad Alam) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Sharat Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

DAUPHINE (Surya P.) jumped awkwardly inwards and inconvenienced KANTHAKA (A. Sandesh) whereby he could not ride from his desired  $2^{nd}/3^{rd}$  - position.

Jockey Vijay Kumar, the rider of PERFECTASTHER was reprimanded for riding an indifferent race.

An enquiry is being held into the running and riding of KANTHAKA, trained by Mr. Narayana Gowda V. and ridden by Jockey A. Sandesh in the above race.

PERFECTASTHER (Vijay Kumar) was impounded for veterinary examination but no abnormality was reported.

KANTHAKA (A. Sandesh) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f NAAYAAB.

#### <u>2<sup>nd</sup> Race: 180. The Kudremukh Plate - (About) 1400 metres. Horses</u> rated 15 to 35, 5 years old and over (12 Runners).

Jockey Ashok Kumar A., the rider of AIR OF DISTINCTION was fined Rs.1,000/- for shifting out and causing interference to SKYBOUND (T. S. Jodha) on his outside soon after the start.

Jockey Arshad Alam, the rider of HAFNIUM was fined Rs.1,000/- for shifting 'in' and causing interference to SKYBOUND (T. S. Jodha) on his inside soon after the start.

It was observed that Jockey Arshad Alam, the rider of HAFNIUM had to steady his mount to avoid striking the front runner GANDHARVA (P. Trevor) passing the 900 Metres

Jockey M. Mark, the rider of ADMIRABLE reported that he accidentally lost his whip passing the 250 Metres.

HAFNIUM (Arshad Alam) ran detached in the final stages of the race. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. F. Sirajuddin was informed to ensure a better performance of his charge in future.

GANDHARVA (P. Trevor) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b g GANDHARVA.

Routine Sample was taken for analysis from the winner b g LAND OF LIBERTY.

#### <u>3<sup>rd</sup> Race: 181. The Karwar Plate - Div. I - (About) 1100 metres.</u> Horses rated 00 to 20 (11 Runners).

As Jockey Rajesh Kumar M, the rider of SO I THINK was certified medically unfit to ride before the start of race, under the circumstances, SO I THINK was permitted to be withdrawn from the race.

Jockey Mohd Asif Khan, the rider of HAVE A NICE DAY reported that he lost his left stirrup soon after the start which he regained passing the 800 Metres and the horse was also observed to be running detached. The horse was impounded for veterinary examination. On examination, it was found to have pulled up lame on left fore. Trainer Mr. S. Dominic was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that ASTRON (Vijay Kumar) could not get a clear run between 450 Metres to 400 Metres due to a closely packed field.

Jockey T. S. Jodha, the rider of INDIAN FURY reported that his mount was changing legs repeatedly as such he had to stop riding in the final 100 Metres. The horse was impounded for veterinary examination. On examination, it was found to have sustained bleeding injury on right fore fetlock.

CAPSTONE (Darshan R.N) was impounded for veterinary examination. On examination, it was found to have pulled up lame on left fore. Trainer Mr. Kishan Thomas was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f NO OPINION.

#### <u>4<sup>th</sup> Race: 182. The Prince Ardent Salver - (About) 1400 metres.</u> Maiden Horses 3 years old only. (9 Runners).

Jockey T. S. Jodha replaced the indisposed Jockey P.S. Chouhan on JAI VIKRAM.

Jockey Suraj Narredu, the rider of CHANTELLE was fined Rs.1,000/- for shifting out and causing interference to KIRKWOOD (A. Sandesh) on his outside passing the 400 Metres.

Jockey Prashant P.Dhebe, the rider of PORT OF BEAUTY was fined Rs.1,000/for shifting 'in' and causing interference to KIRKWOOD (A. Sandesh) on his inside in the final 50 Metres.

NORTHERN ALLIANCE (Arshad Alam) ran detached from the field. Trainer Mr. Neil B Devaney was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b c ALEXANDRE DUMAS.

#### 5<sup>th</sup> Race: 183. The Becket Trophy - Div. I - (About) 1200 metres. Horses rated 30 to 50, 5 years old and over (11 Runners).

Jockey Rayan Ahmed R replaced the indisposed Jockey Rajesh Kumar. M on TAQDEER KA BADSHAH.

BEOND REACH (Manish R) was extremely fractious at the start and refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under starter's order.

Jockey Suraj Narredu, the rider of TARINI was fined Rs.1,000/- for shifting out and causing interference to ALBERETTA (Shamaz Shareef) on his outside passing the 250 Metres.

KVASIR (P. Trevor) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade - III). Trainer Mr. Prasanna Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from dk b g KVASIR.

Routine Sample was taken for analysis from the winner b m MADAME SULTANA.

# 6<sup>th</sup> Race: 184. The Kanteerva Cup - (About) 1400 metres. Horses rated 60 and above (8 Runners).

Jockey Suraj Narredu replaced the indisposed Jockey P.S. Chouhan on THE LIEUTENANT.

LOFTY THOUGHTS (A. Sandesh) stood flat footed and lost many lengths at the start. In view of its behaviour, Trainer Mr. Prasanna Kumar was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

THE LIEUTENANT (Suraj Narredu) was impounded for veterinary examination. On examination, it was found to have pulled up lame on right fore. Trainer Mr. K.P.G Appu was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f PUNJABI GIRL.

#### <u>7<sup>th</sup> Race: 185. The Hemavati Salver - (About) 1400 metres. Horses</u> rated 30 to 50 (9 Runners).

Jockey A. Sandesh, the rider of STAR MAN was fined Rs. 2,000/- for shifting out and taking out the horses on his outside viz; ARECA ANGEL (Neeraj Rawal) and REFERENCE (Arshad Alam) soon after the start.

Jockey Neeraj Rawal, the rider of ARECA ANGEL was fined Rs.1,000/- for shifting 'in' and causing interference to BLUE MOON (A.Imran Khan) on his inside soon after the start.

Jockey Antony Raj .S, the rider of SPIRITOUS was fined Rs.3,000/- for coming 'in' and cutting across the field before passing the red marker post.

Jockey A.Imran Khan, the rider of BLUE MOON was reprimanded for shifting out and inconveniencing REVAN STAR (T. S. Jodha) on his outside passing the 1200 Metres.

Jockey A. Sandesh, the rider of STAR MAN was fined Rs.1,000/- for shifting 'in' and causing interference to ORENDA (Nazerul Alam) on his inside passing the 1100 Metres.

Routine Sample was taken for analysis from the winner b f INTO THE GROOVE.

#### <u>8<sup>th</sup> Race: 186. The Brahmaputra Plate - (About) 1100 metres. Horses</u> rated 15 to 35, 6 years old and over (12 Runners).

TINDERELLA (T. S. Jodha) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.M. Rajendra Singh was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

MISCHIEF FLYER (Manish R) jumped awkwardly outwards and inconvenienced PROPINE (P. Trevor) on its outside soon after the start.

Jockey Naveen M., the rider of PERFECTGOLDENERA was fined Rs.1,000/for shifting 'in and causing interference to DESERT GILT (Arshad Alam) on his inside passing the 250 Metres.

Jockey P. Trevor, the rider of PROPINE was fined Rs.2,000/- for shifting out and taking out the horses on his outside viz; SOVIET UNION (A. Sandesh) and TINDERELLA (T. S. Jodha) passing the 200 Metres.

Jockey Naveen M., the rider of PERFECTGOLDENERA was fined Rs.2,000/for the loss of whip in the final stages of the race (2nd infringement).

An enquiry is being held into the running and riding of SOVIET UNION, trained by Mr. Narayana Gowda V. and ridden by Jockey A. Sandesh in the above race.

Surprise Sample was taken for analysis from dk b g SOVIET UNION.

Routine Sample was taken for analysis from the winner b g PROPINE.

#### <u>9th</u> Race: 187. The Becket Trophy - Div. II - (About) 1200 metres. Horses rated 30 to 50, 5 years old and over (12 Runners).

Permission was granted to trainer Mr. Dheeraj.V to change the declared rider from Jockey Mohd. Asif Khan to Jockey Antony Raj .S to ride GOLD MIST.

Jockey Antony Raj S., the rider of GOLD MIST was fined Rs.1,000/- for shifting 'in' and causing interference to INTERESTING (A. Velu) on his inside approaching 1000 Metres.

Jockey Antony Raj S., the rider of GOLD MIST reported that his saddle shifted behind passing the 300 Metres. After due examination of the equipment, Trainer Mr.Dheeraj.V was fined Rs.3,000/- for faulty saddling of his charge.

Jockey Arshad Alam, the rider of SILKEN STRIKER was fined Rs.1,000/- for shifting out and causing interference to HIDDEN SOLDIER (Rayan Ahmed R.) on his outside passing the 200 Metres.

Jockey Adarsh G., the rider of MIDNIGHT SKY was reprimanded for dropping hands before passing the winning post.

DONNA ROSSA (Nazerul Alam) ran detached from the field. The horse was impounded for veterinary examination. On examination, it was found to have pulled up lame on left fore. Trainer Mr.S. Dominic was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SILKEN STRIKER (Arshad Alam) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b g SILKEN STRIKER

Routine Sample was taken for analysis from the winner b m MAYBE FOREVER.

# Race: 163. The Haveri Plate - Div. II - (About) 1400 metres. Horses rated 30 to 50, 5 years old and over.

#### (A)

The Stipendiary Stewards reported Jockey Arshad Alam to the Stewards at their meeting held on  $13^{\text{th}}$  March, 2019 for unsatisfactory riding on his mount HELENKA. In that :

- "(a) He failed to follow the trainer instructions;
  - (b) He checked his mount gradually and fell back from the 1300 Metres much contrary to the trainers instructions;
  - (c) He did not make an attempt to improve his position thereafter till about the 500 Metres; and
  - (d) He did not ride out his mount vigorously from 400 Metres till about the final 150 Metres".

The Stewards examined Jockey Arshad Alam and viewed the CCTV Replay of the above race. After deliberations, they decided that:

- (a) Should he apply for an "A" Jockeys Licence under BTC Rules of Racing, the same shall remain suspended with effect from 10<sup>th</sup> May, 2019 to 26<sup>th</sup> May, 2019 (both days inclusive) for the unsatisfactory riding on his mount HELENKA (permitted to ride work).
- (b) He was informed of his right to appeal.

### **(B)**

The Stipendiary Stewards reported Trainer Mr. F. Sirajuddin to the Stewards at their meeting held on 13<sup>th</sup> March, 2019 for unsatisfactory running of his charge HELENKA, (thereby violating - alleged breach of rules) i.e., Rule No. 202 (XVI) of the BTC Rules of Racing read with BTC Calendar Notification under the heading **"Punishment to Trainers by Stipendiary Stewards / Stewards" - (Unsatisfactory running of charge under clause - 10)**. The Stewards examined Trainer Mr. F. Sirajuddin and viewed the CCTV

The Stewards examined Trainer Mr. F. Sirajuddin and viewed the CCTV Replay of the above race. After deliberations, they decided to:

- (a) Fine him a sum of Rs.10,000/- for unsatisfactory running of his charge HELENKA for violating alleged breach of rules i.e., Rule No. 202 (XVI) of the BTC Rules of Racing read with BTC Calendar Notification under the heading "Punishment to Trainers by Stipendiary Stewards / Stewards" (Unsatisfactory running of charge under clause 10).
- (b) He was informed of his right to appeal.

#### (a)

The Stipendiary Stewards reported trainer Mr. Narayan Gowda. V to the Stewards for not running his charge **WINGS OF FORTUNE** on its merits [Rule No.159 (a) read with Rule No. 202 (I)] in the above race. The Stewards held an enquiry on 13-3-2019 and examined trainer Mr. Narayan Gowda. V. Considering the deposition made by him and spokesperson Mr.Ashok Raghavan, after viewing the CCTV replay of the race and acting on their own observation of the running of the race decided to severely caution trainer Mr. Narayan Gowda. V.

#### (b)

The Stipendiary Stewards reported Jockey Kiran Rai.P, the rider of **WINGS OF FORTUNE** to the Stewards for not allowing his mount to run on its merits [Rule No.159 (a) read with Rule No. 202 (I)] in the above race. The Stewards held an enquiry on 13-3-2019 and examined Jockey Kiran Rai. P. after viewing the CCTV replay of the race and acting on their own observation of the running of the race decided that:

- (a) Should he apply for an "A" Jockeys Licence under BTC Rules of Racing, the same shall remain suspended with effect from 10<sup>th</sup> May, 2019 to 9<sup>th</sup> June, 2019 (both days inclusive) for not allowing his mount to run on its merits [Rule No.159 (a) read with Rule No. 202 (I)] in the above race on his mount **WINGS OF FORTUNE** (permitted to ride work).
- (b) He was informed of his right to appeal.
