**RACING INCIDENTS**

**(197 - 204)**

**GOING : GOOD**

**PENETROMETER READING : 3.2 Cms.**

**RAILING POSITION : Railing fixed at its original position.**

**1<sup>st</sup> Race: 197. The Ranganathittu Stakes - Div. II - (About) 1100 Metres. Maiden Horses 3 years old only. (10 Runners).**

Permission was granted to Trainer Mr. Faraz Arshad to withdraw DEBONAIR (Irvan Singh) on veterinary grounds as it was found to be suffering from colic. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Antony Raj S., the rider of EMERALD GREEN was fined Rs.1,000/- for shifting out and causing interference to ECO FRIENDLY (K. Nazil) on his outside soon after the start.

Routine Sample was taken for analysis from the winner b c EXCLUSIVE MANDATE.

**2<sup>nd</sup> Race: 198. The Devarayanadurga Stakes - Div. II - (About) 1200 Metres. Horses rated 00 to 20 (9 Runners).**

As Jockey A.R.Pradeep could not fulfill his riding engagements due to personal reasons. Permission was granted to trainer Mr. Azhar Ali to declare Jockey Surya P to ride AQUA BLESSING in place of the declared rider.

Permission was granted to Trainer Mr. Faraz Arshad to withdraw TORONTO (Irvan Singh) on veterinary grounds as it was found to be lame on right fore. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

FUTURE BRIGHT (Arshad Alam) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Sharat Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Raghu K, the rider of SCORCHING was fined Rs.1,000/- for shifting out and causing interference to SANTE FE (Manish R) on his outside soon after the start.

Jockey Md.Akram, the rider of DALLAS was fined Rs.2,000/- for coming 'in' and causing interference to ALL SAID AND DONE (Adarsh G.) and SCORCHING (Raghu K) on his inside along the rails passing the 1100 Metres.

Jockey Surya P., the rider of AQUA BLESSING was fined Rs.1,000/- for coming 'in' and causing interference to ALL SAID AND DONE (Adarsh G.) on his inside along the rails passing the 950 Metres.

Jockey T. S. Jodha, the rider of KRUGER PARK reported that his mount was hanging 'in' after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Warren Singh was informed to take appropriate corrective measures before accepting with it again.

Jockey P. Mani, the rider of ONE TO NOTE was reprimanded for riding an indifferent race.

Jockey Prashant P.Dhebe, the rider of FEET ON FIRE reported that his mount was scratchy throughout the race. The horse was impounded for veterinary examination. On examination, it was found to have pulled up lame on left fore. Trainer Mr. Hidayat Khan was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that ALL SAID AND DONE (Adarsh G.) had apparently splayed its right fore shoe during the race.

Routine Sample was taken for analysis from the winner b m AQUA BLESSING.

**3<sup>rd</sup> Race: 199. The Ranganathittu Stakes - Div. I - (About) 1100 Metres. Maiden Horses 3 years old only. (8 Runners).**

Permission was granted to Trainer Mr. Neil Darashah to withdraw LIGHT BRINGER (Prashant P.Dhebe) on veterinary grounds as it was found to be trotting lame on right fore. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Permission was granted to Trainer Mr. Faraz Arshad to withdraw SOUTHERN POWER (Arshad Alam) on veterinary grounds as it was found to be suffering from fever. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SCORCHER (Rayan Ahmed R.) took a fly jump.

Jockey Adarsh G., the rider of HEAVENLY ANGEL was severely reprimanded for not sufficiently persevering with his mount in the final 200 Metres.

Routine Sample was taken for analysis from the winner b c KARADENIZ.

**4<sup>th</sup> Race: 200. The Malaprabha Trophy - (About) 1200 Metres. Horses rated 45 to 65 (8 Runners).**

FAIR WARNING (Antony Raj S.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Arjun Mangalorkar was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Irvan Singh, the rider of CHINA ONE reported that he accidentally lost his whip in the final 100 Metres of the race.

It was reported after the race that BAYMAX (Arshad Alam) burst its blood vessels. Trainer Mr. Neil B Devaney was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b g WAR HERO.

**5<sup>th</sup> Race: 201. The Racing Patrons Cup - (About) 1600 Metres. Horses rated 75 and above (9 Runners).**

Routine Sample was taken for analysis from the winner b h ROYAL SCEPTRE.

**6<sup>th</sup> Race: 202. The Katil Stakes - (About) 1600 Metres. Horses rated 30 to 50 (10 Runners).**

STARS IN HIS EYES (Khurshad Alam) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Narredu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Antony Raj S., the rider of CASEY was fined Rs.2,000/- for unnecessarily slowing down the pace and hampering the run of horses behind him viz; VELOCIDAD (P. S. Chouhan) and GAME CHANGER (Arshad Alam) in the first 400 Metres.

Jockey Prashant P.Dhebe, the rider of ANNALEASE reported that he was hampered for room in the first 200 Metres as the front runner slowed down the pace.

Jockey Arshad Alam, the rider of GAME CHANGER reported that he was hampered for room in the first 200 Metres as the front runner slowed down the pace.

GAME CHANGER (Arshad Alam) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g SPIRIT BRUCE.

**7<sup>th</sup> Race: 203. The Devarayanadurga Stakes - Div. I - (About) 1200 Metres. Horses rated 00 to 20 (12 Runners).**

DONTBREAKTHERULES (Arshad Alam) took a fly jump.

Jockey M. Mark, the rider of IRISH PRINCE reported that his mount was not galloping fluently throughout the race. The horse was impounded for veterinary examination but no abnormality was reported.

Jockey Manish R, the rider of ICE SPEED was fined Rs.5,000/- for not making sufficient effort on his mount during the race.

RACY PRINCESS (Darshan R.N) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g SHAKTIMAN.

**8<sup>th</sup> Race: 204. The Byerley Turk Stakes - (About) 1600 Metres.  
Horses rated 15 to 35 (11 Runners).**

As Jockey A.R.Pradeep could not fulfil his riding engagements due to personal reasons. Permission was granted to trainer Mr. Darius R. Byramji to declare Jockey Irvan Singh to ride JE NE SAIS QUOI in place of the declared rider.

FIORENZO (Anjar Alam) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Irfan Ghatala was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Prashant P.Dhebe, the rider of CAMILA reported that he accidentally lost his whip passing the 450 Metres.

Routine Sample was taken for analysis from the winner b f CAMILA.

**BANGALORE WINTER MEETING 2018-2019**

**TWENTYFIRST DAY , SATURDAY , 9<sup>TH</sup> FEBRUARY, 2019**

**Race: 152. The Planetarium Plate - (About) 1600 Metres. Horses rated 15 to 35, 6 years old and over.**

**(A)**

The Stipendiary Stewards reported Trainer Mr. Sharat Kumar to the Stewards on 23<sup>rd</sup> March, 2019 for unsatisfactory running of his charge SUMMER DAWN, (thereby violating - alleged breach of rules) i.e., Rule No. 202 (XVI) of the BTC Rules of Racing read with BTC Calendar Notification under the heading **"Punishment to Trainers by Stipendiary Stewards / Stewards"** - (Unsatisfactory running of charge under clause - 10).

The Stewards examined Trainer Mr. Sharat Kumar and viewed the CCTV Replay of the above race. After deliberations, they decided that:

- (a) Should he apply for an "A" Trainer Licence under BTC Rules of Racing, the same shall remain suspended with effect from 10-5-2019 to 19-5-2019 (both days inclusive) for unsatisfactory running of his charge SUMMER DAWN thereby violating - alleged breach of rules i.e., Rule No. 202 (XVI) of the BTC Rules of Racing read with BTC Calendar Notification under the heading **"Punishment to Trainers by Stipendiary Stewards / Stewards"** - (Unsatisfactory running of charge under clause - 10).
  
- (b) He was informed of his right to appeal.

**(B)**

The Stipendiary Stewards reported Jockey P. Trevor to the Stewards on 23<sup>rd</sup> March, 2019 for Injudicious manner of riding under Rule No. 161 (ii) of BTC Rules of Racing on his mount SUMMER DAWN in the above race.

The Stewards examined Jockey P. Trevor, after viewing CCTV replay of the above race and after due enquiry and deliberations, they decided to severely caution him as to his selection of rides in future.

**TWENTYFOURTH DAY , FRIDAY , 8<sup>TH</sup> MARCH, 2019**

**Race: 170. The Honnavar Plate - (About) 1200 Metres. Horses rated 00 to 20.**

An enquiry was held into the running and riding of WINX by the Stipendiary Stewards on 11<sup>th</sup> March, 2019.

The Stipendiary Stewards interviewed Trainer Mr. Imtiaz Khan and Jockey Darshan. R.N. After deliberations, the Stipendiary Stewards decided to:

- (a) Caution Trainer Mr. Imtiaz Khan as to the future running of his charge;
- (b) Fine Jockey Darshan R.N a total sum of Rs.6,000/- for the improper use of whip during the race and for not sufficiently persevering with this mount WINX in the final 200 Metres of the race.
