# BANGALORE WINTER MEETING 2018-2019 TWENTYFOURTH DAY, FRIDAY, 8<sup>TH</sup> MARCH, 2019 RACING INCIDENTS (170-178)

**GOING: Good** 

PENETROMETER READING: 3.0 Cms.

RAILING POSITION: Railing fixed at average width of 4 Meters from 1600 Meters to winning

post from its original position.

1<sup>st</sup> Race: 170. The Honnavar Plate - (About) 1200 metres. Horses rated 00 to 20 (11 Runners).

Trainer Mr. Pradeep Annaiah was fined Rs.10,000/- for having accepted his charge DARAHASINI (Raghu.K) when it was under B.T.F. BAN. Subsequently, permission was granted to him to withdraw the horse from the above race.

JERSEY STORM (Arshad Alam) reared up as the gates opened, planted, lost many lengths and ran detached thereafter. In view of its behaviour, Trainer Mr. K.P.G Appu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

TURF PROSPECTOR (N. S. Parmar) was slowly away and did not raise a fluent gallop for the first 200 Metres. In view of its behaviour, Trainer Mr. Mahmood Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Prashant P.Dhebe, the rider of ATTABOY was fined Rs.1,000/- for coming 'in' and causing interference to WINX (Darshan R.N) on his inside approaching 1100 Metres.

Jockey Mohd Asif Khan, the rider of DALLAS was fined Rs.1,000/- for coming 'in' and causing interference to ZEDCLASS (Vivek) on his inside rounding the final bend.

An enquiry is being held into the running and riding of WINX, trained by Mr. Imtiaz Khan and ridden by Jockey Darshan R.N in the above race.

It was reported after the race that OWN SCRIPT (P. Mani) pulled up lame on left fore. Trainer Mr. Warren Singh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m SAVISA.

# 2<sup>nd</sup> Race: 171. The Zenyatta Stakes - (About) 1200 metres. Madien Horses 3 years old only. (10 Runners).

Permission was granted by the Stewards to trainer Mr. S. Padmanabhan to withdraw LADY OF FAME (Neeraj Rawal) and WELL CONNECTED (David Allan) from the above race.

IT'S MY COUNTRY (Darshan R.N) walked out of the starting gates, swerved towards the right, refused to raise a fluent gallop for the first 100 Metres and ran detached thereafter. In view of its behaviour, Trainer Mr.V. Lokanath was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Vivek, the rider of MEGA IKON was fined Rs.3,000/- for shifting 'in' and causing interference to the horses on his inside viz; MR HUMBLE (Kiran Rai .P) and ECO FRIENDLY (Naveen .M) soon after the start.

Jockey A. Sandesh, the rider of WINALL reported that his mount was running green throughout the race.

Routine Sample was taken for analysis from the winner b f ELECTRA.

## 3<sup>rd</sup> Race: 172. The Icebreaker Plate - (About) 1600 metres. Horses rated 15 to 35, 5 years old and over (12 Runners).

NOBLE SPLENDOR (Irvan Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Faraz Arshad was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that IRON MAN (Antony Raj S.) pulled up lame passing the 500 Metres thereby OCEAN PARK (A.Ramu) which was travelling directly behind had to be checked by its rider to avoid striking the front runner IRON MAN (Antony Raj S.) thereby shifting out and causing interference to the horses on its outside viz; LIMATO (Manish R), ALEEF (Rayan Ahmed R.) and LOVE IS LIFE (Vinod Shinde) approaching 550 Metres. As the incident was accidental no action was taken beyond noting the incident.

Jockey Mohd Asif Khan, the rider of DREAMS UNITED reported that his mount was not galloping fluently throughout the race. The horse was impounded for veterinary examination but no abnormality was reported.

It was reported after the race that IRON MAN (Antony Raj S.) was found to have a fracture of vertebrae during the race. Hence, it was euthanized.

Routine Sample was taken for analysis from the winner b m NINON.

## 4<sup>th</sup> Race: 173. The Nethravathi Trophy - Div. II - (About) 1200 metres. Horses rated 15 to 35 (11 Runners).

BELLA DESTINY (Arshad Alam) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.F. Sirajuddin was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Darshan R.N, the rider of SHE'S SUPERB reported that his mount was hanging out throughout the race. The horse was impounded for veterinary examination. On examination, it was found to have sharp molars on both sides. Hence, Trainer Mr. M. Rajendra Singh was fined Rs.3,000/- for his negligence (1st infringement).

Jockey Mohd Asif Khan, the rider of TOUCH YOUR DESTINY was fined Rs.2,000/- for the loss of whip in the final 100 Meters of the race (2nd infringement). Subsequently his use of whip during the races at Bangalore Turf Club was withdrawn.

CHULA VISTA (A. Sandesh) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from ch f CHULA VISTA.

Routine Sample was taken for analysis from the winner b f TIO RICO.

#### 5<sup>th</sup> Race: 174. The Hassan Plate - (About) 1600 metres. Horses rated 30 to 50, 5 years old and over (12 Runners).

WILD WILD ANGELS (Naveen M.) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Dheeraj.V was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Trainer Mr. Sharat Kumar was fined Rs.10,000/- for the unsatisfactory running of his charge COLOUR OF GOLD (Arshad Alam) in the above race.

It was reported after the race that ROYAL REIN (Manish .R) pulled up lame on right fore. Trainer Mr. Samar Singh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

RAW GOLD (Prashant P.Dhebe) sustained clipped injury on right hind cannon.

Routine Sample was taken for analysis from the winner b m MASADA.

## 6<sup>th</sup> Race: 175. The Madras Race Club Trophy - (About) 1200 metres. Horses rated 60 and above (8 Runners).

An enquiry is being held into the running and riding of LOUISIANA, trained by Mr. Faraz Arshad and ridden by Jockey P. Trevor in the above race.

LOUISIANA (P. Trevor) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade- III) and also lot of yellowish mucus in the trachea. Trainer Mr. Faraz Arshad was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from dk b g LOUISIANA.

Compulsory Sample was taken for analysis from the winner b g AEISIR.

## 7<sup>th</sup> Race: 176. The Nethravathi Trophy - Div. I - (About) 1200 metres. Horses rated 15 to 35 (12 Runners).

ULTIMATE CHARM (Darshan R.N) after jumping out swerved towards the left and did not take practical part in the race. In view of its behaviour, Trainer Mr. V. Lokanath was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Surya P., the rider of DON DELA VEGA reported that his mount brushed the gates while jumping out.

Jockey N. S. Parmar, the rider of ANOTHER RAINBOW reported that his mount was hanging 'in' after entering the straight. Trainer Mr. Mahmood Khan was informed to take appropriate corrective measures before accepting with it again.

Jockey Rajesh Kumar M, the rider of BAZINGA was reprimanded for shifting 'in' and inconveniencing BLARNEY STONE (A. Ramu) passing the 300 Metres.

Jockey Ganesh N., the rider of REGAL FORCE was fined Rs.3,000/- for shifting out and causing interference to GREAT CELEBRATION (P. S. Chouhan) on his outside passing the 250 Metres.

Jockey Ganesh N., the rider of REGAL FORCE reported that he accidently lost his whip passing the 150 Meters.

Jockey N. S. Parmar, the rider of ANOTHER RAINBOW reported that he could not get a clear run in the final 100 Metres due to closely packed field.

Routine Sample was taken for analysis from the winner gr c ARMIN.

## 8<sup>th</sup> Race: 177. The Bhagamandala Plate - (About) 1600 metres. Horses rated 45 to 65 (12 Runners).

Jockey Arshad Alam, the rider of GOOD TIME INDEED reported that his mount got keen from the 1500 Metres till the bend despite the best efforts and thereafter the horse did not gallop.

Routine Sample was taken for analysis from the winner b f SHESMYSCRIPT.

# 9<sup>th</sup> Race: 178. The Dashmesh Stud Plate - (About) 1200 metres. Horses rated 30 to 50 (12 Runners).

Jockey Md.Akram, the rider of BAYMAX was fined Rs.2,000/- for coming 'in' and causing interference to SAHARA (Nazerul Alam), which in turn passed it onto PRINCESS HOLLY (Rayan Ahmed R.) on his inside soon after jumping out of the starting gates.

Compulsory sample was taken for analysis from ch g ACEROS.

Routine Sample was taken for analysis from the winner ch f SECRETSUPERSTAR.
