PENETROMETER READING: 3.1 Cms.

RAILING POSITION: Railing fixed at average width of 6 Meters from 1600 Meters to winning post from its original position.

1st Race: 96. The Infants Plate - (About) 1100 metres. Maiden Horses 3 years old only. (8 Runners).

Jockey Nazerul Alam replaced the indisposed Jockey V.R.Jagadeesh on ROC GIRL.

Routine Sample was taken for analysis from the winner b f BORN QUEEN.

2nd Race: 97. The Kalhatti Falls Plate - Div. II - (About) 1400 metres. Horses rated 15 to 35 (9 Runners).

CAMELEONS IMAGE (Nazerul Alam) jumped awkwardly outwards and inconvenienced the horses on his outside viz; ALTAIR (Irvan Singh) and GIRL WITH PEARL (T. S. Jodha) at the start.

It was reported after the race that CAMELEONS IMAGE (Nazerul Alam) had a frequent urination, swishing of tail and filly was in visible heat.

Routine Sample was taken for analysis from the winner b g ASGARDIA.

3rd Race: 98. The Srirangapatna Plate - (About) 1100 metres. Horses rated 15 to 35, 5 years old and over (11 Runners).

Trainer Mr. Sharat Kumar was fined Rs.10,000/- for having accepted his charge PERFECTGOLDENERA (Shreyas Singh) when it was under B.T.F. BAN. Subsequently, permission was granted to him to withdraw the horse from the above race.

Jockey Manish R, the rider of RAMON was reprimanded for shifting out and inconveniencing AGNAR (Arvind Kumar) on his outside at the start.

It was observed that AGNAR (Arvind Kumar) accidentally brushed the running rails passing the 1000 Metres.

Jockey Naveen Kumar. V, the rider of INDUSTRIALIST was fined Rs.1,000/for shifting 'in' and causing interference to AGNAR (Arvind Kumar) on his inside approaching 900 Metres.

Jockey Saddam Hussain, the rider of ANNALEASE was fined Rs.2,000/- for shifting 'in' and causing interference to RAMON (Manish R) on his inside approaching 900 Metres.

Jockey Saddam Hussain, the rider of ANNALEASE was reprimanded for shifting 'in' and inconveniencing SONGKRAN (Chethan Gowda) on his inside approaching 700 Metres.

Routine Sample was taken for analysis from the winner b g PROPINE.

4th Race: 99. The Shivaganga Falls Plate - (About) 1100 metres. Horses rated 00 to 20 (9 Runners).

BELLA MAMMA (Vishwanath A.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Mahmood Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was reported after the race that GRECIAN LIGHT (R. Vaibhav) burst its blood vessels. Trainer Mr.Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that HIGH HAWK (Rayan Ahmed R.) burst its blood vessels. Trainer Mr. Hidayat Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m GIN DAISY.

5th Race: 100. The Bangalore City Police Commissioner Trophy - (About) 1200 metres. Horses rated 45 to 65 (12 Runners).

PANAMA (Shreyas Singh) jumped awkwardly inwards and inconvenienced ALPHA (Shelar R.) soon after the start.

It was observed that AACHEN (C.Umesh) was inclined to run out between the 800 Metres till about 600 Metres.

Jockey Shreyas Singh, the rider of PANAMA was fined Rs.1,000/- for shifting out and taking out AACHEN (C.Umesh) on his outside rounding the final bend.

Jockey P. Trevor, the rider of COMMODUS reported that due to kick back of the earth he had a partial vision during the race.

It was observed that ALPHA (Shelar. R) accidentally stumbled passing the 700 Metres.

It was reported after the race that KIMERA (Arvind Kumar) burst its blood vessels. Trainer Mr. Pradeep Annaiah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch g CUBAN PETE.

6th Race: 101. The Makara Sankranti Trophy - (About) 1600 metres. Horses rated 30 to 50 (9 Runners).

Routine Sample was taken for analysis from the winner b m FOI ET AMOUR.

7th Race: 102. The Kalhatti Falls Plate - Div. I - (About) 1400 metres. Horses rated 15 to 35 (9 Runners).

Jockey Irvan Singh replaced the indisposed Jockey A. Imran Khan on KING OF THE SAND.

Jockey Antony Raj S., the rider of KNOTTY OAK reported that his mount suddenly shied from the rails passing the 1300 Metres, thereby inconveniencing the horses on his outside viz; KING OF THE SAND (Irvan Singh) and ALBERTO (Akshay Kumar).

Jockey S. John, the rider of FIND reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade- IV). Trainer Mr. S.S. Attaollahi (is deputising on behalf of trainer Mr. Arjun Mangalorkar) was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b q KNOTTY OAK.

Permission was granted to trainer M/s. S. Dominic, S. Narredu, S.S. Attaollahi and Pradeep Annaiah to deputize on behalf of trainer M/s. Neil Darashah, Rajesh Narredu, Arjun Mangalorkar and V. Lokanath who were unable to attend the races.
