BANGALORE WINTER MEETING 2019-2020 FOURTEENTH DAY, FRIDAY, 17th JANUARY, 2020 RACING INCIDENTS (103-111)

GOING : Good

PENETROMETER READING : 3.2 Cms.

RAILING POSITION: Railing fixed at average width of 7.5 Meters from 1600 Meters to winning post from its original position.

<u>1st Race: 103. The Yedamuri Falls Plate - (About) 1400 metres.</u> Horses rated 00 to 20 (12 Runners).

FIRESTONE (S Imran) planted, after jumping out did not raise a fluent gallop and lost many lengths at the start. In view of its behaviour, Trainer Mr.Mahmood Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

It was observed that FIRESTONE (S Imran) accidentally brushed the running rails passing the 1000 Metres.

Jockey S Imran, the rider of FIRESTONE was fined Rs.3,000/- for not exercising sufficient control on his mount under the use of whip, whereby he shifted from the rails to the outer strip of the grass track and caused interference to ICONIC PRINCESS (Shreyas Singh) on his outside passing the 100 Metres.

It was reported after the race that FIRESTONE (S Imran) pulled up lame on right fore. Trainer Mr. Mahmood Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SKY MOON (V.R.Jagadeesh) ran detached from the field. Trainer Mr. S. Inayathulla was informed to ensure better performance of his charge in future.

ADELA (A.Imran Khan) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch m SHOW GIRL.

<u>2nd</u> Race: 104. The Black Caviar Plate - (About) 1200 metres. Maiden Horses 3 years old only. (10 Runners).

Jockey Kiran Rai P, the rider of DREAM CHASER was reprimanded for shifting out and inconveniencing SHERWIN (Suraj Narredu) on his outside approaching 900 Metres.

Jockey Akshay Kumar, the rider of NISUS was reprimanded for shifting 'in' and inconveniencing CAPITAL GAIN (Rayan Ahmed R.) on his inside passing the 700 Metres.

Jockey Imran Chisty, the rider of JACK RYAN reported that his mount shied from SHERWIN (Suraj Narredu) in the final 50 Metres, whereby he shifted 'in' and inconvenienced ARLETTE (P. Trevor).

Trainer Mr. Arjun Mangalorkar and Jockey Suraj Narredu were questioned regarding running and riding of SHERWIN. The trainer stated that:

- (a) Since it was a first run of his charge, he had asked the jockey to ride his own race and do his best in the straight.
- (b) He also added that his charge did not take a smart jump was slightly lethargic;
- (c) He would have ideally liked his charge to be ridden from a forward position.

The Jockey while corroborating the statement of the trainer stated that:

- (a) He was inconvenienced passing the 900 Metres as such he had to travel wide from thereon;
- (b) His mount was running green, according to him it needed more distance and when he had worked the horse it had a habit of suddenly ducking into the gaps as such he was more cautious and used the whip in a back hand position.

Their explanations were noted for future reference.

Routine Sample was taken for analysis from the winner b f RANI JINDAN.

<u>3rd Race: 105. The Premium Spirit Plate - Div. II - (About) 1200</u> metres. Horses rated 15 to 35, 5 years old and over (12 Runners).

Jockey T. S. Jodha, the rider of SMILE OF PEACE reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have sustained bleeding gum injury on right hind side cheek. Trainer Mr. Dheeraj.V was informed to take appropriate remedial measures before accepting with it again.

It was observed that Jockey Nazerul Alam, the rider of NERVA had to steady his mount due to the crowding of the field passing the 900 Metres.

Trainer Mr. K.P.G Appu was severely reprimanded to ensure better performance of his charge ZAFRINA in future.

It was reported after the race that TURF SPIRIT (Rayan Ahmed R.) pulled up lame on right fore. Trainer Mr.Hidayat Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b m DALLAS.

<u>4th Race: 106. The Gadag Plate - (About) 1100 metres. Horses rated</u> <u>15 to 35 (12 Runners).</u>

SANDY STAR (R. Vaibhav) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Rajesh Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey R. Vaibhav, the rider of SANDY STAR was severely reprimanded for not improving his position from the start till about 400 Metres.

Jockey Chethan Gowda, the rider of SILVER SWIFT reported that his mount was hanging 'in' passing the 1000 Metres, whereby he inconvenienced ELITE AGENT (Imran Chisty) on his inside, which in turn passed it onto DESERT MIRAGE (Kiran Rai P) along the rails. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.S. Dominic was informed to take appropriate corrective measures before accepting with it again.

It was observed that Jockey David Allan, the rider of MRS THATCHER had to steady his mount approaching 900 Metres due to the crowding of the field.

It was observed that Jockey Dharshan Antony.B, the rider of DEFINITIVE had to steady his mount to avoid striking the front runner TAZAMOUR (R. Anand) passing the 900 Metres.

Jockey R. Anand, the rider of TAZAMOUR was fined Rs.1,000/- for allowing his mount to drift out under the use of whip between the 250 Metres till about the final 50 Metres.

Routine Sample was taken for analysis from the winner dk b g SINGHSAAB.

<u>5th</u> Race: 107. The Makybe Diva Trophy - Div. I - (About) 1200 metres. Horses rated 30 to 50, 5 years old and over (12 Runners).

TIO RICO (Chethan Gowda) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Neil Darashah was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey C.Umesh, the rider of VARCASVA reported that his mount lost its footing passing the 900 Metres.

Jockey R. Anand, the rider of BIG BOON was fined Rs.5,000/- for not making sufficient effort on his mount in the straight.

Jockey Suraj Narredu, the rider of SECRETSUPERSTAR reported that due to kick back of the earth he had a partial vision during the race.

Jockey A. Imran Khan, the rider of WINGS OF DESIRE reported that due to kick back of the earth he had a partial vision during the race.

It was reported after the race that LAWRENCE OF ARABIA (Arvind Kumar) pulled up lame on left fore and was found to have sustained clipped injury on both bulb of right hind. Trainer Mr. M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

VARCASVA (C.Umesh) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch h ROYAL RESOLUTION.

<u>6th Race: 108. The Dharwad Plate - (About) 1400 metres. Horses</u> rated 45 to 65 (8 Runners).

Permission was granted to Trainer Mr.Prithviraj B. to withdraw TORSORO (A.Imran Khan) on veterinary grounds as it was found to be suffering from colic. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

BLUE MOON (Imran Chisty) jumped awkwardly outwards and inconvenienced BLUEJACK (V.R.Jagadeesh) on its outside at the start.

BLUEJACK (V.R.Jagadeesh) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. M. Rajendra Singh was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b g CORONA DEL CORSA.

<u>7th Race: 109. The Kempe Gowda Cup - (About) 1600 metres. Horses</u> rated 60 and above (9 Runners).

AUSTRALIS (P. Trevor) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

THE LIEUTENANT (K. Raja Rao) took a fly jump.

It was observed that Jockey Arul J.H., the rider of INTO THE GROOVE was dislodged from his mount after passing the winning post. On examination, by the medical officer it was reported that Jockey Arul J.H. had dislocated his left shoulder. As Jockey Arul J.H. was disabled and could not be walked or carried to the scales. The Stipendiary Stewards in accordance of Rule No. 177 (c) of the BTC Rules of Racing cleared the above race. An enquiry is being held into the incident.

Routine Sample was taken for analysis from the winner b g BERNARDINI.

<u>8th Race: 110. The Makybe Diva Trophy - Div. II - (About) 1200</u> metres. Horses rated 30 to 50, 5 years old and over (12 Runners).

Jockey Arvind Kumar replaced the indisposed Jockey Arul J.H. on YERWAZAN.

Jockey Kiran Rai P, the rider of CAPSTONE was fined Rs.3,000/- for shifting out and taking out RADIANT TREASURE (Saddam Hussain) on his outside passing the 250 Metres.

Routine Sample was taken for analysis from the winner dk b g BENEDICTION.

<u>9th</u> Race: 111. The Premium Spirit Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35, 5 years old and over (11 Runners).

BOLD RUNNER (A.Ramu) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Dheeraj.V was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Kiran Rai P, the rider of LOOK OUT reported that his mount was hanging 'in', whereby he inconvenienced NAGARJUNA (A.R.Pradeep) on his inside passing the 250 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Kishan Thomas was informed to take appropriate corrective measures before accepting with it again.

It was reported after the race that ALVAREZ (R. Vaibhav) burst its blood vessels. Trainer Mr. Samar Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that JAYADRATHA (Naveen M.) burst its blood vessels. Trainer Mr.Sharat Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

TYTO ALBA (R. Anand) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g LOOK OUT.

Permission was granted to trainer M/s. Arjun Mangalorkar, Kishan Thomas, Darius R. Byramji and Mahmood Khan to deputize on behalf of trainer M/s. S.S. Attaollahi, Neil B. Devaney, Parvati Byramji and S. Padmanabhan who were unable to attend the races.
