# BANGALORE WINTER MEETING 2019-2020 FIFTEENTH DAY, SATURDAY, 25<sup>th</sup> JANUARY, 2020 RACING INCIDENTS (112-119)

**GOING: Good** 

PENETROMETER READING: 3.2 Cms.

RAILING POSITION: Railing fixed at average width of 4 Meters from 1600 Meters to winning post from its original position.

1<sup>st</sup> Race: 112. The Parfait Amour Trophy - Div. II - (About) 1200 metres. Horses rated 15 to 35 (11 Runners).

Permission was granted to Trainer Mr. Faraz Arshad to withdraw QUEEN ISABELLA on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

KING OF THE SAND (C.Umesh) jumped awkwardly inwards.

Jockey R Manjunath, the rider of AEROSPEED was reprimanded for shifting 'in' and inconveniencing RICHMOND HILL (Naveen M.) on his inside passing the 1100 Metres.

Jockey Arshad Alam, the rider of SADAQAT was fined Rs.3,000/- for shifting 'in' and tightening the horses on his inside viz; RICHMOND HILL (Naveen M.) and DESERT COMBAT (S. John) passing the 1100 Metres.

It was observed that UP FRONT (Shamaz Shareef) was inclined to run out between the 800 Metres till about 600 Metres.

Jockey Shamaz Shareef, the rider of UP FRONT reported that his left rein slipped passing the 150 Metres which he regained within a few strides.

Routine Sample was taken for analysis from the winner ch g KING OF THE SAND.

### 2<sup>nd</sup> Race: 113. The Raichur Trophy - Div. I - (About) 1400 metres. Horses rated 15 to 35, 5 years old and over (12 Runners).

HIGH ADMIRAL (R Manjunath) was slowly away. In view of its behaviour, Trainer Mr.Imtiaz Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

ARMENIA (Shelar R.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey R Manjunath, the rider of HIGH ADMIRAL was severely reprimanded for not improving position from 900 Metres till about 600 Metres.

Routine Sample was taken for analysis from the winner dk b m AMAZING ANGEL.

3<sup>rd</sup> Race: 114. The Parfait Amour Trophy - Div. I - (About) 1200 metres. Horses rated 15 to 35 (10 Runners).

QUEEN OF SANDS (Y. S. Srinath) reared up and fell over in the saddling enclosure and was found to be sore on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer Mr. Imtiaz Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

KONICHIWA (Shamaz Shareef) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Imran Chisty, the rider of ESTELLA reported that his mount was inclined to run out passing the 800 Metres.

KASAULI (Rayan Ahmed R.) was subjected to veterinary examination. On examination, it was found to be listless and reluctant to trot.

Routine Sample was taken for analysis from the winner b g SKYFIRE.

#### 4<sup>th</sup> Race: 115. The Sohna Stud Trophy - (About) 1400 metres. Horses rated 30 to 50, 6 years old and over (12 Runners).

Jockey Khurshad Alam replaced the indisposed Jockey S. Mubarak on MORRANE GABRIELLA.

FANTASTIC APP (A.R.Pradeep) reared up as the gates opened, dislodged its rider and ran riderless thereafter.

STARI GRAD (Vishwanath A.) was slowly away at the start.

Jockey V.R.Jagadeesh, the rider of LIGHTNING ATTACK was reprimanded for shifting 'in' and inconveniencing GYPSY (R. Vaibhav) on his inside passing the 800 Metres.

Jockey C.Umesh, the rider of POWER OF SHAMBHALA was fined Rs.2,000/- for not sufficiently persevering with his mount in the final 200 Metres.

STARI GRAD (Vishwanath A.) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g OPTIMISTICAPPROACH.

### 5<sup>th</sup> Race: 116. The Srikantadatta Narasimharaja Wadiyar Memorial Trophy - (About) 1200 metres. Horses rated 60 and above (10 Runners).

Jockey C.Umesh, the rider of KVASIR reported that he accidentally lost his whip passing the 100 Metres.

It was reported after the race that MEGA IKON (V.R.Jagadeesh) burst its blood vessels. Trainer Mr. S. Inayathulla was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that AIR COMMAND (S. John) pulled up lame on left fore. Trainer Mr.Arjun Mangalorkar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m CERISE NOIR.

## 6<sup>th</sup> Race: 117. The Bangalore Race Course 157th year Commemoration Trophy - (About) 1600 metres. 4 years old and over at the time of starting. (7 Runners).

Routine Sample was taken for analysis from the winner b m WATCHMYSCRIPT.

7<sup>th</sup> Race: 118. The B.N.Gudiyappa Bangalore Winter Million - (About) 1200 metres. 3-year-old horses (foaled in 2017). (5 Runners).

Routine Sample was taken for analysis from the winner b c NISUS.

8<sup>th</sup> Race: 119. The Raichur Trophy - Div. II - (About) 1400 metres. Horses rated 15 to 35, 5 years old and over (12 Runners).

Jockey P. Trevor, the rider of GLORIOUS DAYS reported that he had to ride his mount in check between the 1000 Metres till about 800 Metres due to the crowding of the field.

Jockey V.R.Jagadeesh, the rider of ADMIRAL ONE reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Darius R. Byramji was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b m WINNING FORCE.
