RAILING POSITION: Railing fixed at its original position.

1st Race: 120. The Saddle Up Cup - Div. I - (About) 1200 metres. Horses rated 00 to 20 (11 Runners).

SRI LAKSHMI (Mohd Asif Khan) jumped out awkwardly.

It was observed that Jockey C.Umesh, the rider of SUN SPLASH had to steady his mount to avoid striking the front runner LE MARC (Nazerul Alam) passing the 700 Metres.

Routine Sample was taken for analysis from the winner b m LE MARC.

2nd Race: 121. The Totalizator Cup - Div. II - (About) 1400 metres. Horses rated 15 to 35 (9 Runners).

Permission was granted to Trainer Mr. Dheeraj.V to withdraw NOSTRADAMUS (A.Ramu) on veterinary grounds as it was found to be suffering from colic. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Nazerul Alam, the rider of SEA OF CORTEZ was fined Rs.2,000/- for shifting out and causing interference to AWESOME GIRL (Antony Raj S.) on his outside soon after the start.

Jockey C.Umesh, the rider of AUGUSTINA was fined Rs.1,000/- for shifting 'in' and causing interference to STAR SAPPHIRE (Suraj Narredu) on his inside passing the 1300 Metres.

GREEN CHANNEL (T. S. Jodha) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Neil B Devaney was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b f SEA OF CORTEZ.

3rd Race: 122. The Mysore Race Club Trophy - (About) 1200 metres. Maiden Horses 3 years old only (Outstation horses eligible). (14 Runners).

Jockey R. Anand, the rider of HITOMI SAKUMA was fined Rs.1,000/- for shifting 'in' and bumping LIMITED SOURCE (Ryan Marshall) on his inside at the start.

It was observed that LONGSTRIDE (Akshay Kumar) was running green throughout the race.

It was observed that CARACAS (Arshad Alam) was running green throughout the race.

Routine Sample was taken for analysis from the winner b c GENERAL PATTON.

4th Race: 123. The Totalizator Cup - Div. I - (About) 1400 metres. Horses rated 15 to 35 (9 Runners).

Trainer Mr.Samar Singh was fined Rs.10,000/- for accepting his charge HAPPY

DANCING, when it was under treatment. Subsequently, permission was granted to him to withdraw it from the above race.

Jockey David Allan, the rider of LEGENDARY PRINCESS reported that he did not get a clear run between the 350 Metres till about 250 Metres due to the crowding of the field.

Jockey Vinod Shinde, the rider of GOODWILL WARRIOR was fined Rs.1,000/- for shifting 'in' and bumping CUSTOM CUT (David Egan) on his inside passing the 150 Metres.

POLAR EXPRESS (Imran Chisty) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f COSMIC FEELING.

5th Race: 124. The R.W.I.T.C Cup - (About) 1400 metres. Horses rated 30 to 50 (14 Runners).

Jockey Ryan Marshall, the rider of SCHAFENBERG reported that he did not have his right leg in the stirrup when the start was given, which he regained passing the 1200 Metres.

Jockey S. Selvaraj, the rider of MEMORITER reported that he accidentally lost his whip passing the 250 Metres.

Routine Sample was taken for analysis from the winner b g MUSTERION.

6th Race: 125. The Indian Republic Trophy - (About) 1200 metres. Horses rated 75 and above (7 Runners).

Permission was granted to Trainer Mr. S. Padmanabhan to withdraw KERAZANO (David Allan) on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

COURAGE (S. John) jumped out awkwardly.

STAR CARNATION (Ashok Kumar A.) ran detached from the field. The horse was subjected to veterinary examination. On examination, it was found to be lame on left fore. Trainer Mr. S. Ganapathy was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g SAINT PETERSBURG.

7th Race: 126. The Shree Meenakshi Sundereshwara Bangalore Derby(Grade I) - (About) 2400 metres. 4-year-old Indian Horses (Foaled in 2016) (8 Runners).

Permission was granted to Trainer Mr.Arjun Mangalorkar to withdraw STREAMING GOLD on veterinary grounds as it was found to be suffering from fever. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

8th Race: 127. The T.B. Hanumantharaj Memorial Trophy - (About) 2000 metres. Horses rated 30 to 50, 5 years old and over (9 Runners).

Permission was granted to Trainer Mr. Prasanna Kumar to withdraw ASTRAL FORCE (Antony Raj S.) on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey David Allan replaced the indisposed Jockey A. Imran Khan on SPIRIT BRUCE.

Jockey P. Trevor, the rider of GREY CHANNEL reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to be lame on right fore. Trainer Mr. S. Inayathulla was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch m SHOW GIRL.

9th Race: 128. The Saddle Up Cup - Div. II - (About) 1200 metres. Horses rated 00 to 20 (8 Runners).

Jockey P. Trevor replaced the indisposed Jockey A. Imran Khan on SONG DANCE.

Permission was granted to Trainer Mr. Mahmood Khan to withdraw BRAVADO (Mohd Asif Khan) on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

APTHAMITRA (Irvan Singh) was examined at the starting gate by the Club's Veterinary Officer and was found to be lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Samar Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

RANCHO (T. S. Jodha) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Imtiaz Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that EL MATADOR (Vishwanath A.) accidentally struck the front runner PRINCESS AMU (Vinod Shinde) passing the 700 Metres.

It was reported after the race that PRINCESS AMU (Vinod Shinde) burst its blood vessels and sustained clipped injury on right hind fetlock. Trainer Mr.Neil Darashah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey R. Anand, the rider of SILENT RULER reported that he accidentally lost his whip passing the 100 Metres.

Routine Sample was taken for analysis from the winner b m SHIVALIK SHOW.
