RACING INCIDENTS

(81-87)

GOING : Good

PENETROMETER READING : 3.4 Cms.

RAILING POSITION: Railing fixed at average width of 4.5 Meters from 1600 Meters to winning post from its original position.

1st Race: 81. The Moodabidri Plate - (About) 1400 metres. Horses rated 00 to 20, 5 years old and over (Whips not allowed) (12 Runners).

NOBLE SPLENDOR (Shamaz Shareef) jumped awkwardly outwards.

Jockey Shamaz Shareef, the rider of NOBLE SPLENDOR was reprimanded for shifting 'in' and inconveniencing PURITY (Ankit Yadav) on his inside approaching 1000 Metres.

Jockey Chethan Gowda, the rider of SULTANA was reprimanded for dropping hands before passing the winning post.

Routine Sample was taken for analysis from the winner b g SOUTH BELL.

2nd Race: 82. The Amber Regent Plate - (About) 1600 metres. Horses rated 15 to 35 (12 Runners).

AKASI (P. Trevor) jumped awkwardly inwards.

Jockey P. Trevor, the rider of AKASI reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination but no abnormality was reported.

It was observed that AKASI (P. Trevor) was running erratic thereby inconvenienced SAINTHOOD (C. Umesh) on its outside approaching 1000 Metres.

Jockey Shamaz Shareef, the rider of ICONIC PRINCESS reported that his mount stumbled passing the 800 Metres.

Jockey A.Imran Khan, the rider of COSMIC FEELING reported that his mount stumbled passing the 800 Metres and also reported that the track was very shifty.

Jockey Colm O'Donoghue, the rider of SCINTILLA reported that his mount was not galloping fluently from its hind as such he pulled up his mount before passing the winning post and dismounted. The horse was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade - IV). Trainer Mr. S. Ganapathy was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b f SCINTILLA.

Routine Sample was taken for analysis from the winner ch g AFERPI.

3rd Race: 83. The Lal Bagh Plate - (About) 1400 metres. Horses rated 60 and above (8 Runners).

Jockey P. Trevor, the rider of PELUCHE reported that his mount was not getting a grip of the track as it was too shifty and also was not galloping fluently in the final 300 Metres. The horse was impounded for veterinary examination but no abnormality was reported.

Jockey Colm O'Donoghue, the rider of TURF MAGIC reported that his mount was not galloping fluently in the final 300 Metres. The horse was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade - IV). Trainer Mr. S. Ganapathy was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b g PELUCHE.

Routine Sample was taken for analysis from the winner b g TREASURE DELIGHT.

4th Race: 84. The G. Krishnappa Memorial Trophy - Div. I - (About) 1200 metres. Horses rated 30 to 50 (10 Runners).

CONSTANZA (P. Trevor) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr. S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SIYOUNI (Nikhil Naidu) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr. S. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Arul J.H, the rider of INDIAN EMPRESS was reprimanded for shifting 'in' and tightening WINALL (S. John) on his inside passing the 1000 Metres.

Jockey David Allan, the rider of INDIAN DEMOCRAT reported that the ground was very shifty and his mount was not finding its feet between the 1000 Metres till about 400 Metres.

Jockey S. John, the rider of WINALL reported that due to the kick back of the earth his left eye got injured and he had partial vision during the race.

It was reported after the race that PALM READER (C.Umesh) pulled up lame on right fore. Trainer Mr.Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g BIG BOON.

5th Race: 85. The Chief Minister's Trophy - (About) 2000 metres. 4 years old and over at the time of starting. (6 Runners).

Jockey Y. S. Srinath, the rider of SALAZAAR reported that his mount was lugging under pressure in the final 150 Metres.

Routine Sample was taken for analysis from the winner ch h DESERT GOD.

6th Race: 86. The January Plate - (About) 1400 metres. Maiden Horses 3 years old only at the time of starting. (12 Runners).

Jockey A. Imran Khan the declared rider on WELCOME SURPRISE was fined Rs.3,000/- for not drawing the declared weight on the scales. Subsequently, permission was granted to trainer Mr. S. Dominic to substitute Jockey Antony Raj to ride WELCOME SURPRISE in place of the declared rider.

Jockey Antony Raj S., the rider of WELCOME SURPRISE was fined Rs.3,000/- for shifting 'in' and causing interference to the horses on his inside viz; CLASSIC CHARM (A. Sandesh) and MOUNTAIN LION (P. Trevor) at the start.

Jockey Antony Raj S., the rider of WELCOME SURPRISE reported that his mount stumbled passing the 800 Metres.

Jockey Y. S. Srinath, the rider of REDOUBTABLE, Jockey Ryan Marshall, the rider of ANGEL HEART, Jockey V.R.Jagadeesh, the rider of OSIBISA and Jockey T. S. Jodha, the rider of AL BURAAQ reported that the kick back was bad and they could not have a clear view during the race.

CLASSIC CHARM (A. Sandesh) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g MOUNTAIN LION.

7th Race: 87. The G. Krishnappa Memorial Trophy - Div. II - (About) 1200 metres. Horses rated 30 to 50 (11 Runners).

Jockey B. Nayak, the rider of DESERT ROSE weighed "in" 400 grams less in relation to weighing out. Hence, Trainer Mr. Nityanand G. was fined Rs.3,000/- for not informing the change of girth on his charge DESERT ROSE.

SCHAFENBERG (P. Trevor) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

DESERT ROSE (B. Nayak) planted, after jumping out did not raise a fluent gallop for the first 50 Metres. In view of its behaviour, Trainer Mr. Nityanand G. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

PRINCESS HOLLY (K. Sai Kiran) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner b m DARAHASINI.

Permission was granted to trainer Mr. M. Rajendra Singh to deputize on behalf of trainer Mr. Azhar Ali who was unable to attend the races.
