RAILING POSITION: Railing fixed at its original position.

1st Race: 88. The Gumbaz Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35 (14 Runners).

Jockey T. S. Jodha, the rider of SNOW QUEEN was fined Rs.1,000/- for shifting 'in' and causing interference to MR HUMBLE (Kiran Rai P) on his inside passing the 1000 Metres.

Jockey Imran Chisty, the rider of ESTELLA reported that his mount was inclined to run out between the 800 Metres till about 700 Metres despite his best efforts, thereby inconvenienced the horses viz; RULER OF NATION (D. Patel) and AEROSPEED (Mohammed Aliyar) on his outside.

Jockey A.Imran Khan, the rider of SUPER GLADIATOR reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. S. Dominic was informed to take appropriate corrective measures before accepting with it again.

Jockey S. John, the rider of STROKE OF GENIUS was reprimanded for shifting 'in' and inconveniencing MR HUMBLE (Kiran Rai.P) on his inside in the final 50 Metres.

ESTELLA (Imran Chisty) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g STROKE OF GENIUS.

2nd Race: 89. The Murdeshwar Plate - (About) 1100 metres. Horses rated 00 to 20 (12 Runners).

Jockey Darshan R.N, the rider of AIR FORCE ONE reported that he lost his right stirrup at the start which he regained within a few strides.

Jockey A.Imran Khan, the rider of LOVE MUSIC was reprimanded for dropping hands before passing the winning post.

Jockey Darshan R.N, the rider of AIR FORCE ONE was fined Rs. 3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Jockey A. Sandesh, the rider of TEQUILA TORNADO reported that due to kick back a lump of earth hit his face as such he had partial vision during the race.

It was reported after the race that AMALFI COAST (Raghu K) burst its blood vessels. Trainer Mr. Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that LADY DIANA (Naveen Kumar. V) burst its blood vessels. Trainer Mr. Dheeraj.V was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch m PRINCESS PRIDE.

3rd Race: 90. The Gumbaz Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35 (14 Runners).

Jockey Vishwanath.A replaced the indisposed Jockey Harish. B on CHARMAINE.

BLARNEY STONE (Arshad Alam) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Imtiaz Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey P. Trevor, the rider of DARING PRINCE reported that his mount stumbled passing the 900 Metres.

Jockey P. Mani, the rider of RED INDIAN was reprimanded for travelling wide rounding the final bend for no apparent reason.

Jockey Akshay Kumar, the rider of OROGENESIS reported that his mount stopped galloping in the final 350 Metres. The horse was subjected to veterinary examination. On examination, it was found to have sharp molars on right side. Hence, Trainer Mr. Prasanna Kumar was fined Rs.3,000/- for his negligence (1st infringement).

Jockey A.Imran Khan, the rider of DEBONAIR was reprimanded for dropping hands in the final 50 Metres.

Routine Sample was taken for analysis from the winner ch g DARING PRINCE.

4th Race: 91. The Kolar Plate - (About) 1400 metres. Horses rated 30 to 50, 5 years old and over (14 Runners).

Jockey Chethan Gowda, the rider of GRAND EMPIRE was fined Rs. 2,000/for shifting 'in' and causing interference to the horses on his inside viz; ULTIMATE POWER (Darshan R.N) and ALEEF (Vishwanath A.) soon after the start.

Jockey Nazerul Alam, the rider of MOHICAN was fined Rs.2,000/- for not sufficiently persevering with his mount in the final 150 Metres.

It was reported after the race that GRAND EMPIRE (Chethan Gowda) pulled up lame on right fore. Trainer Mr. S. Ganapathy was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g TORSORO.

5th Race: 92. The New Year Cup(Grade III) - (About) 1400 metres. 4 years old and over at the time of starting. (9 Runners).

Jockey Suraj Narredu, the rider of AEOLUS reported that his mount stumbled passing the 850 Metres.

Jockey S. Zervan, the rider of DREAM CATCHER reported that the track was shifty.

It was reported after the race that AEOLUS (Suraj Narredu) pulled up lame on left fore. Trainer Mr.Darius R. Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

b h SNOWDON I b h KNOTTY ASH II b m SHESMYSCRIPT III

6th Race: 93. The Bangalore Oaks(Grade II) - (About) 2400 metres. 4-year-old Indian Fillies (Foaled in 2016) (9 Runners).

Jockey Colm O'Donoghue, the rider of QUEEN REGNANT reported that his mount stumbled passing the 800 Metres.

SEVENTH MILE (P. Trevor) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. P. Shroff was informed to ensure better performance of his charge in future.

Compulsory urine and blood samples were taken for analysis from the following I, II & III placed horses viz:

b f ANJEZE I gr f SPEEDSTER II b f RHAPSODY III

7th Race: 94. The Esquire Stud Stakes - (About) 1600 metres. Horses rated 45 to 65 (7 Runners).

Permission was granted to Trainer Mr. M. Rajendra Singh to withdraw BLUEJACK on veterinary grounds as it was found to be suffering from colic. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that SUPERB SUCCESS (Shamaz Shareef) accidentally brushed the running rails passing the 900 Metres.

Jockey Akshay Kumar, the rider of ROMA VICTOR reported that his mount was lugging 'in' under pressure in the final 200 Metres.

SUPERB SUCCESS (Shamaz Shareef) ran detached from the field. Trainer Mr. M. Rajendra Singh was informed to ensure better performance of his charge in future.

Trainer Mr. Narayana Gowda.v was questioned as regards the unwarranted practice of running his charge LAND OF LIBERTY over 1600 Metres when it had not performed in the said distance and also fancying it.

The trainer stated that:

- (a) His horse was working well;
- (b) His horse had received a drop and was running in the lower class;
- (c) The horse was running close races in its previous three starts as such he ran in this distance and fancied his charge as it was a relatively poor company.

His explanations were noted with a severe warning onto the future running of his horses and he was also informed to give sufficient time before running this horse the next time.

LAND OF LIBERTY was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade – IV). Trainer Mr. Narayana Gowda. V was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b g LAND OF LIBERTY.

Routine Sample was taken for analysis from the winner b g ROMA VICTOR.

8th Race: 95. The Cordon Bleu Plate - (About) 1600 metres. Horses rated 15 to 35, 5 years old and over (12 Runners).

JE NE SAIS QUOI (Irvan Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Darius R. Byramji was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

EKALAVYA (David Allan) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Padmanabhan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey T.S. Jodha, the rider of MARIACHI was reprimanded for shifting 'in' and inconveniencing CASEY (S. John) on his inside passing the 1400 Metres.

DECLARATIONOFLOVE (Darshan R.N) was subjected to veterinary examination. On examination, it was found to have pulled up lame on left fore. Trainer Mr. Imtiaz Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b g EKALAVYA.

Permission was granted to trainer Mr. Pradeen Annaigh to deputize on hehalf

Permission was granted to trainer Mr. Pradeep Annaiah to deputize on behalf of trainer Mr. Neil Darashah who was unable to attend the races.

ADDITIONAL REPORT

BANGALORE WINTER MEETING 2019-2020 TENTH DAY, SATURDAY, 28th DECEMBER 2019

Race: 75. The Agumbe Plate - (About) 1200 metres. Horses rated 00 to 20.

The Stipendiary Stewards reported Jockey Chetan Kalay.S to the Stewards on Friday, 3rd January, 2020 for Unsatisfactory riding Rule No. 161 (ii) of the BTC Rules of Racing on his mount DARING SWEETHEART in the above race. In that:

- (a) after jumping out when his horse was travelling very well he did not make any effort to ride from the second/ third position the way he was instructed to ride by his trainer;
- (b) He did not make any effort to improve his position even from 800 Metres till about 500 Metres;
- (c) He put his mount in a disadvantageous position from the start of the race till about 500 Metres; and
- (d) He rode in desperation thereafter; as such he put his mount under pressure to cover a lot of ground and finally finished close fourth to the winner.

The Stewards after considering the Charge Sheet No. 678 issued to Jockey Chetan Kalay.S, after viewing the CCTV replay of the race and acting on their own observations decided to suspend the Jockeys licence granted to Jockey Chetan Kalay.S from 17th January, 2020 to 14th February, 2020 (both days inclusive) Unsatisfactory riding Rule No. 161 (ii) of the BTC Rules of Racing on his mount DARING SWEETHEART in the above race (permitted to ride work).
