# BANGALORE WINTER MEETING 2019-2020 THIRD DAY , FRIDAY , 22<sup>№</sup> NOVEMBER 2019 RACING INCIDENTS

# <u>(16-23)</u>

GOING : GOOD PENETROMETER READING : 3.5 Cms. RAILING POSITION: Railing fixed at average width of 3.5 Meters from 1600 Meters to winning post from its original position.

## <u>1<sup>st</sup> Race: 16. The Belur Plate - (About) 1200 metres. Horses rated 00</u> to 20, 5 years old and over (12 Runners).

ALL BY MYSELF (Shiva Kumar S.) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.K.P.G Appu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

MIMING (Kiran Rai P) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Prithviraj B. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

HIGH HAWK (Rayan Ahmed R.) jumped awkwardly outwards and inconvenienced the horses on its outside viz; DONTBREAKTHERULES (Ryan Marshall), MASTER OF WAR (P. S. Chouhan) and EL MATADOR (Vishwanath A.) soon after the start. As the incident was accidental no action was taken beyond noting the incident.

Jockey Rajesh Kumar M, the rider of KANTHAKA was fined Rs.20,000/- for coming 'in' and causing severe interference to the horses on his inside viz; SAVISA (R. Vaibhav), AQUA BLESSING (Chetan Kalay S.) and BAROG (Imran Chisty) which had to be checked by their respective riders whereby they lost position before passing the red marker post.

Jockey P. S. Chouhan, the rider of MASTER OF WAR placed 2nd by the judge objected against Jockey Ryan Marshall, the rider of DONTBREAKTHERULES placed 1st for " At the start the winner came on to me and bumped twice, whereby my horse stopped galloping at the start which cost me a certain race". The Stewards held an enquiry immediately after the race and interviewed the Jockeys concerned. After deliberations, they decided to overrule the objection.

It was reported after the race that MASTER OF WAR (P. S. Chouhan) burst its blood vessels. Trainer Mr. S. Dominic was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

GOOD WORD (Shamaz Shareef) sustained superficial injury on back of left fore knee.

Routine Sample was taken for analysis from the winner ch g DONTBREAKTHERULES.

## <u>2<sup>nd</sup> Race: 17. The Aihole Plate - (About) 1400 metres. Maiden Horses</u> <u>3 years old only. (12 Runners).</u>

Jockey Akshay Kumar was fined Rs.2,000/- for not arriving to fulfill his riding engagement. Subsequently, Permission was granted to trainer Mr. S.S. Attaollahi to substitute Jockey S. Zervan to ride ASGARDIA in place of the declared rider.

SIR SUPREMO (Arshad Alam) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SUPER GLADIATOR (P. S. Chouhan) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Dominic was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

CAVALIERE (Y. S. Srinath) jumped awkwardly outwards.

STAR AND GARTER (David Egan) jumped awkwardly outwards.

It was observed that Jockey P. S. Chouhan, the rider of SUPER GLADIATOR had to steady his mount to avoid striking the front runner SIR SUPREMO (Arshad Alam) approaching 700 Metres and again passing the 600 Metres.

It was observed that Jockey Arshad Alam, the rider of SIR SUPREMO had to steady his mount to avoid striking the front runner HEAVENLY ANGEL (Darshan R.N) approaching 500 Metres.

TAZAMOUR (R. Anand) ran detached from the field. Trainer Mr. Narayana Gowda. V was informed to ensure better performance of his charge in future.

Jockey Rajesh Kumar M, the rider of TOROSANTO reported that his mount was running green throughout the race. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Arshad Alam, the rider of SIR SUPREMO was fined Rs.3,000/- for the excessive use of whip on his mount during the race ( $1^{st}$  infringement).

Routine Sample was taken for analysis from the winner b g SIR SUPREMO.

#### <u>3<sup>rd</sup> Race: 18. The Master Key Plate - (About) 1200 metres. Horses</u> rated 15 to 35, 5 years old and over (12 Runners).

Jockey Akshay Kumar was fined Rs.2,000/- for not arriving to fulfill his riding engagement. Subsequently, Permission was granted to trainer Mr. Dheeraj.V to substitute Jockey P. S. Chouhan to ride INDUSTRIALIST in place of the declared rider.

AGNAR (Darshan R.N) reared up as the gates opened, lost many lengths and ran detached. In view of its behaviour, Trainer Mr. Pradeep Annaiah was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Kiran Rai P, the rider of DAGOBERT was reprimanded for shifting 'in' and inconveniencing SMILE OF PEACE (Surya P.) on his inside approaching 350 Metres.

Routine Sample was taken for analysis from the winner b g DAGOBERT.

## <u>4<sup>th</sup> Race: 19. The Altenburg Plate - (About) 1400 metres. Horses</u> rated 15 to 35, 4 years old and over (12 Runners).

DESERT ANGEL (P. S. Chouhan) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr. S. Dominic was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race. SOVIET UNION (Raghu K) jumped awkwardly inwards.

Jockey Raghu .K, the rider of SOVIET UNION was fined Rs.2,000/- for coming 'in' and tightening the field on his inside viz; SHARP RESPONSE (David Egan), HAFNIUM (Shiva Kumar S.) and BELLA MAMMA (Arul J.H) passing the 1200 Metres.

It was observed that Jockey A. Sandesh, the rider of CANDLELIGHTQUEEN had to ride his mount in check as it raced fiercely between the 1000 Metres till about 850 Metres.

Jockey Antony Raj S., the rider of HONEY TRAP was fined Rs.3,000/- for coming 'in' and tightening the field on his inside viz; CANDLELIGHTQUEEN (A. Sandesh), FIERCE FIGHTER (Darshan R.N), thereby SHARP RESPONSE (David Egan) and BROWN BESS (S. John) which were travelling directly behind had to check their respective mounts passing the 900 Metres.

It was observed that FIERCE FIGHTER (Darshan R.N) was inclined to run out and inconvenienced the horses on his outside viz; BROWN BESS (S. John) and NAWABZAADI (T. S. Jodha) passing the 800 Metres.

Jockey Arul J.H, the rider of BELLA MAMMA reported that his mount was not galloping fluently after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey S. John, the rider of BROWN BESS was reprimanded for shifting 'in' and bumping CANDLELIGHTQUEEN (A. Sandesh) on his inside approaching 300 Metres.

Jockey Rayan Ahmed R., the rider of ALEEF reported that he accidentally lost his whip passing the 200 Metres.

Jockey David Egan, the rider of SHARP RESPONSE was reprimanded for shifting 'in' and inconveniencing DESERT ANGEL (P. S. Chouhan) on his inside passing the 200 Metres.

Jockey S. John, the rider of BROWN BESS was fined Rs. 3,000/- for shifting 'in' and causing interference to CANDLELIGHTQUEEN (A. Sandesh) on his inside passing the 150 Metres.

Jockey Arul J.H, the rider of BELLA MAMMA was fined Rs.1,000/- for not wearing the goggles during the race.

Jockey Shiva Kumar .S, the rider of HAFNIUM was fined Rs.5,000/- for not making sufficient effort on his mount during the race.

Jockey Darshan R.N, the rider of FIERCE FIGHTER was reprimanded for dropping hands before passing the winning post.

ANDRA KING (Tauseef Ahmed) was subjected to veterinary examination. On examination, it was found to have burst its blood vessels (on Endoscopy Grade-IV). Trainer Mr. Pradeep Annaiah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SHARP RESPONSE (David Egan) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g SHARP RESPONSE.

## 5<sup>th</sup> Race: 20. The Bidar Plate - Div. II - (About) 1200 metres. Horses rated 30 to 50, 4 years old and over (12 Runners).

Jockey Akshay Kumar was fined Rs.2,000/- for not arriving to fulfill his riding engagement. Subsequently, Permission was granted to trainer Mr. Irfan Ghatala to substitute Jockey S. Zervan to ride VARCASVA in place of the declared rider.

Jockey S. Zervan, the rider of VARCASVA reported that he got squeezed between BENEDICTION (Irvan Singh) and SCARLET PRINCESS (Arshad Alam) at the start as such he could not ride from the desired position.

Jockey Vinod Shinde, the rider of MAHANATI was fined Rs.1,000/- for shifting out and causing interference to ARMIN (Antony Raj S.) on his outside approaching 900 Metres.

Jockey Md. Akram, the rider of CALL ME MAYBE was fined Rs.1,000/- for shifting 'in' and causing interference to ARMIN (Antony Raj S.) on his inside approaching 900 Metres.

It was observed that in a tightly packed field, LAND OF LIBERTY (Rajesh Kumar M) travelling directly behind ARMIN (Antony Raj S.) had to be checked by its rider and shift 'in' causing interference to LOOK OUT (Kiran Rai P) which was travelling along the rails approaching 900 Metres.

It was reported after the race that MAHANATI (Vinod Shinde) burst its blood vessels. Trainer Mr. Mahmood Khan (deputizing on behalf of Trainer Mr. Azhar Ali) was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g LAND OF LIBERTY.

## <u>6<sup>th</sup> Race: 21. The Dharmasthala Trophy - (About) 1600 metres.</u> Horses rated 30 to 50 (12 Runners).

THREE WISHES (Colm O'Donoghue) brushed the gates while jumping out and lost many lengths at the start. In view of its behaviour, Trainer Mr. S. Ganapathy was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey A. Sandesh, the rider of ELECTRA reported that his mount was running green throughout the race.

Jockey T. S. Jodha, the rider of LAWRENCE OF ARABIA was reprimanded for dropping hands before passing the winning post.

MARCO POLO (Y. S. Srinath) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g KIRKWOOD.

## <u>7<sup>th</sup> Race: 22. The Karnataka Police Trophy - (About) 1400 metres.</u> Horses rated 60 and above (10 Runners).

Permission was granted to Trainer Mr. Irfan Ghatala to withdraw DR LOGAN (Shamaz Shareef) on veterinary grounds as it was found to be lame on left

fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

HAEDI'S FOLLY (S. John) was extremely fractious and refuse to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

STRIKING GREY (Darshan R.N) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey R. Vaibhav, the rider of REGAL MUSIC reported that his mount was continuously changing its legs during the race. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b c WAR HAMMER.

## <u>8<sup>th</sup> Race: 5. The Rajyotsava Trophy (Grade III) - (About) 1400</u> metres. 3 years old and over. (7 Runners).

Jockey Akshay Kumar was fined Rs.2,000/- for not arriving to fulfill his riding engagement. Subsequently, Permission was granted to trainer Mr. S.S. Attaollahi to substitute Jockey P. S. Chouhan to ride SAKURA in place of the declared rider.

AEOLUS (S. Zervan) brushed the gates, while jumping out and lost many lengths at the start. In view of its behaviour, Trainer Mr. Darius R. Byramji was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Vishwanath A., the rider of ASHWA RAFTAR was fined Rs.1,000/- for dropping hands in the final 100 Metres for no apparent reason.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

#### <u>9<sup>th</sup> Race: 13. The Royal Calcutta Turf Club Cup - (About) 1400</u> metres. 3-year-old horses (foaled in 2016). (7 Runners).

Permission was granted to Trainer Mr. Aravind G. to withdraw QUEEN REGNANT (Imran Chisty) from the above race.

Permission was granted to Trainer Mr.S.S. Attaollahi to withdraw BOSTONIA (N. S. Parmar) from the above race.

Jockey Akshay Kumar was fined Rs.2,000/- for not arriving to fulfill his riding engagement. Subsequently, Permission was granted to trainer Mr. S.S. Attaollahi to substitute Jockey David Egan to ride MALWA in place of the declared rider.

Jockey Y. S. Srinath, the rider of COMMODUS reported that he had to steady his mount to avoid striking the front runner MALWA (David Egan) passing the 800 Metres. Jockey S. Zervan, the rider of MAGIC STREAM was reprimanded for shifting out and taking out HERE AND NOW (T. S. Jodha) on his outside approaching 600 Metres.

Routine Sample was taken for analysis from the winner b c MALWA.

## <u>10<sup>th</sup> Race: 23. The Bidar Plate - Div. I - (About) 1200 metres. Horses</u> rated 30 to 50, 4 years old and over (12 Runners).

Jockey Akshay Kumar was fined Rs.2,000/- for not arriving to fulfill his riding engagement. Subsequently, Permission was granted to trainer Mr. Dheeraj.V to substitute Jockey Y. S. Srinath to ride TOKYO ROSE in place of the declared rider.

Jockey Raghu K, the rider of DEPTH CHARGE was fined Rs.5,000/- for coming 'in' sharply and causing severe interference to PROPINE (Rayan Ahmed R.), which in turn passed it onto TOKYO ROSE (Y. S. Srinath) on his inside approaching 1000 Metres.

Jockey Kiran Rai P, the rider of SECRETSUPERSTAR was reprimanded for shifting 'in' and tightening PROPINE (Rayan Ahmed R.) on his inside approaching 200 Metres.

It was reported after the race that PROPINE (Rayan Ahmed R.) had apparently lost its left hind shoe during the race.

SECRETSUPERSTAR (Kiran Rai P) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g DEPTH CHARGE.
