### BANGALORE WINTER MEETING 2019-2020 FIFTH DAY, SATURDAY, 30<sup>th</sup> NOVEMBER 2019 RACING INCIDENTS

(31-38)

**GOING: GOOD** 

PENETROMETER READING: 3.4 Cms.

RAILING POSITION: Railing fixed its original position.

### 1<sup>st</sup> Race: 31. The Mount Joy Plate - Div. II - (About) 1400 metres. Horses rated 15 to 35 (14 Runners).

FIRESTONE (Vishwanath A.) planted, after jumping out swerved towards the left, went onto the sand track and did not take any practical part in the race. In view of its behaviour, Trainer Mr. Mahmood Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

MR HUMBLE (Manish R) jumped awkwardly inwards and inconveniencing CAPELLA (B. Nayak) on its inside at the start.

Jockey David Allan, the rider of HIGH PRIESTESS reported that his mount was running green throughout the race.

Jockey Arshad Alam, the rider of QUEEN OF SANDS reported that his mount was lugging 'in' under pressure in the final 250 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Bhanu P. Singh, the rider of RULER OF NATION was reprimanded for dropping hands before passing the winning post.

Trainer Mr. Imtiaz Khan and Jockey Arshad Alam were questioned regarding running and riding of QUEEN OF SANDS. Trainer stated that:

- (a) He had instructed the Jockey to ride from 2<sup>nd</sup>,3<sup>rd</sup> or 4<sup>th</sup> position and do his best in the straight;
- (b) He had instructed the jockey to keep the whip on the left as the filly had a tendency to lug out in the morning track work.
- (c) That it was a first run of his charge and;
- (d) But in the race the horse lugged 'in' under pressure in the final 200 Metres and was hesitated to pass the winner.

The Jockey corroborated the statements of the trainer and their explanations were noted for future reference.

Jockey A.R. Pradeep, the rider of SAINTHOOD was fined Rs.2,000/- for not improving his position from 800 Metres till about 500 Metres for no apparent reason.

Routine Sample was taken for analysis from the winner b f ZHU ZHU ZEST.

### 2<sup>nd</sup> Race: 32. The Hornadu Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35, 4 years old and over (12 Runners).

DALLAS (Rayan Ahmed R.) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Samar Singh was informed

to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that UNIFIER (Shamaz Shareef) stumbled approaching 800 Metres.

Jockey Arvind Kumar, the rider of ANAKIN reported that his mount was inclined to run out from 800 Metres till about 500 Metres in the process he took out SHE'S INNOCENT (Chetan Kalay .S).

Jockey Shamaz Shareef, the rider of UNIFIER was fined Rs.2,000/- for shifting 'in' and causing interference to ARROGANCE (Saddam Hussain), which in turn passed it onto GLORIOUS DAYS (D. Patel) on his inside passing the 300 Metres.

Jockey Shamaz Shareef, the rider of UNIFIER was reprimanded for shifting out and inconveniencing SHE'S INNOCENT (Chetan Kalay S.) on his outside passing the 150 Metres.

Jockey Chetan Kalay S., the rider of SHE'S INNOCENT was fined Rs.1,000/- for dropping hands in the final 100 Metres.

ANAKIN (Arvind Kumar) was observed to have lost position rapidly in the last 300 Metres and thereafter it was subjected to veterinary examination. On examination, it was found to have burst its blood vessels. Trainer Mr.Pradeep Annaiah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that SNOW QUEEN (T. S. Jodha) burst its blood vessels. Trainer Mr.Dheeraj.V was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch f LUCKY ISABELLA.

## 3<sup>rd</sup> Race: 33. The Hebbe Falls Plate - (About) 1600 metres. Horses rated 00 to 20 (14 Runners).

Permission was granted to trainer Mr. Samar Singh to run his charge ROMANTIC HAVEN without Tongue Strap in the above race as the horse was very fractious and the mare did not allow the Tongue Strap to be put on in the saddling enclosure.

Jockey Irvan Singh, the rider of JE NE SAIS QUOI was fined Rs.3,000/- for coming 'in' and tightening the horses on his inside viz; SOUTH BELL (K. Sai Kiran) and TEQUILA TORNADO (David Allan) along the rails approaching 1300 Metres.

Jockey T. S. Jodha, the rider of SILVER ECLIPSE reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. S. Dominic was informed to take appropriate corrective measures before accepting with it again.

Jockey Vishwanath A., the rider of EL MATADOR reported that he did not get a clear run approaching 300 Metres.

It was reported after the race that JE NE SAIS QUOI (Irvan Singh) had apparently lost its right fore shoe during the race.

It was reported after the race that ROMANTIC HAVEN (V.R.Jagadeesh) pulled up lame on right fore. Trainer Mr. Samar Singh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g JE NE SAIS QUOI.

4th Race: 34. The Bold Majesty Plate - (About) 1400 metres. Horses rated 30 to 50, 4

#### years old and over (14 Runners).

LIGHTNING ATTACK (V.R.Jagadeesh) reared up as the gates opened, dislodging its rider and ran rider less.

Routine Sample was taken for analysis from the winner b g BERNARDINI.

### 5<sup>th</sup> Race: 35. The Hoysala Trophy - (About) 1600 metres. Horses rated 60 and above (11 Runners).

Jockey Chethan Gowda, the rider of SAHARA was fined Rs.2,000/- for allowing his mount to drift out under the use of whip in the final 200 Metres.

Jockey P. Trevor, the rider of AUSTRALIS was reprimanded for shifting out and inconveniencing COSMOS (S. Zervan) on his outside passing the 150 Metres.

Routine Sample was taken for analysis from the winner b m AUSTRALIS.

### 6<sup>th</sup> Race: 36. The Bangalore 1000 Guineas(Grade II) - (About) 1600 metres. 3-year-old Indian Fillies (Foaled in 2016) (7 Runners).

Jockey P. Trevor, the rider of ANJEZE was fined Rs. 2,000/- for shifting 'in' and tightening the horses on his inside viz; GLORIOUS DANCER (Darshan R.N) and QUEEN REGNANT (Colm O'Donoghue) passing the 1500 Metres.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

b f ANJEZE I
b f GIFT OF GRACE II
b f WELL CONNECTED III

# 7<sup>th</sup> Race: 37. The Mount Joy Plate - Div. I - (About) 1400 metres. Horses rated 15 to 35 (14 Runners).

Jockey Irvan Singh replaced the indisposed Jockey V.R. Jagadeesh on SKY MOON.

INVICTA (Imran Chisty) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr. Prasanna Kumar was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SLOVENIA (Saddam Hussain) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr. Rajesh Narredu was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

Jockey Nazerul Alam, the rider of ADELA reported that he did not get a clear run due to the crowding of the field passing the 300 Metres.

Jockey Kiran Rai P, the rider of INDIAN STAR reported that he accidentally lost his whip passing the 100 Metres.

SKY MOON (Irvan Singh) ran detached from the field. Trainer Mr. Hidayat Khan (deputizing on behalf of Trainer Mr. S. Inayathulla) was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b c INDIAN DEMOCRAT.

## 8<sup>th</sup> Race: 38. The Hornadu Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35, 4 years old and over (11 Runners).

Permission was granted to Trainer Mr. Samar Singh to withdraw HALFSIES (Rayan Ahmed R.) on veterinary grounds as it was found to be suffering from colic. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

POWER OF SHAMBHALA (Chethan Gowda) jumped out awkwardly.

SIMPLY MAGICAL (Saddam Hussain) after jumping out swerved towards the left, thereby totally unbalancing the rider at the start.

Jockey Surya P., the rider of RED INDIAN reported that his mount was inclined to run out between the 800 Metres till about 600 Metres.

It was observed that ADIOS (Harish B.) was inclined to run out between the 800 Metres till about 600 Metres.

Jockey Shamaz Shareef, the rider of WHIZZO reported that his mount was not galloping fluently after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

It was reported after the race that POWER OF SHAMBHALA (Chethan Gowda) burst its blood vessels. Trainer Mr. R. V. Manohar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b g WHIZZO.

Routine Sample was taken for analysis from the winner ch c ROYAL RESOLUTION.

Permission was granted to trainers M/s. Neil B Devaney, S. Dominic and Hidayat Khan to deputize on behalf of trainers M/s. Azhar Ali, Neil Darashah and S. Inayathulla who were unable to attend the races.
