**RACING INCIDENTS**

**GOING : Good**

**PENETROMETER READING : 3.5 Cms.**

**RAILING POSITION: Railing fixed at average width of 3 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 47. The Belgaum Stakes - (About) 1400 metres. Horses rated 00 to 20 (10 Runners).**

Jockey Irvan Singh replaced the indisposed Jockey Vivek on APTHAMITRA.

Jockey S. John replaced the indisposed Jockey P. Trevor on CUSTOM CUT.

APTHAMITRA (Irvan Singh) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr. Samar Singh was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

TURF PROSPECTOR (Arul J.H) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr. Mahmood Khan was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

It was observed that DESERT GILT (Raghu K) accidentally brushed the running rails passing the 1000 Metres.

Jockey T. S. Jodha, the rider of PHOENIX REACHED was reprimanded for dropping hands before passing the winning post.

Routine Sample was taken for analysis from the winner b f CUSTOM CUT.

**2<sup>nd</sup> Race: 48. The Brahmagiri Stakes - Div. II - (About) 1200 metres. Horses rated 15 to 35 (11 Runners).**

Trainer Mr. K.P.G Appu was fined Rs.2,000/- for using a cloth (towel) to cover the side cheek pieces and brow band in respect of his charge ZAFRINA and the same was removed at the starting gates.

AUGUSTINA (S. John) jumped awkwardly inwards.

AMALFI COAST (R. Anand) jumped awkwardly outwards and inconvenienced SHE'S INNOCENT (Chetan Kalay S.) on its outside at the start.

Jockey K. Raja Rao, the rider of SUPER GLADIATOR was fined Rs.1,000/- for shifting out and taking out CAPELLA (B. Nayak), which in turn passed it onto AUGUSTINA (S. John) on his outside passing the 1000 Metres.

Jockey Chandrashekar, the rider of ZAFRINA was reprimanded for travelling wide from 650 Metres till about the final bend for no apparent reason.

Jockey A.Ramu, the rider of SMILE OF PEACE was fined Rs.3,000/- for not making sufficient effort on his mount in the final 300 Metres.

Jockey Irvan Singh, the rider of RULER OF NATION was fined Rs.2,000/- for shifting out and taking out SHE'S INNOCENT (Chetan Kalay S.) on his outside passing the 150 Metres.

RULER OF NATION (Irvan Singh) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f SHE'S INNOCENT.

**3<sup>rd</sup> Race: 49. The B.A.R.I Trophy - (About) 1200 metres. Horses rated 30 to 50 (12 Runners).**

Jockey David Allan replaced the indisposed Jockey P. Trevor on SCHAFENBERG.

ANOTHER RAINBOW (Bhanu P. Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. M. Rajendra Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SAN BERNARDINO (Imran Chisty) jumped out awkwardly.

PRINCESS HOLLY (R. Anand) jumped awkwardly outwards and inconvenienced onto DONNA BELLA (R. Vaibhav) on its outside at the start.

Jockey R. Vaibhav, the rider of DONNA BELLA reported that he had to steady his mount approaching 900 Metres due to the crowding of the field.

It was observed that Jockey Rajesh Kumar M, the rider of BIG BOON had to steady his mount and shift out to avoid striking the front runner KIMERA (Arvind Kumar) approaching 800 Metres.

Jockey Darshan R.N weighed 'in' 750 grams in excess in relation to weighing out. After due enquiry, Trainer Mr. V. Lokanath was fined Rs.2,000/- for not informing the change of girth and surcingle in respect of his charge LIGHTNING ATTACK before the race.

It was reported after the race that KIMERA (Arvind Kumar) burst its blood vessels. Trainer Mr. Pradeep Annaiah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry was held into the unauthorized entry of an individual into the paddock along with trainer Mr. M. Rajendra Singh and owner Mr. Syed Muheeb before the start of the above race in respect of the runner ANOTHER RAINBOW. After due enquiry, Trainer Mr. M. Rajendra Singh was fined a sum of Rs.20,000/- for the negligence in discharge of his duties as a trainer, thereby contravening Rule No. 114 (b) (i) of the BTC Rules of Racing.

Routine Sample was taken for analysis from the winner b f INDIAN EMPRESS.

**4<sup>th</sup> Race: 50. The Chintamani Stakes - Div. II - (About) 1100 metres. Horses rated 15 to 35, 4 years old and over (10 Runners).**

KUDLA PUNCH (Arul J.H) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Pradeep Annaiah was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Chethan Gowda, the rider of NERVA was reprimanded for travelling wide rounding the final bend for no apparent reason.

GLORIOUS DAYS (D. Patel) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch f ARROGANCE.

**5<sup>th</sup> Race: 51. The Vidhana Soudha Trophy - (About) 1400 metres. Horses rated 60 and above (9 Runners).**

Jockey IndraJeet Singh, the rider of CERISE NOIR was reprimanded for shifting out and inconveniencing PELUCHE (Chethan Gowda), which in turn passed it onto SET TO WIN (K. Sai Kiran) on his outside approaching 700 Metres.

Jockey Shamaz Shareef, the rider of STAR CRACKER reported that he accidentally lost his whip approaching 200 Metres.

It was reported after the race that CERISE NOIR (IndraJeet Singh) pulled up lame on right fore. Trainer Mr. S.S. Attaollahi was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b c SNOWDON.

**6<sup>th</sup> Race: 52. The Chintamani Stakes - Div. I - (About) 1100 metres. Horses rated 15 to 35, 4 years old and over (10 Runners).**

Jockey T. S. Jodha replaced the indisposed Jockey P. Trevor on BROWN BESS.

Jockey Naveen Kumar. V, the rider of INDUSTRIALIST was fined Rs.2,000/- for not improving his position from 900 Metres till about 500 Metres for no apparent reason.

Routine Sample was taken for analysis from the winner dk b f SIMONE.

**7<sup>th</sup> Race: 53. The Brahmagiri Stakes - Div. I - (About) 1200 metres. Horses rated 15 to 35 (11 Runners).**

Jockey Arshad Alam replaced the indisposed Jockey P. Trevor on AKASI.

BELLA MAMMA (Vishwanath A.) jumped out awkwardly and inconvenienced AKASI (Arshad Alam) at the start.

Jockey Vishwanath A., the rider of BELLA MAMMA reported that his mount was not galloping fluently after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey T. S. Jodha, the rider of BRIGADIER GENERAL reported that his mount was running green rounding the final bend and thereafter, it started hanging 'in' very badly. The horse was subjected to veterinary examination. On examination, it was found to have ulcers on both sides inside cheeks near oral commissure. Trainer Mr.Dheeraj. V was informed to take appropriate remedial measures before accepting with it again.

AKASI (Arshad Alam) sustained bleeding injury on right hind inside hock.

Routine Sample was taken for analysis from the winner b c PERFECT RENDITION.
