PENETROMETER READING : 3.4 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 54. The Gulbarga Plate - (About) 1100 metres. Horses rated 00 to 20 (8 Runners).

Jockey Manish R, the rider of SEABORN reported that kick back was too much during the race.

Jockey Ashok Kumar A., the rider of TUDOR PRINCE reported that his mount stopped galloping in the final 100 Metres and was making a roaring noise. The horse was subjected to veterinary examination. On examination, it was found to have paralysis on left side of vocal cord (on Endoscopy).

SEABORN (Manish R) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Sriram Komandur was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner ch g DEBONAIR.

2nd Race: 55. The Mekedatu Plate - (About) 2000 metres. Horses rated 60 and above (5 Runners).

Jockey T. S. Jodha replaced the indisposed Jockey P. Trevor on BROTHERS IN ARMS.

Routine Sample was taken for analysis from the winner b g COSMOS.

3rd Race: 56. The S.V.Subramaniam Memorial Trophy - (About) 1200 metres. Horses rated 45 to 65 (14 Runners).

Jockey David Allan replaced the indisposed Jockey P. Trevor on ROMA VICTOR.

ROMA VICTOR (David Allan) jumped awkwardly inwards.

Jockey Darshan R.N, the rider of SILVER DEW was fined Rs.5,000/- for shifting out and causing severe interference to the horses on his outside viz; SPANISH BEAUTY (S. John), MAYBE FOREVER (Rajesh Kumar M) and ROMA VICTOR (David Allan) soon after the start.

Jockey Saddam Hussain, the rider of ANIMAL QUEEN was fined Rs.3,000/- for persistently shifting 'in' and tightening AKITA PRO (Shamaz Shareef) between the 900 Metres till about 600 Metres along the rails.

MAYBE FOREVER (Rajesh Kumar M) was subjected to veterinary examination. On examination, it was found to have sustained severe clipped injury on right fore cannon.

DEPTH CHARGE (Raghu K) sustained clipped injury on right hind hock.

ROMA VICTOR (David Allan) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b g ROMA VICTOR.

Routine Sample was taken for analysis from the winner dk b g KVASIR.

4th Race: 57. The Air Force Cup - (About) 1600 metres. Horses rated 30 to 50, 4 years old and over (10 Runners).

Jockey Darshan R.N, the rider of DUXTON reported that he had to steady his mount due to the crowding of the field passing the 1400 Metres.

It was observed that Jockey Saddam Hussain, the rider of ARMENIA had to steady his mount to avoid striking the front runner SPIRIT BRUCE (Manish R), whereby he shifted out taking out the horses on his outside viz; ULTIMATE POWER (Chethan Gowda), DUXTON (Darshan R.N) and MEMORITER (Chetan Kalay S.) approaching 1300 Metres.

Jockey T. S. Jodha, the rider of LAWRENCE OF ARABIA reported that his goggles came off approaching 300 Metres.

It was reported after the race that LAWRENCE OF ARABIA (T. S. Jodha) pulled up lame on left hind. Trainer Mr.M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ARMENIA (Saddam Hussain) sustained clipped injury on right hind outer bulb of heel.

Routine Sample was taken for analysis from the winner b g THREE WISHES.

5th Race: 58. The Bangalore 2000 Guineas (Grade II) - (About) 1600 metres. 3-year-old Indian Horses (Foaled in 2016) (4 Runners).

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

6th Race: 59. The Kentucky Stakes - (About) 1200 metres. Maiden Horses 3 years old only. (14 Runners).

Jockey Y. S. Srinath replaced the indisposed Jockey P. Trevor on HARBOUR SUNRISE.

CAESARS PALACE (M. Mark) reared up as the gates opened and dislodged the rider.

TOROSANTO (Rajesh Kumar M) after jumping out did not raise a fluent gallop and ran detached thereafter. In view of its behaviour, Trainer Mr. Narayana Gowda V. was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Colm O'Donoghue, the rider of MUSTERION was fined Rs.5,000/- for shifting out and taking out the horses on his outside viz; STAR SAPPHIRE (Naveen M.), ASGARDIA (Suraj Narredu) and ALTAIR (Shamaz Shareef) at the start.

HARBOUR SUNRISE (Y. S. Srinath) sustained bleeding injury on right hind coronet.

AACHEN (C.Umesh) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g AACHEN.

7th Race: 60. The Krishna Raja Sagara Plate - (About) 1400 metres. Horses rated 15 to 35, 4 years old and over (10 Runners).

ZALA PRINCESS (Nazerul Alam) was examined at the saddling enclosure and found to have sustained cut injury on right fore pastern. Under the circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer Mr. Hidayat Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey S. John the rider of HONEY TRAP was fined Rs.1,000/- for shifting 'in' and causing interference to KING OF SHADOWS (V.R.Jagadeesh), which in turn passed it onto KINGSFIELD (Saddam Hussain) on his inside approaching 350 Metres.

SMILE OF JOY (T. S. Jodha) ran detached from the field. The horse was impounded for veterinary examination. On examination, it was found to have sharp molars on right side. Hence, Trainer Mr. S. Dominic was fined Rs.3,000/- for his negligence (1st infringement).

An enquiry is being held into the relatively performance of ALEEF, trained by Mr. Mahmood Khan and ridden by Jockey Vishwanath.A as compared to its previous run in race no.25 i.e., The Manipal Plate (about) 1600 Metres, Horses rated 15 to 35, run on 29 th November, 2019 where it ran unplaced.

AIR OF DISTINCTION (Darshan R.N) was subjected to veterinary examination. On examination, it was found to have burst its blood vessels. Trainer Mr. S. Ganapathy informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

KING OF SHADOWS (V.R.Jagadeesh) was subjected to veterinary examination. On examination, it was found to have burst its blood vessels. Trainer Mr. Nityanand G. informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from dk b g BACK OF BEYOND.

Surprise sample was taken for analysis from b f SMILE OF JOY.

Routine Sample was taken for analysis from the winner b g ALEEF.

Permission was granted to trainer Mr. S. Narredu to deputize on behalf of trainer Mr. Rajesh Narredu who was unable to attend the races.
