**RACING INCIDENTS**

**(61-66)**

**GOING : Good**

**PENETROMETER READING : 3.2 Cms.**

**RAILING POSITION: Railing fixed at average width of 7.5 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 61. The Kokkarebellur Plate - (About) 1200 metres. Maiden Horses 2 years old only. (9 Runners).**

Permission was granted to trainer Mr. S.S. Attaollahi to substitute Jockey T. S. Jodha to ride EMINENCE GRISE in place of the declared rider (as there was a delay in flight).

ANNE BOLEYN (P. S. Chouhan) jumped awkwardly outwards and inconvenienced ULTIMATE CHOICE (Kiran Rai P) on its outside at the start.

Routine Sample was taken for analysis from the winner dk b f ANNE BOLEYN.

**2<sup>nd</sup> Race: 62. The Linganamakki Plate - (About) 1400 metres. Horses rated 00 to 20, 5 years old and over (12 Runners).**

ALL BY MYSELF (Chethan Gowda) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. K.P.G Appu was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

It was observed that Jockey Darshan R.N, the rider of WINX had to steady his mount to avoid striking the front runner SOUTH BELL (Arshad Alam) passing the 900 Metres.

Jockey Vishwanath A., the rider of EL MATADOR reported that due to the kick back of the earth he had a partial vision during the race.

Jockey Chandrashekar, the rider of ALL SAID AND DONE was reprimanded for dropping hands before passing the winning post. As the Jockey was found wanting in the race, he was reprimanded in presence of the Master Trainer Mr. K.P.G. Appu and was informed to ensure improvement in riding in future.

It was reported after the race that ALL BY MYSELF (Chethan Gowda) pulled up lame on right fore. Trainer Mr. K.P.G Appu was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g PROUDWISH.

**3<sup>rd</sup> Race: 63. The Nilgiris Plate - (About) 2000 metres. Horses rated 15 to 35 (6 Runners).**

Jockey P. S. Chouhan, the rider of AFERPI was reprimanded for shifting 'in' and inconveniencing MIGHTY RED (Darshan R.N) on his inside in the final 75 Metres.

Routine Sample was taken for analysis from the winner b f STAR AND GARTER.

**4<sup>th</sup> Race: 64. The Dr.M.A.M.Ramaswamy Memorial Trophy - (About) 1200 metres. Horses rated 75 and above (9 Runners).**

AIR COMMAND (Ankit Yadav) jumped out awkwardly and inconvenienced SAINT PETERSBURG (P. Trevor) on its outside at the start.

Jockey Kiran Rai P, the rider of SILVER IKON was fined Rs.1,000/- for shifting 'in' and tightening the horses on his inside viz; MERLOT (Antony Raj S.) and DIAMOND RAYS (P. S. Chouhan) approaching 1000 Metres.

Jockey P. Trevor, the rider of SAINT PETERSBURG reported that he had to steady his mount passing the 300 Metres due to the crowding of the field.

SILVER IKON (Kiran Rai P) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g MULTIFACETED.

**5<sup>th</sup> Race: 65. The Secretariat Trophy - (About) 1400 metres. Horses rated 30 to 50 (8 Runners).**

Trainer Mr. Neil Darashah was fined Rs. 2,000/- for declaring Jockey Nazerul Alam to ride MOHICAN in the above race without his prior consent. Subsequently, permission was granted to him to declare Jockey M. Prabhakaran to ride MOHICAN in place of the declared rider.

WINNING HEART (Mohd Asif Khan) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Praveen Jesu was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Tauseef Ahmed, the rider of YERWAZAN was fined Rs.1,000/- for shifting 'in' and causing interference to MAGIC STREAM (Imran Chisty) on his inside approaching 100 Metres.

Routine Sample was taken for analysis from the winner ch g CUBAN PETE.

**6<sup>th</sup> Race: 66. The Longchamp Plate - (About) 1100 metres. Horses rated 15 to 35, 4 years old and over (10 Runners).**

Permission was granted to Trainer Mr.Pradeep Annaiah to withdraw REVAN STAR (A.R.Pradeep) on veterinary grounds as it was found to be lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SONGKRAN (Mohd Asif Khan) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. S. Dominic was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

WINNING FORCE (Saddam Hussain) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. V. Lokanath (deputizing on behalf of Trainer Mr. Rajesh Narredu) was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

PROPINE (S. John) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Kishan Thomas was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was reported after the race that MISCHIEF FLYER (Imran Chisty) burst its blood vessels. Trainer Mr.Imtiaz Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

PROPINE (S. John) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch g ACEROS.
