

**BANGALORE WINTER MEETING 2019-2020**  
**NINTH DAY , FRIDAY , 20<sup>th</sup> DECEMBER 2019**  
**(Preponed from Saturday, 21<sup>st</sup> December, 2019)**  
**RACING INCIDENTS**

**(67-72)**

**GOING : Good**

**PENETROMETER READING : 3.0 Cms.**

**RAILING POSITION: Railing fixed at average width of 7.5 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 67. The Beloved Prince Plate - (About) 1200 metres. Horses rated 15 to 35, 4 years old and over (11 Runners).**

Jockey Kiran Rai P replaced the indisposed Jockey A. Ramu on NOSTRADAMUS.

Permission was granted to Trainer Mr. Imtiaz Khan to withdraw REGAL FORCE (Imran Chisty) on veterinary grounds as the horse got cast in the stables which resulted in severe lameness. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

PRINCEAZEEM (T. S. Jodha) jumped awkwardly outwards and inconvenienced the horses on his outside viz; FORESIGHT (A.R.Pradeep) and DARAHASINI (Surya P.) at the start.

NAAYAAB (Chethan Gowda) took a fly jump.

Jockey Arshad Alam, the rider of BAROG reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination. On examination, it was found to be trotting lame on left hind. Trainer Mr. Sharat Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry was held on 22<sup>nd</sup> December, 2019 by the Stipendiary Stewards for the above race where Jockey Rayan Ahmed R the rider of GIN DAISY shifted 'in' sharply and caused interference to NOSTRADAMUS (P.Kiran Rai), DARAHASINI (P.Surya) , PRINCEAZEEM (T.S Jodha) & UNIFIER (P.S Chouhan) whereby the respective riders had to check their mounts approaching the 1000 Metres and he further shifted 'in' and tightened the horses on your inside viz;- AEROSPEED (Arvind kumar) CANDLELIGHTQUEEN (S.John) passing the 300 Metres.

Jockey Rayan Ahmed R was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey Rayan Ahmed R. After viewing the CCTV they decided to charge Jockey Rayan Ahmed R for Careless Riding Rule No. 161(i) of the BTC Rules of Racing.

The Stipendiary Stewards thereafter suspended Jockey Rayan Ahmed R with effect from 1<sup>st</sup> January, 2020 to 4<sup>th</sup> January, 2020 (both days inclusive) as he had pleaded guilty of the charge for Careless Riding Rule No. 161(i) of the BTC Rules of Racing on his mount GIN DAISY. (He is permitted to ride work and was informed of his right to appeal).

It was reported after the race that FORESIGHT (A.R.Pradeep) collapsed in the paddock after coming back from the race and did not respond to the emergency treatment given and thereafter died.

Routine Sample was taken for analysis from the winner ch f CANDLELIGHTQUEEN.

**2<sup>nd</sup> Race: 68. The Chamundi Hills Plate - (About) 1400 metres. Horses rated 15 to 35, 5 years old and over (12 Runners).**

AGNAR (Darshan R.N) jumped awkwardly outwards and inconvenienced the horses on his outside viz; FIND (S. John), JAMES BOND (Vishwanath A.) and LIMATO (Kiran Rai P) at the start.

Jockey T. S. Jodha, the rider of AZEEMKI PRINCESS had to steady his mount to avoid striking the front runner BLARNEY STONE (Chethan Gowda) in a closely packed field and shifted out inconveniencing the horses on his outside viz; ISPELLDANGERTOALL (Mohd Asif Khan), ADMIRAL ONE (Irvan Singh) and AMAZING ANGEL (V.R.Jagadeesh) approaching 900 Metres.

Jockey Rayan Ahmed R., the rider of HAPPY DANCING was reprimanded for shifting out and inconveniencing ISPELLDANGERTOALL (Mohd Asif Khan) on his outside approaching 300 Metres.

It was observed that ISPELLDANGERTOALL (Mohd Asif Khan) did not get a clear run approaching 250 Metres due to a closely packed field.

ISPELLDANGERTOALL (Mohd Asif Khan) was subjected to veterinary examination. On examination, it was found to be trotting lame on right fore. Trainer Mr. Praveen Jesu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

FIORENZO (R. Vaibhav) was subjected to veterinary examination. On examination, it was found to be trotting lame on right fore. Trainer Mr. Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that JAMES BOND (Vishwanath A.) pulled up lame on left fore. Trainer Mr. Mahmood Khan was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b m PARADISO.

**3<sup>rd</sup> Race: 69. The Bellary Plate - Div. II - (About) 1200 metres. Horses rated 30 to 50, 4 years old and over (12 Runners).**

STARS IN HIS EYES (M. Prabhakaran) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. S. Narredu was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SILKEN STRIKER (R. Vaibhav) ran detached from the field. Trainer Mr. Prithviraj B. was informed to ensure better performance of his charge in future.

At the behest of the Stipendiary Stewards, the Stewards held an enquiry into the interference caused by Jockey Ankit Yadav, the rider of ARMIN, whereby he shifted 'in' sharply soon after jumping out causing severe interference to the horses on his inside viz; RED GALILEO (Arshad Alam), LUCKY ISABELLA (A.Imran Khan) and RADIANT TREASURE (Saddam Hussain) resulting in Jockey Shiva Kumar S., the rider of CAPSTONE getting totally unbalanced and was dislodged. The Stewards held an enquiry immediately after the race and interviewed the respective Jockeys viz; Ankit Yadav, Arshad Alam, A.Imran Khan and Saddam Hussain. After deliberations, the Stewards decided to disqualify ARMIN which was placed 4<sup>th</sup> from the above race.

The revised order of placings are as under:

An enquiry is being held into the interference caused by Jockey Ankit Yadav, the rider of ARMIN in the above race.

Routine Sample was taken for analysis from the winner b m PANAMA.

**4<sup>th</sup> Race: 70. The Kabini Cup - (About) 1400 metres. Horses rated 60 and above (8 Runners).**

Jockey David Allan replaced the indisposed Jockey Y.S. Srinath on INTO THE GROOVE.

Jockey P. Trevor, the rider of ANGELINO reported that he lost his right stirrup at the start which he regained approaching 1200 Metres.

Jockey M. Kumar, the rider of SET TO WIN was reprimanded for shifting 'in' and inconveniencing ASHWA RAFTAR (Imran Chisty) on his inside approaching 1100 Metres.

Routine Sample was taken for analysis from the winner dk b g ANGELINO.

**5<sup>th</sup> Race: 71. The Garden City Trophy - (About) 2000 metres. Horses rated 45 to 65 (6 Runners).**

Routine Sample was taken for analysis from the winner b g HERE AND NOW.

**6<sup>th</sup> Race: 72. The Bellary Plate - Div. I - (About) 1200 metres. Horses rated 30 to 50, 4 years old and over (12 Runners).**

In a closely packed field, Jockey David Allan rider of ROYAL RESOLUTION clipped the front runner TRIGGAR (J.H.Arul) whereby the rider was totally unbalanced and was dislodged from his mount, thereafter the riderless horse bumped ROYAL RESOLUTION on his outside whereby, SIYOUNI (M.Mark) OPTIMISTICAPPROACH (Manish R) and SHARP RESPONSE(S.Zervan) who were travelling alongside were hampered and the riders had to check their respective mounts approaching the 1000 Metres. As the incident was accidental no action was taken beyond noting the incident.

It was observed that the rider less horse TRIGGAR hampered the running of SHARP RESPONSE passing 800 Metres and again shifted out and took out TIO RICO passing 700 Metres.

It was reported after the race that TRIGGAR (Arul J.H) burst its blood vessels. Trainer Mr. Imtiaz Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ROYAL RESOLUTION (David Allan) was subjected to veterinary examination but no abnormality was reported.

An enquiry was held on 22<sup>nd</sup> December, 2019 by the Stipendiary Stewards for the above race where Jockey Kiran Rai P the rider of BIRCHWOOD shifted 'in' sharply and caused interference to SHARP RESPONSE (S.Zervan) and WINGS OF DESIRE (A. Imran Khan) before the red marker post and thereafter shifted across the field dangerously approaching the 1000 Metres violating the practice of the safety of other riders.

Jockey Kiran Rai P was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey Kiran Rai P. After viewing the CCTV they decided to charge Jockey Kiran Rai P for Careless Riding Rule No. 161(i) of the BTC Rules of Racing.

The Stipendiary Stewards thereafter suspended Jockey Kiran Rai P with effect from 28<sup>th</sup>

December, 2019 to 3<sup>rd</sup> January, 2020 (both days inclusive) as he had pleaded guilty of the charge for Careless Riding Rule No. 161(i) of the BTC Rules of Racing on his mount BIRCHWOOD. (He is permitted to ride work and was informed of his right to appeal).

Routine Sample was taken for analysis from the winner ch m ALBERETTA.

**BANGALORE WINTER MEETING 2019-2020**  
**SEVENTH DAY , SATURDAY , 14<sup>th</sup> DECEMBER 2019**

(A)

**Race: 60. The Krishna Raja Sagara Plate – (About) 1400 metres. Horses rated 15 to 35, 4 years old and over.**

An enquiry was held on 16<sup>th</sup> December, 2019 by the Stipendiary Stewards for the above race into the running and riding of BACK OF BEYOND, trained by Mr. Praveen Jesu and ridden by Jockey Mohd. Asif Khan in that Jockey Mohd. Asif Khan the ride BACK OF BEYOND was in a comfortable lead of about 2 lengths approaching 100 Metres marker and he dropped hands and eased up his mount in the final 50 Metres, thereby riding an over confident race.

Jockey Mohd. Asif Khan was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey Mohd. Asif Khan. After viewing the CCTV decided to charge Jockey Mohd. Asif Khan for contravention of Calendar Notification under the heading "PUNISHMENT TO JOCKEYS BY STIPENDIARY STEWARDS / STEWARDS".

The Stipendiary Stewards thereafter suspended Jockey Mohd. Asif Khan with effect from 26<sup>th</sup> December, 2019 to 4<sup>th</sup> January, 2020 (both days inclusive) as he had pleaded guilty of the charge for contravention of Calendar Notification under the heading "PUNISHMENT TO JOCKEYS BY STIPENDIARY STEWARDS / STEWARDS" on his mount BACK OF BEYOND. (He is permitted to ride work and was informed of his right to appeal).

**(B)**

An enquiry was held on 16<sup>th</sup> December, 2019 into the relatively performance of BACK OF BEYOND, trained by Mr. Praveen Jesu and ridden by Jockey Mohd. Asif Khan as compared to its previous run in race no.25 i.e., The Manipal Plate (about) 1600 Metres, Horses rated 15 to 35, run on 29<sup>th</sup> November, 2019 where it ran unplaced.

The trainer stated that:

- (a) His charge BACK OF BEYOND had come down in class after its two runs in Mysore;
  - (b) It was running in the lower class with a relatively poor company and;
  - (c) Since, it had rained in the previous race the going also suited his charge.
- His explanations were noted for future reference.

**(C)**

An enquiry was held on 16<sup>th</sup> December, 2019 into the relatively performance of ALEEF, trained by Mr. Mahmood Khan and ridden by Jockey Vishwanath.A as compared to its previous run in race no.25 i.e., The Manipal Plate (about) 1600 Metres, Horses rated 15 to 35, run on 29<sup>th</sup> November, 2019 where it ran unplaced. After due enquiry, Trainer Mr. Mahmood Khan was fined a sum of Rs.5,000/- for the relative performance of his charge ALLEF in the above race.
