1st Race: 73. The Bugs Bunny Plate - (About) 1200 metres. Maiden Horses 2 years old only (Outstation horses eligible). (8 Runners).

It was observed that Jockey T. S. Jodha, the rider of LIVISILLA had to check his mount to avoid striking the front runner GALLIC (Y. S. Srinath), whereby GOLDEN OAKS (Nathan Evans) which was travelling directly behind also had to check and fall back passing the 800 Metres.

Jockey David Egan, the rider of FOREST FLAME was reprimanded for shifting 'in' and inconveniencing GOLDEN OAKS (Nathan Evans) on his inside approaching 200 Metres.

Routine Sample was taken for analysis from the winner b f FOREST FLAME.

2nd Race: 74. The Amathos Plate - Div. II - (About) 1100 metres. Horses rated 15 to 35 (Whips not allowed) (11 Runners).

Jockey Chethan Gowda was fined Rs.2,000/- for not coming in a proper attire to the weighing room for the race days.

ZAFRINA (Irvan Singh) was extremely fractious, reared up and was stuck for a considerable period of time. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

TEMPLE DANCER (Nathan Evans) after jumping out did not raise a fluent gallop for the first 100 Metres. In view of its behaviour, Trainer Mr.S. Padmanabhan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

COUNTRY'S SPIRIT (Nazerul Alam) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Faraz Arshad was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

MAYURANA (Manish R) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Prithviraj B. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

CADILLAC SKY (A. Velu) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Imtiaz Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SMILE AROUND (Naveen M.) jumped out awkwardly.

Jockey Khurshad Alam, the rider of SANTORINI SECRET was reprimanded for shifting out and inconveniencing UP FRONT (Shamaz Shareef) on his outside passing the 1000 Metres.

Jockey Bhanu P. Singh, the rider of ANAKIN was fined Rs.5,000/- for not making sufficient effort on his mount during the race.

Trainer Mr. Prasanna Kumar reported that he was not happy with the riding of Jockey Chetan Kalay S in the above race, especially in the last 200 Metres where he felt the jockey was soft on the horse. The Stewards held an enquiry after the last race and examined trainer Mr. Prasanna Kumar and Jockey Chetan Kalay S. After deliberations, viewing the CCTV replay and acting on their own observations, they decided to give Jockey Chetan Kalay. S a grave benefit of doubt.

It was reported after the race that RADIANT BEAUTY (Chethan Gowda) burst its blood vessels. Trainer Mr. S. Narredu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner gr f RADIANT BEAUTY.

3rd Race: 75. The Agumbe Plate - (About) 1200 metres. Horses rated 00 to 20 (10 Runners).

RANCHO (Arshad Alam) took a fly jump.

Jockey R. Vaibhav, the rider of SHOW GIRL reported that he had to steady his mount passing the 800 Metres, whereby HIGH TIDE (Irvan Singh) which was travelling directly behind also had to check his mount.

Jockey Chandrashekar, the rider of ABOVE THE REST was fined Rs.1,000/for shifting 'in' and causing interference to RANCHO (Arshad Alam) on his inside passing the 300 Metres.

Jockey Chandrashekar, the rider of ABOVE THE REST was severely reprimanded for dropping hands in the final 100 Metres and he was also directed to not to accept any mounts till he proves his riding atleast in two Mock Races.

An enquiry is being held into the running and riding of DARING SWEETHEART, trained by Mr. Azhar Ali and ridden by Jockey Chetan Kalay .S in the above race.

Routine Sample was taken for analysis from the winner ch f SHOW GIRL.

4th Race: 76. The Kunigal Stud Plate - (About) 1400 metres. Horses rated 45 to 65, 4 years old and over (12 Runners).

Jockey Imran Chisty, the rider of BLUE MOON reported that his mount was inclined to run out between the 900 Metres till about 600 Metres.

It was observed that RECZAI (Arshad Alam) did not get a clear run in the final 100 Metres.

Routine Sample was taken for analysis from the winner b g BERNARDINI.

5th Race: 77. The S. Rangarajan Memorial Trophy - (About) 2000 metres. Horses rated 30 to 50 (5 Runners).

It was reported after the race that OZARK (David Egan) had apparently lost its right fore shoe during the race.

Routine Sample was taken for analysis from the winner ch g MIGHTY RED.

6th Race: 78. The Stewards Cup - (About) 1200 metres. Horses rated 60 and above (8 Runners).

Routine Sample was taken for analysis from the winner b g ATTORNEY GENERAL.

7th Race: 79. The Native Chieftan Plate - (About) 1400 metres. Horses rated 15 to 35, 4 years old and over (10 Runners).

Jockey Naveen Kumar. V, the rider of SMILE OF PEACE was fined Rs.1,000/-for travelling wide from 600 Metres till about 500 Metres for no apparent reason.

Jockey R. Anand, the rider of HIDDEN SOLDIER reported that he accidently lost his whip passing the 200 Meters.

DREAMS UNITED (Rayan Ahmed R.) ran detached from the field. The horse was subjected to veterinary examination. On examination, it was found to have sharp molars on right side. Hence, Trainer Mr. Sharat Kumar was fined Rs.3,000/- for his negligence (1st infringement).

Jockey C.Umesh, the rider of WHIZZO reported that his mount was not galloping fluently in the final 50 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g WHIZZO.

8th Race: 80. The Amathos Plate - Div. I - (About) 1100 metres. Horses rated 15 to 35 (Whips not allowed) (12 Runners).

IT'S MY COUNTRY (Darshan R.N) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey A.R.Pradeep, the rider of THE PREACHER reported that his mount was running green throughout the race.

Jockey Naveen M., the rider of DRAGON MOUNTAIN reported that he lost his right rein at the start which he regained within a few strides.

Jockey S.K.Paswan, the rider of BAHURUPAH was reprimanded for shifting out and inconveniencing STAR CITIZEN (Chethan Gowda) on his outside passing the 800 Metres.

Jockey A.R.Pradeep, the rider of THE PREACHER was reprimanded for shifting out and inconveniencing BOLD RUNNER (A. Ramu) on his outside passing the 500 Metres.

Jockey Chethan Gowda, the rider of STAR CITIZEN was reprimanded for hitting the horse with his hands passing the 300 Metres.

Jockey A. Ramu, the rider of BOLD RUNNER was reprimanded for hitting the horse with his hands passing the 200 Metres.

Routine Sample was taken for analysis from the winner b f SANDARINA.

ADDITIONAL REPORTS

BANGALORE WINTER MEETING 2019-2020 SEVENTH DAY, SATURDAY, 14th DECEMBER 2019

Race: 60. The Krishna Raja Sagara Plate - (About) 1400 metres. Horses rated 15 to 35, 4 years old and over.

An enquiry was held on 28th December, 2019 by the Stipendiary Stewards into the running and riding of SMILE OF JOY, trained by Mr. S. Dominic and ridden by Jockey T.S. Jodha. After deliberations, Jockey T.S. Jodha was fined Rs.3,000/- for not improving position during the initial stage of the race with the aid of whip.

NINTH DAY, FRIDAY, 20th DECEMBER 2019

Race: 69. The Bellary Plate - Div. II - (About) 1200 metres. Horses rated 30 to 50, 4 years old and over.

The Stipendiary Stewards reported Jockey Ankit Yadav to the Stewards on Saturday, 28th December, 2019 for dangerous riding Rule No. 161 (i) of the BTC Rules of Racing on his mount ARMIN in the above race. In that he shifted 'in' dangerously from (draw No. 8) soon after jumping out and caused severe interference to the horses on his inside viz; RED GALILEO (Arshad Alam), LUCKY ISABELLA (A.Imran Khan) and RADIANT TREASURE (Saddam Hussain) whereby the Jockeys had to check their respective mounts and lose position and also resulting in Jockey Shiva Kumar S., the rider of CAPSTONE getting totally unbalanced and being dislodged approaching 1000 Metres.

The Stewards after considering the Charge Sheet No. 676 issued to Jockey Ankit Yadav, after viewing the CCTV replay of the race and acting on their own observations decided to suspend the Jockeys licence granted to Jockey Ankit Yadav from 7th January, 2020 to 7th February, 2020 (both days inclusive) for dangerous riding Rule No. 161 (i) of the BTC Rules of Racing on his mount ARMIN in the above race (permitted to ride work).

ORDER OF THE STEWARDS

<u>Detection of prohibited substance in the urine sample of gr.m.</u>

<u>MAJESTIC RAJKUMARI, 5 yrs old during testing in training. The horse trained by Mr. Praveen Jesu.</u>

The Stewards of the Bangalore Turf Club Ltd. at their meeting held on Saturday, 28th December, 2019 considered the enquiry report submitted by the Stipendiary Stewards pertaining to the detection of the drug 16-Beta Hydroxy-Stanozolol under Anabolic Steroids and Sex Hormones – (proscribed list) the sample taken during testing in training on 17th October, 2019 from gr.m MAJESTIC RAJKUMARI. The horse owned by Mr. K.L. Gangadhar and trained by Mr. Praveen Jesu.

The Stewards interviewed trainer Mr. Praveen Jesu and after deliberating themselves decided to withdraw the licence granted to trainer Mr. Praveen Jesu and treat him as a disqualified person for a period of eleven months (1st infringement - under Medication Rules under proscribed list) i.e., from 7-1-2020 to 6-12-2020 (both days inclusive) in respect of his charge gr.m MAJESTIC RAJKUMARI as contained in BTC Calendar Notification under the heading "Medication and treatment of horses in Training and Racing and Anti-Doping Control" reading as follows:

"The trainer is always responsible for the protection and security of the horse in his care. The trainers are warned that they will be held responsible if an examination of a horse, results in the finding of any prohibited substances".

The Stewards also decided that gr.m MAJESTIC RAJKUMARI shall not be permitted to race for a period of six months i.e. with effect from 28th November, 2019 to 27th May, 2020 (both days inclusive) in terms of the BTC Medication Rules (Medication and Treatment of horses in Training and Racing and Anti-Doping Control with effect from 16th May, 2015) under the heading "Anabolic Steroids and Sex Hormones" (proscribed list).
