**RACING INCIDENTS**  
**(145-150)**

**GOING : Good**

**PENETROMETER READING : 3.0 Cms.**

**RAILING POSITION: Railing fixed at average width of 7.5 Meters from 1600 Meters to winning post from its original post.**

**1<sup>st</sup> Race: 145. The Somanathapura Plate - (About) 1600 metres. Horses rated 00 to 20, to be ridden by Indian Jockeys claiming allowance (8 Runners).**

Jockey Sameer Qureshi replaced the indisposed Jockey Ajay Kumar. R on NOBLE SPLENDOR.

Jockey A.S. Peter could not arrive in time to fulfill his riding engagement (flight delay). Subsequently, permission was granted to trainer Mr.Faraz Arshad to substitute Jockey Shreyas Singh to ride FIERCE FIGHTER in place of the declared rider.

NOBLE SPLENDOR (Sameer Qureshi) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Faraz Arshad was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

WINX (Md.Akram) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Imtiaz Khan was informed to ensure better performance of his charge in future.

Jockey Sameer Qureshi, the rider of NOBLE SPLENDOR reported that his goggles accidentally came off passing the 200 Metres.

Jockey Chethan Gowda, the rider of BAZINGA placed 2nd by the judge objected against Jockey Naveen Kumar. V, the rider of TURF PROSPECTOR placed 1st for "In the 50 Metres the winner cut cross me sharply whereby I could not ride my mount, which cost me the race". The Stewards held an enquiry immediately after the race and interviewed the Jockeys concerned. After deliberations, they decided to overrule the objection.

Jockey Naveen Kumar. V, the rider of TURF PROSPECTOR was reprimanded for not maintaining a straight course in the final 50 Metres.

Routine Sample was taken for analysis from the winner dk b g TURF PROSPECTOR.

**2<sup>nd</sup> Race: 146. The Classic Story Plate - Div. II - (About) 1100 metres. Horses rated 15 to 35, 5 years old and over (9 Runners).**

Trainer Mr.Dheeraj.V was fined Rs.10,000/- for having accepted his charge BOLD RUNNER (A.Ramu) to run in the above race when the trainer was specifically instructed not to accept his charge before getting it passed fit by the Club's Veterinary Officer, when it was under veterinary ban. Subsequently, it was withdrawn from the above race.

COMMANDPOST (Ajeet Kumar) brushed the gates while jumping out and lost few lengths. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey T. S. Jodha, the rider of ZEHNASEEB was fined Rs.5,000/- for shifting 'in' and causing severe interference to SOVIET UNION (K. Sai Kiran) on his inside passing the 1000 Metres.

Jockey Arshad Alam, the rider of PERFECT KING reported that his mount accidentally stumbled passing the 350 Metres.

Jockey Ashok Kumar A., the rider of FLICKA reported that his whip got stuck in the reins for a few strides between the 175 Metres till about 150 Metres.

Jockey Ajeet Kumar, the rider of COMMANDPOST reported that he accidentally lost his whip passing the 100 Metres.

Jockey Chethan Gowda, the rider of SANTORINI SECRET was fined Rs.1,000/- for dropping hands in the final 100 Metres.

Jockey S. Hussain, the rider of ANNALEASE was fined Rs.2,000/- for not wearing the goggles during the race.

Jockey S. Hussain, the rider of ANNALEASE was severely reprimanded in presence of Master Trainer Mr. S. Narredu that he should make every effort to improve his riding in future failing which he would be reported to the Stewards.

Routine Sample was taken for analysis from the winner b m ZEHNASEEB.

**3<sup>rd</sup> Race: 147. The Dashmesh Stud Plate - Div. I - (About) 1200 metres. Horses rated 30 to 50, 5 years old and over (Whips not allowed) (12 Runners).**

Jockey S. Hussain, the rider of TARINI was fined Rs.1,000/- for shifting out and causing interference to TOKYO ROSE (P. Trevor) on his outside passing the 1000 Metres.

It was observed that Jockey T. S. Jodha, the rider of SINGHSAAB had to steady his mount passing the 900 Metres due to crowding of the field.

It was observed that Jockey Shreyas Singh, the rider of CABALLO RAPIDO had to steady his mount passing the 900 Metres due to crowding of the field.

Jockey Arshad Alam, the rider of FLAT OUT reported that his mount was not galloping fluently in the final 300 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

It was observed that VARCASVA (Irvan Singh) did not get a clear run between the 250 Metres to 200 Metres.

Routine Sample was taken for analysis from the winner b g BIG BOON.

**4<sup>th</sup> Race: 148. The Godolphin Barb Trophy - (About) 1400 metres. Horses rated 45 to 65 (11 Runners).**

It was observed that SAHARA (Nazerul Alam) jumped out awkwardly and bumped WHIZZO (Vinod Shinde) on his outside, totally unbalancing Jockey Nazerul Alam whereby he was dislodged and the horse ran riderless thereafter.

Jockey M. Prabhakaran, the rider of ALPHA was fined Rs.1,000/- for shifting 'in' and bumping SPIRIT OF LONDON (Ajeet Kumar) on his inside at the start.

Jockey Irvan Singh, the rider of PIPER REGINA reported that his mount stumbled at the start whereby his mount shifted out and inconvenienced the horses on his outside viz; POSEIDON (Darshan R.N) and STAR CRACKER (K. Sai Kiran) before passing the red marker post. As the incident was accidental no action has been taken beyond noting the incident.

Jockey M. Prabhakaran, the rider of ALPHA was reprimanded for travelling wide between the 600 Metres till about 400 Metres for no apparent reason.

Jockey Darshan R.N, the rider of POSEIDON was fined Rs.5,000/- for shifting 'in' and causing severe interference to ICE FLOE (David Allan) on his inside passing the 200 Metres.

Jockey Harish B., the rider of GOOD TIME INDEED was fined Rs.3,000/- for shifting 'in' and causing interference to WHIZZO (Vinod Shinde) on his inside passing the 300 Metres.

It was reported after the race that GOOD TIME INDEED (Harish B.) burst its blood vessels. Trainer Mr.Pradeep Annaiah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b r POSEIDON.

**5<sup>th</sup> Race: 149. The Bangalore Juvenile Million(Grade III) - (About) 1400 metres. 3 years old only (foaled in 2017). (6 Runners).**

Jockey P. Trevor, the rider of MOUNTAIN LION reported that his mount was lugging out under pressure in the final 200 Metres.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

**6<sup>th</sup> Race: 150. The Dashmesh Stud Plate - Div. II - (About) 1200 metres. Horses rated 30 to 50, 5 years old and over (Whips not allowed) (12 Runners).**

STARI GRAD (Vishwanath A.) jumped out awkwardly and inconvenienced EMIDIO (Naveen Kumar. V) at the start.

Jockey Naveen M., the rider of SECRETSUPERSTAR was fined Rs.3,000/- for shifting 'in' and tightening the horses on his inside viz; ARECA ANGEL (Dharshan Antony.B) and HABANERO (Tousif Khan) soon after the start.

Jockey Naveen Kumar. V, the rider of EMIDIO was fined Rs.3,000/- for shifting out and tightening the horses on his outside viz; STARI GRAD (Vishwanath A.) and CAPSTONE (Rayan Ahmed R.) before passing the red marker post.

It was observed that Jockey Naveen M., the rider of SECRETSUPERSTAR had to steady his mount to avoid striking the front runner LUCKY ISABELLA (Chethan Gowda) passing the 1000 Metres.

It was observed that Jockey T. S. Jodha, the rider of BLACK WHIZZ was forced to travel wide from 900 Metres to 800 Metres.

TANOURA (Darshan R.N) ran detached from the field. Trainer Mr. V. Lokanath was informed to ensure better performance of his charge in future.

Jockey Rayan Ahmed R., the rider of CAPSTONE reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Kishan Thomas was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner ch m LUCKY ISABELLA.

**7<sup>th</sup> Race: 151. The Classic Story Plate - Div. I - (About) 1100 metres. Horses rated 15 to 35, 5 years old and over (9 Runners).**

Trainer Mr. Pradeep Annaiah was fined Rs.10,000/- for having accepted his charge REVAN STAR (A.R.Pradeep) to run in the above race when the trainer was specifically instructed not to accept his charge before getting it passed fit by the Club's Veterinary Officer, when it was under veterinary ban. Subsequently, it was withdrawn from the above race.

Jockey A.Ramu replaced the indisposed Jockey Surya.P on INDUSTRIALIST.

TYTO ALBA (Ajeet Kumar) was extremely fractious, reared up and sat down. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

Jockey S. John, the rider of GIN DAISY reported that he lost his left stirrup soon after the start which he regained within a few strides. In the process, he shifted out and tightened ARROGANCE (Saddam Hussain) on his outside passing the 1000 Metres.

Jockey Ankit Yadav, the rider of CHULA VISTA was reprimanded for shifting out and inconveniencing ARROGANCE (Saddam Hussain) on his outside passing the 800 Metres.

Jockey S. John, the rider of GIN DAISY was reprimanded for easing his mount in the final 100 Metres.

CHULA VISTA (Ankit Yadav) was subjected to veterinary examination. On examination, it was found to be bleeding from right nostril. Trainer Mr. Arjun Mangalorkar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m GIN DAISY.
