RACING INCIDENTS
(152-158)

GOING : Good

PENETROMETER READING : 2.9 Cms.

RAILING POSITION: Railing fixed at average width of 7.5 Meters from 1600 Meters to winning post from its original post.

1st Race: 152. The Ardent Knight Plate - (About) 1200 metres. Maiden Horses 3 years old only. (11 Runners).

Permission was granted to Trainer Mr.Prithviraj B. to withdraw STONE HOUSE (Irvan Singh) on veterinary grounds as it was found to be lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

DARING BOY (A.R.Pradeep) was slowly away, lost few lengths and ran detached thereafter. In view of its behaviour, Trainer Mr.Azhar Ali was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

STORMY KNIGHT (V.R.Jagadeesh) jumped awkwardly inwards and inconvenienced SPEAKING OF SKIES (T. S. Jodha) on its inside at the start.

Routine Sample was taken for analysis from the winner dk b f FLAMINGO ROAD.

2nd Race: 153. The Dandeli Plate - (About) 1100 metres. Horses rated 00 to 20 (8 Runners).

Trainer Mr. Dheeraj.V was fined Rs.10,000/- for having accepted his charge NOSTRADAMUS (A.Imran Khan) to run in the above race when the trainer was specifically instructed not to accept his charge before getting it passed fit by the Club's Veterinary Officer, when it was under veterinary ban. Subsequently, it was withdrawn from the above race.

Jockey Dharshan Antony.B, the rider of ZAFRINA was fined Rs.5,000/- for shifting 'in' and causing severe interference to the horses on his inside viz; AIR FORCE ONE (M. Mark) and ALTAIR (Irvan Singh) passing the 1000 Metres.

ZAFRINA (Dharshan Antony.B) was subjected to veterinary examination. On examination, it was found to be lame on right fore. Trainer Mr. K.P.G Appu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch g HUNTERS MOON.

3rd Race: 154. The Melukote Plate - (About) 1600 metres. Horses rated 15 to 35, 5 years old and over (12 Runners).

Jockey S. John, the rider of FICTIONEER was fined Rs.2,000/- for shifting out and taking out SOUTH BELL (Shreyas Singh) on his outside passing the 200 Metres.

Routine Sample was taken for analysis from the winner ch g BROWN BESS.

4th Race: 155. The Chatrapathi Cup - (About) 1200 metres. Horses rated 60 and above (10 Runners).

LIFE AWAITS (Vishwanath A.) jumped out awkwardly and inconvenienced CORONA DEL CORSA (A. Sandesh) at the start.

Jockey Vishwanath A., the rider of LIFE AWAITS was fined Rs.1,000/- for shifting out and taking out the horses on his outside viz; FIRE GLOW (Arshad Alam) and MANCHESTER (T. S. Jodha) approaching 900 Metres.

Jockey Kiran Rai P, the rider of PSYCHIC WARRIOR was fined Rs.3,000/- for shifting 'in' and tightening SUPER SUCCESS (Ryan Marshall) on his inside passing the 600 Metres.

MANCHESTER (T. S. Jodha) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Imtiaz Khan was informed to ensure better performance of his charge in future.

LIFE AWAITS (Vishwanath A.) was subjected to veterinary examination. On examination, it was found to have sharp molars on both sides. Hence, Trainer Mr. Sriram Komandur was fined Rs.3,000/- for his negligence (1st infringement).

Routine Sample was taken for analysis from the winner b g PSYCHIC WARRIOR.

5th Race: 156. The F. K. Irani Memorial Trophy - (About) 1400 metres. Horses rated 30 to 50 (11 Runners).

Trainer Mr. Azhar Ali was fined Rs.10,000/- for having accepting his charge VENUS BAY (Naveen M.) when it was under B.T.F. Ban. Subsequently, permission was granted to him to withdraw the horse from the above race.

Jockey A.Imran Khan, the rider of AFTER HOURS was reprimanded for shifting 'in' and inconveniencing MARCO POLO (Arvind Kumar) on his inside soon after the start.

Jockey K. Sai Kiran, the rider of ALEXANDRE DUMAS was fined Rs.1,000/- for not maintaining a straight course passing the 1100 Metres, whereby PRINCEAZEEM (P. Trevor) shied from ALEXANDRE DUMAS, thereby his mount shifted out and GLORIOUS DANCER (Darshan R.N) which was travelling directly behind stumbled unbalancing its rider passing the 1200 Metres.

It was observed that Jockey Arshad Alam, the rider of AMAZING ANGEL had to steady his mount to avoid striking the front runner GLORIOUS DANCER (Darshan R.N) passing the 1100 Metres.

Jockey Antony Raj S., the rider of KNOTTY OAK was fined Rs.2,000/- for shifting out and taking out CAVALIERE (S. John), which in turn passed it onto INDIAN DEMOCRAT (David Allan) on his outside passing the 250 Metres.

Jockey David Allan, the rider of INDIAN DEMOCRAT reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr.S. Padmanabhan was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b g KNOTTY OAK.

6th Race: 157. The Planetarium Plate - (About) 1100 metres. Horses rated 15 to 35 (8 Runners).

DONTBREAKTHERULES (Arshad Alam) reared up, bolted from the barrier while loading, ran with the rider and completed one round of the course. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

Routine Sample was taken for analysis from the winner ch g DEBONAIR.

7th Race: 158. The Royal Russian Plate - (About) 1400 metres. Horses rated 15 to 35 (12 Runners).

Jockey Naveen.M replaced the indisposed Jockey Chethan Gowda on DEFINITIVE.

Jockey G .Sai Vamshi replaced the indisposed Jockey Nazerul Alam on SOUTHERN POWER.

It was observed that the cross nose band of CAESARS PALACE (Saddam Hussain) had come off soon after the start. After due examination of the equipment, Trainer Mr. S. Narredu was fined Rs.2,000/- for his negligence.

Jockey Saddam Hussain, the rider of CAESARS PALACE was fined Rs.1,000/- for shifting 'in' and inconveniencing DEFINITIVE (Naveen M.) and TAZAMOUR (Ajeet Kumar) on his inside at the start.

Routine Sample was taken for analysis from the winner b c CAESARS PALACE.

Permission was granted to trainer M/s. Arjun Mangalorkar, S. Narredu and Pradeep Annaiah to deputize on behalf of trainer M/s. S.S. Attaollahi, Darius R. Byramji and Faraz Arshad who were unable to attend the races.
