**RACING INCIDENTS**  
**(137-144)**

**GOING : Good**

**PENETROMETER READING : 3.2 Cms.**

**RAILING POSITION: Railing fixed at average width of 6.5 Meters from 1600 Meters to winning post from its original post.**

**1<sup>st</sup> Race: 137. The Forever Elegance Plate - Div. III - (About) 1200 metres. Horses rated 15 to 35 (11 Runners).**

MRS THATCHER (David Allan) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on left hind. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.S. Padmanabhan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey M. Mark, the rider of COUNTRY'S SPIRIT was reprimanded for shifting 'in' and inconveniencing ECO FRIENDLY (Arshad Alam) on his inside at the start.

Jockey R Manjunath, the rider of AEROSPEED was fined Rs.2,000/- for not maintaining a straight course, whereby BELLA MAMMA (Nazerul Alam) and DARING SWEETHEART (S.Mubarak) had to be checked by their respective riders passing the 800 Metres.

Jockey Irvan Singh, the rider of AZEEMKI PRINCESS reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have sharp molars on both sides. Hence, Trainer Mr. Sharat Kumar (deputizing on behalf of trainer Mr. M. Rajendra Singh) was informed that he was fined Rs.3,000/- for his negligence (1st infringement).

Jockey S.Mubarak, the rider of DARING SWEETHEART was fined Rs.3,000/- for not making sufficient effort on his mount during the race.

Jockey K. Sai Kiran, the rider of COMMANDPOST was fined Rs.2,000/- for not wearing the goggles during the race.

Routine Sample was taken for analysis from the winner dk b f UP FRONT.

**2<sup>nd</sup> Race: 138. The February Plate - (About) 1100 metres. Maiden Horses 3 years old only. (12 Runners).**

Jockey A. Sandesh, the rider of ORLEANS reported that his mount was running green throughout the race.

Jockey Arshad Alam, the rider of CAPABLE reported that he accidentally lost his whip approaching 300 Metres.

CODE OF HONOUR (David Allan) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f VIOLIN.

**3<sup>rd</sup> Race: 139. The Davangere Plate - (About) 1200 metres. Horses rated 00 to 20 (12 Runners).**

Jockey G Sai Vamshi, the rider of PRIME STAR was fined Rs.2,000/- for shifting out and taking out ELITE AGENT (Irvan Singh) on his outside passing the 1000 Metres.

Jockey Chethan Gowda, the rider of DESERT GOLD was fined Rs.1,000/- for shifting 'in' and tightening ELITE AGENT (Irvan Singh) on his inside approaching 900 Metres.

It was observed that Jockey Irvan Singh, the rider of ELITE AGENT had to steady his mount to avoid striking the front runner PRIME STAR (G Sai Vamshi) passing the 700 Metres.

Jockey Arshad Alam, the rider of SHE'S STYLISH was fined Rs.1,000/- for shifting out and taking out PRIME STAR (G Sai Vamshi) on his outside passing the 200 Metres.

Jockey V.R.Jagadeesh, the rider of ASTRON reported that due to kick back he was seriously injured on his cheek bone with bleeding resulting in partial vision during the race.

Jockey G Sai Vamshi, the rider of PRIME STAR was reprimanded for dropping hands before passing the winning post.

It was reported after the race that DESERT GILT (R. Anand) had apparently lost its right fore shoe during the race.

Routine Sample was taken for analysis from the winner b m ARECA ANGEL.

**4<sup>th</sup> Race: 140. The Bharachukki Plate - Div. I - (About) 1200 metres. Horses rated 30 to 50 (11 Runners).**

Jockey S. John, the rider of INDIAN EMPRESS was fined Rs.5,000/- for shifting 'in' and tightening the horses on his inside viz; AACHEN (R. Vaibhav), SKYFIRE (Suraj Narredu) and SINGHSAAB (Naveen M.) before passing the red marker post.

Jockey R. Vaibhav, the rider of AACHEN reported passing the 1000 Metres his horse grabbed the bit on the left side and shifted out despite his best efforts and caused interference to the horses on his outside viz; PRINCESS HOLLY (K. Sai Kiran) and YERWAZAN (Tauseef Ahmed) approaching 900 Metres. The horse was subjected to veterinary examination. On examination, it was found to have pulled up lame on right fore. Trainer Mr. Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f INDIAN EMPRESS.

**5<sup>th</sup> Race: 141. The Forever Elegance Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35 (10 Runners).**

Permission was granted to Trainer Mr.Imtiaz Khan to withdraw HIGH ADMIRAL (Manish R) on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

KUDLA PUNCH (G Sai Vamshi) after jumping out did not raise a fluent gallop at the start. In view of its behaviour, Trainer Mr.Pradeep Annaiah was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

Routine Sample was taken for analysis from the winner b f QUEEN OF SANDS.

**6<sup>th</sup> Race: 142. The Sprinters Trial Stakes (Grade III) - (About) 1200 metres. 4 years old and over at the time of starting. (10 Runners).**

Jockey Kiran Rai P, the rider of SILVER IKON shifted 'in' and caused interference to KNOTTY ASH (Antony Raj S.) and MAURITANIA (David Allan) at the start and again shifted 'in' sharply and caused severe interference to the horses on his inside viz; KNOTTY ASH (Antony Raj S.) and MAURITANIA (David Allan) passing the 1000 Metres and he further shifted 'in' and caused severe interference to KNOTTY ASH (Antony Raj S.) on his inside passing the 300 Metres. An enquiry is being held into the above incident.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

b g MULTIFACETED I

b h KNOTTY ASH II

dk b h MAURITANIA III

**7<sup>th</sup> Race: 143. The Bharachukki Plate - Div. II - (About) 1200 metres. Horses rated 30 to 50 (11 Runners).**

ISPELLDANGERTOALL (Vishwanath A.) planted, lost many lengths and ran detached thereafter. In view of its behaviour, Trainer Mr.Samar Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Arvind Kumar, the rider of DALLAS was reprimanded for travelling wide from 700 Metres till about rounding the final bend.

Routine Sample was taken for analysis from the winner b f HARBOUR SUNRISE.

**8<sup>th</sup> Race: 144. The Forever Elegance Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35 (11 Runners).**

HEAVENLY ANGEL (Darshan R.N) reared up as the gates opened, flipped over, dislodged its rider and ran riderless thereafter.

Jockey T. S. Jodha, the rider of BLARNEY STONE reported that his mount was throwing its head up in the air for the first 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Chethan Gowda, the rider of STAR CITIZEN reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have sharp molars on left side. Hence, Trainer Neil Darashah was fined Rs.3,000/- for his negligence (1st infringement).

Jockey Nazerul Alam, the rider of SOUTHERN POWER reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. Faraz Arshad was informed to take appropriate corrective measures before accepting with it again.

Jockey Kiran Rai.P, the rider of DESERT MIRAGE was fined Rs.2,000/- for the loss of whip passing the 300 Metres (2<sup>nd</sup> infringement).

Routine Sample was taken for analysis from the winner b g THE PREACHER.
