PENETROMETER READING : 3.1 Cms.

RAILING POSITION: Railing fixed at average width of 5.5 Meters from 1600 Meters to winning post from its original post.

1st Race: 175. The Karwar Plate - Div. II - (About) 1400 metres. Horses rated 00 to 20 (11 Runners).

As Jockey A. Imran Khan could not arrive to fulfill his riding engagements (due to death in the family). Permission was granted to trainer Mr. Faraz Arshad to declare Jockey Nazerul Alam to ride ONLY PRINCE in place of the declared rider.

DESERT GILT (Ravi R.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SHAKTIMAN (S. John) jumped awkwardly inwards and inconvenienced SULTANA (T. S. Jodha) on its inside at the start.

Jockey Nazerul Alam, the rider of ONLY PRINCE was reprimanded for shifting 'in' and inconveniencing SULTANA (T. S. Jodha) on his inside rounding the final bend.

Jockey Darshan R.N, the rider of DUTY CALL reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to be lame on right fore. Trainer Mr. Mahmood Khan was was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that ONLY PRINCE (Nazerul Alam) pulled up lame on right fore. Trainer Mr. Pradeep Annaiah (deputizing on behalf of trainer Mr. Faraz Arshad) was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that EL MATADOR (Naveen Kumar. V) burst its blood vessels. Trainer Mr. Mahmood Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b c ECO FRIENDLY.

2nd Race: 176. The March Plate - (About) 1200 metres. Maiden Horses 3 years old only. (9 Runners).

Permission was granted to trainer Mr. Sriram Komandur to declare Jockey T. S. Jodha to ride PERFECT PERFECTO in place of the declared rider.

MORGANITE (Arshad Alam) fell over in the paddock and was examined by the Club's Veterinary Officer and was found to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's Order. Trainer Mr. Azhar Ali was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SWEET KISS (Bhawani Singh) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.S. Ganapathy was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

STAR HOPPER (P. Trevor) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey David Egan, the rider of EXCELLENT QUEEN was fined Rs.2,000/- for shifting out and taking out SUCCESSFUL AFFAIR (P. S. Chouhan) on his outside in the final 200 Metres.

EXCELLENT QUEEN (David Egan) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels. Trainer Mrs. Parvati Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from gr f EXCELLENT QUEEN.

Routine Sample was taken for analysis from the winner b c ANSALDO.

3rd Race: 177. The Icebreaker Plate - (About) 1600 metres. Horses rated 15 to 35 (11 Runners).

GREEN CHANNEL (Rayan Ahmed R.) was slowly away, swerved towards the right and lost many lengths at the start. In view of its behaviour, Trainer Mr.Neil B Devaney was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Nazerul Alam, the rider of MY VISION reported that his mount was running green during the race.

Jockey Chethan Gowda, the rider of APOLLO BAY was fined Rs.2,000/- for taking a unduly long lead till about the final bend.

Jockey Manish R, the rider of JAI VIKRAM reported that his right stirrup broke just before the finishing line.

Routine Sample was taken for analysis from the winner dk b g FICTIONEER.

4th Race: 178. The Karwar Plate - Div. I - (About) 1400 metres. Horses rated 00 to 20 (12 Runners).

Permission was granted to trainer Mr. Faraz Arshad to declare Jockey P. S. Chouhan to ride FIERCE FIGHTER in place of the declared rider.

Jockey P. Trevor replaced the indisposed Jockey P. S. Chouhan on FIERCE FIGHTER.

Jockey Nazerul Alam, the rider of NOBLE SPLENDOR was fined Rs. 2,000/- for shifting 'in' and causing interference to WINX (T. S. Jodha) on his inside before passing the winning post.

Jockey P. Trevor, the rider of FIERCE FIGHTER reported that his mount was not galloping fluently after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f ADELA.

5th Race: 179. The Becket Plate - (About) 1600 metres. Horses rated 30 to 50, 5 years old and over (12 Runners).

Permission was granted to trainer Mr. Neil Darashah to declare Jockey P. Trevor to ride LE MARC in place of the declared rider.

Jockey Imran Chisty replaced the indisposed Jockey P. S. Chouhan on INCITATUS.

Jockey Manish R, the rider of SPIRIT BRUCE reported that his mount was not galloping fluently after entering the straight. The horse was subject to veterinary examination but no abnormality was reported.

Jockey Irvan Singh, the rider of MARIACHI reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. Dheeraj. V was informed to take appropriate corrective measures before accepting with it again.

Jockey Antony Raj S., the rider of ASTRAL FORCE reported that he accidentally lost his whip passing the 200 Metres (3rd infringement). An enquiry is being held into the incident.

It was reported after the race that INCITATUS (Imran Chisty) pulled up lame on right fore. Trainer Mr. Prithviraj B. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m LE MARC.

6th Race: 180. The Dr. K. T. B. Menon Memorial Trophy - Div. I - (About) 1200 metres. Horses rated 30 to 50 (12 Runners).

Permission was granted to trainer Mr. Faraz Arshad to declare Jockey P. S. Chouhan to ride DEBONAIR in place of the declared rider.

Jockey Arshad Alam replaced the indisposed Jockey P. S. Chouhan on DEBONAIR.

It was observed that Jockey Arshad Alam, the rider of DEBONAIR had to steady his mount passing the 700 Metres due to a tightly packed field.

Jockey Irvan Singh, the rider of SKYFIRE reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. Prithviraj B. was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner ch f WINALL.

7th Race: 181. The Manas Sarovar Trophy - (About) 1400 metres. Horses rated 60 and above (9 Runners).

DEPTH CHARGE (K. Sai Kiran) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

CORONA DEL CORSA (Darshan R.N) jumped awkwardly inwards and inconvenienced PSYCHIC WARRIOR (V.R.Jagadeesh) on its inside at the start.

Trainer Mr. Pradeep Annaiah and Jockey S. John were questioned regarding running and riding of ATTORNEY GENERAL. The trainer stated that:

(a) He had instructed the Jockey to ride from 2nd /3rd position if no one is passing to the front then to make the pace wait till 200 Metres as it had a very short burst and do his best.

(b) Jockey while corroborating the statements of the trainer, stated that his mount just gave up in the final 25 Metres.

Their explanations were noted for future reference.

ATTORNEY GENERAL (S. John) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (on endoscopy Grade - III). Trainer Mr. Pradeep Annaiah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b g ATTORNEY GENERAL.

Routine Sample was taken for analysis from the winner b m BLUE MOON.

8th Race: 182. The Dr. K. T. B. Menon Memorial Trophy - Div. II - (About) 1200 metres. Horses rated 30 to 50 (12 Runners).

ON THE TROT (S. John) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Arjun Mangalorkar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey R. Vaibhav, the rider of UP FRONT was reprimanded for shifting 'in' and inconveniencing AGNAR (Darshan R.N) on his inside passing the 700 Metres.

It was observed that SILKEN STRIKER (Manish R) did not get a clear run in the final 100 Metres due to the crowing of the field.

Jockey Chetan Kalay S., the rider of MEMORITER was fined Rs. 2,000/- for his negligence in wearing wrong colours to the paddock. Subsequently, the colour was changed before the horse left the paddock.

It was reported after the race that SLICE OF HEAVEN (Ryan Marshall) pulled up lame on left fore. Trainer Mr.Prithviraj B. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b f UP FRONT.

9th Race: 183. The Honavar Plate - (About) 1200 metres. Horses rated 15 to 35, 5 years old and over (12 Runners).

BELLA MAMMA (Naveen Kumar. V) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Mahmood Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

SHE'S SUPERB (Chethan Gowda) took a fly jump.

Jockey Vivek, the rider of RUDRAM was reprimanded for shifting 'in' and inconveniencing GLORIOUS DAYS (V.R.Jagadeesh) on his inside passing the 800 Metres.

Jockey V.R.Jagadeesh, the rider of GLORIOUS DAYS was fined Rs.1,000/- for shifting 'in' and tightening SOVIET UNION (K. Sai Kiran) on his inside passing the 200 Metres.

Routine Sample was taken for analysis from the winner dk b g ISPELLDANGERTOALL.

Permission was granted to trainer M/s. Pradeep Annaiah and M. Rajendra Singh to deputize on behalf of trainer M/s. Faraz Arshad and Azhar Ali who were unable to attend the races.

Race: 98. The Srirangapatna Plate - (About) 1100 metres. Horses rated 15 to 35, 5 years old and over.

The Stewards of the Bangalore Turf Club Ltd. at their meeting held on Friday, 6th March, 2020 considered the Charge Sheet No: 680 dated 5th March, 2020 pertaining to the positive finding of **FLUNIXIN** (Class IV) - prohibited substance in the urine sample taken from b g PROPINE after it placed First in Race No. 98, i.e., The Srirangapatna Plate - (About) 1100 metres. Horses rated 15 to 35, 5 years old and over run on Saturday, 11th January, 2020. The horse trained by Mr. Kishan Thomas and owned by Mr. Mr. Nanda Kumar. N.

The Stewards examined trainer Mr. Prasanna Kumar spokesperson for trainer Mr. Kishan Thomas and Mr. Kishan Thomas himself. After deliberations, the Stewards decided to fine trainer Mr. Kishan Thomas a sum of Rs.20,000/- (1st infringement of Medication Rules) in respect of his charge **b g PROPINE** as contained in BTC Calendar Notification under the heading "Medication and treatment of horses in Training and Racing and Anti-Doping Control" reading as follows:

"The trainer is always responsible for the protection and security of the horse in his care. The trainers are warned that they will be held responsible if an examination of a horse, results in the finding of any prohibited substance/s"

Trainer was informed of his right to appeal.
