RACING INCIDENTS

(97-104)

GOING : Good

PENETROMETER READING: 3.4 Cms.

RAILING POSITION: Railing fixed at average width of 4 Meters from 1600 Meters to winning post from its original position.

1st Race: 97. The Sringeri Plate - Div. III - (About) 1200 metres. Horses rated 15 to 35 (12 Runners).

HITOMI SAKUMA (Ravi R.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey M.Mark, the rider of BOMBIX was reprimanded for shifting 'in' and inconveniencing RIGHTLY NOBLE (Satish Nayak) on his inside passing the 1000 Metres.

Jockey P. S. Chouhan, the rider of LIMITED SOURCE was fined Rs.3,000/- for shifting 'in' and causing interference to ROC GIRL (Chethan Gowda) on his inside passing the 500 Metres.

Jockey R. Shelar, the rider of STAR CITIZEN was fined Rs.2,000/- for not fastening his colour cap whereby it came off along with his goggles passing the 900 Metres due to which the Jockey vision was hampered during the race.

Jockey Satish Nayak, the rider of RIGHTLY NOBLE was fined Rs.1,000/- for not exercising sufficient control on his mount, in the process shifting out and caused interference to SAND CASTLES(Naveen Kumar. V) passing the 700 Metres.

Routine Sample was taken for analysis from the winner b f LIMITED SOURCE.

2nd Race: 98. The Bagalkot Plate - (About) 1600 metres. Horses rated 00 to 20 (11 Runners).

Trainer Mr. Pradeep Annaiah was fined Rs.1,000/- for using Tongue Strap on his charge DARING SWEETHEART for which prior permission was not obtained. Subsequently, Tongue Strap was removed before the horse left the paddock.

DARING SWEETHEART (A.R.Pradeep) was extremely fractious, reared up and flipped over in the starting gates. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

It was observed that ANNALEASE (Khurshad Alam) accidentally stumbled approaching 1400 Metres.

It was observed that Jockey IndraJeet Singh, the rider of ICONIC PRINCESS had to steady his mount to avoid striking the front runner TRACK STRIKER (Akshay Kumar) approaching 750 Metres.

Jockey Nazerul Alam, the rider of MY VISION was fined Rs.3,000/- for the excessive use of whip on his mount during the race (1st infringement).

DARING SWEETHEART (A.R.Pradeep) sustained cut injury on right stifle.

COMMANDPOST (Ravi R.) was subjected to veterinary examination but no abnormality was reported.

An enquiry was held on 27th January, 2021 into the relatively improved performance of his charge IRONIC HUMOUR, trained by Mr. Prasanna Kumar. P and ridden by Jockey S. John in the above race as compared to its previous run in Race No.81 i.e., The Rajghat Plate - Div.III (about) 1200 Metres, Horses rated 15 to 35 run on 9th January, 2021 where it ran unplaced. After due enquiry, not being fully satisfied with the explanations tendered by trainer Mr. Prasanna Kumar. P, he was fined a sum of Rs.5,000/- for the unsatisfactory explanations tendered by him during the enquiry.

Routine Sample was taken for analysis from the winner b f IRONIC HUMOUR.

3rd Race: 99. The Sringeri Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35 (11 Runners).

RAW GOLD (Vivek) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right hind. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. S. Inayathulla was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that ENCOUNTER (V.R.Jagadeesh) was inclined to run out between the 900 Metres and 700 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

It was observed that KINGS SPEECH (Neeraj Rawal) was running green in the final 150 Metres.

Jockey Naveen Kumar. V, the rider of LIFEISAMIRACLE was fined Rs.2,000/- for not making any effort to improve his position from 1000 Metres till about 400 Metres.

Blood Sample was taken for analysis from the winner dk b f GLENARY.

4th Race: 100. The Statue of Unity Plate - (About) 1200 metres. Horses rated 60 and above (12 Runners).

CUBAN PETE (S. Zervan) was subjected to veterinary examination. On examination, it was found to have sharp molars. Hence, Trainer Mr. S.S. Attaollahi was fined Rs.3,000/- for his negligence (1st infringement).

It was observed that SUPER SMART (Khurshad Alam) was pulled up by its rider before passing the winning post and the rider dismounted at 100 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g GALVARINO.

5th Race: 101. The A.S.Ramaiah Winter Million - (About) 1200 metres. 3-year-old horses(foaled in 2018) (7 Runners).

WINMYLOVE (A. Sandesh) jumped awkwardly outwards and inconvenienced WAR CHIEFTAIN (Prashant P.Dhebe) at the start.

Routine Sample was taken for analysis from the winner dk b f SCRUPLES.

6th Race: 102. The Bangalore Race Course 158th year Commemoration Trophy - (About) 1600 metres. 4 years old and over at the time of starting. (6 Runners).

It was observed that NORTHERN ALLIANCE (Y. S. Srinath) raced fiercely between the 1400 Metres till about 1100 Metres and brushed the running rails passing the 1000 Metres.

PREVALENT FORCE (Suraj Narredu) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch m COSMIC RAY.

7th Race: 103. The Sriharikota Plate - (About) 1400 metres. Horses rated 30 to 50, 5 years old and over (12 Runners).

Trainer Mr. Neil Darashah was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge COSMIC FEELING.

Routine Sample was taken for analysis from the winner b g ASGARDIA.

8th Race: 104. The Sringeri Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35 (12 Runners).

Jockey Harish. B, the rider of ARECA ANGEL was reprimanded for riding an indifferent race.

DUXTON (R. Vaibhav) was subjected to veterinary examination. On examination, it was found to have pulled up lame on right fore. Trainer Mr. V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f SEE MY HEELS.
