**(25-32)**

**GOING : Going**

**PENETROMETER READING: 3.4 Cms.**

**RAILING POSITION: Railing fixed at average width of 7.5 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 25. The Manipal Plate - (About) 1200 metres. Maiden Horses 3 years old only. (12 Runners).**

EXALTATION (Suraj Narredu) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that ZEE ZEE TOP (A.R.Pradeep) raced fiercely between the 900 Metres till about 800 Metres.

Jockey Suraj Narredu, the rider of EXALTATION was reprimanded for shifting 'in' and inconveniencing ZEE ZEE TOP (A.R.Pradeep) on his inside as such the latter had to be checked and steadied by its rider approaching 800 Metres.

Jockey Neeraj Rawal, the rider of JOKSHAN was reprimanded for shifting out and inconveniencing CARMINE (P. Trevor) on his outside passing the 500 Metres.

Jockey Antony Raj S., the rider of OCEAN DUNES was fined Rs.1,000/- for shifting 'in' and causing interference to TOP NEWS (Rayan Ahmed R.) on his inside passing the 300 Metres.

Jockey P. Trevor, the rider of CARMINE reported that his mount wobbled in the last 150 Metres. The horse was subjected to veterinary examination but no abnormality was reported

Routine Sample was taken for analysis from the winner ch f BLOOM BUDDY.

**2<sup>nd</sup> Race: 26. The November Plate - Div. II - (About) 1400 metres. Horses rated 15 to 35 (12 Runners).**

DIAMANTISSIMO (Tauseef Ahmed) reared up as the gates opened.

Jockey Y. S. Srinath, the rider of JAN ZIZKA was reprimanded for shifting 'in' and inconveniencing SPECIAL STONE (Afsar Khan) on his inside approaching 1000 Metres.

Jockey Shamaz Shareef, the rider of MARIACHI was reprimanded for shifting 'in' and inconveniencing COUNTRY'S JEWEL (Surya P.) on his inside passing the 250 Metres.

Jockey Manish R, the rider of DREAM CHASER reported that he accidentally lost his whip passing the 100 Metres.

MARVELLOUS MAGGI (Rayan Ahmed R.) ran detached from the field. Trainer Mr. V. Lokanath was informed to ensure better performance of his charge in future.

Jockey Prashant P. Dhebe, the rider of AMALFI SUNRISE reported that his mount was not galloping fluently in the final 100 Metres of the race.

Routine Sample was taken for analysis from the winner b g SADAQAT.

**3<sup>rd</sup> Race: 27. The World Television Day Plate - (About) 1400 metres. Maiden Horses 3 years old only. (11 Runners).**

After the race, the Stipendiary Stewards reported Trainer Mr. Irfan Ghatala to the Stewards held an enquiry and interviewed Trainer Mr. Irfan Ghatala for not declaring his charge GARAMOND to start in the above race when it was under treatment. After deliberations, the Stewards decided to fine him a sum of Rs.20,000/- for his negligence in discharge of his duties as a trainer in respect of his charge GARAMOND.

SECRET SOURCE (Suraj Narredu) jumped awkwardly outwards onto CANOTINA (Antony Raj S.) on its outside soon after the start.

RAINBOW RISING (G Sai Vamshi) jumped awkwardly outwards onto SHIVALIC GOLD (Shelar R.) on its outside soon after the start.

Jockey Suraj Narredu, the rider of SECRET SOURCE was reprimanded for shifting out and inconveniencing RAINBOW RISING (G Sai Vamshi) on his outside approaching 1200 Metres.

Jockey Suraj Narredu, the rider of SECRET SOURCE reported that his mount was not comfortable after the start. The horse was subjected to veterinary examination and found to have lost its left fore shoe during the race.

DECORUM (A.R.Pradeep) ran detached from the field. Trainer Mr. Darius R. Byramji was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b g REALIA.

**4<sup>th</sup> Race: 28. The Chikkaballapur Plate - (About) 1200 metres. Horses rated 45 to 65 (12 Runners).**

Jockey Afsar Khan, the rider of THE STRENGTH reported that his mount threw its head in the air soon after the start. In view of its behaviour, Trainer Mr. Sharat Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that Jockey Kiran Rai P, the rider of REGAL MUSIC had to steady his mount to avoid striking front runner due to the crowding of the field passing the 1000 Metres.

It was observed that Jockey V.R.Jagadeesh, the rider of BENEDICTION had to steady his mount to avoid striking front runner due to the crowding of the field passing the 1000 Metres.

Jockey Rayan Ahmed R., the rider of SALVADOR DALI reported that his mount was not galloping fluently in the last 400 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

BENEDICTION (V.R.Jagadeesh) sustained bleeding cut injury on right hind fetlock.

Routine Sample was taken for analysis from the winner ch c GOLDEN OAKS.

**5<sup>th</sup> Race: 29. The Hoysala Salver - (About) 1600 metres. Horses rated 60 and above (8 Runners).**

An enquiry is being held into interference caused by Jockey A.Imran Khan, the rider of TENNO SHO to SOUTHERN RULER (A. Sandesh) passing the 300 Metres in the above race.

Routine Sample was taken for analysis from the winner b f WELL CONNECTED.

**6<sup>th</sup> Race: 30. The Bangalore Turf Club Trophy(Grade III) - (About) 1200 metres. 3 years old and over. (7 Runners).**

It was observed that the left fore shoe of AUGUSTUS CAESAR (Neeraj Rawal) had come off and permission was granted to Trainer Mr. S.S. Attaollahi (deputizing on behalf of Trainer Mr. Altamash Ahmed) to re-shoe the horse and it was passed fit by the veterinary officer before leaving the paddock.

Jockey Suraj Narredu, the rider of MULTIFACETED was fined Rs.5,000/- for shifting 'in' and causing severe interference to AUGUSTUS CAESAR (Neeraj Rawal), which in turn passed it onto PSYCHIC WARRIOR (Kiran Rai P) on his inside soon after the start.

Jockey Neeraj Rawal, the rider of AUGUSTUS CAESAR was fined Rs.1,000/-for coming 'in' and tightening PSYCHIC WARRIOR (Kiran Rai P) on his inside passing the 300 Metres.

Jockey Suraj Narredu, the rider of MULTIFACETED reported that he accidentally lost his whip passing the 200 Metres. After watching the replay an enquiry is being initiated into the matter.

MULTIFACETED (Suraj Narredu) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b g MULTIFACETED.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

b g AUGUSTUS CAESAR            I

b g DREAM CATCHER            II

b h KNOTTY ASH                 III

**7<sup>th</sup> Race: 31. The Lal Bagh Plate - (About) 1600 metres. Horses rated 30 to 50, 4 years old and over (12 Runners).**

DREAMS UNITED (N. B. Kuldeep) reared up as the gates opened and lost few lengths at the start. In view of its behaviour, Trainer Mr.Sharat Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

WHIZZO (Y. S. Srinath) took a fly jump at the start.

It was observed that WHIZZO (Y. S. Srinath) raced fiercely between the 1450 Metres and 1350 Metres.

Jockey Afsar Khan, the rider of RIVERS OF BABYLON was reprimanded for shifting 'in' and inconveniencing DREAMS UNITED (N. B. Kuldeep) on his inside approaching 300 Metres.

Jockey Prashant P.Dhebe, the rider of SEA OF CORTEZ reported that his mount was not galloping fluently in the last 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey P. Trevor, the rider of HIGH PRIESTESS reported that his mount was lugging out under pressure in the last 150 Metres.

Routine Sample was taken for analysis from the winner b g ASTRAL FORCE.

**8<sup>th</sup> Race: 32. The November Plate - Div. I - (About) 1400 metres. Horses rated 15 to 35 (12 Runners).**

LITTLE JOE (Antony Raj S.) after jumping out swerved towards the left, dislodged the rider and did not take any practical part in the race. In view of its behaviour, Trainer Mr.S. Dominic was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SUN SPLASH (Shamaz Shareef) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Irfan Ghatla was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey N. B. Kuldeep, the rider of LADY NECTAR was fined Rs.3,000/- for shifting 'in' and causing interference to STRIKING MEMORY (Darshan R.N) on his inside soon after the start.

Jockey N. B. Kuldeep, the rider of LADY NECTAR was reprimanded for shifting 'in' and inconveniencing GIRL WITH PEARL (Manish R) on his inside passing the 1200 Metres.

It was observed that Jockey Manish R, the rider of GIRL WITH PEARL had to steady his mount to avoid striking the front runner due to closely packed field approaching 900 Metres.

Routine Sample was taken for analysis from the winner ch g BELLATOR.
