**RACING INCIDENTS**  
**(9-16)**

**GOING : Soft**

**PENETROMETER READING: 4.6 Cms.**

**RAILING POSITION: Railing fixed at average width of 2.5 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 9. The Antar Gange Plate - Div. II - (About) 1400 metres. Horses rated 15 to 35 (12 Runners).**

ANDRA KING (Rayan Ahmed R.) jumped awkwardly inwards and inconvenienced SOUTH BELL (Shreyas Singh) soon after the start.

DIAMANTISSIMO (Tauseef Ahmed) jumped awkwardly outwards and inconvenienced the horses viz; NIGHT SECRET (A.Imran Khan) and HANDSOME (Suraj Narredu) on its outside soon after the start.

Jockey Prashant P.Dhebe, the rider of TARTUFO reported that his mount running green in the straight.

It was observed that ULTIMATE STRIKER (V.R.Jagadeesh) shifted 'in' under the use of whip passing the 300 Metres.

Jockey Aravind Kumar.N, the rider of TRACK STRIKER was reprimanded for dropping hands in the final 200 Metres.

It was observed that RULE OF ENGAGEMENT (Arul J.H.) was lugging 'in' under pressure in the final 150 Metres. The horse was subjected to veterinary examination. On examination, it was found to have sustained bleeding cut injury on right hind cannon.

It was observed that RICHMOND HILL (K. Sai Kiran) stumbled and fell down after passing the winning post whereby the rider was injured. On immediate examination, by the Club's Veterinary Officer it was found to have burst its blood vessels. Trainer Mr. Narayana Gowda V. informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that ANDRA KING (Rayan Ahmed R.) burst its blood vessels. Trainer Mr. V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f NIGHT SECRET.

**2<sup>nd</sup> Race: 10. The Aihole Plate - (About) 1200 metres. Maiden Horses 3 years old only. (12 Runners).**

Jockey Rayan Ahmed R. replaced the indisposed Jockey K. Sai Kiran on HANDSOME ROCKY.

Jockey Prashant P.Dhebe, the rider of GALLIC was reprimanded for shifting out and inconveniencing BELLI DEEPA (A.R.Pradeep) on his outside approaching 150 Metres.

Jockey Neeraj Rawal, the rider of SILVERITA was reprimanded for not wearing goggles during the race.

It was reported after the race that FLAMING ORANGE (S. Zervan) burst its blood vessels. Trainer Mr.Darius R. Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SILVERITA (Neeraj Rawal) sustained cut injuries on left fore canon, left hind fetlock and pastern.

Routine Sample was taken for analysis from the winner gr g KATANA.

**3<sup>rd</sup> Race: 11. The Antar Gange Plate - Div. I - (About) 1400 metres. Horses rated 15 to 35 (12 Runners).**

FLAMINGO ROAD (S. John) jumped awkwardly outwards and inconvenienced the horses viz; KING CREOLE (IndraJeet Singh) and SMILE AROUND (Afsar Khan) on its outside soon after the start. In view of its behaviour, Trainer Mr. Arjun Mangalorkar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey A.Imran Khan, the rider of CARACAS reported that he accidentally lost his whip approaching 300 Metres. After watching the replay an enquiry is being initiated into the matter.

Jockey Neeraj Rawal, the rider of JACK RYAN reported that his mount was lugging 'in' under pressure in the final 200 Metres.

Jockey Naveen Kumar. V, the rider of INDUSTRIALIST was reprimanded for not wearing goggles during the race.

Jockey Kiran Rai P, the rider of RED INDIAN was reprimanded for not wearing goggles during the race.

FLAMINGO ROAD (S. John) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g JACK RYAN.

**4<sup>th</sup> Race: 12. The Kokkarebellur Plate - (About) 1600 metres. Maiden Horses 3 years old only. (10 Runners).**

Jockey Darshan R.N, the rider of OMBUDSMAN reported that his mount was running green in the straight.

Jockey A.Imran Khan, the rider of CHRISTOPHER WREN was reprimanded for shifting out and inconveniencing the horses viz; SPORTING MEMORIES (M. Mark) and LORD FRANKEL (P. Trevor) on his outside passing the 600 Metres.

Routine Sample was taken for analysis from the winner gr c LORD FRANKEL.

**5<sup>th</sup> Race: 13. The Air Force Trophy - (About) 1400 metres. Horses rated 45 to 65 (12 Runners).**

Jockey Rayan Ahmed R.replaced the indisposed Jockey K. Sai Kiran on COLONEL HARTY.

Jockey Arshad Alam replaced the indisposed Jockey V.R. Jagadeesh on POSEIDON.

COLONEL HARTY (Rayan Ahmed R.) jumped awkwardly inwards at the start.

Jockey Arshad Alam, the rider of POSEIDON was fined Rs.1,000/- for shifting 'in' and causing interference to LE MARC (Likith appu) on his inside, whereby the rider had to check and shift out inconveniencing the horses viz; THREE WISHES (Darshan R.N) and AARON THE BARON (G Sai Vamshi) on his outside approaching 800 Metres.

Routine Sample was taken for analysis from the winner b c NISUS.

**6<sup>th</sup> Race: 14. The Madras Race Club Trophy - (About) 1400 metres. Horses rated 75 and above (9 Runners).**

Permission was granted to Trainer Mr. S. Narredu to withdraw TREASURE DELIGHT on veterinary grounds as it was found to be lame on right hind due to cellulitis of cannon. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g COSMOS.

**7<sup>th</sup> Race: 15. The Bidar Plate - (About) 1200 metres. Horses rated 30 to 50 (12 Runners).**

Jockey Rayan Ahmed R.replaced the indisposed Jockey K. Sai Kiran on ARECA ANGEL.

Jockey S. Zervan, the rider of ANNE BOLEYN was questioned regarding his riding in the final 300 Metres. After due enquiry, his explanations were noted for future reference.

SUPERB SUCCESS (Mohammed Aliyar) was subjected to veterinary examination. On examination, it was found to have sharp molars on left side. Hence, Trainer Mr. M. Rajendra Singh was fined Rs.3,000/- for his negligence (1st infringement).

Routine Sample was taken for analysis from the winner dk b f DONNA BELLA.

**8<sup>th</sup> Race: 16. The Bangarpet Plate - (About) 1400 metres. Horses rated 30 to 50, 4 years old and over (12 Runners).**

Jockey Shelar R. replaced the indisposed Jockey V.R. Jagadeesh on GREY CHANNEL.

THE RESPONSE (Shreyas Singh) jumped awkwardly inwards and inconvenienced DREAMS UNITED (Shamaz Shareef) on its inside soon after the start.

Jockey Kiran Rai P, the rider of CANDLELIGHTQUEEN reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Prithviraj B. was informed to take appropriate corrective measures before accepting with it again.

JAIN SAHAB (Irvan Singh) was subjected to veterinary examination. On examination, it was found to be lame on left fore. Trainer Mr. M. Rajendra

Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f RORITO.
