SEVENTH DAY, SATURDAY, 12TH DECEMBER, 2020

RACING INCIDENTS

(49-56)

GOING : Good

PENETROMETER READING: 3.5 Cms.

RAILING POSITION: Railing fixed at average width of 8.5 Meters from 1600 Meters to winning post from its original position.

1st Race: 49. The Beloved Prince Plate - (About) 1200 metres. Maiden Horses 3 years old only. (12 Runners).

Jockey A.Ashhad Asbar, the rider of MASTER OF SUCCESS was fined Rs.1,000/- for shifting out and taking out GOLDEN VISION (Arshad Alam), which in turn passed it onto PRAIA DO CASSINO (M. Mark) on his outside soon after the start.

It was observed that CANOTINA (S. John) was inclined to run out between the 700 Metres till about 500 Metres.

Jockey Irvan Singh, the rider of JOKSHAN reported that his mount was lugging 'in' under pressure in the final 100 Metres of the race.

Jockey P. Trevor, the rider of WATCHMYSTARS reported that he could not ride from desired position due to the interference at the start.

WATCHMYSTARS (P. Trevor) was impounded for veterinary examination but no abnormality was reported.

An enquiry was held on 13th December, 2020 by the Stipendiary Steward for the above race into the interference caused by Jockey Indrajeet Singh, the rider of CARMINE in that he shifted 'in' and caused severe interference to the horses on his inside viz; CANOTINA(S.John), WATCHMYSTARS(P. Trevor) and MARVELLOUS MAGGI (V.R.Jagadeesh) soon after the start.

Jockey Indrajeet Singh was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Indrajeet Singh and after viewing the CCTV decided to charge Jockey Indrajeet Singh for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Indrajeet Singh with effect from 24th December, 2020 to 9th January, 2021 (both days inclusive) as he had pleaded guilty of the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount CARMINE (he was permitted to ride work) and was informed of his right to appeal.

Surprise sample was taken for analysis from b f WATCHMYSTARS.

Routine Sample was taken for analysis from the winner b g JOKSHAN.

2nd Race: 50. The Murudeshwar Plate - Div. II - (About) 1400 metres. Horses rated 00 to 20, 4 years old and over (12 Runners).

SKY MOON (Chethan Gowda) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Hidayat Khan (deputizing on behalf of Trainer Mr. S. Inayathulla) was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SOUTH BELL (Chandrashekar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Sharat Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Nazerul Alam, the rider of CHALLENGING STAR was fined Rs.2,000/- for shifting 'in' and causing interference to ELITE AGENT (Harish B.), which in turn passed it onto PROUDWISH (G Sai Vamshi) on his inside approaching 1200 Metres.

Jockey Ravi R., the rider of COMMANDPOST reported that his mount was hanging out after entering the straight. Trainer Mr.Narayana Gowda V. was informed to take appropriate corrective measures before accepting with it again.

Jockey Ankit Yadav, the rider of DEFINITIVE was severely reprimanded for the undesirable practice of dropping hands during the final stages of the race.

Routine Sample was taken for analysis from the winner b g DEFINITIVE.

3rd Race: 51. The Badami Plate - (About) 1200 metres. Horses rated 15 to 35, 5 years old and over (Whips not allowed) (12 Runners).

Permission was granted to trainer S. Dominic (deputizing on behalf of Trainer Mr. Neil Darashah) to use all black colors in respect of his charge NERVA (R. Shelar).

TYTO ALBA (Prashant P.Dhebe) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

GOLD MIST (Surya P.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Dheeraj.V was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SAN BERNARDINO (M. Prabhakaran) took a fly jump at the start.

Jockey Shamaz Shareef, the rider of AZEEMKI PRINCESS reported that he lost his right stirrup soon after the start, which he regained within few strides.

Jockey Arul J.H, the rider of PREMIER PREMISES was fined Rs.2,000/- for shifting 'in' and causing interference to CHARMAINE (A.Ashhad Asbar) and THE RESPONSE (Naveen M.) on his inside passing the 1000 Metres, whereby APOLLO BAY (Arvinda Kumar) who was travelling directly behind had be checked by its rider.

Jockey A. Ashhad Asbar, the rider of CHARMAINE was fined Rs.3,000/- for not sufficiently persevering with his mount in the final 250 Metres.

Jockey Shelar R., the rider of NERVA weighed 'in' 900 grams in excess in relation to weighing out. Hence, Trainer Mr. S. Dominic (deputizing on behalf of Trainer Mr.Neil Darashah) was fined Rs.3,000/-for his negligence in not reporting the change of girth and surcingle on his charge NERVA.

Routine Sample was taken for analysis from the winner b g THE RESPONSE.

4th Race: 52. The Adichunchanagiri Plate - (About) 1400 metres. Maiden Horses 3 years old only. (11 Runners).

MORGANITE (A.Ashhad Asbar) was extremely fractious and refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

FIRST IMPRESSION (Naveen M.) reared up as the gates opened.

It was observed that Jockey Ryan Marshall, the rider of RAINBOW RISING had to steady his mount to avoid striking the front runner FIRST IMPRESSION (Naveen M.) passing the 700 Metres.

Jockey Shreyas Singh, the rider of PERFECT HALO reported that his mount was running green after entering the straight.

Jockey Naveen M., the rider of FIRST IMPRESSION was fined Rs.2,000/- for shifting out and taking out TOWERING PRESENCE (Prashant P.Dhebe) on his outside in the final 100 Metres of the race.

Jockey P. Trevor, the rider of AMAZING BLAZE weighed 'in' 400 grams less in relation to weighing out. Hence, Trainer Mr. S. Padmanbhan was fined Rs.3,000/- for his negligence in not reporting the change of girth on his charge AMAZING BLAZE .

WELCOME SURPRISE (Arshad Alam) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch f AMAZING BLAZE.

5th Race: 53. The Garden City Trophy - (About) 1200 metres. Horses rated 45 to 65 (12 Runners).

THE STRENGTH (Naveen M.) jumped awkwardly outwards.

Jockey Ryan Marshall, the rider of KNOTTY OAK was fined Rs.1,000/- for shifting out and causing interference to FAIR WARNING (S. John) on his outside passing the 1000 Metres.

Jockey S. John, the rider of FAIR WARNING was fined Rs. 2,000/- for shifting 'in' and tightening the horses on his inside viz; ALBERETTA (R. Vaibhav), FIRE GLOW (Arshad Alam) and WINALL (Ankit Yadav) approaching 900 Metres.

Jockey Ryan Marshall, the rider of KNOTTY OAK was reprimanded for shifting out and inconveniencing ALBERETTA (R. Vaibhav) on his outside approaching 800 Metres.

Jockey Naveen M., the rider of THE STRENGTH reported that he could not get a clear run between 300 Metres and 200 Metres due to a closely packed field.

Routine Sample was taken for analysis from the winner ch g CUBAN PETE.

6th Race: 54. The Racing Patrons Trophy - (About) 1600 metres. Horses rated 60 and above (9 Runners).

Jockey Ryan Marshall, the rider of VELOCIDAD reported that his mount knuckled, thereby inconvenienced TENNO SHO (A. Imran Khan) soon after the start.

Jockey A.Ashhad Asbar, the rider of INDIAN PHARAOH was fined Rs.1,000/-for shifting 'in and causing interference to TENNO SHO (A.Imran Khan) on his inside passing the 1500 Metres.

Jockey Darshan R.N, the rider of SOUTHERN RULER was reprimanded for shifting 'in' and inconveniencing VELOCIDAD (Ryan Marshall) on his inside passing the 1000 Metres.

Jockey V.R.Jagadeesh, the rider of COMMODUS was reprimanded for shifting out and inconveniencing TENNO SHO (A.Imran Khan) on his outside passing the 100 Metres.

It was reported after the race that MYSTIC FLAME (Irvan Singh) burst its blood vessels. Trainer Mrs. Parvati Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

TENNO SHO (A.Imran Khan) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade - II). Trainer Mr. S. Dominic (deputizing on behalf of Trainer Mr.Neil Darashah) was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry is being held into the relative performance of KNIGHT TEMPLAR, trained by Mr. S. Padmanabhan and ridden by P. Trevor in the above race as compared to its previous run in Race No. 6 i.e., The Rajyotsava Trophy (Grade – III) (about) 1400 Metres, 3 years old and over run on 1st November, 2020 where it ran unplaced.

Surprise sample was taken for analysis from dk b g TENNO SHO.

Routine Sample was taken for analysis from the winner b c KNIGHT TEMPLAR.

7th Race: 55. The Becket Plate - (About) 1600 metres. Horses rated 30 to 50, 4 years old and over (12 Runners).

KALYAN (V.R.Jagadeesh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Darius R. Byramji was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey R. Vaibhav, the rider of SHOW GIRL reported that he could not get a clear run from 1500 Metres till about 1400 Metres due to a closely packed field.

Jockey R. Vaibhav, the rider of SHOW GIRL was reprimanded for shifting 'in' and tightening STAR SAPPHIRE (Arshad Alam) on his inside passing the 1400 Metres.

Jockey Arshad Alam, the rider of STAR SAPPHIRE was fined Rs.2,000/- for shifting out and causing interference to CANDLELIGHTQUEEN (S. Zervan) on his outside approaching 900 Metres.

An enquiry is being held into the relative performance of ALEXANDRE DUMAS, trained by Mr. Narayana Gowda. V and ridden by Rayan Ahmed. R in the above race as compared to its previous run in Race No. 7 i.e., The Belgaum Plate (about) 1400 Metres, Horses rated 30 to 50, run on 1st November, 2020 where it ran unplaced.

RORITO (S. John) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g ALEXANDRE DUMAS.

8th Race: 56. The Murudeshwar Plate - Div. I - (About) 1400 metres. Horses rated 00 to 20, 4 years old and over (11 Runners).

Trainer Mr. Prithviraj B. was fined Rs.10,000/- for having accepted his charge (INDIAN STAR) when the owner was under **B.T.F. BAN**. Subsequently, permission was granted to him to withdraw the horse from the above race.

FORTUNEER (Prashant P.Dhebe) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Sharat Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Chethan Gowda, the rider of MY VISION was reprimanded for shifting 'in' and inconveniencing to GAZEBO TALK (M. Prabhakaran) on his inside soon after the start.

It was observed that Jockey Naveen M., the rider of SPECIAL STONE had to ride his mount in check between the 900 Metres and 700 Metres due to a closely packed field.

An enquiry is being held into the relative performance of LOVELY SIERRA, trained by Mr. Azhar Ali and ridden by A.Ashhad Asbar in the above race as compared to its previous run in Race No. 17 i.e., The B.A.R.I Plate about (1400 Metres), Horses rated 00 to 20, run on 14th November, 2020 where it ran unplaced.

Routine Sample was taken for analysis from the winner ch m LOVELY SIERRA.

Permission was granted to trainers M/s. Rajesh Narredu, S. Dominic and Hidayat Khan to deputize on behalf of trainers M/s. S. Narredu, Neil Darashah and S. Inayathulla who were unable to attend the races.
