RACING INCIDENTS
(57-64)

GOING : Good

PENETROMETER READING: 3.4 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 57. The Davangere Plate - (About) 1200 metres. Horses rated 00 to 20, 5 years old and over (14 Runners).

ARROGANCE (Yash Narredu) jumped awkwardly outwards.

SAVISA (Shamaz Shareef) jumped out awkwardly and inconvenienced ANNALEASE (S.Mubarak) at the start.

An enquiry was held on 20th December, 2020 by the Stipendiary Steward for the above race into the interference caused by Jockey S. Imran, the rider of AEROSPEED in that he shifted 'in' and caused severe interference to ECO BONITA (N. B. Kuldeep) on his inside, whereby NERVA (M. Prabhakaran) which was travelling directly behind had to be checked by its rider to avoid clipping the front runner, whereby his mount stumbled totally unbalancing its rider passing the 900 Metres and he further shifted 'in' and caused interference to FIERCE FIGHTER (A.Imran Khan) approaching 700 Metres.

Jockey S. Imran was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey S. Imran and after viewing the CCTV decided to charge Jockey S. Imran for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to S. Imran with effect from 1st January, 2021 to 25th January, 2021 (both days inclusive) as he had pleaded guilty of the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount AEROSPEED (he was permitted to ride work) and was informed of his right to appeal.

Jockey S. Imran, the rider of AEROSPEED was reprimanded for not wearing the goggles during the race.

It was reported after the race that NERVA (M. Prabhakaran) burst its blood vessels (Endoscopy - Grade IV) and also sustained bleeding cut injury on right fore outer bulb. Trainer Mr.Neil Darashah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that PHOENIX REACHED (Akshay Kumar) burst its blood vessels. Trainer Mr.M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g ANAKIN.

2nd Race: 58. The Atmanirbhar Bharat Plate - (About) 1200 metres. Maiden Horses 3 years old only. (9 Runners).

COMPLIANCE (Naveen M.) was extremely fractious while being loaded and was stuck on its left flank inside the gates for considerable period of time. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Prasanna Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ENCOUNTER (Arshad Alam) after jumping out swerved towards the left and lost few lengths at the start. In view of its behaviour, Trainer Mr.V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that GLENARY (Yash Narredu) shied inwards from PERFECT PERFECTO (Anjar Alam), thereby inconvenienced IRONIC HUMOUR (Ryan Marshall) before passing the red marker post.

Jockey Akshay Kumar, the rider of WAR SONG was fined Rs.1,000/- for shifting 'in' and tightening OCEAN DUNES (S. John) on his inside passing the 800 Metres.

PRICELESS GOLD (Suraj Narredu) sustained bruise on right hind fetlock.

Routine Sample was taken for analysis from the winner b g PRICELESS GOLD.

3rd Race: 59. The Jog Falls Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35, 4 years old and over (Whips not allowed) (14 Runners).

PASTICHE (Ashok Kumar A.) stopped galloping fluently passing the 1000 Metres and ran detached thereafter. In view of its behaviour, Trainer Mr.Aravind G. was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SHE'S SUPERB (Rayan Ahmed R.) was slightly slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Kishan Thomas was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

PERFECTGOLDENERA (Irvan Singh) jumped awkwardly outwards and inconvenienced UNIFIER (Manish R), which in turn passed it onto REVAN STAR (A.R.Pradeep) on its inside soon after the start.

Jockey Prashant P.Dhebe, the rider of LIGHT OF LOVE reported that his mount accidentally stumbled passing the 250 Metres.

Jockey Nazerul Alam, the rider of CELESTIAL HIGHWAY was fined Rs.3,000/- for not making sufficient effort on his mount during the race.

LIGHT OF LOVE (Prashant P.Dhebe) sustained bleeding injury on right hind fetlock.

Routine Sample was taken for analysis from the winner b g ULTIMATE STRIKER.

4th Race: 60. The Bold Majesty Plate - (About) 1400 metres. Horses rated 30 to 50 (14 Runners).

RIVERS OF BABYLON (N. B. Kuldeep) jumped awkwardly inwards and inconvenienced JOHNNY BRAVO (Y. S. Srinath) on its inside soon after the start.

Jockey Akshay Kumar, the rider of REALIA reported that his mount was grabbing the bit on the right side throughout the race as such he had considerable difficulty in riding out his mount in the straight. The horse was subjected to veterinary examination but no abnormality was reported.

It was reported after the race that JAIN SAHAB (Shamaz Shareef) pulled up lame on right fore. Trainer Mr.M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

STROKE OF GENIUS (Prashant P.Dhebe) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g WHIZZO.

5th Race: 61. The Hampi Plate - Div. II - (About) 1200 metres. Horses rated 30 to 50, 4 years old and over (13 Runners).

Jockey G Sai Vamshi replaced the indisposed Jockey Kiran Rai. P on YERWAZAN.

YERWAZAN (G Sai Vamshi) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Pradeep Annaiah was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SHE'S INNOCENT (Chetan Kalay S.) jumped awkwardly inwards and inconvenienced SCHAFENBERG (IndraJeet Singh) on its inside at the start.

Jockey Ryan Marshall, the rider of ACEROS was reprimanded for shifting out and inconveniencing SEA OF CORTEZ (Y.S. Srinath) on his outside passing the 150 Metres.

An enquiry is being held into the improved performance of ON THE TROT, trained by Mr. Arjun Mangalorkar and ridden by S. John in the above race as compared to its previous run in Race No. 44 i.e., The December Plate (About) 1200 Metres, Horses rated 30 to 50, run on 3rd December, 2020 where it ran unplaced.

Routine Sample was taken for analysis from the winner ch c ON THE TROT.

6th Race: 62. The Bangalore 2000 Guineas(Grade II) - (About) 1600 metres. 3-year-old Indian Horses (Foaled in 2017) (11 Runners).

CAVALLINI (C.Umesh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Irfan Ghatala was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey A. Sandesh, the rider of MANIFEST was reprimanded for shifting out and inconveniencing CAVALLINI (C.Umesh) on his outside approaching 500 Metres.

It was reported after the race that MANIFEST (A. Sandesh) pulled up lame on left fore. Trainer Mr.S. Ganapathy was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr. S.S. Attaollahi was questioned with regard to performance of his charge LAGARDE in the above race as compared to its previous race in Race No.22 of Bangalore Winter Meeting 2020-21 run on 14th November, 2020.

The trainer stated that:

- a) He had instructed the rider not to break its stride during the race as it was a big made horse and do his best in the straight;
- b) His charge had pulled up lame in its previous run;
- c) When he had scoped his charge after its previous run, it was found to have displaced its soft palate;
- d) The private veterinarian had advised him to use a Cross Nose Band on his charge due to the soft palate displacement; as such he opted to use a Cross Nose Band on his charge;
- e) His charge was supposed to run in a Mock Race on the 3rd of December, 2020, but the Mock Race got cancelled;
- f) As such he changed the work pattern and gave his charge more number of open canters keeping in mind the soft palate displacement and it had worked very well with Jockey Suraj Narredu in the final work out; and
- g) His charge weighed 7 kilos lesser than its previous start.

His explanations were noted for future reference.

7th Race: 63. The Hampi Plate - Div. I - (About) 1200 metres. Horses rated 30 to 50, 4 years old and over (14 Runners).

Jockey Y. S. Srinath, the rider of THE CORPORAL reported that he accidentally lost his whip approaching 150 Metres.

PROPINE (Arshad Alam) was subjected to veterinary examination but no abnormality was reported.

Jockey Naveen. M, the rider of THE RESPONSE reported that his left foot got hurt in the starting gates.

Routine Sample was taken for analysis from the winner b g ALEXANDRE DUMAS.

8th Race: 64. The Jog Falls Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35, 4 years old and over (Whips not allowed) (13 Runners).

Jockey A.R.Pradeep replaced the indisposed Jockey Kiran Rai. P on MR HUMBLE.

As Jockey Naveen .M was certified medically unfit to ride after his ride in the 7th race and as no suitable substitute rider was available. Permission was granted to trainer Mr. Sharat Kumar to withdraw ARMIN from the above race.

GREEN CHANNEL (Arul J.H) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Inayathulla was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey S.Mubarak, the rider of CAESARS PALACE was reprimanded for not wearing the goggles during the race.

Jockey Naveen Kumar. V, the rider of DONTBREAKTHERULES reported that his mount was hanging out after entering the straight. Trainer Mr. Azhar Ali was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b f GREEN CHANNEL.

Permission was granted to trainers Mr. Pradeep Annaiah to deputize on behalf of trainers Mr. Faraz Arshad who was unable to attend the races.

After deliberations, the Stewards decided to fine Jockey A. Ashhad Asbar a sum of Rs.5,000/- for Unsatisfactory Riding of his mount TWINKLE FEET in the above race.

Horses rated 00 to 20.

Detection of prohibited substance in the urine sample of b.m SHIVALIK SHOW.

The Stewards of the Bangalore Turf Club Ltd. at their meeting held on Saturday, 19th December, 2020 considered the Charge Sheet No. 682 dated 11th November, 2020 issued to Trainer Mr. Azhar Ali by Stipendiary Steward pertaining to the positive finding of **PHENYLBUTAZONE AND OXYLPHENYBUTAZONE** which is classified under (Class - IV) - prohibited substances in the urine sample taken from b.m SHIVALIK SHOW after it placed First in Race No. 128, **The Saddle Up Cup - Div. II - (About) 1200 metres. Horses rated 00 to 20**, run on Sunday, 26th January, 2020. The horse trained by Mr. Azhar Ali and owned by M/s. Nirmal Singh and S. Thiruppathy.

The Stewards examined trainer Mr. Azhar Ali and after deliberations decided to fine him a sum of Rs.20,000/- (**1st infringement**) for contravention of Medication Rules in respect of his charge **b.m SHIVALIK SHOW** as contained in BTC Calendar Notification under the heading "Medication and treatment of horses in Training and Racing and Anti-Doping Control" reading as follows:

"The trainer is always responsible for the protection and security of the horse in his care. The trainers are warned that they will be held responsible if an examination of a horse, results in the finding of any prohibited substances"

He was informed of his right to appeal.
